On 9/2/59 SUZAN RYAN had apparently run away from the supervision of the Catholic Children's Home and was located in Alton, Illinois, with a Mrs. MARY MAHER.

On 8/31/59 SUZAN RYAN was located with her mother, 1209 East Fourth Street, Alton, Illinois, where the mother lived under the name of BERNES. Apparently at one time the mother had resided at a home in St. Louis that was condemned at which time she had moved to Alton, date of the move or other information not shown.

The file contained information that JAMES RYAN resided at 1913 Hickory Street, St. Louis, Missouri, or 1727 South Eleventh Street, St. Louis, Missouri, where he lived with CAROL RYAN. The file did not indicate whether this was the father or son, JAMES RYAN.

The file contained a letter dated 3/30/60 that JACK was going to Chicago and that he had been held "for those licenses".

The file showed that MELBA RYAN, CAROL RYAN, and FRANKLIN RYAN were born in St. Louis County, Missouri, and SUZAN and [REDACTED], Quincy, Illinois.

On 8/9/55 MELBA MARIE RYAN was committed to the Jacksonville State Hospital, Jacksonville, Illinois, and custody of RYAN taken from GEORGE PARSONS and given to the Illinois Youth Commission. Judge SCHOLZ advised that apparently at that time MELBA MARIE RYAN had attempted to set fire to the PARSONS' home. He stated that this had been kept quiet by PARSONS and was not known generally.

On 6/13/56 CAROL RYAN was declared a delinquent for wandering about the streets at night without lawful business and also since her mother LUCILE RYAN was declared a depraved person.

Judge SCHOLZ advised that this was due to LUCILE RYAN soliciting prostitution date for CAROL RYAN. He advised that LUCILE RYAN had worked as a prostitute during most of her life and that the area around 214 Spring Street was an area infested by houses of prostitution at the time of the RYAN/RAY family lived in that area. He stated that there had been testimony that LUCILE RYAN had attempted to solicit prostitution dates for herself in a tavern and when she was unable to find any dates had brought in her fourteen year old daughter, CAROL, and attempted to obtain prostitution dates for CAROL.

On 8/6/57 MELBA MARIE RYAN was granted a discharge from the Jacksonville State Hospital.

On 10/24/57 custody of FRANKLIN RYAN and SUSAN RYAN was given to the Catholic Charities of Springfield, Illinois.

A notation was contained in the file that on 7/57 LUCILE RYAN moved to St. Louis, Missouri, and was residing at 1135 South Tenth Street, Apartment 8, St. Louis, Missouri.

At that time the father of the RYAN children, GERALD RYAN or GERALD RAY, was residing at 4149 West Pine Street, St. Louis, Missouri.

The file contained information that [REDACTED] in County Court, Sangamon County, Illinois, on [REDACTED]

On 6/30/60 a letter was addressed to the Court from Mrs. JENNY RAYNES from St. Louis, Missouri.

Judge SCHOLZ advised that apparently this would be a woman living with the father of the RYAN children.

On 128/60 JERRY RAYNES was shown residing at 1727 South Eleventh Street, St. Louis, Missouri; his DOB was shown as 11/24/1899, and employed by J & R Auto Sales, St. Louis, Missouri. At that time he was living with daughter, CAROL RYAN, DOB 1/30/41, who was employed by the Kresge Company in the St. Louis area.

At this time JERRY RAYNES gave JACK RANDOLPH, 5901 South Broadway, St. Louis, Missouri, as a reference. The file showed that JACK RANDOLPH was the owner of J & R Auto Sales and that RAYNES was employed as a car salesman on a used car lot for RANDOLPH.

The file showed that custody of FRANKLIN D. RYAN was given to his father JERRY RAYNES, 1727 South Eleventh Street, St. Louis, Missouri, on 3/30/60.

Judge SCHOLZ advised that FRANKLIN D. RYAN had died in approximately 1962 or 1963 when an automobile in which he was riding drove into the Mississippi River in West Quincy, Missouri. He advised that any records concerning the death of FRANKLIN D. RYAN would be in Missouri.

Judge SCHOLZ advised that FRANKLIN D. RYAN was also known as BUZZY RYAN and that possibly some people would not know the true name of FRANKLIN D. RYAN.

The file showed that FRANKLIN D. RYAN was first declared a dependent on 9/8/52 and at that time was residing at 214 1/2 Spring Street.

Included in the FRANKLIN D. RYAN section of the dependency records was a letter dated 3/29/59 from LUCILE RYAN, his mother, who at that time was residing at 1913 Hickory Street, St. Louis, Missouri. In the letter she stated that "JIMMY is going to Chicago". The letter indicated that at that time JIMMY was residing with LUCILE RYAN at 1913 Hickory Street, St. Louis, Missouri.

The file contained information showing that before 9/24/59 Mrs. LUCILE BERNES, aka LUCILE RAY and LUCILE RYAN resided 1209 East Fourth Street, Alton, Illinois, and that she had moved from that address to 1913 Hickory Street, St. Louis.

A notation was contained in the file that one 8/20/59 LUCILE RYAN's son, JAMES EARL RAY, and an accomplice JOSEPH ELMER AUSTIN were arrested for an armed robbery of a supermarket in Alton, Illinois, and that this matter was pending in Circuit Court, Madison County, Illinois.

The file contained a section concerning JERRY W. RYAN, DOB 7/16/35. He was declared a delinquent on 3/10/50 for unlawfully growing up in idleness and crime and was to be sent to St. Charles Boys' Reformatory, St. Charles, Illinois.

At that time his father was GERALD RYAN, 214 Spring Street, Quincy, Illinois, and mother, LUCILE RYAN, at same address.

Psychological tests given JERRY W. RYAN at that time showed he functioned between a low, average and dull in intelligence.

The file showed that SUZAN RYAN, aka SUSANNE RYAN, DOB 4/28/47, had been a ward of the court from 9/8/52 until 4/15/65 when she was discharged from the supervision of the court.





CARL DRAKE, a self-employed contractor, 2934 St. Vincent, St. Louis, Mo., home phone PR 6-3540, was located and interviewed by SA WALTER C. JOHNSON on 4/29/68, and stated while an inmate of the Missouri State Penitentiary (MSP), he became acquainted with JAMES EARL RAY who was incarcerated in either 1960 or 1961, and subsequently became close friends until DRAKE's release in June 1965. Their main association was while they both walked together in the prison yard and DRAKE feels he became as close a friend to RAY as anyone at the prison. He described RAY as "a loner, close-mouthed" who kept his own council and did not even consult him prior to RAY's unsuccessful attempt to go over the wall by the use of a ladder. RAY had very few friends, however, he mixed well with other inmates, both black and white, and had never showed any propensity for violence or appeared to be a racist.

DRAKE pointed out there were several instances of racial trouble at the penitentiary but RAY never seemed involved or expressed his feelings in the matter.

RAY often mentioned that he could not do his 20-year sentence but never indicated any escape plans or any contacts with outside individuals. RAY's brother, JACK RAY, from St. Louis, Mo., was the only member of the family he mentioned and believed JACK averaged visiting RAY about once a year at the penitentiary. He vaguely recalled RAY mentioning he had another brother killed in an auto accident. He did not discuss his general background other than mentioning on several occasions he had previously done time at Menard Prison, Chester, Illinois.

RAY was not addicted to use of drugs, however, DRAKE said nearly all inmates "fooled around" with anything they could get their hands on. DRAKE said about two weeks after his release in June 1965, he visited JACK RAY upon the request of JIMMY, and that was the last time he saw JACK. Their conversation concerned primarily JIM's welfare at the MSP.

DRAKE had not heard of JIM's escape and presumed he was still in prison until the recent publicity.

DRAKE regards RAY as a small-time robber mentally incapable of planning the assassination of Doctor MARTIN LUTHER KING without additional intelligent guidance from some other source. He believes RAY may be capable of being hired for this but would certainly not be alone in this matter. He is also of the opinion that whoever hired RAY, that person or group, has disposed of RAY. He commented that with the "heat" on RAY and rewards advertised, it would be extremely difficult for a fellow like RAY to hide.

CARL DRAKE indicated that he would cooperate in any way he could with the FBI in the event any information came to his attention re the whereabouts of JAMES EARL RAY.

CARL DRAKE said his brother, JAMES FRANCIS DRAKE was also an inmate at the MSP and was acquainted with RAY in a similar manner. All three formerly walked the yard together and that was JAMES DRAKE's main association with JAMES RAY. CARL DRAKE, a self-employed contractor, 2934 St. Vincent, St. Louis, Mo., home phone PR 6-3540, was located and interviewed by SA WALTER C. JOHNSON on 4/29/68, and stated while an inmate of the Missouri State Penitentiary (MSP), he became acquainted with JAMES EARL RAY who was incarcerated in either 1960 or 1961, and subsequently became close friends until DRAKE's release in June 1965. Their main association was while they both walked together in the prison yard and DRAKE feels he became as close a friend to RAY as anyone at the prison. He described RAY as "a loner, close-mouthed" who kept his own council and did not even consult him prior to RAY's unsuccessful attempt to go over the wall by the use of a ladder. RAY had very few friends, however, he mixed well with other inmates, both black and white, and had never showed any propensity for violence or appeared to be a racist.

DRAKE pointed out there were several instances of racial trouble at the penitentiary but RAY never seemed involved or expressed his feelings in the matter.

RAY often mentioned that he could not do his 20-year sentence but never indicated any escape plans or any contacts with outside individuals. RAY's brother, JACK RAY, from St. Louis, Mo., was the only member of the family he mentioned and believed JACK averaged visiting RAY about once a year at the penitentiary. He vaguely recalled RAY mentioning he had another brother killed in an auto accident. He did not discuss his general background other than mentioning on several occasions he had previously done time at Menard Prison, Chester, Illinois.

RAY was not addicted to use of drugs, however, DRAKE said nearly all inmates "fooled around" with anything they could get their hands on. DRAKE said about two weeks after his release in June 1965, he visited JACK RAY upon the request of JIMMY, and that was the last time he saw JACK. Their conversation concerned primarily JIM's welfare at the MSP.

DRAKE had not heard of JIM's escape and presumed he was still in prison until the recent publicity.

DRAKE regards RAY as a small-time robber mentally incapable of planning the assassination of Doctor MARTIN LUTHER KING without additional intelligent guidance from some other source. He believes RAY may be capable of being hired for this but would certainly not be alone in this matter. He is also of the opinion that whoever hired RAY, that person or group, has disposed of RAY. He commented that with the "heat" on RAY and rewards advertized, it would be extremely difficult for a fellow like RAY to hide.

CARL DRAKE indicated that he would cooperate in any way he could with the FBI in the event any information came to his attention re the whereabouts of JAMES EARL RAY.

CARL DRAKE said his brother, JAMES FRANCIS DRAKE was also an inmate at the MSP and was acquainted with RAY in a similar manner. All three formerly walked the yard together and that was JAMES DRAKE's main association with JAMES RAY. JAMES FRANCIS DRAKE was released two years before CARL and later served time at Terre Haute Federal Prison, and was released in November 1967. CARL said his brother, JAMES, resides with his mother, OLA DRAKE, at Modesta, Ill., and is currently employed at the Valley Steel Co., Jacksonville, Ill.


