Re memorandum of SA JACK J. FISHER dated 4/23/68, reporting information from ROBERT JOSEPH TRINGALI who encountered an individual at the Stadium Club in East St. Louis, Illinois, later identified as BRIAN EVERETT GALLAGHER.

It will be recalled that available photographs of RAY were shown to TRINGALI who said definitely they did not resemble GALLAGHER.

Communication was had with the Kansas City Division which forwarded mug shots of RAY taken at the Missouri State Penitentiary, January 4, 1966. These were the photographs which were displayed on KSD-TV on the evening of April 22,1968, and were the photographs which TRINGALI desired to view again as he thought them reminiscent of GALLAGHER. Upon display of these photographs to TRINGALI, on April 25, 1968, TRINGALI said he was satisfied that GALLAGHER is not identical with RAY. He displayed the picture to his girlfriend, unnamed, who was with him when he was confronted with GALLAGHER and reports that she, too, was of the opinion that the man who identified himself to them as GALLAGHER is not RAY.

No further investigation is being conducted on this matter.
