Special Agent in Charge

RAMAGE stated that PORTER had remained in Oklahoma City from 4/19 and she had last seen him approximately 10 AM, 4/23/68. She stated that he must have left town or else he would have been in contact with her.

RAMAGE stated PORTER had told her that he had been in Cedar Rapids. Iowa and had traveled around the State of Iowa and that he had left his home in Waverly, Iowa taking with him his mother's ring which he had pawned and sent her the pawn ticket. PORTER further told her that he had been released from the MSP on 12/8/67 and that he had known JAMES EARL RAY while in the penitentiary. He stated that while in the Penitentiary that RAY had escaped from the penitentiary in a guard's uniform while he was working in the dry cleaning plant and that RAY had obtained this uniform from a guard who has since been fired. He stated that RAY and this guard were very close friends. She further stated that PORTER told her that RAY had not escaped in a bakery truck as the newspapers had reported. RAMAGE stated that she had sent a check, in February, 1968, in the amount of \$23.00 to PORTER in Waverly so that he could obtain a bus ticket to come to Oklahoma City to see her. She stated that PORTER had called her from the bus depot in Oklahoma City approximately 7:30 PM 4/19/68 and told her that he was drinking with a person who had an amputated hand at the knuckles at Winnie's Bar which is located across the street from the bus depot.

RAMAGE stated that PORTER had possibly applied for employment as machinery operator at an automatic car wash in the 4000 block of North Pennsylvania or through the Key Personnel, 110 N. Robinson or at some Mortgage and Loan Company across the street from the city library. RAMAGE further advised that PORTER had told her that he had lost his luggage in Kansas City and was currently traveling without any luggage.

Continuous and intensive investigation was conducted to locate PORTER at Oklahoma City.

On 4/29/68, PORTER was located through an Oklahoma City PCI at the Blood Plasma Donor Center, 505 West Main, Oklahoma City and was subsequently interviewed furnishing the following information:

ROBERT DALE PORTER, temporarily residing at Hudson Hotel, Oklahoma City, stated that he had been in the Missouri State Penitentiary (MSP), Jefferson City, Mo. from June or July, 1961 through 9/1/62 and again from 3/2/64 until his

release on 12/8/67. PORTER stated that upon his release from MSP, that he had gone to Waverly, Iowa to live at the residence of his mother, CLARA PORTER, 103-1/2 E. Bremer, Waverly.

PORTER stated that he left Waverly in the latter part of February, 1968 and the following is approximately his itinerary.

Waterloo, Iowa - where he remained approximately 2 days.

Des Moines, Iowa - remaining 3 to 4 days.

Cheyenne, Wy. - remaining 3 days.

Pocahontas, Iowa - over night with uncle HANS NIELSON.

Humble, Iowa - over night with uncle HANS PORTER.

Aplington, Iowa - over night where he contacted his brother-in-law's mother and brother, LOUELLA and MELVIN ACKER.

Iowa City, Iowa - remaining approx. one week. While there he pawned a man's black face ring at the Hock-Eye Pawn Shop for \$7 on 3/11/68. PORTER resided he believes at the Berkley Hotel, where the bus station is located and left town on 3/11/68.

Storm Lake, Iowa - remaining approx. 2 days.

Red Oak, Iowa - over night. Porter resided at the hotel across the street from the Police Dept.

PORTER then hitchhiked to Barstow, Calif. leaving approx. 10 AM, one day and arriving in Barstow early the next evening. This ride was with a mechanic from Marshal Town, Iowa. That same date, PORTER hitched a ride to Visalia, Calif. with a girlfriend employed at Nellis AFB, Las Vegas, Nev., arriving Visalia that evening. PORTER stayed at Visalia approximately one week and visited with his daughter, VICTORIA RAY PORTER. He stated VICTORIA is residing with a JOSIE ACOSTA PORTER who is living with a CHUCK (LNU). JOSIE, PORTER's ex-wife, resides at 124 N.W. 1st, Visalia.

PORTER then spent two or three days hitchhiking to Nevada where he stayed over night.

Las Vegas, Nev. - where PORTER stayed at the McDonald Hotel, approximately 3 nights.

Salt Lake City - remaining 2 nights.

Laramie, Wy. - remaining one night.

Denver, Colo. - where PORTER visited with a BETTY LOU LUCAS, 3626 Perry Street.

PORTER hitchhiked from Denver to Colorado Springs, Colo. with a PHILLIP E. MEHL, 432 W. Bijou, where he remained for 2 or 3 days.

Albuquerque, N.M. - PORTER resided at Albuquerque for 2 to 3 days and contacted a ROSE SINKEY, who formerly resided in Waverly, Iowa.

Las Cruses, N.M. - PORTER spent approx. 2 days traveling from Las Cruses to Van Horn, Texas where he resided at the only hotel in town over night.

Fort Worth, Texas - PORTER resided for approximately 2 days at a cheap motel located near the bus depot.

Durant, Okahoma - residing over night.

McAlester, Oklahoma - PORTER resided with a couple that live behind a cab stand for two days.

Canadian, Oklahoma - residing one day, while there PORTER helped an individual paint 55-gallon oil drums for use on his boat dock.

PORTER then went to Miami, Oklahoma where he resided one night at the St. James Hotel.

PORTER traveled by bus from Miami, Okahoma to Carthage, Missouri stopping for approx. one hour in Joplin, Mo. While in Joplin, PORTER attempted to contact a ROGER ZINN, a former convict but stated he was unable to do so. PORTER stated that he recalls while waiting in the bus depot that he heard of the assasination of MARTIN LUTHER KING.

While in Carthage, PORTER contacted a BETTY ELLIOTT, 901 Fulton St., while attempting to contact a girl he had known in 1947.

PORTER traveled to Warsaw, Mo. staying overnight. While in Warsaw, he contacted a JACK LANPHERE by telephone and stated he wanted to see LANPHERE, that he wanted to borrow money from him. LANPHERE advised that he was unable to get into town because of his parole status.

PORTER traveled to Columbia, Mo. where he was a sleeper at the Police Dept. and the next day contacted an uncle, MARION MURRAY, 102 Thistledown Dr., Columbia.

PORTER then traveled to California, Mo. and attempted to locate a LEWIS BARGEON who had been in the MSP Maximum Security with PORTER. He was unable to contact him but stayed overnight at California, Mo:

PORTER then traveled to Maysville, Mo. where he resided at the Lincoln Hotel overnight and contacted Sheriff O. L. Maddox.

St. Joseph, Mo. - PORTER checked in at a small hotel but met a person, name unrecalled, in a bar and they then went to Kansas City, Mo. by car and stayed at the Gladstone Hotel. PORTER met with a MIKE COX at a bar on 9th St. in downtown, Kansas City, Mo. While with MIKE COX, he and COX drove on a Sunday to St. Louis, Mo. attempting to contact a LAWRENCE MOBLEY, a former convict described as a large Negro male. They were unable to contact MOBLEY. They contacted a Mrs. RICHARD PESEK, a sister-in-law of BETTY REITTER, the mother of a illegitimate son of PORTER by the name fo THOMAS DALE REITTER.

COX and PORTER returned to Kansas City that evening which he believes was a Sunday.

PORTER then traveled from Kansas City to Oklahoma City hitching a ride with two young boys from Peculiar, Mo. PORTER stated he believes that this was on 4/19/68. PORTER resided with a CARMEN RAMAGE, 1642 N.W. 12th, Oklahoma City until approx. 4/23/68 when he left hitching a ride with a Naval Lieutenant to Long Beach, Calif.

PORTER stayed one day in Los Angeles at the bus depot and left Los Angeles on Friday.

PORTER arrived Oklahoma City Saturday night 4/27/68 where he stayed with a LLOYD HISE, 2728 N.W. 39th.

On 4/28/68, PORTER drove HISE and his pickup truck to Ft. Smith, Ark. and hitchhiked back arriving approx. 1 PM.

PORTER stated that while incarcerated in the MSP, that JAMES EARL RAY known to him as JIMMY RAY was involved in selling amphetamines to his fellow inmates. He stated that a JOHN STOUT, an ex-guard in the MSP was his source of these amphetamines. PORTER stated that STOUT and RAY were very good friends.

PORTER stated that RAY was extremely quiet, was a person who did not take much from anyone. He stated that to his knowledge RAY has taken amphetamines but had never taken any hard narcotics.

He further stated that whenever RAY was pushed around that he would retaliate fiercely. PORTER stated that on two previous occasions RAY had attempted to escape from the MSP - once by going over the wall and once when he hid in a ventilator shaft and subsequently broke his elbow. PORTER stated that RAY had never mentioned to him where he was from or where he would go when he got out of prison.

He further stated that RAY had never indicated that he disliked Negroes and to PORTER's knowledge was even associated with several while in the penitentiary. PORTER stated that he was leaving Oklahoma City on 4/29/68 and was hitchhiking to the home of his mother in Waverly where he would obtain work as a construction worker.

RAY EUGENE WARREN was received at the MSP on June 9, 1955, to serve a 10 year sentence on charge of robbery first degree by means of a dangerous and deadly weapon under court case #1941-C. He completed this sentence and began an additional 20 year sentence on July 11, 1961, on charge of robbery first degree by means of a dangerous and deadly weapon, court case number 1945-C. He was assigned MSP number 69963. WARREN was discharged by commutation of sentence from April 13, 1968. Relatives listed on WARREN's correspondence and visiting list are wife DORIS WARREN, 3330 Sims, St. Anne, Missouri; brother-in-law BILL SCOTT, same address; sister, BETTY WARREN, Route 2, Box 187, Robertson, Missouri. Records reflect that WARREN was visited by his mother and brother, PAUL WARREN, Robertson, Missouri, and brother, SCOTT WARREN, Pomona, California. While WARREN was in the MSP, he was in the following cells:

From November 6, 1959, until January 4, 1960, G70; From January 4, 1960, until July 1, 1960, G89; From Jly 1, 1960, until August 31, 1960, C20; From August 31, 1960, until October 31, 1960, E80; October 31, 1960, until January 6, 1961, E33; January 6, 1961, until March 17, 1961, F96. KC 44-760 2

Warden HAROLD SWENSON advised confidentially that WARREN had assisted his department in an investigation which had been conducted and that from November, 1965, until after JAMES EARL RAY escaped from the MSP, that WARREN was in solitary confinement being given maximum security for fear of his life. Warden SWENSON continued that if at all possible, WARREN should not be contacted as he is extremely nervous and fearful for his life. However, Warden SWENSON advised that WARREN is to be living with his brother, SCOTT L. WARREN at 17902 Edmond Place, Covina, California.

SINCE WARREN WAS SENTENCED TO THE MSP FOR A TOTAL PERIOD OF 30 YEARS ON CHARGE OF ROBBERY WITH A DANGEROUS AND DEADLY WEAPON AND IS EXTREMELY NERVOUS, HE SHOULD BE APPROACHED WITH CAUTION AND POSSIBLY CONSIDERED ARMED AND DANGEROUS.

Mrs. JONES advised it is her opinion that RAY EUGENE WARREN is not identical with JAMES EARL RAY, as none of the photographs of RAY displayed to her appeared to be identical with RAY EUGENE WARREN.

She advised that on the night of 4/21/68 or early morning of 4/22/68 her husband was awakened by the dogs barking outside the farm residence which is located up a farm lane one-half mile from the main rural road. She advised her husband and her father, E. P. CARMICHAEL, upon making a search of the outside area, found that the STRADER's 1967 Oldsmobile Delta "88", cream colored with black vinyl top, had been broken into. Mrs. STRADER advised nothing was missing from the car and no one was located or seen in the area. Mrs. STRADER advised her husband left alone from the CARMICHAEL residence on the morning of 4/22/68 en route Detroit, Michigan.  Mrs. STRADER advised that in a short period of time,

STRADER stated he had found a note in the recessed area of the speedometer of his car. (Mrs. STRADER pointed out that the speedometer has been broken; therefore, her husband was not normally attracted to the speedometer). She related this note was made up of words cut from newspapers and pasted on the back of a pocket calender (unable to describe the calendar). Mrs. STRADER said the note read in substance. "If you go to the police or the FBI you will be killed." Mrs. STRADER advised her husband, after returning with the note, proceeded en route Detroit, Michigan, and after a short period of time had elepsed, he telephonically contacted her, stating he was at the Holiday Inn, Bloomington, Illinois. Mrs. STRADER stated her husband informed her that upon reaching the road one mile north of the CARMICHAEL residence, and Route 66, he saw a 1966 or 1967 Chevrolet, tan in color, no license information, with two men in the car, parked along the road. Mrs. STRADER stated her husband told her that this car followed him en route Bloomington. However, they did not turn into the Holiday Inn when he did. Mrs. STRADER advised her husband then told her he was proceeding on to Detroit, Michigan,

Mrs. STRADER advised upon discussing above with her parents, her mother, Mrs. E. P. CARMICHAEL, stated she had noticed a late model, tan car, making several trips on the main rural road near the CARMICHAEL residence on the early morning of 4/22/68.

Mrs. STRADER advised that on the night of 4/22/68 her husband telephonically contacted her, but he would not disclose his location as he stated he was afraid to mention his location over the phone. She related her husband told her that he stopped at a rest stop area after leaving Indianapolis, Indiana. Upon leaving his car and walking the direction of the men's restroom, he saw a tan automobile occupied by two men driving very slow. He stated at this time the rider in this automobile fired a shot at him. STRADER told his wife the shot just missed his ear and he, STRADER, hit the ground where he laid as if he had been hit. STRADER stated that the tan car disappeared and he has not seen it since.

Mrs. STRADER stated her husband believesthis action was due to his being in the men's restroom at the Gulf Truck Stop, Lebanon, Tennessee, on 3/27/68, where he allegedly overheard five men planning to kill Dr. MARTIN LUTHER KING, JR. Mrs. STRADER stated her husband told her that one of the men in the restroom was RAY, whom he recognized after RAY's photograph was published. She stated he further informed her that he would be able to recognize the other men he saw in the restroom. Mrs. STRADER advised she recalls being at the Gulf Truck Stop at Lebanon, Tennessee, on 3/29/68. She stated upon their leaving the truck stop, her husband did not mention to her anything of hearing of the plan to kill KING. She stated she does recall her

husband remarked, "If King goes back to Memphis he will be killed." Mrs. STRADER advised her husband did say he wanted to see CARL STERN of NBC, Washington, D.C, whom he knew but did not state why he desired to see STERN.

Mrs. STRADER advised her husband returned to the CARMICHAEL residence at Lexington, Illinois, on Friday, 4/26/68, where he stayed until the morning of Saturday, 4/27/68, at which time STRADER and his mother-in-law had an argument over Mrs. STRADER's son by a previous marriage. Mrs. CARMICHAEL told STRADER to leave, which he did.

Mrs. STRADER stated she told her husband she had contacted Mr. DONALD T. SULLIVAN, Assistant Special Agent in Charge, Springfield Office of the FBI, and that he, STRADER, should call Mr. SULLIVAN and set up an appointment; that Mr. SULLIVAN had informed her he would make an appointment to meet STRADER at any location or at any time when STRADER was available. Mrs. STRADER stated her husband told her he was afraid to attempt to meet with FBI Agents, as he felt he was being followed. Mrs. STRADER stated she was unable to convince her husband to make arrangements for a meeting with the FBI. She advised her husband is very much interested in obtaining protection.

Mrs. STRADER advised of some of her husband's activities, which are not concerning the murder of Dr. KING. She advised that she does not know all of her husband's business and that she is sure he has not told her all he knows.

Mrs. STRADER advised her husband is acquainted with RAYMOND STARNS of Baton Rouge, Louisiana, who told STRADER in the summer of 1967 that there were several businessmen in the area of Baton Rouge, Louisiana, who were taking up a collection to obtain money to have KING assassinated. Mrs. STRADER advised her husband is well acquainted in the Baton Rouge and Denham Springs, Louisiana, area. She stated he was, in the summer of 1967, connected with the E.C./Donnell Construction Company of Denham Springs, La., which was doing construction work for the telephone company. She related E. C. DONNELL lives in Dallas, Texas. She related DONNELL had an equipment rental business and while STRADER and DONNELL were attempting to rent the equipment they were trying to gain financing for a recreational park in Louisiana similar to "Six Flags Over Texas." She related that some way they came in contact with a CHARLES and LILLIAN SHAPIRO (ph) of Miami, Florida, who advised they could finance same but were not interested, in a recreational park but would be interested in financing a Horse racing track. Mrs. STRADER advised Mr. DONNELL obtained RAYMOND STARNS to help locate his land which could be used as a Morse racing park. He also obtained sanction of the sheriff, (FNU) IRWIN and SAM BOSKO, both of Slidell, La; however, "things got out of hand" and an article

appeared in "Life" magazine, and the Governor of Louisiana placed a stop to the entire operation.

Mrs. STRADER advised her husband is in telephonic contact with her daily but declines to furnish information as to his location over the telephone, as he is very afraid. Mrs. STRADER was advised to inform her husband if he has any information he desires to furnish to the FBI, he can contact any FBI Field Office, who will then arrange for an interview with him.

For information receiving offices, Inspector THOMAS E. BISHOP, SOG, on 4-24-68 advised he had received a telephone call from CARL STERN, Washington, D. C., NBC Office, who told him that a man (FNU) STRADER, whom he had met on one occasion while covering a story in the South, had, on 4-24-68, telephoned him from someplace around Toledo, Ohio. STRADER informed him he was en route to the home of his wife's parents in Lexington, Illinois. He then told STERN a "fantastic tale" about him, STRADER, overhearing a conversation on 3-29-68 in Lebanon, Tennessee, concerning the killing of MARTIN LUTHER KING. Apparently STRADER was of the impression that the people involved in the conversation knew he had overheard them, and they had taken his license number. STRADER believed there had been at least one shot fired at him since that time. STRADER informed STERN he had vital information concerning KING's murder and called STERN for advice as to what he should STERN advised STRADER to call the Springfield Office of the FBI and they would make arrangements to have someone meet him at his convenience in their territory. According to Mr. STERN, BISHOP stated that STRADER is afraid to approach any office and may desire to have someone meet him at a location other than an office.

The files of the Springfield Office contain the following references to ROBERT STRADER, however, it cannot be determined at this point whether or not they refer to ROBERT HOOD STRADER of Lexington, Illinois:

On 11-19-65 ROBERT STRADER, 6'1" - 2", 175 lbs., employed cutting timber near Edwardsville, Illinois, and in construction work at Southern Illinois University, Edwards-ville, Illinois, was considered a suspect in the robbery of the Hamel State Bank, Bufile 91-20560. SIfile 91-2642.

In 10-66 prosecution of ROBERT H. STRADER was declined in an ITSMV matter which involved a rental car. ROBERT H. STRADER had represented himself as an employee of General Telephone Co., of Illinois, registering at two motels at Bloomington, Illinois, and had skipped without properly checking out and without paying for his room. SHRADER could not be located at that time but was described as a white, male, 35 - 40, 5'10" - 6', 150 lbs., dark brown hair, medium build and medium complexion. He was subject of SIfile 26-29006.

One ROBERT HOOD STRADER was subject of an ITSMV; UFAP - AUTO THEFT case in which Milwaukee was 00,9/63, Bufile 26-316708, SIfile 26-23403. This individual had a rather extensive arrest record dating back to 11/48 at which time he was AWOL and which involved record of arrest for issuing worthless checks, mail fraud, investigation of forgery, and defrauding an innkeeper. ROBERT H. STRADER whose FBI No. was given as 244 633 A, was twice a patient at hospitals, one as a patient at the Patton State Hospital concerning which finger-prints were furnished by the State Bureau of Identification, Sacramento, California, on 8-3-60 and subsequently again on 9-21-60, was a patient at Atascadero State Hospital, California. That individual was described as white, male, approximately 6'3", 190 lbs., fair complexion, hazel eyes, brown hair and was considered to have suicidal tendencies.

A check through NCIC on 4-30-68 indicated ROBERT STRADER was not currently wanted.
