Enclosed is an Identification Order containing photographs and description of James Earl Ray, against whom a Federal warrant was issued on April 17, 1968, for conspiring to interfere with the Constitutional Rights of a Citizen (Title 18, United States Code, Section 241).

In the past, Ray was apparently neat in his dress and regularly utilized laundry and dry cleaning services. All such establishments are requested to be alert to the fact that Ray may be a current or future customer of their cleaning establishment.

Property believed to be that of Ray's has borne laundry tags of digits "02B-6" on red Thermo Seal tape and digits "20R-3" on white Thermo Seal tape. The possibility exists that similar tags may still be affixed to Ray's laundry when it is sent to other cleaning establishments.

Ray should be considered armed and extremely dangerous. If any information concerning him comes to your attention, take no action personally, but promptly notify the local Federal Bureau of Investigation office, telephone CHestnut 1-5357.

Please bring this matter to the attention of all appropriate personnel in your establishment. Your cooperation in this matter is sincerely appreciated.

On 5/9/68, PCI MARJORIE LOUISE FETTERS, 2420 Axhold Street, Camden, N.J., telephone number 609-964-4923, advised SA JOHN E. OTTO at about 3:00 p.m. on 5/8/68, JERRY RAY telephonically contacted her at her residence. He said he was calling from St. Louis, Missouri.

He stated he had telephonically contacted his employer at the Northbrook, Illinois, Country Club. His employer advised him to return to work on 5/9/68 or soon thereafter and arrangements would be made for him to begin residing in an apartment away from the club. He said his employer thought such a move could possibly avert the type of attention that was attracted to JERRY RAY by news media when they recently learned he is the subject's brother.

JERRY RAY asked PCI if it would be readily possible for him to obtain employment in the Camden, N.J., area if he decided to come there to live. He said he is strongly thinking of making such a move so he could be closer to PCI. PCI apprised him of various major industries in the South Jersey area and JERRY RAY appeared to her to be favorably impressed. JERRY RAY mentioned he had learned he would be able to receive about \$44 a week in unemployment benefits until he obtained a job should he terminate his present position at the Country Club in Illinois.

For the information of Chicago, JERRY RAY said in a letter he sent to PCI, which was postmarked on 4/29/68 at Wheeling, Illinois, he owns a 1960 DeSoto and a 1961 Plymouth. In a previous telephone conversation with PCI, he said he keeps the Plymouth at his father's farm in Centerville, Missouri.

On 5/8/68, PCI's telephone conversation with JERRY RAY was disconnected. About a half hour later, he called her at her residence again and they completed their conversation.

PCI further advised that JERRY RAY said he is going to send her \$25 enclosed in a letter or to be sent by a wire to reach her by 5/11/68. It is noted he sent PCI a \$25 money order enclosed in the described letter postmarked 4/29/68.

PCI said JERRY RAY told her he would telephonically contact her next on 5/11/68. He commented he would rather talk to her on the telephone than write her. He did not further explain this statement.

PCI again stated under no circumstances does she want her cooperation with the FBI in connection with this matter to ever become known outside of the FBI. She again also said it is a special concern to her that JERRY RAY never know of her assistance to the Bureau.
