

Mrs. DELORES WALDEN, residing 1818 S. Eighth St., St. Louis, Mo., telephone CE1-7864, employed at the Western Printing Company but on sick leave, called to report that she had seen the photograph of RAY in the Sunday paper and had come to the conclusion that she had seen RAY last Friday night in the Petite Lounge at 39th and McRee. She recalled that the individual she believes was RAY was wearing faded bluejeans and a blue and grey, long-sleeved plaid shirt. This person was standing around the piano bar with the other customers and introduced himself as BOB. She first observed him there about 9:30 p.m. and he was there when she left at 11:45 p.m. He was drinking Budweiser Beer and was by himself. He said something about having just come back from Wyoming and spoke like a "hoosier" by which Mrs. WALDEN means an individual from the country. He requested "hoosier type" songs and acted as if his feelings were hurt when the pianist did not play them. He described him as 38 years of age, white male, appeared to be of powerful build, fair complexion, light brown hair. She cannot estimate his height or weight. as she never saw him standing up.

On 4/24/68, Mrs. DELORES WALDEN, 1818 South 8th St., SLMO, was interviewed and advised that on 4/19/68, she observed a white male who resembled JAMES EARL RAY at the Petite Lounge, 39th and Blaine, SLMO, between 9:30 p.m. and midnight.

She stated the individual introduced himself as BOB, was about 37-38 years of age, average height, husky build, wearing a long sleeve plaid shirt and faded bluejeans. She said he had light brown hair cut short, combed straight back and slightly receding and had a fair complexion.

She said he stated he had just gotten back from Cheyenne, and requested hillbilly and country and western type music throughout the night. She said he spoke with a country accent and drank beer.

She says she has never seen this individual before or since. Mrs. WALDEN advised besides other patrons present were the owner, a waitress, barmaid and piano player.

Mrs. WALDEN was shown a photograph of JAMES EARL RAY and advised his face resembled the individual she saw at the Petite Lounge, but that RAY's hair was fuller and darker.

On 4/29/68, DOROTHY BOWLLN, 2727 Armand Pl., SLMO, barmaid, Petite Lounge, 1539 South 39th St., was shown a photo of JAMES EARL RAY and stated she has never see RAY in the tavern. Miss BOWLIN stated, however, that she does not work in the evenings. She advised a barmaid on weekends

She stated GUY (LNU) is separated from his wife, OPAL, and OPAL is employed as a waitress at the Black Forest Restaurant on Cherokee. Mrs. MC GEE stated the owner of the Petite Lounge is LOREN B. MARTIN. She said a waitress at the lounge is SYLVIA TEKULVE, who resides in an apartment at Morganford and Arsenal. Mrs. MC GEE stated she has never seen anyone that resembles RAY in the Petite Lounge and saw no one of that description on 4/19/68.

On 5/1/68, SYLVIA TEKULVE, 3119 Morganford, a waitress at the Petite Lounge, was interviewed. Miss TEKULVE advised she wes working on the night of 4/19/68, and saw no one that resembled a photo of JAMES EARL RAY. She said she has never seen anyone at the Petite Lounge that looks like RAY. Miss TEKULVE advised the individual known as BOB is in all likelihood GUY LANCASTER, a rodeo worker, who is married and separated from his wife. She said LANCASTER is an occasional customer of the lounge but has not been seen in the last few weeks.

LOREN B. MARTIN, 4271 Shenandoah, Apartment 203, owner of the Petite Lounge, was interviewed on 5/1/68. MARTIN was shown a photo of JAMES EARL RAY and stated he had never seen anyone in the tavern that resembles RAY. MARTIN said he was working on the night of 4/19/68, but remembers no one that looks like RAY.





Ray is also sought for unlawful interstate flight to avoid confinement after conviction for armed robbery, based on a Federal warrant issued on July 20, 1967, at Jefferson City, Missouri. He had been confined at the Missouri State Penitentiary, Jefferson City, Missouri, in March, 1960, with a 20-year sentence following conviction for armed robbery and operating a motor vehicle without permission of the owner. In September, 1966, while serving the sentence, he was confined for a time in the maximum security ward at the State Hospital, Fulton, Missouri. He was reported missing from the Missouri State Penitentiary since April 23, 1967.

Ray, who has an arrest record dating back to 1949 and has been convicted of burglary, armed robbery and forging United States Postal Money Orders, has also been confined in the Los Angeles County Jail, the Joliet and Pontiac, Illinois, State Prisons and the United States Penitentiary, Leavenworth, Kansas.

He served in the Army between February, 1946, and December, 1948, received a three-month sentence at hard labor for being drunk and breaking arrest and was given a General Discharge due to ineptness and lack of adaptability for military service.

Ray is a 40-year-old white male, reportedly born in Illinois on He is approximately 5'10" inches tall, weighs from 163 to 174 pounds, has blue eyes and brown hair which he has worn cut short. 

Warden MAX PRYE, Illinois State Penitentiary, Menard Branch, made available the prison records of JOHN EUGENE GAWRON, Illinois State Police #25261 (Joliet Penitentiary #489F). The file reflected the following background data:

GAWRON pareled from Menard on March 21, 1959, to Veterans Administration Hospital,

Wood, Wisconsin. He remained there three days and left without permission. GAWRON carried at that time in an absconder status until November 16, 1961, when he was returned to Menard Penitentiary. He was paroled on April II, 1963, to the Soldiers and Sailors Home, Quincy, Illinois, but was never received at this home. GAWRON's address as of April, 1968, was shown as 1807 South 11th, St. Louis, Missouri.

This inmate was classified as a doubtfully improvable offender with delinquent attitudes and lack of initiative and ambition. His criminality appeared to be related to his alcoholic tendency. He was recently examined when he wrote a request for transfer to Elateville because of problems of ill health. He claimed that he was disabled in the World War and that his ear drums were ruptured. He now complains of head pains and discharging ears. He feels, rather vaguely, that larger, dryer cells at Stateville would be more conducive to good health. His conduct within the Old Prison has been satisfactory. He has been punished on only two or three occasions. He has a fairly good attitude toward his employment. shows no evidence of mental disease. Under the new policy he should be classified for Stateville since it is likely he will have to serve a number of years within the institution. In the interests of his general health and to further the present classification policy, resegregation is recommended.

Continued medical treatment for the ear condition and work in a dry, inside place is suggested.

BEHAVIOR ON PAROLE

This 62 year old white man was paroled from Menard on 3-21-59 to a Veteran's Administra-

tion Hospital at Wood, Wisconsin, but remained there only three days and then left " without permission. He now says, "I got loaded up on liquor and goof balls, and when I came to I was in the Union Station at Chicago and found I had a ticket to St. Louis so I just went on to St. Louis and stayed there." He says he lived in St. Louis during the entire time he was at large as an absconder, and lived with a cousin at a rooming. house at 1913 Hickory Street, St. Louis. He says he obtained employment, usually casual and part-time in nature, through an employment agency, and also received a V.A. compensation check amounting to \$61.00 monthly. During his last few months of liberty he also received public aid assistance. He states that on two occasions, from July to September, 1959 and again from October, 1960 to January, 1961, he was a patient at the Cochran V.A. Hospital in St. Louis because of a heart condition. Inmate says he was not arrested at any time while in St. Louis, but about 11-9-61 he and an acquaintance were picked up at Louisiana, Missouri, his identity as an Illinois violator was then discovered, and he waived extradition for return. He says this acquaintance left St. Louis to drive to Quincy, Illinois, asked inmate to go along, and he accepted. He says they stopped at Louisiana, Missouri and were questioned by police about the burglary of a supermarket in that area, but he knew nothing about that offense. Enclosed with reports from the Division of Supervision concerning this inmate is a detailed report of investigation by the Missouri Highway Patrol of the burglary, but we find nothing in this which would suggest that inmate and his companion were suspected of having any connection with the crime, and it seems evident that no charge was filed in Missouri. However, it will be noted that this episode seems to have at least some points of resemblance to the behavior which led to his return as a parole violator in July, 1956.

REVIEW OF SOCIAL FACTORS:

The Reclassification Report of 9-2-56 offers a summary of inmate's background and we would re-

fer to that report. As indicated above, he assertedly lived with a cousin who operates a rooming house in St. Louis after he absconded from his most recent parole. Although he says he was under the influence of liquor and "goof balls" at the time he absconded from parole, he claims that thereafter he indluged only in moderate drinking. He says he worked at various part-time jobs as a janitor, etc., while in St. Louis until he was placed on public relief following his release from the Cochran V.A. Hospital in January, 1961 following a heart attack. He now corresponds with his cousin in St. Louis.

PERSONALITY:

Physically, inmate's appearance suggests his advancing age, and he gives a history of two fairly. He has also been hard of hearing for a number of

severe heart attacks in recent years. He has also been hard of hearing for a number of years, and receives V.A. disability compensation. We would refer to the current medical report for further information as to his condition. Recent psychometric test indicates superior intelligence, with a score approximating that previously obtained. Temperamentally, he is a rather beaten, prisonized individual who has in the past had a history of heavy drinking during the occasional interludes when he is not incarcerated, but who claims only moderate indulgence following the binge which led to his prompt absconding from his V.A. Hospital placement. We regard him as a rather dependent institutionalized

person who has long been an outcast from conventional society and who tends to submerge himself into anonymity whenever he is confronted with the demands of a free community adjustment.

Group III: Without evident mental disorder or mental defect. Adult unimprovable offender. Superior intelligence (AGCT 115). Inadequate personality makeup. High guarded prog-

nosis.

BEHAVIOR ON PAROLE: This 57 year old white man was paroled from Joliet for the second time on

9-21-54 to placement at the Soldier's and Sailor's Home in Quincy. He renained there until March 1956, then left because he learned the police were looking for him in connection with investigation of an Armed Robbery at LaGrange, Missouri. Reports indicate that inmate had been drinking considerably while at the Soldier's and Sailor's Home, and had also been keeping company with a Mrs. Lucille Ryan, the mother of a Menard parolee, #23737 Ryan. This parolee was also arrested in connection with the armed robbery at La-Grange, Missouri, and is apparently now incarcerated in that state. Records indicate that another parolee, Menard #23686 Cain, was also arrested for questioning in connection with that investigation, but was released. Inmate says he left the home when he learned that police were looking for him, moved to a room in Quincy, and he evidently eluded investigation at that time. Although he refused to reveal where he was living, other information indicates that he was later living with Mrs. Ryan, According to his own story, he obtained employment with a road construction company after he left the home, and it would appear that his whereabouts might have been traced in this manner, had there been sufficient interest. Records indicate that a violation warrant was issued late in March 1956, and that he was then arrested by Quincy police on 6-28-56 as a burglary suspect. Cain, Menard #23686, had been arrested a few days earlier in connection with two burglaries in which inmate does not appear to have been directly implicated, although the loot was apparently taken to Mrs. Ryan's home, where inmate was staying. Cain then admitted some earlier burglaries, and implicated inmate as an associate in at least one of them. Inmate now professes rather naive innocence of any knowledge of these offenses, professes that he did not understand much of the questioning to which he was subjected following his arrest, and is evidently decided on a policy of admitting as little as possible. He does admit considerable drinking while on parole, and his technical violation in failure to send in a few reports. From present information, it would appear that there was a concerted and calculated series of criminal episodes in which two Menard parolees, Cain and Ryan, as well as at least one other associate were involved, and in which inmate was also implicated on the basis of Cain's statements.

REVIEW OF SOCIAL FACTORS:

Subject was born in Chicago on as the sixth of seven children of a

native-born mother of Polish descent and a German immigrant father. During inmate's youth the family lived in a disorderly and delinquent area on the near northwest side in Chicago. He says his father "had a political job" with the Chicago street department, and the family was evidently of limited socio-enonomic status. He now says his father died in 1930 and his mother

Inmate says he now has two living brothers, but has had Asso died in 1951. to contact with either of them for a considerable time. He claims to have completed eighth grade in public school. In February 1915 he was committed o St. Charles for stealing auto tires, apparently escaped twice, and it eems to have been during an escape from that institution that he enlisted n the Marines in May 1916. He was medically discharged from the Marines In April 1918 he was committed to Pontiac under one year n May 1917. entence for larceny. In June 1921 he was committed to Leavenworth under year sentence for altering and passing government obligations. september 1927 he was sentenced to a six month term in the Chicago House of Correction for burglary. In June 1929 he was sentenced to a 1-15 year erm at Folsom for burglary, and was paroled in December 1931. As records .ndicate, it was in November 1934 that he was originally committed to Joliet under his present 1-Life sentence, and his only period in the free community ince have been his recent parole period and one earlier parole from December المارة على المارة المارة during which he worked at the Hines VA Hospital part of the time and was eventually involved in another burglary. His civilian work history has thus been extremely irregular and casual. In previous inerviews inmate has stated that he was married in 1932 and was later divorced, out he now denies that he was ever married and says this was a common-law attachment. Leisure activities have centered primarily around drinking. immate now has no effective community attachments.

EKSONALITY: Physically inmate is an aging individual who is apparently somewhat hard of hearing, and he gives a istory of chronic ear trouble dating from his Marine service in 1916-17. He has received partial disability compensation for a considerable number of gears, and apparently is fearful of giving a history of too satisfactory mealth because he feels that this maight possible be reduced or cut off. revious psychometric tests have indicated superior intelligence, but his present reactions suggest thathe is functioning on a considerably lower evel. Temperamentally he is a rather beaten, prisonized individual wno was been incarcerated much of his life and who has no goals or constructive motivations. He has been inclined toward heavy drinking when not incarcerated, and apparently this was a problem during his recent parole period even before we became involved in more serious violations. In present interview he attempts to create as much sympathy for himself as possible, professes intocence of any serious wrong-doing, and claims to know nothing of the various new criminal charges for which he was under investigation. He now impresses is as an essentially dependent, institutionalized person who is unable to avoid involvement in criminal activity in the free community, and for whom any hope of satisfactory adjustment now seems remote.
