BRIDGEMAN DENIED EVER BEING OUT OF U.S. AND DENIED KNOWING ANYTHING CONCERNING RAY'S WHEREABOUTS. BRIDGEMAN DESCRIBED RAY AS BEING A PRETTY COOL CON WHO MANAGED TO OBTAIN INGREDIENTS, I.E., RAISINS, SUGAR, YEAST, WHICH HE USED TO MAKE INTOXICANTS WHILE AT MSP, MAJORITY OF WHICH HE SOLD TO OTHER INMATES. BRIDGEMAN EXPRESSED OPINION RAY WOULD BE CAPABLE OF MURDER BUT ONLY IF THERE WAS MONEY INVOLVED. IN ADDITION, SUBJECT KNOWN TO HAVE BEEN OWNER OF WHITE MUSTANG DURING FEB., NINETEEN SIXTYEIGHT AS IT WAS SERVICED AT LOS ANGELES ON FEB. THIRTEEN, SIXTY EIGHT. SUBJECT AS GALT WROTE LETTER DATED FEB. SEVENTEEN AS RESULT OF LOCAL SWINGERS CLUB. THIS WOULD ALSO SEEMINGLY PLACE SUBJECT IN LOS ANGELES FOR PERIOD OF INTEREST.

MEMPHIS SUGGESTS OFFICES LISTED ABOVE HOLD INVESTIGATION IN ABEYANCE UNTIL CERTAIN POINTS CLARIFIED IN REINTERVIEW OF PAUL BRIDGMAN, WHOSE RELIABILITY IS QUESTIONABLE. BRIDGMAN SHOULD BE REQUESTED TO BE MORE SPECIFIC AS TO WHEN HE MET RAY, WHERE HE MET RAY, AND WHO CAN CONFIRM PRESENCE OF BRIDGMAN IN KANSAS CITY DURING PERIOD HE CLAIMS HE MET RAY. SPECIFICALLY, WHERE DID BRIDGMAN STAY WHILE IN KANSAS CITY; WHO IS PROSTITUTE BEVERLY HILL, AND WHERE DID SHE LIVE IN KANSAS CITY. WHERE DID BRIDGMAN MEET HER? TRIED TO BE INCONSPICUOUS TO GUARDS. RUSSELL AT FARM AT TIME OF RAY ESCAPE. NO IDEA HOW ACCOMPLISHED. NO INFO OF RAY BACKGROUND. STATED OPINION SMART MAN WOULD NOT COME HOME AFTER ESCAPE. RE EX-CON PAUL BRIDGEMAN: PUSSY CAT A GO GO, SLMO, CLOSED TWO YEARS AGO. OWNER ELIAS MOHANNA CONFINED MSP. KC REQUESTED TO INTERVIEW.

EX-CON WILLIAM RUSSELL KNEW RAY SLIGHTLY MSP. RAY CLOSE MOUTHED, QUIET. NEVER MENTIONED TRAVEL OR DISPLAYED FOREIGN LANGUAGE ABILITY. USED AMPHETAMINE, BUT NOT KNOWN TO SELL SAME. NOT CLOSELY ASSOCIATED WITH ANYONE. RUSSELL AT FARM AT TIME OF ESCAPE. NO INFO RE SAME. RUSSELL RELEASED APRIL FIFTH LAST. NOT CONTACTED BY RAY AND NO KNOWLEDGE OF WHEREABOUTS.
