LAWRENCE J. BURNS of the Waldorf Laundry, Waldorf, Md., phone Butler 3-3251, telephoned WFO at 10:25 a.m. 4/12/68, stating that an FBI Agent whose name he did not recall had made inquiry of him concerning laundry markings, in connection with some case, the nature of which BURNS did not know.

BURNS stated he told the Agent that the only likely source he knew of was R. Frank & Co. in WDC. He now had an afterthought, and wanted to suggest contact with the Textile Marking Machine Company, Alexandria, Va.; the man to contact would be JOE COOMBS; their telephone number is 248-6127.

It appears likely that the above refers to instant investigation, and that BURNS was contacted possibly by an SA of the Baltimore Office, in connection with the canvass of such establishments.

It is assumed that the above-mentioned "R. Frank & Co." would be R. & E. Frank, 725 - 11th St., N. W., WDC, which firm is listed in the Yellow Pages under "Cleaners' & Dyers' Supplies," although not under "Cleaners' & Dyers' Equipment." (For info, it was observed that the yellowpages have four headings of possible interest: Cleaners' & Dyers' Supplies; Cleaners' & Dyers' Equipment; Laundry Equipment; & Laundry Supplies.)

Mr. HERBERT BRADFORD, 2722 Stanton Road, S. E., Washington, D. C., on 4/11/68, advised that he had been to Atlanta, Georgia, to attend the funeral of Reverend MARTIN LUTHER KING, JR. He arrived at about 9:00 p.m., on 4/8/68, and he stayed at the Holiday Inn, at the airport in Atlanta. Between 10:00 p.m., and midnight on 4/8/68, he saw an individual on the road who was wearing a red beard (not heavy) and his hair partially covered his forehead. He said this man was driving a foreign-make car, light blue, and it did not bear Georgia license plates. He thought the car might be a SAAB but he could not be sure. Subsequently, he saw a picture in the newspapers of the man being sought, and he recalled the man he had seen in Atlanta strongly resembled the suspect.

On 4/12/68, BRADFORD again called WFO and advised that the wished to correct information furnished on 4/11/68. He stated the correct make of the car he had observed in Atlanta was a 1960-61 blue or Alcapulco blue SAAB or similar form of car. The license plates were blue numbers on a white background, state unknown. He felt the individual he had seen strongly resembled the composite drawing of the suspected killer.

# Boston, Massachusetts April 8, 1968

#### MINUTEMEN

The following information was received from a source who claims to be familiar with activities and plans of the Minutemen:

The Minutemen had a general plan to foment civil strife by killing Negro Leaders, Martin Luther King, Rap Brown, and Stokely Carmichael and, therefore, seize power in the confusion. No specific time table set and Carmichael had least priority because he was already fomenting civil strife himself.

The Minutemen also planned to kill New York Attorney General Louis Lefkowitz and to kidnap and kill the United States Attorney in Kansas City, Missouri, for prosecution against the Minutemer and Robert B. DePugh, and Alcohol, Tobacco and Tax Unit Agencs James Moore and Frank Belliki of Kansas City, Missouri, and FBI Investigator of the Minutemen in Kansas City whom they described as elderly, short and with gray hair.

They planned to place a bomb at the door of the FBI Office in New Haven, Connecticut, after working hours, not to injure people but to cause confusion.

From time to time, the Minutemen have conducted surveillances of individuals in their offices concerning these plans. The Minutemen members in Connecticut are identified as Doctor Convard, Optometrist, Bridgeport, Connecticut, George Brown, Fire Department, Waterbury, Connecticut, Thomas Hart, Bridgeport, Connecticut, Joseph Pabiano, 272 Wall Street, Waterbury, Connecticut. The meetings are held on a farm in Naugatuck, Connecticut. DePugh has standing orders to blow up the courtroom or court house rather than let himself be tried and convicted.

This document contains neither recommendations nor conclusions of the FBI. It is the property of the FBI and is loaned to your agency; it and its contents are not to be distributed outside your agency.

#### APPENDIX

## "MINUTEMEN"

The "Minutemen" was organized in June, 1960. Its present headquarters are Norborne, Missouri. Robert B. DePugh, Norborne, Missouri, has been publicly identified as the National Coordinator of the organization. DePugh has stated the membership of the "Minutemen" to be in excess of 35,000 members, however, confidential sources state this figure is greatly exaggerated and that a more true estimate would be between 800 and 2,000 members. Statements by DePugh and literature distributed by the organization indicate its purpose to be the resistance to, and exposure of, the spread of Communist influence within the United States; for the formation of a guerrilla or underground organization to combat the troops of any foreign powers which might eventually occupy this country; and resist passage of laws which would regulate private ownership of firearms.

The Kansas City Star newspaper has on numerous occasions contained articles concerning the "Minutemen", wherein it was stated that members of the organization participate in maneuvers utilizing guerrilla tactics with machine guns, mortars, grenades, and other firearms. DePugh has publicly stated the "Minutemen" as an organization does not buy or store arms or ammunition; however, individual members are urged to maintain arms and ammunition, which is their constitutional right. "Minutemen" has given instructions in the use of explosive compounds from such readily accessible ingredients as common fertilizer, ammonium nitrate. Robert DePugh, along with his close associate Walter Patrick Peyson and Troy Haughton, West Coast Regional Coordinator, were convicted in U. S. District Court of violation of the Federal Firearms Act. All were sentenced to prison and all are free on bond pending their appeals to the 8th Circuit Court of Appeals, St. Louis, Missouri.

On October 30, 1966, the New York City Police Department arrested 19 members of the "Minutemen", charging them with "conspiracy to commit arson", and "Illegal possession of firearms". An inventory of firearms seized as a result of these arrests included 115 rifles, 26 handguns, 8 automatic weapons, 3 bazookas, 2 mortars, 1 anti-tank gun and an unknown quantity of ammunition.

## "MINUTEMEN"

In April, 1966, DePugh stated the 'Minutemen' organization was then dividing itself into two bodies: one group to be members who have been able to maintain their identity in complete secrecy from the public and government investigative agencies, and the other group to be made up of members who have been publicly identified and who will become active in the Patriotic Party. The first group will go completely underground and will continue to emphasize intelligence activities and resistance warfare training programs. The first national convention of the Patriotic Party was held July 3 and 4, 1966, at Kansas City, Missouri, with DePugh acting as chairman. About 300 individuals attended this convention. The second annual convention of the Patriotic Party was held July 2, 3, & 4, 1967, Kansas City, Kansas, with approximately 240 persons attending. DePugh resigned as National Chairman at the convention, however, he stated he would continue in an advisory capacity. The delegates, at DePugh's urging, endorsed former Governor of Alabama, George Wallace, and William Penn Patrick, millionnaire cosmetics manufacturer of San Rafael, California, as presidential and vice-presidential candidates in the 1968 elections.

CIVIL RIGHTS

At approximately 7:30 p.m., one CHARLES RUNFORD telephonically advised that he was calling from St. Elizabeths Hospital, Washington, D.C. (WDC). He stated that he resided at 1926½ 7th Avenue, North, St. Petersburg, Florida. He stated that some time last week he had called the FBI in St. Petersburg, Florida, and had been interviewed by SA CHARLES HUGHS and another Agent concerning information he wanted to furnish regarding one JAMES A. FOUNCEY of 216 South Albany Avenue, Apartment 7, Tampa, Florida. He said that he had heard POUNCEY speak of the assassination of Dr. KING approximately three weeks prior to the assassination. He said the Agents had attempted to locate POUNCEY at the above address with negative results.

RUNFORD subsequently came to WDC and attempted to bring some flowers to President JOHNSON but was denied entry to the White House by the Secret Service even though he offered to wait as long as necessary to see him. He said that he had additional information which might assist in locating POUNCEY, but he would not furnish it unless the writer would arrange an appointment for RUNFORD to see President JOHNSON or Vice President HUMPHREY. He stated he had been committed to St. Elizabeth's two days previous but had not yet seen a doctor. He said that after speaking with the doctor tomorrow, 4/15/68, he would request the doctor to call the FBI regarding his request. Supervisor REDFIELD advised him we were unable to arrange an appointment for him with the President or Vice President but would be happy to accept any information he desired to offer.

He said that agents had attempted to locate POUNCEY at the above address with negative results.

RUNFORD advised he subsequently came to WDC and attempted to take some flowers to President JOHNSON, but was denied entry to the White House by the Secret Service, even though he had offered to wait as long as necessary to see President JOHNSON. He said he

had additional information which might assist in locating POUNCEY, but he would not furnish it unless the FBI would arrange an appointment for him to see President JOHNSON or Vice President HUMPHREY. He stated he had been committed to St. Elizabeth Hospital two days previous, but he had not yet seen a doctor. He said that after speaking to the doctor on 4/15/68, he would request the doctor to call the FBI regarding his request. RUNFORD was advised that the FBI would be unable to arrange an appointment for him to see the President or Vice President, but would be happy to accept any information he desired to offer.
