Also, the Reverend Frederick Kirkpatrick, a New York coordinator for the project, had furnished Jones with material entitled "Declaration of Principle on the March in April." This pamphlet was being distributed by the "Committee of National Negro Churchmen."

Another WFO informant learned from Lafayette's assistant, Anthony Henry, that a secret meeting had been held by King's group and they had set April 27, 1968, as the date for the project to start. Henry indicated this date can be moved up or back depending on future developments.

It is felt that the President would be interested in receiving information showing the communist help King is receiving in his proposed "Washington Spring Project."

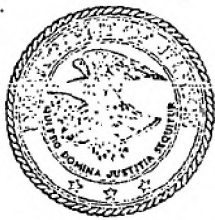

A confidential source who has furnished reliable information in the past and who holds a responsible position was available a written statement dated May 18, 1964, prepared by an investigator of that agency. The investigator will be advised that he has received information that during the early morning hours of April 27, 1964, Martin Luther King had been "laying up" with a local white prostitute and the prostitute had received \$100.00 for her services. After learning the identity of the prostitute as one Call, last name unknown, Source A met with her at 3 a.m., May 16, 1964, and obtained the following information which is set forth below as it appears in Source A's written statement:

"Call stated that about 2 a.m. on April 27, 1964 she was called by the bellman of one of the local hotels and told to go to the New Frontier Hotel and see Clara Ward, who has the Clara Ward Singers, a Negro girl group singing at the New Frontier Hotel. Call proceeded to the New Frontier Hotel and approached Clara Ward in the lobby. After introducing herself to Call, Clara Ward handed her \$100 and said 'I have a couple of friends in town that would like to meet you and have you take care of them.' Clara Ward then stated that the reason she was handing Call the money was because Clara Ward did not believe in paying a girl for her services and for Call to keep quiet about receiving any money.

"Clara Ward then took this prostitute, Gail, to the room and there they had a drink, then Clara Ward made a phone call and shortly thereafter, Rev. Martin Luther King approached them at the bar and they both accompanied him to his room in the Lorch Hotel. Clara Ward introduces Gail to the Rev. King as a very good friend who worked as a dancer in the line at the Tropicana.

Gail stated that she, the Rev. King and Clara Ward all sat down in his room and started drinking. Then and the drinks and the Rev. King started talking about his 'partner' around the country, which was a very good friend of his and he told her that a hit man the Rev. King was. After a short time drinking and talking, the Rev. King called, by phone, to another room above as he said, 'my partner is staying, sleeping off a drunk', and made to 'his partner', with the following remark, 'Don't call up a black son of a bitch but get your damn ass down to my room because I have a beautiful video board here'. He then hung up and told Gail that he, the partner, told him he would be down pretty soon.

"At this time both the Rev. King and Clara Ward stripped naked and told Gail to do the same. Gail stated that she had another drink and then stripped naked and sat down on a chair. At this time, the Rev. King went down on his knees and started nibbling on her right breast, while Clara Ward did the same with her left breast. Gail then stated, 'I mean the Reverend got tired of that and put his head down between my legs and started nibbling on that'. After a while he got up and told Clara Ward to try some of it, so Clara Ward went down on Gail for awhile. Gail stated, 'I think Clara Ward is queer'.

"The Rev. King then told Gail on the bed and had intercourse with her while Clara Ward sat by in the chair and watched the action. After a while Gail started to get a little drunk, then rolled off and had intercourse with Clara Ward. After a while she got up and went to the door. After awhile King rolled off again and about that time, King's partner, a Negro male, came

unknown, entered the room and had a drink and then returned to the invitation of King and he had intercourse with Gail on the bed while both Clara Ward and the Rev. King watched the action and the Rev. King, during the necessary breaks in the action, Clara Ward would do a little feeling and clapping of her own.

"Gail then stated that she was getting scared as they were really doing and all things really happening and at last she told Clara Ward she would have to go. Gail then told King that as Gail had to rehearse the following morning, they would

Gail's car, 'I would like to try you sometime again if I could get you away from Clara'. At this time Gail and Clara Ward had another drink at the bar in the lounge before parting company.

"Gail stated to this investigator that 'that was the worst orgy I've ever gone through' and that after the orgy later Clara Ward called her on the phone and asked her to come up to her, Clara's, room for a few drinks later in the evening, which Gail stated she refused to do."

On May 15, 1964, the following additional information was orally obtained from Source A. He stated that he contacted Gail again on May 15, 1964, and learned the following additional information from her.

Gail's full name is Gail LaRue (phonetic). She is 33 years old and married to one Harvey LaRue and resides with her husband in the Baltimore Arms Apartments, 131 Baltimore Avenue, Iron Forge. She has previously been married and has 4 children by her first marriage who are presently living in Sheridan, Wyoming.

Source A stated that he returned for a follow-up call with Gail and to inform himself that there was no further information of King. He said that Gail is absolutely certain that the circumstances along on the night of April 11, 1964, at the time of the orgy, which had a lot of people in it, he was not there. He said that he was not there at the time and that it was during the time that the Rev. King was in the room with his pleasure in the room and was alone.

Source A said that he knew very little concerning Clara Ward other than the fact that she poses as an entertainer at the El Rancho Hotel and Casino with a other female lounge singers. According to him, the rumor around Las Vegas is that Clara Ward is a lesbian.

Source A also furnished the following additional details concerning the King - Gail association as revealed to him by Gail on May 13, 1961. Gail said that when Clara Ward, King and Gail arrived at the King's suite in the Sands Hotel, King and Ward immediately started drinking gin and vodka. Within 10 minutes Gail arrived in the room, King had Gail completely disrobed. King and Ward also disrobed. King had Gail lie on the bed and King then started "fart-out this." King then called another Negro male, unknown to Gail, who was in a nearby room and told him to come in and join the party. Shortly thereafter this individual appeared and he too disrobed. King then began having intercourse with Gail and while this was occurring the other two male comrades, on the bed on his hands and tried to place his sex organs in her mouth. While King was having intercourse with Gail, Clara Ward had her hand on King's back and was touching Gail's sex organs. After King completed the intercourse the other male then had intercourse with Gail and King got on the bed on his hands and told Gail to "fart this also." The source stated that the two men continued to change places. Gail stated that she complied with this request, to "fart" the sex organs, but Source A stated she was not too emphatic in her denial.

According to Source A, Gail stated that she was in the King suite in the Sands Hotel until about 4:45 a.m. She stated that she was quite "soured" with the activities going on since King, Ward and the other Negro male were all very drunk. She said that she was actually afraid to indicate that she wanted to leave but finally was so disgusted with the activity that she did. She stated that she had agreed initially with Clara Ward that she could not stay any longer than one hour.

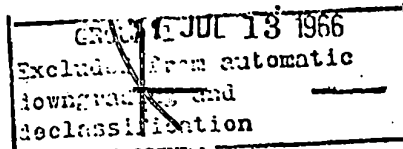

Levison has described King as

The Attorney General was contacted at his request this afternoon. He had before him our memorandum of October 7, 1963, requesting authority for technical surveillances on Martin Luther King at his residence at Atlanta and at the office of the Southern Christian Leadership Conference, of which he is president, at New York City.

The Attorney General said that he recognized the importance of this coverage if substantial information is to be developed concerning the relationship between King and the Communist Party. He said there was no question in his mind as to the coverage in New York City but that he was worried about the security of an installation covering a residence in Atlanta, Georgia. He noted that the last thing we could afford to have would be a discovery of a wire tap on King's residence.

I pointed out to the Attorney General the fact that a residence was involved did not necessarily mean there was any added risk because of the technical nature of the telephone system. He was informed that the Bureau had had years of experience in this field and that we continually reviewed our procedures to insure that every measure possible to secure such installations was taken. It was nevertheless noted that of necessity we had to deal with established contacts in the telephone company to get the necessary leased lines, but once again we had procedures which minimized the risks to the nth degree.

After this discussion the Attorney General said he felt we should go ahead with the technical coverage on King on a trial basis, and to continue it if productive results were forthcoming. He said he was certain that all Bureau representatives involved would recognize the delicacy of this particular matter and would thus be even more cautious than ever in this assignment. He asked to be kept advised of any pertinent information developed regarding King's communist connections.

The following is a brief summary of information in this Bureau's files concerning Abner W. Berry, Aubrey Williams and Myles Horton:

Abner Winston Berry, a Negro, was born on [redacted] [redacted] the Communist Party in 1929, and from 1930 to 1953 he held high-level positions within the Party. In 1951 he relinquished editorship of the Harlem edition of "The Worker" in order to assume the position of Negro-Affairs Editor of the "Daily Worker." He held this position until the "Daily Worker" ceased operation in January, 1953. In September, 1953, Berry was reported to have left the Party; however, he attended the 17th Communist Party National Convention on December 9 - 12, 1953, at New York City. He resides in Newark, New Jersey, and is currently employed as an editor by the Antara Indonesian News Agency, with offices in the United Nations Building, New York City. This agency publishes a daily bulletin which has been described as an Indonesian propaganda outlet owned and operated by the Government of Indonesia; however, investigation indicates it actually appears to be a privately owned firm with no subsidization by the Indonesian Government. Upon being interviewed on three occasions by Special Agents of the FBI, Berry has refused to cooperate, indicating that he had severed his connections with the Communist Party because it became a futile organization.

Aubrey Willis Williams is Chairman of the National Committee to Abolish the House Un-American Activities Committee; cited as an organization set up to lead against the Communist Party's "operation abolition" campaign. This committee was organized by Williams and Frank Wilkinson, an individual with a known and admitted past Communist Party membership. Over the years Williams has spoken before, and supported, a number of left-wing and communist-led groups, although he has publicly,

and in appearances before Senate investigating committees, disclaimed any connection with, or knowledge of, the Communist Party. He has worked energetically to discredit the FBI and the Director. As of July, 1961, Williams was President and a member of the Board of Directors of the Southern Conference Educational Fund, Incorporated, previously known as the Southern Conference for Human Welfare, cited as a communist front. A listing of the officers of the Southern Conference Educational Fund dated in January, 1963, indicates Williams is now president emeritus of this organization. According to a confidential informant, in June of 1963, during the time the Southern Conference for Human Welfare was in existence, Communist Party members were affiliated with it and worked actively in it. Since the formation of the Southern Conference Educational Fund, rank and file Party members have not been encouraged to work in it; however, certain Party members in the New Orleans area had been assigned to participate in the organization to further communist principles.

On June 29, 1963, Myles Horton identified himself to the FBI as Director of the Highlander Research and Education Center of Knoxville, Tennessee. This is the successor to the Highlander Folk School, originally at Monteagle, Tennessee, of which Horton was also the director. The latter school was supported primarily by donations from individuals and labor unions and it offered courses of instruction in labor organization, social economics and the general field of labor education. It was known to have Communist Party members on its staff and it followed the practice of securing communists as students. However, according to information received, it was never known to have offered courses of instructions in communism, nor was the Party known to have succeeded in gaining control of the school. There were many allegations that it represented the headquarters for communism in eastern Tennessee; however, these claims were never substantiated. The Tennessee Courts revoked the Highlander Folk School's charter on the grounds that it violated the criminal laws of the state. A state charter for the Knoxville school was issued on August 23, 1961.

On April 21, 1942, a confidential informant advised that Myles Horton was a speaker before the Southern Conference for Human Welfare. On April 19, 1949, Paul Crouch, a self-admitted former Communist Party member, described Horton as

a left-wing socialist who was always close to the Communist Party, meeting with officials and representatives to discuss policy and procedure during the period from 1939 to 1941. This informant also described Horton's wife, Zylphia, as being even closer to the Party in 1941. Another confidential informant advised this Bureau in 1950 that Horton continued to follow the Communist Party line during the period 1947 to 1950 and that he associated with known Party members. This informant doubted that Horton was actually a Communist Party member. In 1950 and 1951 a third confidential informant, who is a former member of the Party, advised that Horton was not a member even though he had close association with Party members. He stated Horton had been criticized by the Party members as an opportunist who used the Party for his own purposes.

Horton was reported to be listed as one of the speakers for a "Bill of Rights Dinner" which was to be sponsored by the Emergency Civil Liberties Committee on December 15, 1959.

The above confirms information furnished to Assistant Attorney General Burke Marshall on the morning of July 16, 1953.
