The new organization was established after the Uruguayan police carried out during the last three weeks numerous searches of private homes, persecution, and detention of leftists, using the pretense of seeking pertinent information about a clandestine organization.

In the above-cited reports, it is stated that "the oligarchy, which seeks to destroy a process while it is still an embryo, has already begun its repressive offensive with the required consultations of yankee imperialism, applying the foreign recipe which includes the formulas of the International Monetary Fund, the techniques of the F. B. I., the corruption of the C. I. A., and even the ultra-modern stupidity of the security commission of the OAS.

"For the individual who is faced with police terror, social disgrace, social disqualification if he does not think as the holders of power or those who pull the strings from abroad (from the United States) wish him to think, it is more urgent than ever to take a global, conscientious stand on the problem. They who are now directly and immediately threatened are the leftist militants who are being imprisoned, tortured and killed.

"But in addition to the immediate problem, the police, and their accomplices the judges and ministers, are creating a stagnant society whose only hope rests in the changing of its structure, the removal of those who now pose behind democratic masks yet reveal their true face of reaction."

"Epoca" states that "when the interests of a minority which has in its hands a greater part of the national wealth are supported, and when the government acts for the benefit of this oligarchy, when the dictates of U. S. imperialism are accepted and the country is handed over to a foreign ravisher, then this policy already contains the seeds for violence."

During the last four years, during each conflict in which the labor unions joined the protest, repeated resort was made to violence under the guise of security measures. These measures included a type of state of seige, prohibition of public gatherings, closing of newspapers, and the imprisonment of hundreds of workers."

"When the people, protesting against an international policy which was subordinated to the dictates of the United States State Department, flocked to the airport to bid good-bye to the first Latin-American country to struggle against imperialism, an act of police reprisal was carried out. This occurred when thousands of people bid good-bye to Cuban diplomats when leaving Uruguay."

Title: "Yankee Spies Kill More Than 100 Guianans" (Latin Press)

The article says that Mr. Robert Edwards, a member of Parliament (British), "accused the Central Intelligence Agency of having direct responsibility in the killing of more than 100 persons" in British Guiana.

P. 4 Columns 3 and 4

Title: "Beastly Assassination of a Negro Student"
(Latin Press)

The article begins with an editor's note which says:
"The intransigence of American racists, who now support the
reactionary Senator Barry Goldwater for the Presidency of the
United States, has unleashed a wave of violence against Negro
citizens who demand equality in Civil Rights."

The article comments on the recent race riots in
Harlem and criticizes the "brutal killing" of the 15 year-old
Negro, James Powell, who was killed by policeman Thomas Gilligan.

The article continues mentioning the racial disturbances
in Mississippi, Chicago and elsewhere in the U. S.

P. 4 Columns 3 and 4

Title: "The United States is Responsible for the War in
Vietnam" (Latin Press)

The article informs that the Russian columnist,
Olga Chechetkina, who writes for the newspaper "Pravda," says
the United States is directly responsible for the dangerous
situation and the war in Vietnam.

P. 7 Columns 1, 2 and 3 (continued on P. 14 Column 3)

Title: "Because If Goldwater Were To Win ..."

The article attacks the "extreme right" of the U. S.
and Senator Barry Goldwater. The following are comments made
against Senator Goldwater and his movement.

"The man that we thought was crazy, without importance,
won the primary elections for the Presidency of the United States....
That same man (Goldwater) aspires to atomize the world..."

In his comments about the Goldwater "movement," the
author says:

"What alarm this happening causes; the American right
used the assassination of its own President to open the road

for absolute power within the United States, (sic) (the right) is much more in favor of atomic war against the people of the world, (sic) for the purpose of obtaining universal dominion. (The above is a near verbatim translation. It is just as incoherent in Spanish as it appears in English.)

P. 7 Columns 4 and 5

Title: "July 26, Symbol of Liberty, Heroism and Dignity of the People"

This article praises Fidel Castro and the Cuban Revolution. The article is consequently anti-American, anti-O. A. S., and anti-CIA; however, no important comments are made.

P. 8 Column 5 and P. 9 Columns 1 and 2

Title: "A 'Gringo' Provokes Bloody Clash Between Peasants"

The article states that Herbert N. Williams, an American, led a group of sixty peasants to "invade" (settle unlawfully) certain plots of land in the Municipality of Ocampo.

The article says that the clash was due to political problems (article does not discuss these problems) that exist and have been in dispute in that municipality.

P. 9 Columns 3, 4 and 5

Title: "Yankee Firm and Government Functionaries Evict Humble Peasants"

The article says that the General Motor Corporation and the Federal Electricity Company (of Mexico) have unrightfully taken possession of land in the area of Santa Ana Atlapatitlan. The article says that the land belongs to the peasants.

P. 11 Columns 1, 2, 3, 4 and 5

Title: "China's Intrigue To Conquer the World"

The article generally assails China for its policies and actions. The author feels that China wants a split with

Russia. The author feels that this split would allow the leaders of China to play Russia off against the United States. After an armed clash between Russia and the United States, China would dominate the world.
