- ① Speed 1.2 cm/s no movement on meter
- ② Extremely low level, reverb. voices, recording with a male + a female, male does most of talking + female talks at times - Probably other persons present + occasionally talk, at least one other female voice
- ③ Continues like this for a 3/5 of side - 55 min phone rings possibly + recording conv. ends and remainder of side A - recorded noise ends some minutes later the remainder of side is quiet

Sides ④ Cued + listened to this side - No noted recorded info

- ⑤ Recording starts immediately at beg of side A (brief area with poss RE + no recording) - Damaged area with this audio plays back OK
↳ difficult intelligibility, added reverb effects
