## Another CIA Hoax

#### What's Really Behind That Phony Nixon Assessination Plot

Those Arabs are really getting troublesome, aren't they?

Not content with having assessinated Presidential candidate Robert Kennedy, they now take on President-elect Richard Nixon. By Allah, who knows if tomorrow they are not going to went their spleen on poor old grandpa LBJ himself, by blasting him right out of his rocking chair!

The truth of the matter is, of course, that the whole thing is just another hoax concocted by the CIA for shoring up that all too rickety "motive" Sirhan Sirhan is supposed to have had in killing Sen. Konnedy.

The forthcoming Sirhan trial, now scheduled to begin December 9, is very much on the minds of the CIA strategists these days. Not that there is much of a chance that that trial will ever be held - any more than the James Earl Ray trial or the Clay Shaw trial. Each and all of these cases hold the threat of exposing CIA skulduggery and therefore they all must and will be stopped at all costs, one way or the other.

But if by any chance Sirhan abould reach the courtroom alive, great care must be taken to publicize his "motive" again and again before the defendant is disposed of. And if he hangs himself in his cell, falls out of a window or dies of instant cancer, like Ruby, it will be a good thing for the world to know that here goes a young fanctic so carried away by his hatred for Israel that he felt a compulsion to kill the Catholic Robert Kennedy.

Gullible beyond belief as most Americans are, there has been some balking at the logic and likelihood of such a cause-end-effect relationship. The number of those who couldn't quite bring themselves to believe that ultra-phony story has been substantially greater from the start than the number of people who were immediately account of how and why President Kennedy was killed.

So it became an urgent task for the CIA masterminds to consup with a corroborative incident that would make people say: "Well, it seems to be true, after all was the victim of Arab spite because he had put in a good word for Israel some time ago. Lock at those other Arabs the also wanted to get Mixon for the same reason!"

The newsfakers, of course, jumped at the occasion to ingratiate themselves with the powers-that-be. When these R. Nemer and his two sons were arrested, the Associated Press on Nov. 11 per out a dispatch that included this hypocritical paragraph: "No notive for the alleged plot

had been revealed but Nixon, like Kennedy, has said the United States is committed to maintain Israel's military superiority over its Arab foes."

Nowspapers around the world picked up this cue. For instance, the German mass circulation deily Bild promptly trumpeted: "Evidently the motive is the same as in the assassination of Senator Kennedy."

To make the deception complete, the "official sources" who had first implanted this suggestion in reporters' minds, acted coy. It would be "pure speculation," they announced, to see a link between the two cases "at this time." The next day, however, the same sources revealed "that the three Temenis had made several trips to los Angeles recently. Ergo, they must have been in touch with Sirhan.

Posides, where did those poor immigrants got the money for such exponsive travels; an FBI spokesman wordered aloud. He might have added: "And where did they get the huge sum which they had offered to the (still unidentified) marksman who was to have taken the contract for shooting Nixon, but who backed out of the deal and gave the show away?"

There, indeed, did all that money come from?

Pressed to ensuer that question, the authorities next began to hint darkly that Namer may have been a Soviet intelligence agent. To bolster that assumption, they then pretended to have found "subversive" literature at his home. The old Oswald story all over again.

And it is precisely the sameness of the pattern, the recurrence of the same old tricks, the fabrication of a seemingly plausible motive where there is none that botray the guiding hand of the CIA in this affair as in the two Kennedy murders and the James Earl Ray case.

The CIA has a lot of Arabs on its strings, just as it has a lot of shady characters of every other race or nationality on its payroll. When ther Sirhan and Hamer were unwitting dupes of the CIA, or willing tools, remains to be seen. Most likely they were used, double-crossed and thrown to the wolves, just like those other two CIA operatives, Oswald and Ruby and some others as well.

One thing is certain: the Zionist issue is just a red herring:
drawn across the trail by cunning plotters in order to camouflage the
real issues at take. Robert Kennedy was murdered by the CIA and LEJ because
he had the presidency within his grasp (who can doubt that he would have
defeated Nixon if even Humphrey came close to doing it?) and the assassing
of President Kennedy could not afford a re-opening of the sham investigation into his death conducted by the Warren Commission. And the Nixon plot
was conceded to lend plausibility to the epurious motive for that killing.
A contributing cause was the desire by the real conspirators to make it
appear as though the scales of political murder in the United States were
evenly calanced. This is their answer to those who have been wondering
why only leading Mberals have been the targets of assassins' bullets
since Lyndon B. Johnson became Vice-President. By rigging up a phony plot
against a staunch Conservative like Nixon, they try to give the impression
that assassination is a general risk in politics whereas in fact the murderere are always on the Right and the victims elways on the Left.

Since the Gestapo went out of business, the CIA has been the world's No. 1 criminal organization. It methods are goveral rungs below those of the Mafia (with which it is closely allied). It a favorito practice is to squeeze every ounce of usefulness out of its operatives and then from them on a murder charge or some other phony ray.

#### Harguerike Oswald's Pathotic Ploa

Mrs. Marguarite Oswald the most abused, reviled and libelled nother in America, has appeared to Prosident-elect Nixon to re-open the Konnedy-Oswald case. For pathetic plea for justice, however, is most likely to fell on deaf cays. The American Establishment is made up in almost equal parts of Democrats and Republicans and it is committed to only one goal self-proservation. It was, efter all, a Republican, Earl Warren, who instead of exposing the monstruous crime committed by the Southern Democrat Lyndon B. Johnson moved heaven and earth to cover up for it.

The latest example of bipartisan complicity with the essassins of President John F. Kennedy is afforded by the Asclaion of Governor Ronald Reagen of California not to extradite Edgar Hugene Bradley to Louisiana for trial as a co-conspirator against President Kennedy (see TRUTH LETTER, No. 2 - "The Ill-Smelling Bradley Affair"). While the ruling was eade on specious technical grounds, its obvious purpose was to erect another stumbling-block in the path of District Attorney Jim Garrison.

Not that it matters much at this juncture whether or not Bradley is extradited. As long as the case of the chief defendant, Clay Shaw, is being held up by the Supreme Court (TRUTH LETTER, No. 1 ~ "Stalling Off Justice"), Bradley and all the other accomplices are safe enough. The Establishment knows how to take care of its own.

#### Garrison Going for Broke

"District Attorney Jim Garrison is literally broke," an inside source recently wrote to TRUTH LETTER. It seemed hardly believable at the time, but further inquiries have brought out that "Truth and Consequences," the group of New Orleans businessmen who had pledged to finance the Garrison investigation is drying up as a source of funds. And the emount of money available to Garrison for that purpose from the city treasury is totally inadequate for an enquiry of such vast scope.

The opposition is well aware of this situation and has developed a new tactic of aggravating Garrison's financial problems as much as possible. A case in point is that of read fee Crisman alias Free Lee, alias Dr. Jon Gold the was subpossed to appear before the New Origans Grand Jury on November 21,1968. In reply, the witness, who had received from Garrison a check for \$500 for the trip from Tacoma, Washington, where he lives, to New Orleans, asked for additional expense money so that his larger could accompany him. If the request is granted, the DA will be out of pocket to the tune of at least \$1,000 for this one witness alone.

However, Crisman apparently is morth the expanditure. He is a former "business partner" of Thomas Edward Eackham, that poculiar "evangelist-ontertainer" who testified before the Now Orleans Grand Jury for six hours on February 9, 1968. Eackham, a close friend of the late David Ferris the was high up on the local CIA ladder, and a chief suspect of Garrison's in the early stage of his investigation, was questioned extensively by a four-wan toam of DA's assistants and by Garrison himself. These circustances indicate that Eackham knows a lot about the assassination and perhaps had comething to do with it, though no charges have been filed yet against him. The same goes apparently also for Crisman and that makes him well worth the price - even if Garrison is broke.

#### How to Groom a Witness

When and if the trial of James Earl Ray finally takes place, won will be hearing a great deal about an alleged star witness named Charles of them. His case is a prime example of the way potential witnesses are ground and coached in America to serve the cause of injustice.

(where the warrant for Galt's arrest was issued), dated April 17,1963, Staphens Pailed to identify the man in the picture as the one he had seen: Winless he was wearing a wig or had had a face lift or something, it's not the man I saw," Stephens stated unequivocally and he added, "The hair is too full and the face is too young."

Mext, Stephens found himself in the custody of the Memphis police as a "material witness." He was lodged in the Shelby County Jail where he soon changed his mind about testifying. When the extradition hearing concerning Ray was held in London on June 27, 1968, the representative of the US Government read an affidavit by Stephens stating, among other things, that on April 24, -i.e. about ten days after he had first been questioned by the FBI and haddenied seeing Ray -he had identified an FBI wanted profile" as very much like the man he had seen. A complete aboutface, then, which was clearly due to police pressure.

Time magazine, in its issue of Sept. 13,1968, reported that Stephene, after he had "identified" Ray and thereby "leaped to importance as central witness," was first free to come and go as he pleased, but accompanied by a bodyguard while at the County Jail. But - "he was away too often to suit the police." So in July Stephene was imprisoned on \$10,000 bail which he couldn't raise. However, he found a couple of claver law-yers and in late August he was "aprung" on a writ of habeas corpus. "Last wask Stephene was free and living in a small, police-protected apartment in Memphie." One gathers he never had it so good as when he became a co-operative "central witness."

### A Snug Place Where to Hide

"His full name is given as Sirhan Bishara Sirhan Abu Khatar," the dispatch by Jon Kinche in the London Evening Standard went on to say. "He was first ofought to the United States as a four-year-old child in 1948 - notin 1957."

According to the official version, Sirhan in 1957 immigrated to the U.S. with his parents and never left the country again after that. All the accounts of his life published in the American press agree on this point. For instance, Life magazine, in the context of what purports to be a complete roundup of Sirhan's background and movements, flatly stated on July 8, 1968, that the Sirhans emigrated to the U.S. in January 1957 and that Sirhan B. Sirhan then was 12.

This is the first clear-cut indication of underhanded dealings, for, as we shall presently see, Kimche's contrary information is based on excellent authority. Why was the date of Sirhan's arrival in the U.S. altered so drastically? Why was that fact that the immigrant did leave the country again, not just once, but several times, suppressed? Jon Kimche's report provides if not the answer, at least a plausible hint:

"We returned to Jordan in 1957 and the records show that he was married in the Orthodox Church at Es Salt, 15 miles vest of Ammen on June 27, 1957, when he was only 15, to Leila Yussef Mikhael from Es Salt."

Let us stop here again for a moment, as the picture of official deception comes clearer into focus. Not a word has been breathed in the American press - which obtained most of its information in the case from government sources - about the fact that young sirhan the year he was supposed to have first come to the U.S. actually returned to his homeland to get married. No mention has been made even of the fact that he is or was married. Not there can be no doubt whatsoever that Mr. Kimche's information is correct, for it abounds in details that can easily be verified: the name of the bride; her homotown; the Church where the young couple were married. The story also brings out another important fact which has been deliberately hushed up - that Sirhan is a Christian Arab. While Christian Arabs are also as a rule antagonistic towards Israel, they are seldem filled with the fenatical hatred of that country which inspires their Moslem countrymen. Thus the hitherto concealed fact that Sirhan is a Christian makes the notive attributed to him in the Kennedy killing even more implausible than it was before.

Mater that year Sirhan returned to the United States," Mr. Kimche continues, "and three months later his wife was brought to him. The records of his journey are not very precise and probably not very important, as both husband and wife were little more than children.

mRather more interest centers on three later journeys which Sirhan made, especially on the last two which, according to this investigation, were made in 1964 and 1966.
