FOREIGN POLITICAL MATTERS - MIDDLE EAST

ON MARCH TWENTYSIX, NINETEEN SEVENTY THREE, AN EXTREMELY HIGH OFFICIAL OF NEW SCOTLAND YARD (NSY) ADVISED OUR REPRESENTATIVE IN LONDON THAT A HIGHLY PLACED FATAH SOURCE REPORTED THAT SIRHAN SIRHAN, THE MURDERER OF ROBERT KENNEDY, WAS NEVER A MEMBER OF FATAH OR ANY OTHER ARAB TERRORIST ORGANIZATION. THE BLACK SEPTEMBER GUERRILLAS WHO SEIZED THE SAUDI ARABIAN EMBASSY IN KHARTOUM AND SUBSEQUENTLY KILLED TWO AMERICANS AND ONE BELGIAN DIPLOMATS, DEMANDED THE RELEASE OF SIRHAN SIRHAN SOLELY BECAUSE THE ARAB TERRORIST LEADERS WERE DEEPLY ANNOYED AND AGGRAVATED WITH THE "EXCESSIVE FINANCIAL AND MILITARY AID" THE U.
