Enclosed to the Bureau are five copies of an LHM captioned Mae Magnin Brussell. Enclosed to WFO are two copies of LHM, original and 9 copies of FD-302, and original of interview notes of Mae Magnin Brussell.

ADMINISTRATIVE:

Mae Brussell is the subject of San Francisco files 9-2954 (victim), and 100-56470. Information contained in these files has been capsulized and made a part of enclosed LHM.

For information of Bureau and WFO, Mae Magnin Brussell is known to the Monterey Resident Agency as being somewhat of a character who is totally convinced of a conspiracy which has been involved in all assassinations which have achieved national notoriety. She attributes this conspiracy to Nazis who came to the United States from Germany after World War II and who have been involved in this assassination and terrorist activity since then. She also attributes the conspiracy to being perpetrated by the FBI and CIA. Mrs. Brussell is not taken seriously by the local

community and is considered somewhat of a character whose mental stability is questioned.

As was reported in referenced teletype to Bureau, 4/24/81, Mrs. Brussell expressed her intention to request the FBI to make available a task force to study the information she has compiled regarding this conspiracy. The sources she wished to make available consists of thousands of newspapers clippings and hundreds of books she has collected.

The Bureau should be advised that any further contact with Mrs. Brussell regarding her theories would not be considered a wise expenditure of investigative effort.

One copy of the LHM is being disseminated to the United States ~~Secret~~ Service, San Francisco, California.
