On the same date IC WERNER reviewed the records of the Miami Beach Police Department which indicate that HENRY DONALD RAMISTELLA, white male, born 3/25/31, at Bronx, New York, was fingerprinted on 12/1/61. He listed a local address as 186 SW 17th Avenue, Apartment 7. He listed his mother's address as 69 Fillmore Street, Providence, Rhode Island and his wife's name as KENNEDY. His employment was listed as Doorman, Place Pigalle, Miami Beach.

The Miami Beach Police Department records further indicated that ROSE RAMISTELLA, aka Bonnie, white female, born 11/27/32, at Providence, Rhode Island, was arrested on 6/14/62, for obtaining drugs by fraud. Her occupation was listed as a waitress and her husband's name was listed HENRY RAMISTELLA. Her local address was carried as 2835 NW 3rd Avenue, Miami. The records indicate further that she received a 60-day suspended sentence for the above charge.

On the same date IC WERNER reviewed the records of the Dade County Department of Public Safety with regard to HENRY RONALD RAMISTELLA. These records indicate that on 9/23/62, RAMISTELLA was arrested for petty larceny. His FBI Number was carried as 365 687-C. He listed a local address at 484 NE 31st Street, Miami. RAMISTELLA never appeared in court to answer these charges.

Dade County Department of Public Safety records further indicated that on 9/9/63, RAMISTELLA was arrested for careless driving, causing an accident while driving intoxicated and resisting arrest with violence. His local address was listed as 484 NE 2nd Avenue, Miami.

No disposition was listed as a result of these arrests.

On the same date IC WERNER reviewed the records of the Miami Police Department which records indicate that HENRY RAMISTELLA was arrested on 12/31/60, for investigation regarding heroin addiction. This case was turned over to the Florida State Narcotics Bureau.

The records of the Miami Municipal Court indicate that **HENRY R. RAMISTELLA** received a seven-day suspended sentence for drunkenness on 8/26/63. These records further indicate that on 8/25/63, **ROSE RAMISTELLA** received a seven-day suspended sentence for drunkenness. **ROSE RAMISTELLA** was also charged with disorderly conduct for a suicide attempt which charges were dismissed on 8/28/63.

The records of the Florida State Racing Commission were reviewed with regard to **HENRY R. RAMISTELLA**, aka Frank Bonmarzanna on 8/12/63, by SA **ELMER C. MILLER** and produced no positive information.

Neighborhood checks were conducted in the vicinity of all local Miami addresses for **RAMISTELLA** contained in police department files and produced no positive information concerning the current whereabouts of either **RAMISTELLA** or his wife.

The following investigation was conducted by
SA THOMAS J. LARDNER:

On August 16, 1968, Patrolman HERBERT MYCROFT, Identification Division, Providence, Rhode Island Police Department, advised from records that HENRY R. RAMISTELLA, of 878 180th Street, Bronx, New York, was arrested by this Police Department, on July 24, 1957, and charged with violation of the banking laws.

On July 26, 1957, the charge was reduced to false pretenses and RAMISTELLA was placed on probation.

Patrolman MYCROFT advised that it appeared from the records that RAMISTELLA was arrested along with JACKSON DURANT, RICHARD S. MC NABB, of 32 Saint Alfonsus Street, Roxbury, Massachusetts, and RONALD X. CHIAVERINI, of 37 Ring Street, Providence, Rhode Island, on a charge of being suspicious persons, and the latter three being released and RAMISTELLA being held for violation of the banking laws.

A stand-up photograph was taken of the four individuals which Patrolman MYCROFT made available.

He also made available a mug shot of RAMISTELLA.

SUBJECT: Report on Rumor About Robert Kennedy Being Shot

1. This office has been informed of a rumor similar to that reported in our out teletype number 06680 of 8 June 1968.

2. On 23 July 1968 our representative in Mogadiscio, Somalia, was contacted (but not deliberately sought out) by a Mr. J. Christian Kinney, a United States citizen, who volunteered information about a rumor of Robert Kennedy having been shot. Mr. Kinney reported that on 18 May 1968 he stopped in Beirut, Lebanon, while enroute to Mogadiscio, with his wife and child. On the evening of May 18th he entered the Phoenicia Bar, Phoenicia Hotel, Beirut, about one-half hour before closing time. This was either 2130 or 2230 hours according to Mr. Kinney. At the bar Mr. Kinney struck up a casual conversation with a Mr. Joseph Strong, a United States citizen. During the conversation Mr. Strong inquired if Mr. Kinney had heard that Robert Kennedy had been shot. Mr. Kinney replied that he had not, and Mr. Strong said that he had heard this just before coming to the bar from a man he did not identify. Mr. Kinney and Mr. Strong reportedly felt that if this were true it would appear in the newspapers the next day, which, of course, it did not.

3. On 19 May Mr. Kinney left Beirut for Jidda, Saudi Arabia, where his company has business. He questioned some of his colleagues in Jidda whether they had heard a story about Robert Kennedy having been shot. The colleagues disclaimed having heard this so Mr. Kinney attributed the story to being a "typical Middle East coffee house rumor", and forgot about it. Mr. Kinney also met Mr. Strong in Jidda during the week of 19 May, and no mention was made by either party about the rumor that Robert Kennedy had been shot.

4. According to our representative in Mogadiscio Mr. J. Christian Kinney is employed as a consultant by the Middle West Service Company, 69 West Washington Street, Chicago, Illinois. He presently is assigned to Mogadiscio as the chief consultant to the Mogadiscio Water Agency on a United States

Agency for International Development (USAID) project. Mr. Kinney is described as being a bright, pleasant, young man in his early thirties who appears to know his business, and is well thought of by USAID officials in Mogadiscio. His wife is reported to be Ecuadorian, and they have one child.

5. The files of this office contain no identifiable information on J. Christian Kinney. Our representative in Mogadiscio reports that Mr. Kinney presently is undergoing a security check for the purpose of permitting him to have access to "need-to-know" classified information in connection with the USAID Mogadiscio water project. It is possible, therefore, that USAID Washington may have information on Mr. Kinney.

6. Our representative in Mogadiscio reports that Mr. Kinney described Mr. Joseph Strong as being the Middle East Sales Manager for Raytheon. According to Mr. Kinney, Mr. Strong is based in New York and travels to his sales territory several times a year. It is possible that Mr. Strong may be identical with Joseph Addington Strong who was born on 5 October 1911 at Chattanooga, Tennessee. According to information dated mid-1967 Joseph Addington Strong resided at 743 Wellesley Street, Weston, Massachusetts. He was employed by the Raytheon Company, Wayland, Massachusetts, as International Sales and Projects Manager, Surface Radar and Navigation Operation. He has been employed by Raytheon since 1950.

7. This office conducted national agency checks on Joseph Addington Strong in 1964. The checks included the Office of Naval Intelligence (ONI); Department of State, Passport Section; House Committee on Un-American Activities; and the Federal Bureau of Investigation. The checks developed no unfavorable information. In 1962 ONI completed a favorable background investigation on Strong. The investigation was predicated on his civilian duties in a contract capacity.

Strong stated Abdel-Malek was reading an Arabic language newspaper, apparently purchased by him in Rome prior to the flight, and he commented to Strong about an article in the paper reporting a rumor to the effect that United States Senator Robert F. Kennedy had been shot. Strong stated that he himself was unable to read the article inasmuch as he could not read or translate Arabic.

Strong stated he recalled commenting about the article to an unidentified American male later on May 18, 1968, in a bar in Beirut; but he never read or heard anything further in newspapers or on radios concerning the rumor in the days immediately following May 18, 1968.

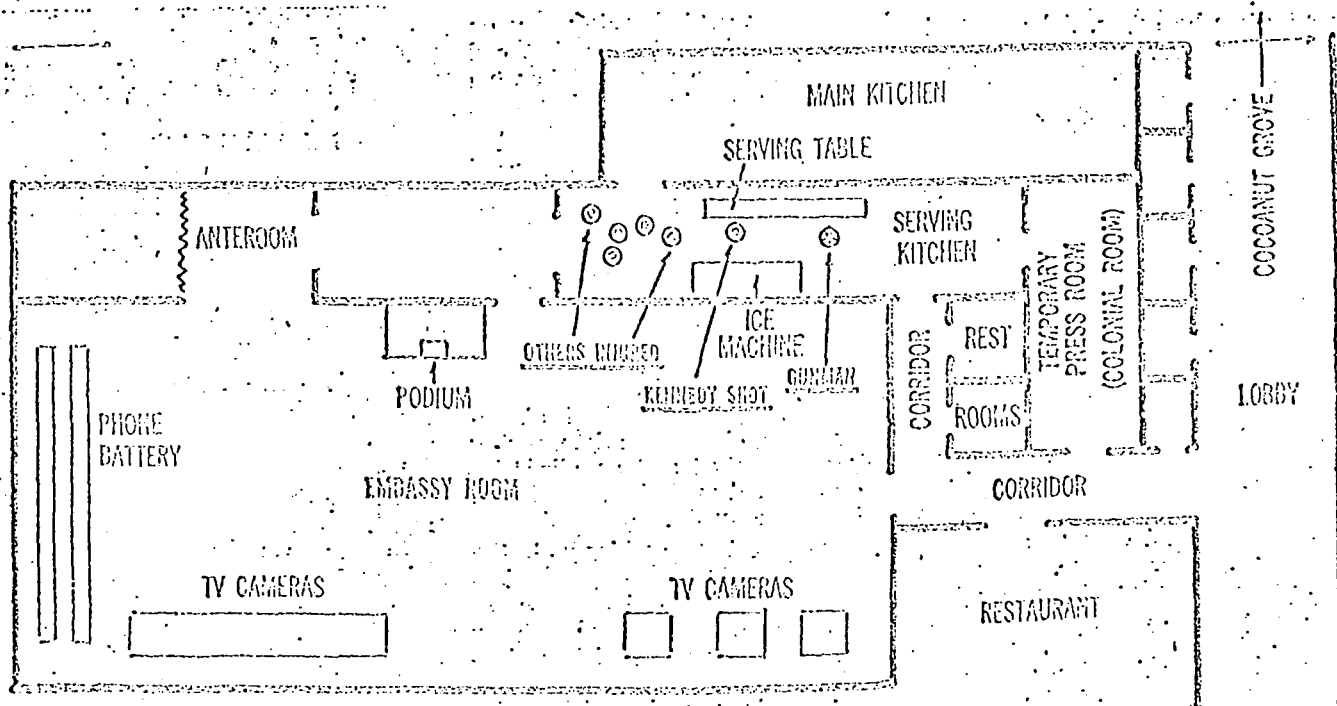


DIAGRAM OF SHOOTING SCENE—Sketch shows the doors leading from behind podium at Embassy

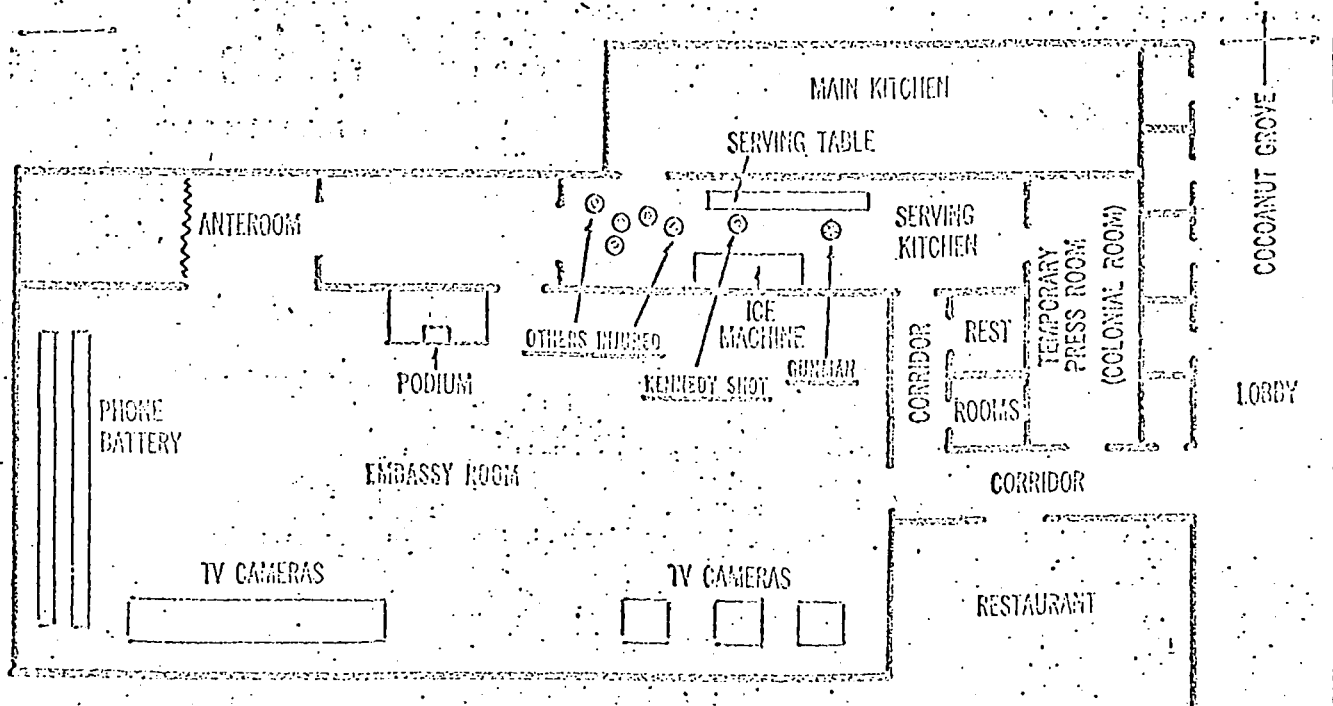


DIAGRAM OF SHOOTING SCENE—Sketch shows the doors leading from behind podium at Embassy

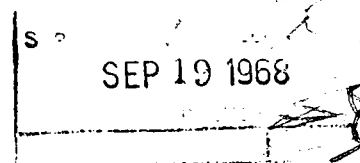

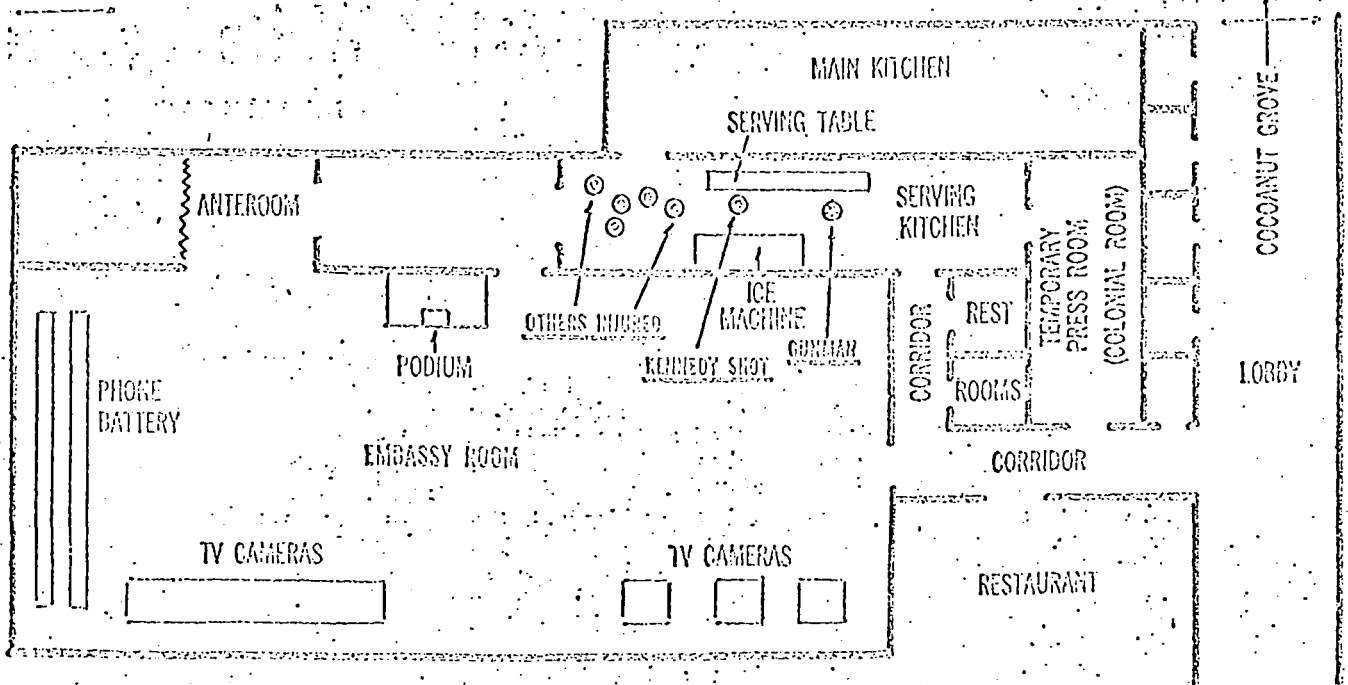
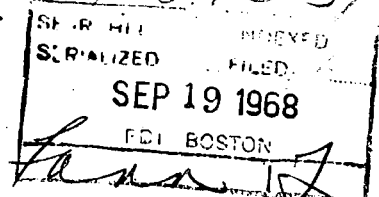


DIAGRAM OF SHOOTING SCENE--Sketch shows the doors leading from behind podium at Embassy

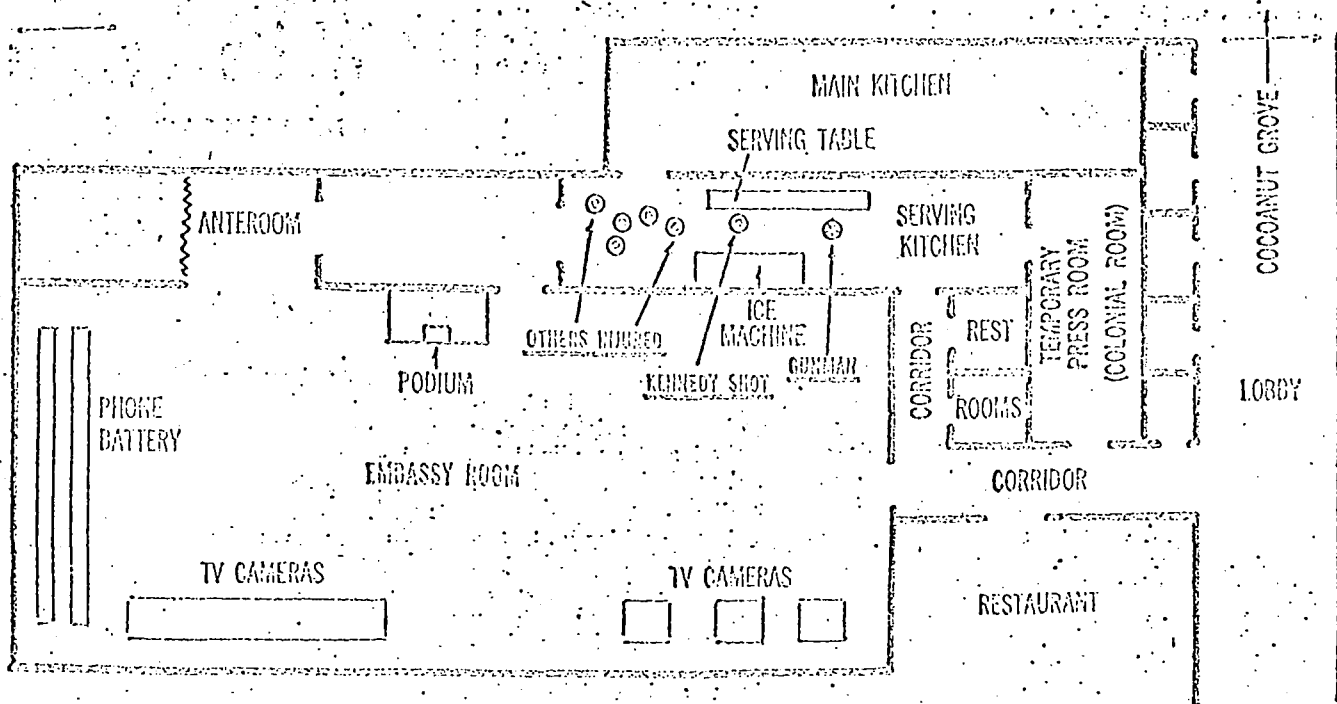


DIAGRAM OF SHOOTING SCENE—Sketch shows the doors leading from behind podium at Embassy

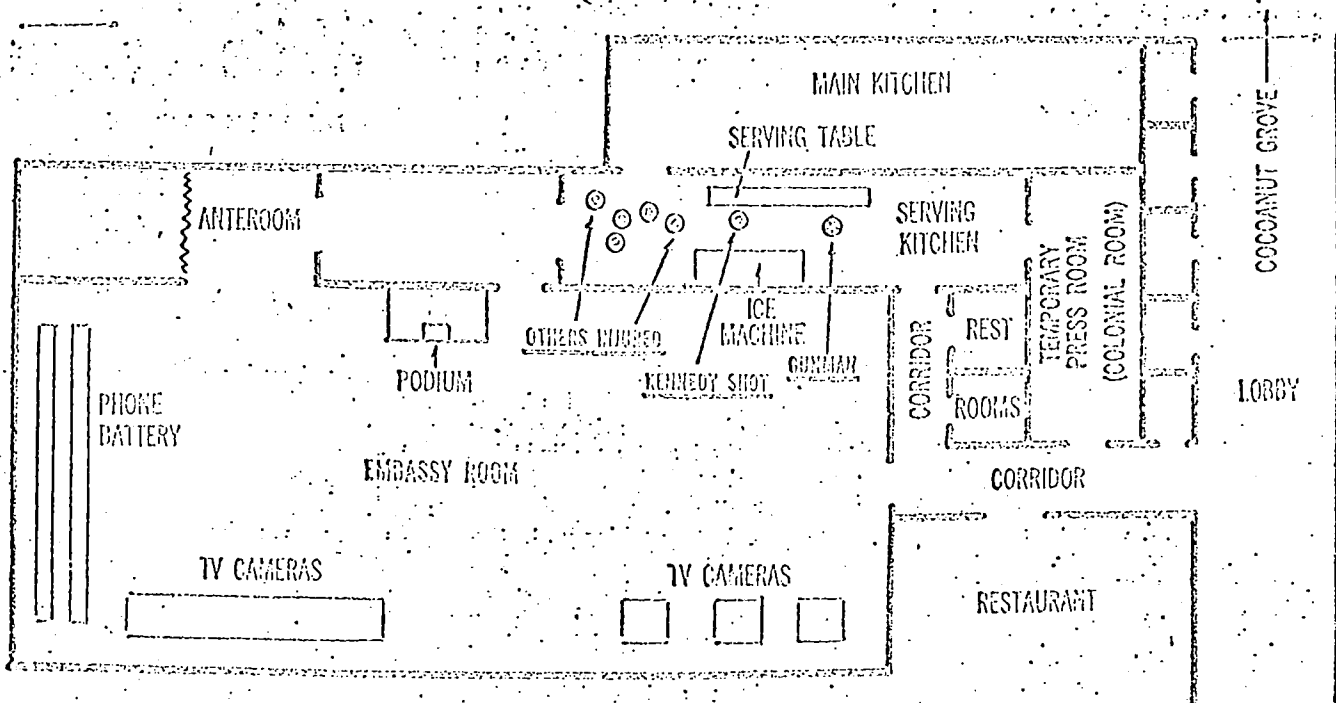


DIAGRAM OF SHOOTING SCENE—Sketch shows the doors leading from behind podium at Embassy

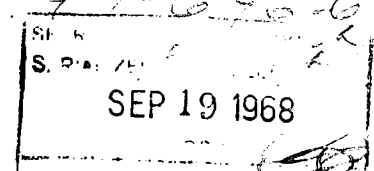

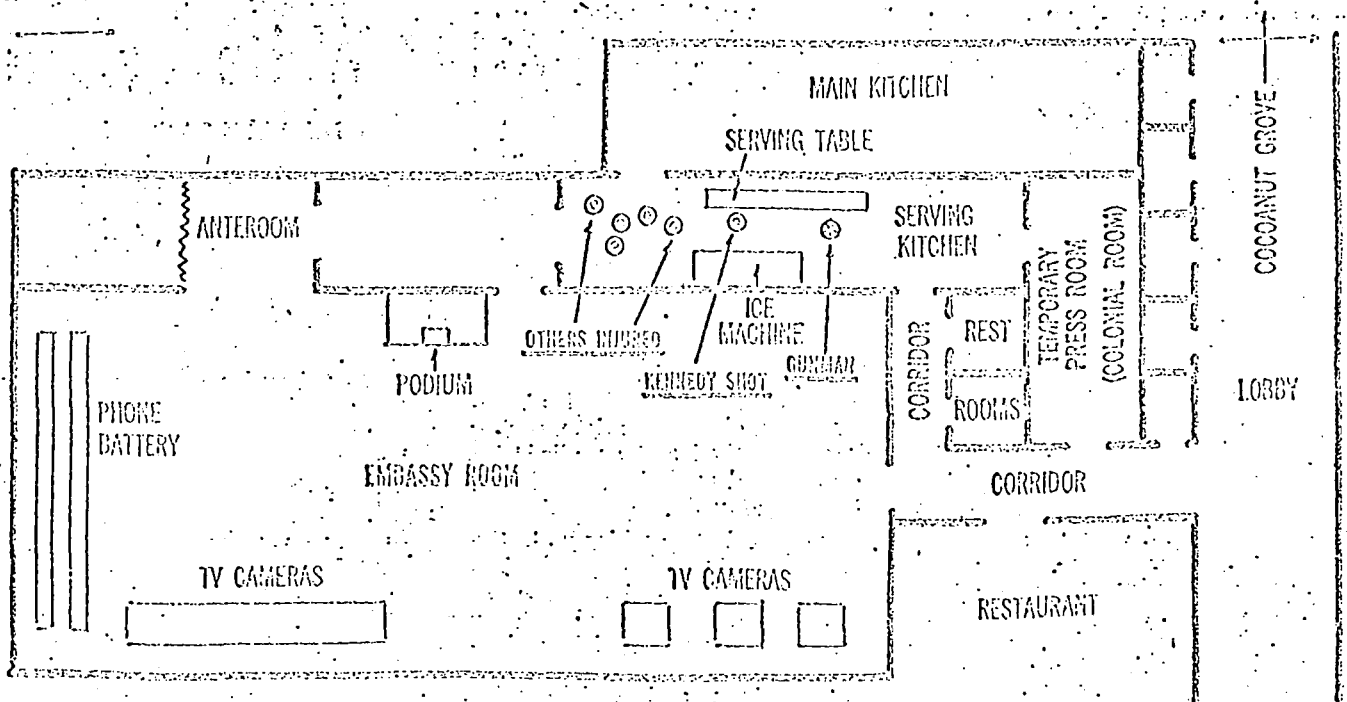


DIAGRAM OF SHOOTING SCENE--Sketch shows the doors leading from behind podium at Embassy

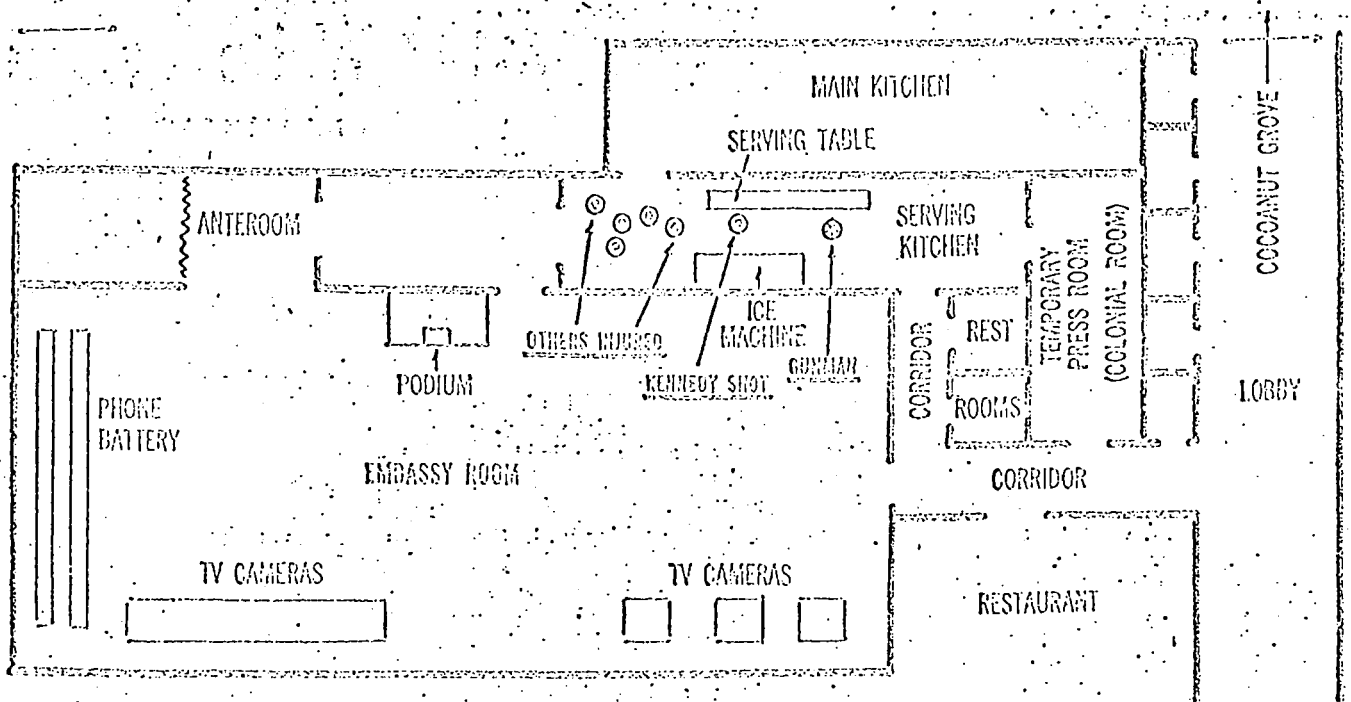


DIAGRAM OF SHOOTING SCENE—Sketch shows the doors leading from behind podium at Embassy

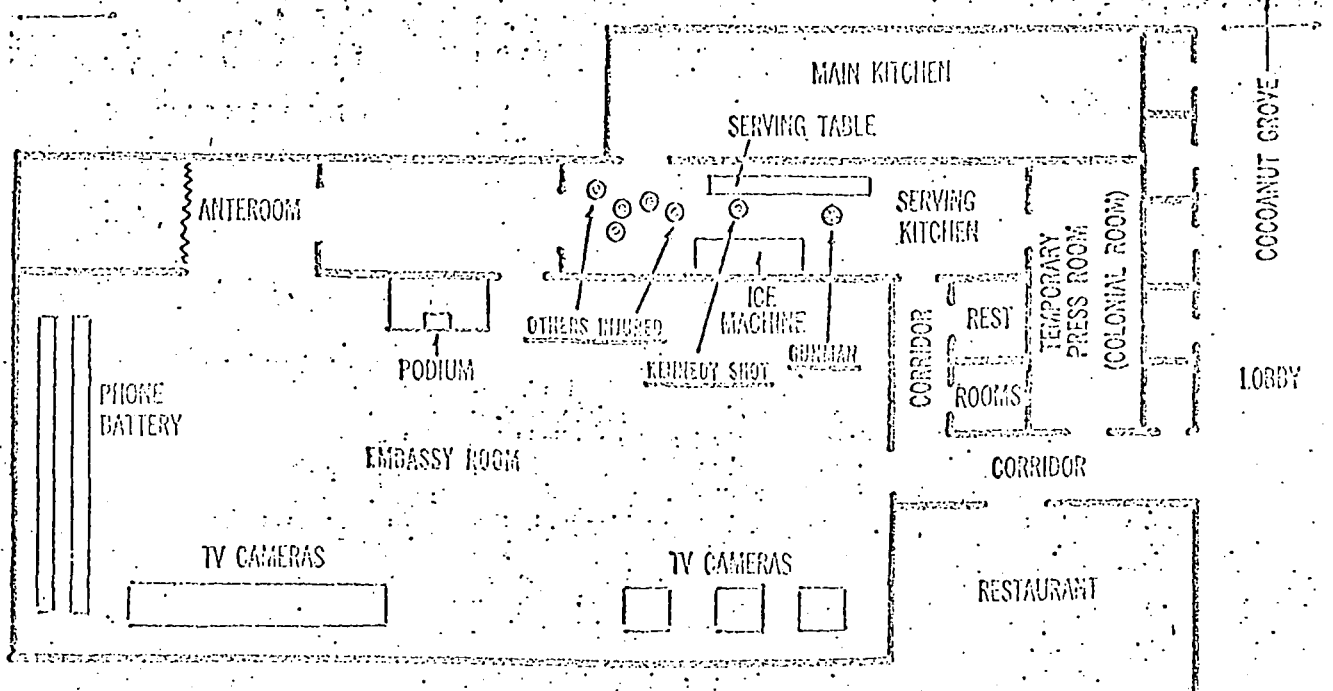


DIAGRAM OF SHOOTING SCENE--Sketch shows the doors leading from behind podium at Embassy

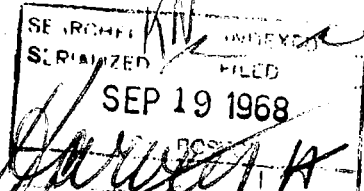

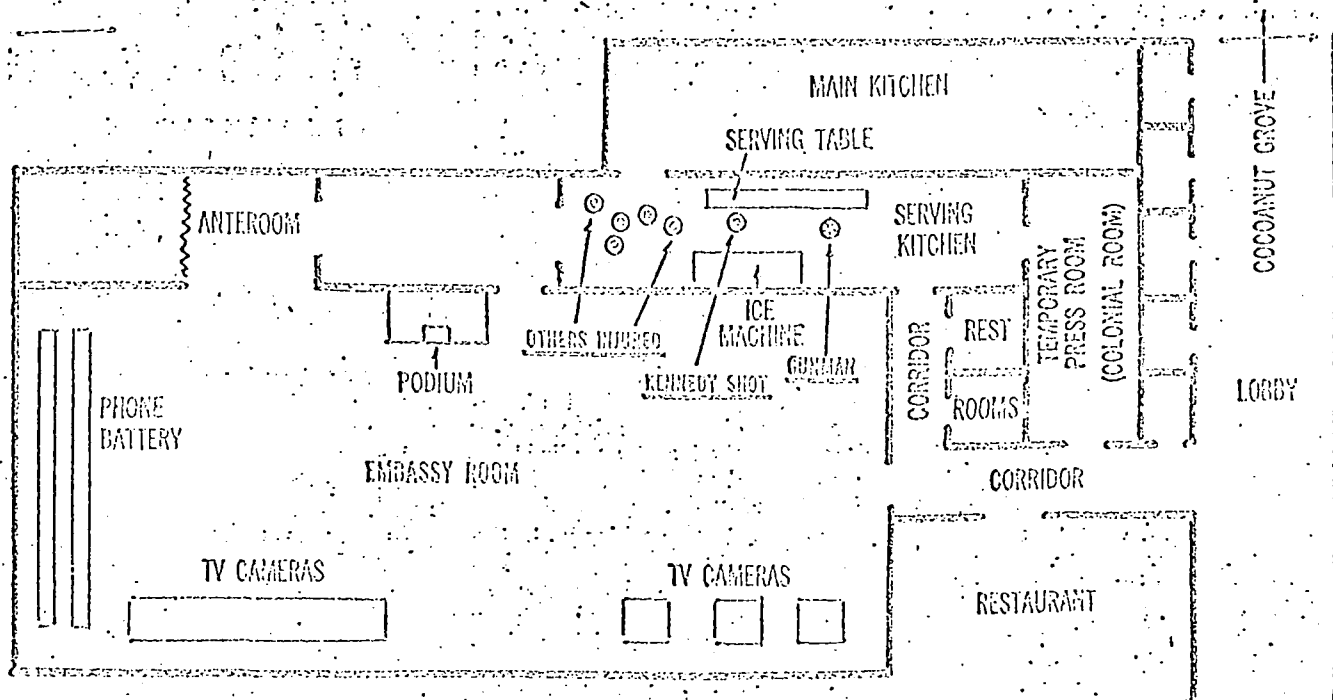


DIAGRAM OF SHOOTING SCENE--Sketch shows the doors leading from behind podium at Embassy

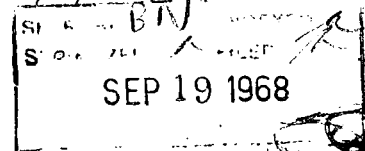

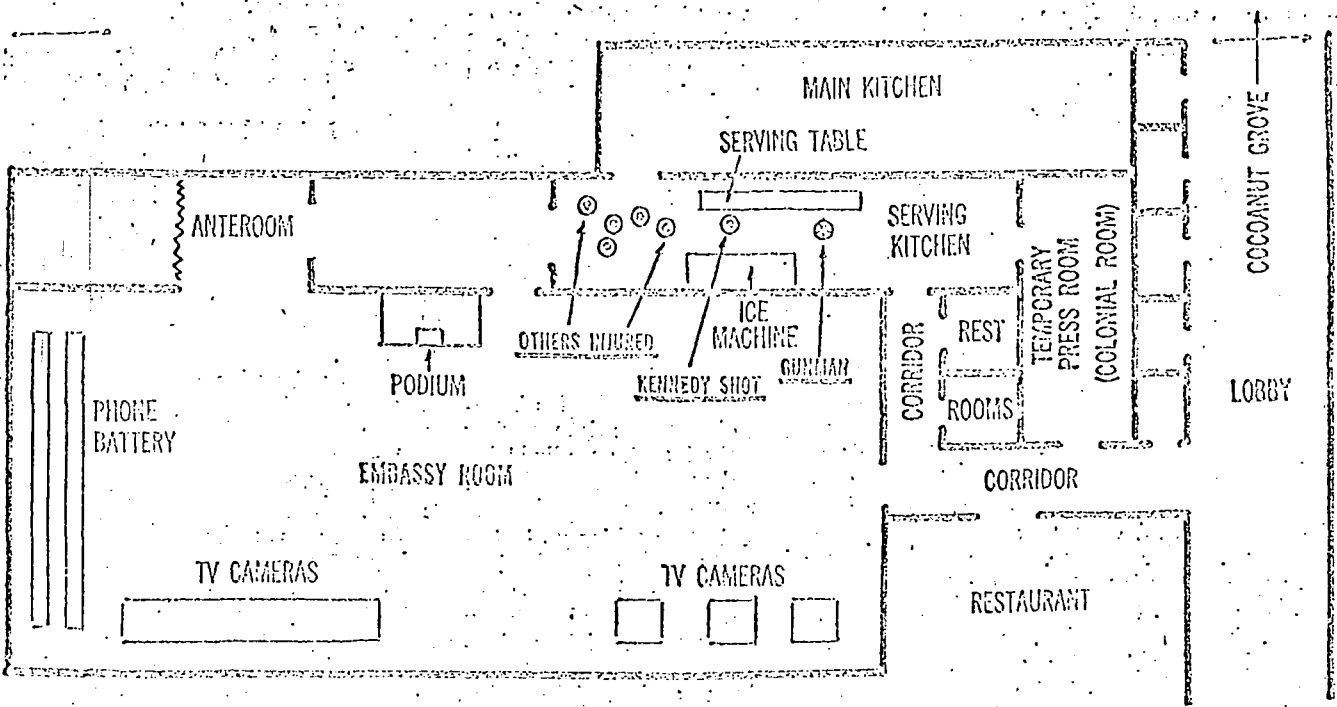


DIAGRAM OF SHOOTING SCENE—Sketch shows the doors leading from behind podium at Embassy

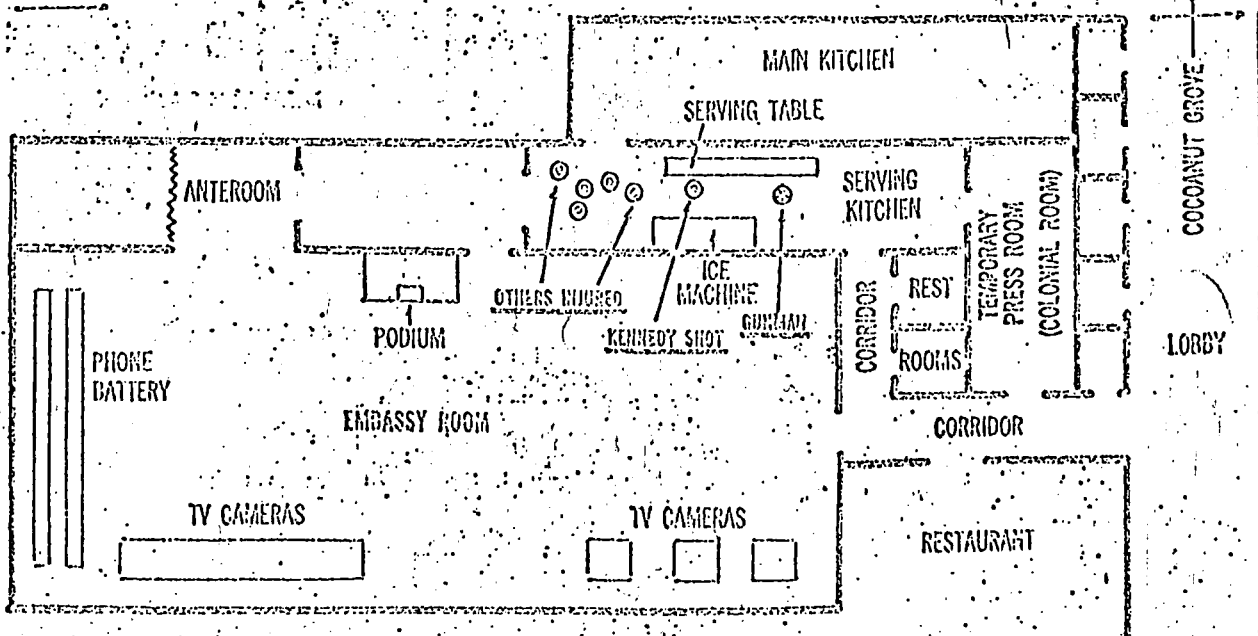


DIAGRAM OF SHOOTING SCENE--Sketch shows the doors leading from behind podium at Embassy
