

DOROTHEA BARTON, NEE CHILDS, RESIDENCE TWO FIVE ZERO WEST ONE HUNDRED FOURTH STREET, APARTMENT FIVE FOUR, NEW YORK CITY, ADVISED THIS DATE THAT HER EX DASH HUSBAND, BOYD ROBERT BARTON, LAST KNOWN ADDRESS, ONE ZERO EIGHT FIVE ZERO KLING STREET, NORTH HOLLYWOOD, CALIFORNIA, IS A MEMBER OF A "CULT" FOUNDED BY DR. (FIRST NAME UNKNOWN) ARMSTRONG WHO IS CONNECTED WITH THE AMBASSADOR COLLEGE, PASADENA, CALIFORNIA. SHE STATED THAT ONE OF THE MAIN BELIEFS OF THE CULT, NAME OF CULT UNKNOWN, IS THAT THE END OF THE WORLD IS EMINENT WITHIN FIVE YEARS. ONE OF THE PURPOSES OF THE CULT IS TO RID THE WORLD OF SOME OF ITS THIEVERY AND OTHER BAD FACTORS WITHIN THIS PERIOD OF TIME.

THEIR PLANS TO ASSASSINATE MARTIN LUTHER KING, JR., AND FURTHER TO "BLOW UP" THE UNITED NATIONS. SHE STATED THAT NO DATES WERE RECALLED BY HER REGARDING THESE PROPOSED ACTIVITIES, HOWEVER, NAMED CULT MEMBERS, KNOWLEDGEABLE OR CONNECTED WITH THESE PLANS, AS HER EX DASH HUSBAND, BOYD ROBERT BARTON; ROY JOHNSON, RUBI STREET, GRENADO HILLS, CALIFORNIA, TELEPHONE NUMBER EM THREE DASH THREE SEVEN ONE FIVE, WIFE MARTHA; AND JIM MONSEES, ONE ZERO TWO SIX RUBERTA, GLENDALE, CALIFORNIA, TELEPHONE NUMBER NINE SIX THREE DASH EIGHT ONE ONE FOUR.

MRS. BARTON STATED THAT SHE RETURNED TO NEW YORK FROM THE LOS ANGELES AREA AROUND MAY, NINETEEN SIXTY SEVEN. SHE STATED PRIOR TO LEAVING CALIFORNIA SHE ACTUALLY SAW NUMEROUS GUNS, HAND GRENADES AND DYNAMITE AS STORED BY THE CULT AT THE KLING STREET ADDRESS OF HER HUSBAND. SHE STATED SHE AND HER HUSBAND HAVE BEEN DIVORCED FOR APPROXIMATELY TWENTY YEARS, HOWEVER, IN THE PAST SEVERAL YEARS RESIDED TOGETHER AT THE ABOVE NORTH

On 6/6/68, 10:37am, DOROTHY BERRIEN, CONUS Intelligence Desk, 108th Military Intelligence Group, NYC, contacted on another matter, advised as follows:

A "confidential" message was left for her by an acquaintance employed with a government agency (not the Army but not further identified by BERRIEN) that SIRHAN BISHARA SIRHAN, alleged assassin of Sen. ROBERT F. KENNEDY, used to associate with CEASER CHAVEZ, Farm Union organizer in California who was at the hotel (Embassy) when KENNEDY was shot. Also, SIRHAN attended meetings of the W.E.B. Du Bois Club in California in 1966.

Above for appropriate action.

ADDENDUM

On 6/6/68 Berrien advised SA Francis L. Cashin that she received above from Herbert Rommerstein, Investigator, House Unamerican Activities Committee, NY, NY, tel/#924-1399 but that he would not be available until 6/7/68.

On 6/7/68 SA Cashin spoke with Rommerstein. He said he got above information from his Washington, DC office and that they got it on a CONFIDENTIAL basis from the Los Angeles Police Dept.

In view of the fact that the original source of the information is the LAPD no further action is being taken as FBI, LA would have picked it up from the original source.

On 6/5/68, DOMINICK FUENTES, Manager, Placement Centre Agency, 1061 East Tremont Avenue, Bronx, N.Y., telephonically contacted the New York Office and advised that he had seen a photograph in the "New York Daily News" of the individual being held by the Los Angeles, California Police Department in connection with the shooting of Senator KENNEDY and he believed this individual was possibly identical with one LUIS GEHEVA HERNANDEZ who had appeared at his agency on 3/25/68 with a JOSE LOPEZ seeking employment.

FUENTES was subsequently interviewed by Buagents on 6/5/68 in an effort to identify the then unidentified assailant. FUENTES said he was 90% sure the assailant and HERNANDEZ were identical. He said that HERNANDEZ who spoke no English and who spoke poor Spanish appeared at his agency with LOPEZ who spoke fluent Spanish. They sought any type of work available. HERNANDEZ initially

said that he was from Puerto Rico but after FUENTES, who is Puerto Rican, told him he did not believe he was from Puerto Rico because of his poor Spanish - HERNANDEZ then said that he was from South America. FUENTES asked him for his visa or other papers but HERNANDEZ stated all his papers were in his luggage which he did not have with him.

While at the agency LOPEZ and HERNANDEZ inquired about a place to stay and LOPEZ stated that he had a friend at 845 Hoe Avenue, Bronx, New York, who would probably get them a room at that address.

LOPEZ filled out a job application card for both HERNANDEZ and himself. On HERNANDEZ' card, he showed the age of HERNANDEZ as 28 years, address as 845 Hoe Avenue and the social security number as [REDACTED]. On his own card, LOPEZ showed his age as 22 years, his address as 845 Hoe Avenue, and his social security number as [REDACTED].

HERNANDEZ and LOPEZ then left the agency and never recontacted FUENTES.

It was also determined on 6/5/68 that there is no address, 845 Hoe Avenue, Bronx, New York. The lowest numbers on Hoe Avenue is 900 which is adjacent to Bruckner Expressway.

The application cards filed by HERNANDEZ and LOPEZ were obtained by agents but are not being submitted to the FBI Laboratory inasmuch as they were filled out by LOPEZ and not HERNANDEZ and because Senator KENNEDY's assailant has been identified.

During the late afternoon of 6/6/68, Supervisor ROGER YOUNG received a telephone call from ARNOLD FINE, Editor of the Jewish Press, 2427 Surf Avenue, Brooklyn, NY, telephone number ES 3-9500, home phone number LA 7-0854. FINE stated that he had just received an anonymous telephone call from an individual with a Cuban accent who stated that on 5/11/68, he spoke with two individuals who he thought may resemble SIRHAN SIRHAN. The anonymous telephone caller was going to call FINE again that evening. FINE was given the home telephone number of SA FRANCIS L. CASHIN and was advised to have the anonymous caller call SA CASHIN.

During the evening of 6/6/68, SA CASHIN, at home, received a telephone call from an individual who eventually identified himself as FRANCIS DURAN, residing at the Hotel Commander, Room 412, 240 W. 73rd St., NY, NY, telephone number 787-1260. He stated he was furnishing the information on a Confidential basis. He stated that he is six foot tall, born 7/29/38, in Havana, Cuba, but is now a citizen of the US. He works nights as a railroad clerk for the NYC Transit Authority. He has no children but his wife is GISELA INES DURAN, who was born in Havana, Cuba, on 2/26/30, but is now a citizen of the US.

He stated that on 5/11/68, between 2:00 and 3:00 a.m., on the downtown side of the IRT subway at 138th St. and Broadway, NY, NY, two males came up to him and asked him how they could get to Kennedy Airport. He told them and one of the two males who was speaking English then translated

the directions received from DURAN to his associate in Arabic. DURAN stated that he does not speak Arabic but he can recognize it when it is spoken. DURAN also stated that he asked the male who spoke English if he was Spanish and he said no "I am Arab."

In further conversation with the male who spoke English, this individual stated that he was going to "the West" and that his friend, the one who did not speak English, was going to an Arab country.

DURAN thinks that these individuals were visiting someone in the neighborhood and that it would be strange for Arabs to be in that neighborhood as the neighborhood consists mostly of Cubans and Dominicans.

DURAN stated that he had seen a picture of SIRHAN SIRHAN in the newspapers and stated that neither one of these two Arabs looked like SIRHAN SIRHAN, but that the reason he was conveying this information was due to the fact that they were Arabs asking directions to get to Kennedy and they had no luggage.

He stated that the Arabs looked liked twins and gave the following descriptions:

As to the one who spoke English:

Skin:	Dark brown skin but not a Negro or mulatto
Hair:	Black and curly but not Negro. A very brilliant black
Height:	5'6" - 5'7"
Build:	Thin to medium
Age:	25 to 35 years
Eyes:	Very, very open
Glasses:	No glasses
Scars:	No scars noted
Language:	Spoke Arabic and English
Clothes:	He was not wearing a hat or tie but had on a dark blue suit with a regular white shirt which was open at the collar.

As to the Arab who spoke no English:

Skin:	Dark brown skin but not mulatto or Negro
Hair:	Black, curly - a very brilliant black
Build:	Thin to medium
Height:	5'6" - 5'7"

Clothes:	He was wearing a dark blue suit with a white shirt and he had a tie on. He was not wearing a hat.

DURAN then went on to state that he receives papers, literature and pamphlets from all over the world and that he knows how to read between the lines and through this process can determine the motives, aims and objectives of the Communists. He stated that by listening to him he could analyze the literature he receives, pinpoint the weaknesses in the Communist movement and exploit such weaknesses. He stated that he is not a genius but that he is a very good reader. A few years ago he received a pamphlet from Cuba which stated that the Israeli Government would disappear and he determined by reading between the lines that the Arabs would attack Israel.

A review of NY file 105-78837, on the cover pages of the report of SA WILLIAM M. DREW, JR., dated 9/20/67, at Miami, Florida, it is stated that a reinterview of DURAN served to reinforce the original impression that he has a "secret agent" complex. During the interview, in Miami, DURAN made a number of recommendations as to how the operations of the FBI could be updated and improved. SA DREW continued that DURAN is obviously addicted to gross exaggeration and that DURAN is convinced that he can deceive a Communist into revealing himself.

Based on the above analysis of DURAN by SA DREW and SA CASHIN's conclusions as to DURAN, which are similar to those of SA DREW, no further action is being taken in this matter.

On 6/8/68, the subject contacted the NYO to advise that one MARSEL FAKOURES, 171 Clinton Street, Brooklyn, New York, telephone number UL 8-3565, who has worked for him part time in his Kesnoglidis's Photo Studio. He told him that he is the cousin of SIRHAN SIRHAN, who is allegedly the assassin of Senator ROBERT F. KENNEDY.

He advised that FAKOURES is a student at the NY School of Photography and was in California sometime during 1967 for an unknown reason. He did not know the reason for the trip to California and subject advised he wanted to furnish this information as FAKOURES seems to have quite a bit of cash lately. He also talked about flying to the Mid-East several months ago but did not do so. FAKOURES was supposedly has a pass which will allow him to fly at anytime on an unknown airline.

Subject advised that FAKOURES bears a close resemblance to SIRHAN SIRHAN, KENNEDY's assassin. He is 28 years of age, 5'7", 175 lbs., with black hair.

It is noted that the subject does not speak good English and was difficult to understand.

4/11/68 MARSEL FAKOURES WAS telephonically contacted for purpose of making an appointment. He advised during this contact that he was not a cousin of S. Sirhan, never met him, knew nothing of him except what he read in paper. He also advised that he was a LEBANESE and Sirhan was a Jordanian.
