On June 12, 1968, an individual identifying himself as NORMAN WEXLER, residence 963 Lexington Avenue, New York, New York, telephone number LO 4-3250, called the New York Office of the Federal Bureau of Investigation, and stated that he is a free-lance playwright and also that he is free lance in advertising. He stated that he was a classmate of Senator ROBERT KENNEDY at Harvard in 1948; that he had gone to California on a voluntary basis to help with the KENNEDY campaign a few days prior to Senator KENNEDY's assassination; and that he was in the Ambassador Hotel on the night of the assassination.

WEXLER stated that there was no security at the Ambassador Hotel and that when the police came in, they acted as though they were "morons". WEXLER stated that he was in a room near the shooting and that he did not see the shooting nor hear the shots. WEXLER went on to state that he had the theory that SIRHAN SIRHAN was a member of Communist International.
