FEDERAL BUREAU OF INVESTIGATION

THOMAS W. BRADEN, writer and former owner, Oceanside Blade Tribune Newspaper, 1331 South Pacific Street, Oceanside, California, advised he was Senator KENNEDY's Northern California Coordinator and handled matters concerning the Senator's campaign in San Francisco, California for approximately two weeks prior to June 4, 1968. He said he flew to Los Angeles the afternoon of June 4, 1968 and joined Senator KENNEDY at his suite on the fifth floor of the Ambassador Hotel, along with about thirty other supporters. He said during the early evening he was in the main ballroom of the hotel with KENNEDY supporters and he noted nothing unusual and he had no reason to be suspicious of any person in the ballroom. He was unable to identify photograph of ADEL, SHARIF, MARY, SAIDALLAH, MUNIR or SIRHAN B. SIRHAN as being a person he saw at any time in the hotel that evening. He was unable to furnish any information concerning SIRHAN B. SIRHAN. He could not furnish any information which might, in any manner, have a connection with the assassination.

He said he was with Senator KENNEDY in his room shortly before the Senator left to appear on television in the main ballroom and as the Senator was leaving, JOHN GLENN suggested he (BRADEN) and TED WHITE, remain in the room and watch the Senator's appearance on television. BRADEN said he and WHITE agreed with GLENN's suggestion, whereupon, Senator KENNEDY suggested they leave then and go to "The Factory" a Beverly Hills nightclub, and he would meet them there in twenty minutes. According to BRADEN, earlier that evening the Senator had made arrangements for a small party of friends to meet at that nightclub.

BRADEN said they watched the Senator on television for the first part of his speech from the main ballroom, left the room before it ended and while walking in the hotel toward the elevator on the fifth floor, PROVY (LNU), Mrs. JACQUELINE KENNEDY's ex-maid, rushed up to them and said the Senator had been shot. Thereafter, an unnamed manager at the hotel told him and WHITE to guard the Senator's room whereupon they returned to the room and protected the area.

BRADEN said he had no personal knowledge of the reason Senator KENNEDY proceeded in the direction of the Colony Room rather than the ballroom where his supporters were however, he had conversation with BILL BERRY, while traveling on the funeral train on June 8, 1968 concerning the change. He said BERRY told him he and another person, possibly JERRY BRUNO (phonetic), had checked the area the Senator was to have proceeded and that the Senator, without prior notice told him, "Let's go this way", thereby causing BERRY to be behind the Senator as BERRY had planned on going in the direction of the ballroom to meet the Senator's supporters. Continuing, BRADEN further said BERRY told him "I kicked Sirhan off the platform three times while the Senator was behind the microphone", referring to the evening of June 4, 1968. He said BERRY felt very badly during the trip and he did not know if he would recall their conversation.

BRADEN said he had heard a rumor from an unrecalled source that it was Mr. UNO (phonetic), Banquet Manager of the hotel who was the person who suggested the Senator proceed in the direction of the Colony Room. BRADEN said the Senator had a definite practice of following the suggestion of advisors when in crowds and it was BRADEN's opinion someone suggested to the Senator he walk in the direction he did, as it was a short way out or gave him some other quick reason which caused him to change his previous plan of departure from the ballroom.

Miss URSO said that she had been talked to by two detectives of the Los Angeles Police Department shortly after the shooting. Later two detectives of the Los Angeles Police Department re-interviewed her San Diego and took a formal statement. Also Miss URSO has appeared on a San Diego TV station to be interviewed during a news show.

Miss LISA LYNN URSO, 6405 Bradford Street, San Diego, advised that in June of this year she was a member of the group at Crawford High School, San Diego, supporting Senator ROBERT F. KENNEDY's campaign for the presidency. On the evening of June 4, 1968, LISA and two of her girl friends, who were also working in the KENNEDY Campaign, drove to Los Angeles to follow the results of the Primary Election vote at the Ambassador Hotel where KENNEDY had his temporary headquarters. Being head of the KENNEDY supporters at Crawford High School LISA had a badge which admitted her to areas not accessible to her two friends. By the time Senator KENNEDY began his victory speech in the ballroom of the Hotel, LISA was separated from her friends. She did not again get together with her friends until hours after the assassination. Her friends had no first hand knowledge concerning the shooting.

LISA said that while KENNEDY was giving his victory speech, she had left the Embassy Room, where he was speaking, and gone to the kitchen to get a drink of water. After getting the drink, she walked in the kitchen to cool off. There were about fifteen or twenty people in the kitchen at this time. She was still in the kitchen when KENNEDY finished his speech. She stayed in the kitchen because she thought he might go to the press room in the hotel after his speech and to go there he would have to go through the hallway of the kitchen. When KENNEDY came out of the Embassy Room and was in the hall of the kitchen LISA noticed, out of the corner of her eye, that a young man in front of her was reaching across his body with his right hand. She subconsciously thought he was getting ready to shake hands with KENNEDY, but when he continued the motion she had the thought that he was reaching for a gun. She then saw him bring his arm back out in front and up and he took a slight step forward.

[REDACTED] certain that she saw a gun in his hand but she heard [REDACTED] saw flames coming from the tip of his hand. She recalls [REDACTED] three definite shots and then there was chaos. There [REDACTED] have been more shots, the sound of which was covered by the outcries of the people in the room. She saw Senator KENNEDY grab the back of his head with his right hand. People closed in on the young man and she lost sight of him, but knew the people were holding him down on a table. She did not see

the young man disarmed.

LISA said that she had not by this time seen the young man's face but in standing behind him she said she noticed his hair as black, thick and "real curly." Also he was wearing a jacket with a weave like denim. She does not remember the color of the jacket, but believes it was blue or beige. It was not a sports coat. He was very close to LISA's height; if anything he was slightly shorter. He had been just forward of her left shoulder but the step he took just before shooting brought him in front of her.

After the shooting LISA went into the press room and next saw the young man when he was being taken out of the building. She saw his face for the first time then as he glared at the people in the press room. She is certain that this was the same young man who had fired the shots.

LISA said that she does not believe anyone was with this young man and she did not see anyone with him nor does she recall him talking with anyone.

On June 19, 1968, a source familiar with Minutemen activities in the San Diego area advised as follows:

MICHAEL VEJVODA, a known associate of Minutemen members, telephonically contacted four Minutemen members in the San Diego area on June 19, 1968, and stated, "If you hear anything about me or read anything, don't worry. What I am about to do I am going to do for God and country."

Source advised that MIKE VEJVODA belongs to an organization named "Staff" and travels frequently between San Diego and Los Angeles. According to source, "Staff" is an organization similar in its aims as the Minutemen.

Sergeant JOHN KENNEDY, San Diego Police Department (SDPD), advised that MICHAEL VEJVODA was detained by the SDPD on June 19, 1968, and a search of his residence located a rifle and several cherry bombs wrapped in plastic material with thumb tacks or similar devices embedded in plastic material, making the cherry bombs extremely dangerous to personnel. Above information furnished by Sergeant KENNEDY on June 19, 1968.

On June 20, 1968, Sergeant JOHN KENNEDY, SDPD, advised as follows:

Approximately one week ago, Lieutenant JACK COCHRAN, Intelligence Division, SDPD, received a telephone call from the Intelligence Division, Los Angeles Police Department (LAPD), requesting investigation by the SDPD to locate MIKE VEJVODA, allegedly residing in the San Diego area. Upon location, the LAPD desired to be notified so that they could send LAPD officers to San Diego to participate in the interview of VEJVODA.

LAPD indicated MIKE VELJODA was developed as a possible associate of SIRHAN B. SIRHAN, alleged assassin of Senator ROBERT F. KENNEDY.

Upon location of VELJODA, Lieutenant COCHRAN telephonically contacted the LAPD and determined that the LAPD no longer was interested in being present at the interview of VELJODA.

Sergeant KENNEDY had no information as to why the LAPD was no longer interested, but suspected the LAPD subsequently determined that MIKE VELJODA was no longer being considered as a possible associate of SIRHAN B. SIRHAN.

MIKE VELJODA was detained by the SDPD, and when questioned regarding any association with SIRHAN B. SIRHAN, he denied any association whatsoever. Investigation by the SDPD failed to develop any information to indicate an association between them.

On June 24, 1968, Sergeant JOHN KENNEDY made available the following notes and information obtained during their investigation:

OFFICER'S REPORT concerning.....INTELLIGENCE INFORMATION REGARDING MICHAEL VEJVODA...

VEJVODA was contacted at his residence regarding information received that he was possibly involved in burglaries in the San Diego Area (see arrest report). Officers had also received information from Los Angeles Intelligence Division that VEJVODA was possibly an associate of Sirhan SIRHAN, the assassin of Senator Robert F. KENNEDY.

Officers ascertained that VEJVODA was living at 3042 State Street and was registered in a room at this location under the name of Paul ANGELO. A knock on the door to his room was answered by him, and requested that the officers step inside so that our conversation could not be heard by other tenants or the landlord of this residence. Officers present at this time were A. L. DENZ, Lt. E. J. COCHRAN, and Sgt. J. W. KENNEDY. VEJVODA was placed under arrest for investigation of burglary and a search of his room was conducted.

The following is a partial list of items impounded at the time of the arrest (see report by Officer DENZ for a complete list of property impounded): Several pages of written material (see attached copies); a 30-caliber carbine; a quantity of ammunition; some ammunition for a .22-caliber weapon; a large bow and twelve steel arrows; two large cherry bomb firecrackers which had been dipped in an adhesive-type substance and rolled in large carpet tacks (this made an explosive substance, including the cherry bomb, mastic and tacks, that was approximately 2" in length and 1 1/4" in diameter); a five-band transistor radio, and a tape recorder.

Subject was brought to Room 16, where he was interrogated by Lt. COCHRAN and myself. The following is a list of his locations since he spent two and a half years in Boys' Town, Nebraska, leaving there in 1954.

August, 1954 to January, 1955 - lived in Minneapolis, Minnesota, with his mother, Rose Ann BOKELMAN.

January, 1955 to April 19, 1955 - Omaha, Nebraska, living with mother and working at St. Vincent's Home for the Aged.

April 19, 1955 to April 17, 1959 - U. S. Marine Corps, serving the enlistment in the United States and Hawaii; was discharged at Terminal Island and returned to Omaha.

April 20, 1959 to December, 1959 - lived in Omaha, Nebraska, worked at St. Vincent's Home for the Aged and the "B" Best Driving School.

December, 1959 to July, 1961 - lived in Minneapolis, Minnesota; worked at the "B" Best Driving School, the Raddison Hotel as a bus boy, and at Charlie's Cafe Exceptional as a bus boy and waiter.

July, 1961 to September, 1961 - lived in Omaha, Nebraska, and worked as an ice cream truck driver.

September, 1961 to February, 1962 - lived in Minneapolis, Minnesota and worked selling diet food.

February, 1962 to September, 1962 - came to San Francisco to visit his half-brother, Frank Edward BOKELMAN; spent some time there and in Long Beach, and while in Long Beach was involved in a car wreck.

September, 1962 to November, 1963 - moved back and forth between Omaha and Minneapolis.

November, 1963 to January, 1964 - traveled extensively through the states of Colorado, New Mexico, Arizona, Texas, Louisiana, Georgia, Florida and then to California.

January, 1964 to August, 1965 - lived in Long Beach and worked as a bus boy at the Lafayette Hotel and the Java Lanes.

August, 1965 - returned to Omaha for a three-week visit - returned to Long Beach in September, 1965.

October, 1965 to March, 1967 - lived in the Long Beach area and was involved in an incident in that city where he threw a brick through the front door of the United Nations Building. In company with him on this occasion was a subject described by him as Ernie TELLIGANIS (phonetic spelling.)

March, 1967 to present date - lived in San Diego at the following addresses: 2300 Union; on 35th Street near El Cajon Boulevard; 3310 - 33rd. Street; 3042 State Street. Worked at the Vallejo and Lubach's restaurants as a bus boy and then did odd jobs for survival.

VEJVODA furnished the following information to the reporting officers; that the below listed three subjects are possibly members of the American Nazi Party in Long Beach:

Shawn MC GUIRE - W/M - 30 - 5'11" - 160 - blond - has a red face. Works as stevedore or in the oil refineries.

Ernie TELLIGANIS - W/M - 32 - 5'5" - 140 - dark (Note: This is subject with VEJVODA in the brick throwing incident. VEJVODA states this subject pressured him into throwing the brick.)

George KING - W/M - 33 - lives at 385 Roswell, Long Beach - works at Douglas Aircraft.

VEJVODA also stated that a Don SISKI and a Mr. ROSE, in the Long Beach area, were members of the Minutemen:

VEJVODA was questioned in regard to the cherry bomb with tacks, and he stated that he has used one or two of these in the country area, but that he made them especially to throw at any person who attacked him in his house.

VEJVODA was questioned in regard to the large amount of rocks in the trunk of his car, as well as the slingshot and small rocks in the glove compartment of his car, and he stated he carried these for protection in case he got in the area where a riot was going on. VEJVODA was questioned also as to why he had his car and house keys taped so that they did not rattle and also as to why he had taped his flashlight. His answer was so that they would be easier to handle.

VEJVODA was questioned as to his dislike for Senator Robert KENNEDY, which he readily admitted and stated that he made a statement while in the Rafferty Headquarters when KENNEDY's picture flashed on TV: "Don't disgrace this headquarters by leaving his picture on TV."

VEJVODA stated that besides the .30-caliber rifle, he also owned, at one time, a Ruger .22 automatic. VEJVODA at first claimed that he had purchased these guns outside the State of California and that he had sold the Ruger to an unknown person in the Long Beach area. In regard to the .30-caliber rifle, a receipt was found from the Frontier Gun Shop, where the gun had been purchased on July 27, 1967, by a person giving the name of N. ACKERMAN, 4210 Texas Street. VEJVODA later admitted that he, in fact, had purchased the gun.

VEJVODA was requested to take a polygraph examination, which he readily agreed to, and this examination was administered by Sgt. R. E. PROUTY (see attached report concerning questions and reactions to polygraph examination).

VEJVODA was again interviewed in Room 16 by Lt. COCHRAN at 1000 hours, June 21, 1968, and admitted to using the additional following aliases: John PARTELOW, Tom ACKERMAN, Bob MAXWELL and Jim SOUTHERN.

- # 3 "Are you responsible for the residential robberies?" He said "No."
- # 4 "Do you belong to the Minute Men?" He answered "No."
- # 5 "Do you belong to the American Nazi Party?" He said "No."
- # 6 "Do you belong to the Peace and Freedom Party?" He said "No."
- # 7 "Do you belong to the Communist Party?" He said "No."
- # 8 "Do you NOW belong to the John Birch Society?" He said "No."
- # 9 "Do you know Sirhan SIRHAN?" He answered "No."
- #10 "Have you lied to the investigating officers, besides what you have told me about?" He answered "No."
- #11 "Are you withholding any information that you know we should find out?" He said "No."

There were slight indications of deception relative to this subject's answer to the following question:

- # 1 "Have you ever conspired with anyone else to take another persons life?" He said "No."

VEJVODA stated that he had been to Mrs. HOUGHTON's home one time and that he had called her twice. He stated he never met Mr. Troy HOUGHTON. He stated his contacts with Mrs. HOUGHTON were to discuss the plans for the picketing of the Moscow Circus while it was at the Sports Arena. He stated he was taken to her home by Barry GODFREY who works at the Telephone Co. and lives on Maple Street in La Mesa. He also stated that he bought the carbine he had at the gun store on University at about 34th the first of this year. He said he bought it for \$70.00 and used the name of ACKERMAN. He stated he bought the Ruger in Phoenix, Arizona about the first of this year for \$45.00 and used the name of PARTELOW. He indicated that he has used other phony names for some of his activities but stated he could not remember what the other names were at this time. He stated that he sold the 22 Ruger to an unknown person at a gun show in Long Beach within the last few weeks. He also stated that he never belonged to the Nazi Party but that he has attended some of their meetings. He stated he joined the John Birch Society but that they kicked him out when he broke the window in Long Beach with the brick.

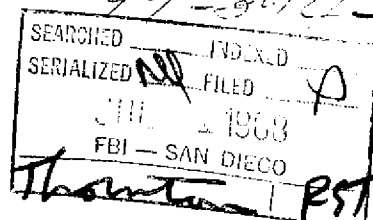

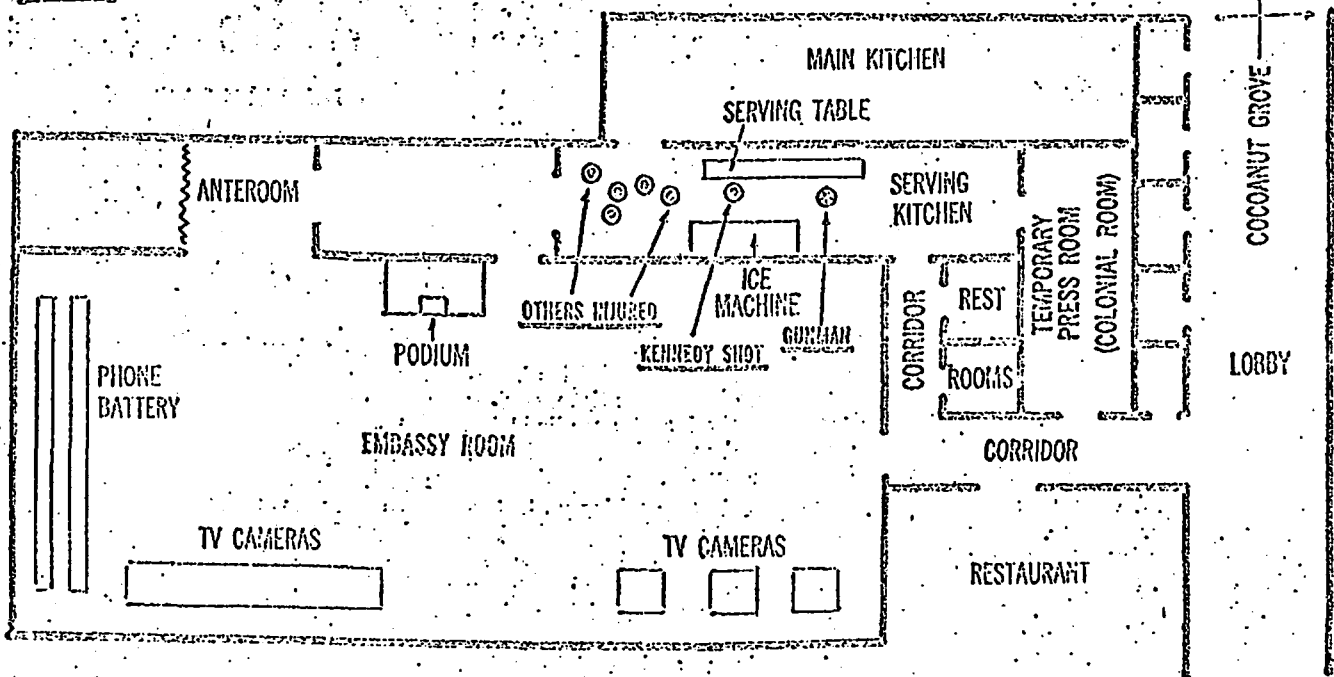


DIAGRAM OF SHOOTING SCENE—Sketch shows the doors leading from behind podium at Embassy

On 6/4/68 the above-captioned person was a registered guest at the Ambassador Hotel, Los Angeles, California.

At 12:15 A.M. on 6/5/68, SIRHAN B. SIRHAN, at the conclusion of a victory rally by the late Senator ROBERT F. KENNEDY (D-New York), in the kitchen area leading off the Embassy Ballroom shot and killed Senator KENNEDY, utilizing a .22 caliber revolver.

The Los Angeles Police Department requested the assistance of the Bureau in the location and interview of guests of the hotel in an effort to determine whether or not any of the guests might be in possession of any information concerning a possible conspiracy, might know SIRHAN, or might have seen him about the hotel on the night of 6/4/68.

All information, negative or positive, should be incorporated into an FD-302, as all information is being disseminated to the District Attorney, Los Angeles County, in report form, such reports being prepared by Los Angeles.

Trial date is tentatively set for the first part of November 1968, and it would be appreciated if the lead is covered in an expedite fashion. For your assistance, there is enclosed a diagram of the hotel area and location of the shooting.

Mrs. FRANCES HOLLAND, 552 Eldorado Drive, Escondido, California, advised as follows:

She is the Southern California Grand Counsellor of the Rosicrucian Order, also known as the Ancient Mystical Order Rosae Crucis (AMORC). She advised the state and international headquarters of AMORC have designated her to handle any inquiries concerning SIRHAN SIRHAN's membership in AMORC. She stated SIRHAN is a member of the Supreme Grand Lodge, San Jose, California, which is a corresponding membership and to her knowledge he did not attend meetings but received correspondence and instructions by mail from San Jose, California, and in turn submitted his lessons by mail to San Jose, California.

Mrs. HOLLAND advised the San Jose Office maintains a complete file of correspondence with all members, which file contains the members original application form. She understands that FBI Agents at San Jose, California, were permitted to review SIRHAN's file and were given a duplicated copy of his application blank.

AMORC has local lodges and chapters to which some members belong, although membership in a local club is not required. Mrs. HOLLAND stated she has checked and determined that SIRHAN was not a member of the Pasadena Chapter or any other lodge or chapter. SIRHAN, however, did once, and only once, visit one of these subordinate bodies. He attended the weekly meeting of the Pasadena Chapter on the evening of June 4, 1968. Mrs. HOLLAND made available a page of the guest register of the Pasadena Chapter, which bears the signature SIRHAN SIRHAN, 696 East Howard, Pasadena, and reflects that he is a member of AMORC, with membership number 3-413-477. On the date column of this form SIRHAN entered the date April 16, 1968. Mrs. HOLLAND stated that this is an error and SIRHAN probably used this date because the last previous registration was on that date. Mrs. HOLLAND

confirmed by talking to the supervisor of the Pasadena Chapter, that SIRHAN visited that chapter on the evening of June 4, 1968. This supervisor is SHERMAN LIVINGSTON, 2555 Vista Laguna Terrace, Pasadena, California, telephone number 794-6141.

LIVINGSTON told Mrs. HOLLAND he recalls SIRHAN telling people at the meeting how to pronounce his name. LIVINGSTON looked for SIRHAN after the meeting but he was unable to find him.

In signing in, SIRHAN showed he was a first degree member. Mrs. HOLLAND stated that this is a beginner's degree which would indicate membership of less than one year.

AMORC has no full time hall in Pasadena. The chapter meets every Tuesday night. Master of the chapter is THEODORE R. STEVENS, 886 Pullman Street, Los Angeles, California, telephone number 257-9368.

Mrs. HOLLAND stated she would call Mr. LIVINGSTON and Mr. STEVENS on the evening of June 12, 1968, to instruct them to cooperate in answering inquiries from the FBI. She stated the wives of both of these individuals are upset with the bad publicity given AMORC in the press and LIVINGSTON and STEVENS should be contacted by telephone to arrange an appointment.

Mrs. HOLLAND subsequently telephonically contacted the FBI Office, San Diego, California, on June 12, 1968, and advised as follows:

She was in telephonic contact with Mr. LIVINGSTON and discussed the matter of being interviewed by the FBI at Los Angeles. She stated that Mr. LIVINGSTON reviewed his notes and indicated that he had attended the Pasadena meeting
