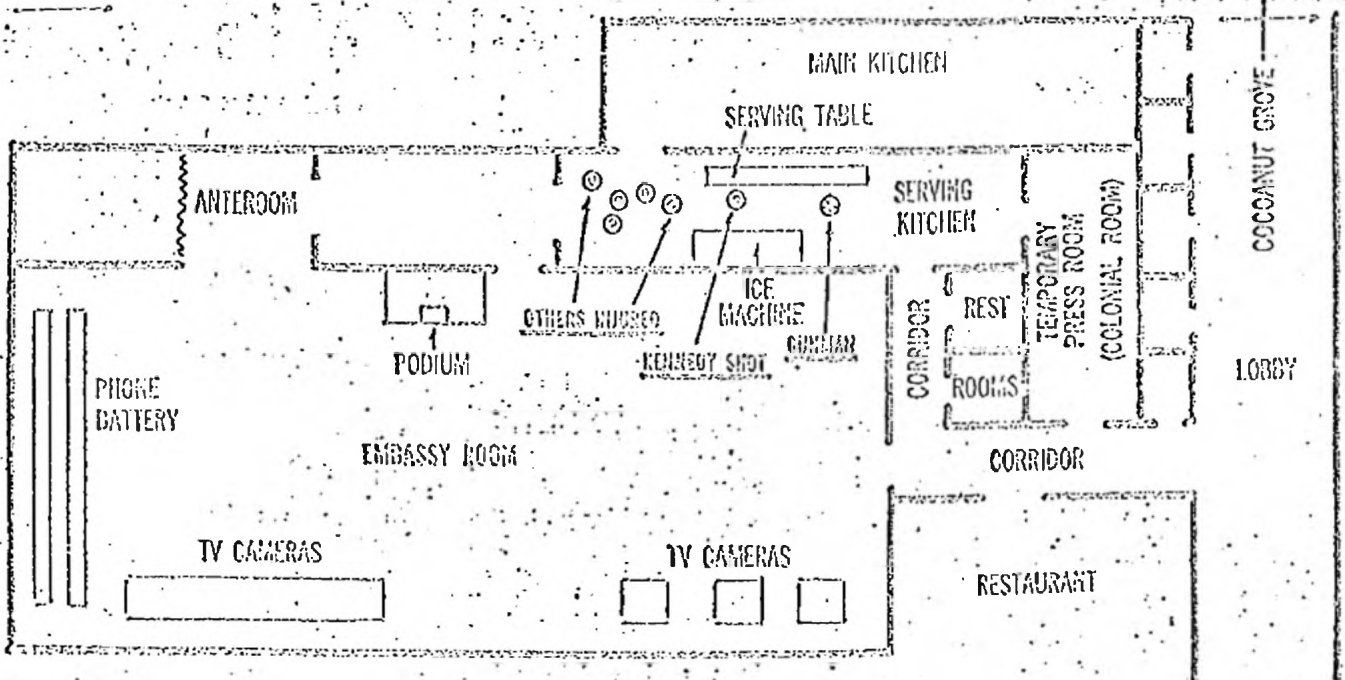


DIAGRAM OF SHOOTING SCENE--Sketch shows the doors leading from behind podium at Embassy

The following is furnished for the information of San Diego:

Mrs. VIRGINIA H. SATIR was one of the speakers at a seminar on hospital administration held at the Ambassador Hotel from June 3 through 6, 1968. She stayed at the Ambassador Hotel during this period on the basis of a reservation made for her by the American College of Hospital Administration, San Francisco, California.

The Los Angeles Office has requested that she be interviewed in an effort to determine whether she might be in possession of any information concerning a possible conspiracy in the shooting of Senator KENNEDY, might know SIRHAN BISHARA SIRHAN, or might have seen SIRHAN about the Ambassador Hotel on the night of June 4, 1968.

All information, whether positive or negative, should be incorporated into an FD-302, with 22 copies to be furnished the Los Angeles Office.

No photograph of SIRHAN for display to Mrs. SATIR is being furnished San Diego as it is assumed that office has such photographs.

Mrs. VIRGINIA M. SATIR, Kairo's-Wishing Well, Rancho Santa Fe, California, advised that she had been staying at the Ambassador Hotel, Los Angeles, from June 3, through June 6, 1968, in connection with a convention of hospital administrators. She said that on the evening of June 4, 1968, she had returned to the hotel from a meeting of the American College of Hospital Administration at about 11:30 in the evening. She went to her room and subsequently watched on TV events in connection with the shooting of Senator ROBERT F. KENNEDY. She did not leave her room during this period and did not see or hear anything first-hand in connection with the shooting. She did not see anyone resembling SIRHAN BISHARA SIRHAN during her stay at the hotel.

Mrs. JEANETTE BRYANS, 5698 Dugan Avenue, La Mesa, California, personally appeared at the San Diego Office of the FBI on March 4, 1969, to furnish information relative to the current trial of SIRHAN SIRHAN at Los Angeles, California.

Mrs. BRYANS stated that at about the time of the Arab-Israeli six-day war in 1967, while watching the Joe Pyne TV Show from Los Angeles, California, she observed a group of about five or six Arabs or Jordanians on this program who spoke about the Arab-Israeli war and, according to the recollection of Mrs. BRYANS, made some comment about the possibility of ROBERT KENNEDY being assassinated. Mrs. BRYANS said she could not positively identify any of the participants on this show in connection with this interview, but believed one had a double name similar to SIRHAN SIRHAN and had the impression that this name when translated meant "wolf." Inasmuch as she could not give a specific date for this program, she indicated it was well appointed in her mind because another participant on this same program but speaking on a different subject was Mr. ARTHUR A. BUCKEL, with whom she is well acquainted due to Mr. BUCKEL's friendship with Mrs. BRYANS' brother.

Mrs. BRYANS stated she did not remember specifically any comments made during the interview of the Arabs or Jordanians but did recall that there was general conversation about the conflict in the Middle East. She indicated this information may be of value if it could be used to prove that SIRHAN SIRHAN had, in fact, been one of the participants on the Joe Pyne TV Show and if the statement was actually made on that show that the life of ROBERT KENNEDY was in danger.

Mr. ARTHUR A. BUCKEL, 3452 Bayonne Drive, San Diego, California, advised that during March, 1967, he and his wife were in the Los Angeles, California, area on business and pleasure. He stated that he was a participant on the Joe Pyne TV Show during this visit and remembered that he participated as a member of the audience when some unidentified individual made comments regarding the support all Negroes should give Senator ADAM CLAYTON POWELL regardless of his moral or personal standards. Mr. BUCKEL said he felt strongly that some of the statements made should be refuted and volunteered to participate in the rebuttal of statements made on the program.

Mr. BUCKEL said he could not recall specifically other parts of the program but did remember that there were some young men believed to be either Arabs or Jordanians who made comments relative to the conflict, in the Middle East. He could not recall any specific mention being made regarding ROBERT KENNEDY but indicated that due to the period of time which has elapsed it was only natural that anything said might be forgotten.

Mr. BUCKEL contacted his wife and after checking some personal records determined that this trip had occurred on the weekend of March 10-13, 1967, and indicated he had located a cancelled check dated March 13, 1967, with which he paid his hotel bill before returning to San Diego from Los Angeles. He said that to the best of his recollection he and his wife attended the JOE PYNE TV Show about 6:00 p.m. on Monday, March 13, 1967, following which they returned to San Diego. He stated the show was recorded at that time and he subsequently viewed this show at San Diego over the Los Angeles station on March 18, 1967.

BUCKEL said he could not recall any of the program participants specifically and could not state whether or not SIRHAN SIRHAN was present at the broadcast.



On this date MARTIN M. SCHORR, Phd., Hillcrest North Medical Center, Suite 550 Washington, San Diego, Tel: 296-4455, came into the office to furnish a theory that he has concerning above matter.

SCHORR stated he was the first witness for the defense at SIRHAN's trial and during the course of interviewing and examination of SIRHAN he formed a theory that SIRHAN may have been psychologically programed to kill KENNEDY without SIRHAN having knowledge of a conspiracy. SCHORR said SIRHAN may have been ~~xxx~~ used in this manner because of his mental condition.

SCHORR said he has ~~xxx~~ no facts to support this theory and only considers this as a possibility due to fact SIRHAN unable to recall anything concerning the shooting and appeared to be in some sort of a trance just prior to and after he killed KENNEDY.

SCHORR requested this be made a matter of record with this office in the event something should happen to him or other information of this nature should ~~h~~ develop in this matter.

On 1/22/71, Dr. SCHORR telephonically contacted the writer to advise him of a meeting to take place on 1/29/71 at Howard Johnson's Restaurant located on Waring Road, San Diego, California. This meeting is to be participated in by Judge BOB STANFORTH, District Attorney ED MILLER, and a Los Angeles lawyer, who was involved in the trial of SIRHAN-SIRHAN. Dr. SCHORR was calling to extend an invitation to writer to attend this meeting since he expects the trial of SIRHAN-SIRHAN to be a main part of the discussion.

It is noted that Dr. SCHORR was a Psychiatrist who gave testimony at the SIRHAN-SIRHAN trial and when previously contacted by writer wished to discuss his theories of how SIRHAN-SIRHAN had been put up to the assassination, which information has already been entered in this file.

Dr. SCHORR was advised that the writer has no authority for attending such a meeting and that the Special Agent in Charge of the San Diego Division is most probably already aware of any forthcoming discussions of local law enforcement officials scheduled to take place, on higher administrative levels.

Dr. SCHORR had called this office late last evening; however, in learning that I was not in the office, advised that he would call me today.

He called to advise that he was participating in a Criminal Justice Series this coming weekend, Friday, 4:30 p.m. to 8:00 p.m., and Saturday, 9:30 a.m. to 12 noon, and the topic was "Victims of Violence." He said that the meeting would take place in the College Grove shopping area in a large hall, exact address unknown to him. He advised that there would be approximately 400 people in attendance and that they would probably discuss at some length the two KENNEDY assassinations and the organization known by, according to Dr. SCHORR, "In The Name of God."

He requested that we furnish a speaker who would speak without being identified as with the FBI or serve as an observer during the proceedings and possibly take photographs of some of those in attendance.

Since this appears to have much potential for possible problems, I politely informed Dr. SCHORR that due to our heavy commitments we would be unable to join in either as a speaker or observer. He advised that he appreciated this situation; however, he did want to mention this meeting to me.

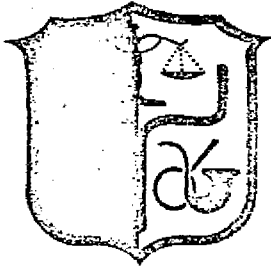

Dear Mr. Gray:

Thank you for your letter of May 24, 1972. I regret that I was unable to respond until this time. Since your letter of May, 1972, arrived I have been sequentially at Sharp Hospital for an acute enteritis due to food poisoning and just spent a remarkably anxiety-free summer vacation in the Upper Lake country of Northern Minnesota where my wife's relatives still whinny away.

The information with respect to the Uniform Crime Reports and the particular information with respect to law enforcement officers killed in the line of duty is of most particular concern to me. I plan to use it with appropriate credits in my forthcoming book and I am currently arranging book publishing affairs with Bob Zappa of McGraw Hill. I was particularly shocked recently over the California Supreme Court's decision on capital punishment and I was especially concerned since that decision revolved itself about the Robert Page Anderson case of which I was a large part. I have been on at least two major murder cases in California in which homicide or murder was predicted through psychological testing and for which officials and authorities had their hands tied and could do nothing until the events actually took place, days later in one case and months later in the next. There were no priors with respect to both of these cases. I thoroughly agree with Hutschnecker, whom I understand is a physician-friend of our President, that psychological test screening and psychiatric screening of six to eight year olds would be most helpful in redirecting aggressive and violent tendencies during the pre-teen years. I do not at all agree with those individuals of the press who label people like Hutschnecker a fascist or an authoritarian type dictator for making such helpful suggestions as a means of improving and enhancing our society rather than tearing it down. I cannot understand some of the recent court rulings which over protect the assassin of law and justice dignified by decisions ranging from the superior court system all the way to the highest court in the land while simultaneously ignoring the rights of the would-be victims and their heirs.

To make no discrimination whatsoever with regard to the particular nature of each personality studied, allowing each death-row inmate complete freedom to live and eventually become paroled not only erodes the judicial process which has made this nation the greatest of the kind in the world in terms of freedom and justice for all, but the latest acts of the Supreme Court in abolishing capital punishment now permits the Charlie Mansons of contemporary America (and there are many) freedom to go out and do it again along with the milque toasts (and there are some) who are less likely to repeat.

I was primarily instrumental as a key-expert in the Robert Page Anderson trial which involved a four hour shoot-out with more than half of San Diego's police force during an active work day. The Whitman case, the Morses, the Mansons need to be stopped and stopped dead in their tracks.

Punishment and its degree should not be mandated away by a group of people who blow Utopian smoke rings in their ivory towers and fiddle away citizen rights while Watts burns.

Is the legacy of Washington, Jefferson, and Lincoln to be surrendered to the murderers of custom and taboo? It seems that our age of anxiety following World War II has now been replaced by the decade of the anti-hero. We are in some ways like Rome before the fall. There is still time to turn this around and fulfill the American dream of our ancestors for all Americans and mankind.

I am trying to incorporate into several chapters material relating to the two Kennedy assassinations and I would like to obtain additional material with reference to the Arthur Bremer investigation. I am now going through a second reading of the 26 volume Warren report and have developed the impression, perhaps against my better judgment, that assassinations during the past decade at least and through Arthur Bremer have been programed, planted, computerized, and tailored by communist or communist-inspired organizations. Lee Harvey Oswald may have, in fact, been a double agent but he sold us down the river. There are remarkable parallels in Oswald, Ruby, Sirhan, and Bremer which might be worthy of considered investigation. Some of the tangents may well extend into Havana, the mideast and Moscow and others into organized crime.

If your department has any material which can be confidentially released that is now archived, I would be most happy to try to put it all together as part of my book on homicide investigation. The book is tentatively called "Murder is A Family Affair" and this includes many cases ranging from parricide to the carcinogenic pollution of our national character.

The greening of America reddens the land with its manifesto for anarchy. It is high time that other voices be heard. We need to return America home and to make freedom with responsibility meaningful once again as we face eventful crisis years ahead.

I deeply apologize for having taken so long to respond to your letter of May 24, Like Avis I shall try harder the next time to be consistently prompt.

While hospitalized I read of the new women appointments to the Bureau and was particularly amused by a statement allegedly made by Barbara Herwig with respect to smoking and opening her own door. In closing, I should like to suggest that I agree completely with Miss Herwig in her statement about equality for women. I would like to tell her that all gentlemen should hold the door open for any lady, regardless of race, creed, color, place of national origin, or sexual differentiation.

If you would be interested in some of the abstracts of the materials I have been writing to date with respect to murderers and their crimes, I'll be happy to release to you copies of my as yet unreleased book materials for your own edification and interest. I realize you are a most busily occupied man these days and I look forward to your next communication however long the wait. I am enclosing a curriculum vitae in this letter as an update for your files and possible convenience.
