Your Excellency Mr. President of the Republic:

The sorrow that invades the world from the first morning hours of yesterday, confuses us profoundly in the great sorrow that invades our hearts because of the crime attempted against the life of Senator Robert F. Kennedy. With this sincere sorrow we express condolences to the cities and governments of the United States of America.

Our organization condemns this criminal act and asks for the maximum punishment for the individual who apparently is the instigator of this crime and we believe he deserves the Guillotine so that once and for all these criminal acts can be abolished for good from your prosperous country in which criminal statistics are great in number. We are sending our views regarding this separately for your study.

As stated before, Mr. President, we ask you with all our heart to express our condolences to your country and our accompanying sorrow to the Kennedy family, whose sorrow at this moment we share.
