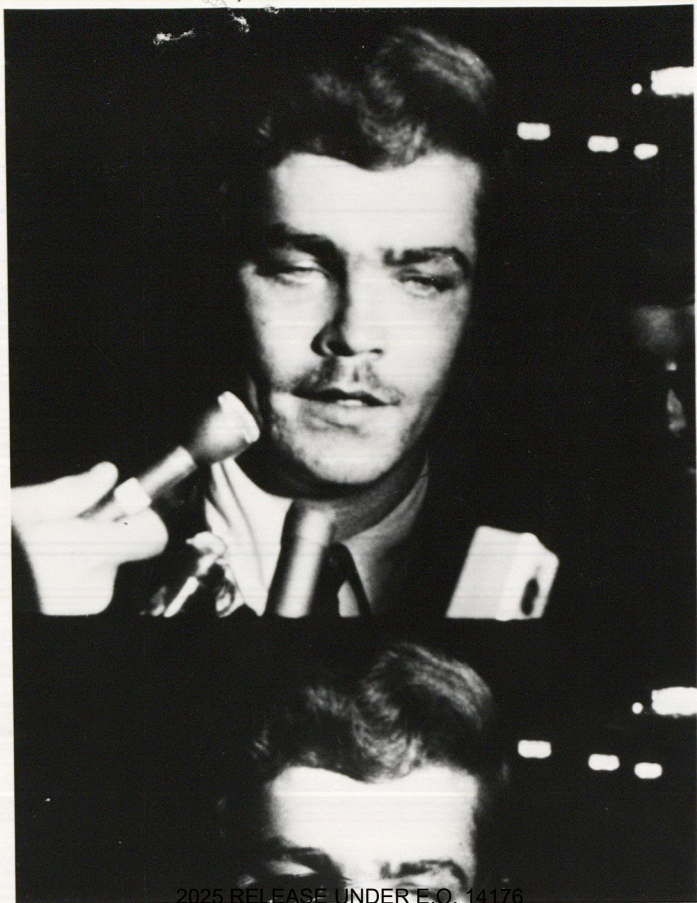

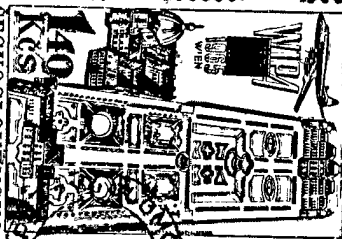

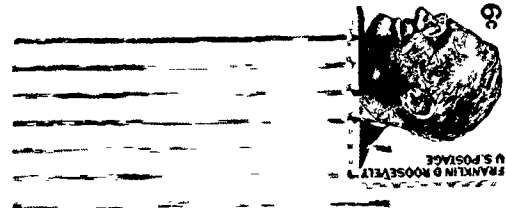

Enclosed is a copy of a letter which was received by an ex-employer of Sirhan B. Sirhan.

Sirhan B. Sirhan, is in custody of the Los Angeles Sheriffs Office for the alleged assassination of United States Senator Robert F. Kennedy.

We are attempting to determine the authenticity of this letter and also the date it was sent from Holland to the United States. Our crime lab interpreted the post mark as being 21 VI 10, 1968. A clarification of this date is requested.

It is further requested that Mr. Esbes, be interviewed and that all information possible with respect to the writer of this letter and his alleged acquaintance with Sirhan be forwarded to this department.

At present there is serious doubt that said writer knew Sirhan. Investigation thus far indicates this letter is a hoax. Please be assured of our cooperation in all matters of mutual interest.

Well dear Sirh I hope you won't do anything you will be sorry for later and please give me finally your real adress. I even believe that this adress is not complete without the name of the street. I thought Los Angeles was so big that this could hardly be enough

Why don't you get married right away than you can have your own adress. Moving from one to the other is'nt good at all.

My daughter is growing up fine. She will be 9 years old at the 6th of August. Send her a nice card will you?"

Well Sirh I am going to bed now because it is pretty late and tomorrow I have a lot of work to do.

I hope you will write pretty soon so we will have better contact with each other than in the past.

I wish you and your girl all the best for the future

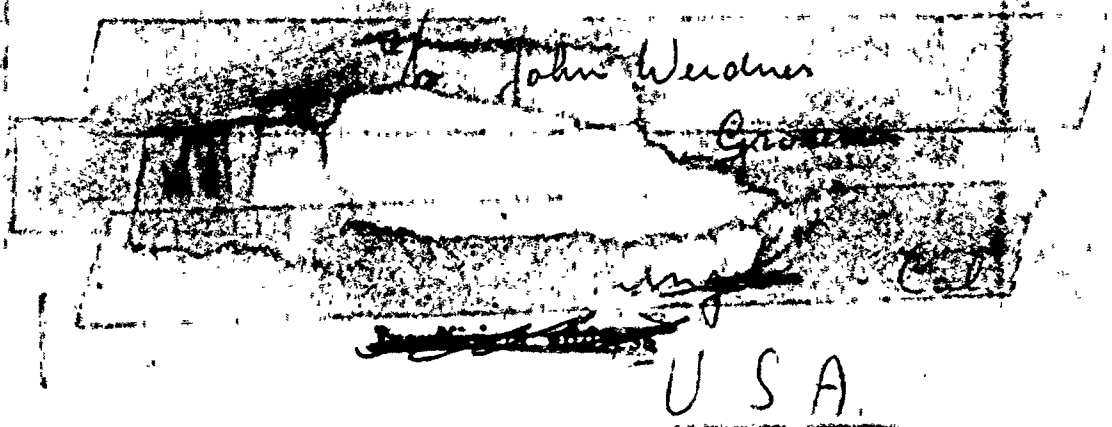

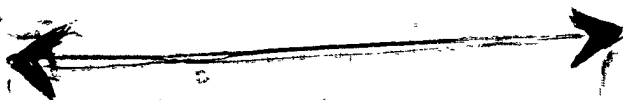
