THE ORDER TRACES ITS ORIGIN TO THE MYSTERY SCHOOLS OR SECRET SCHOOLS OF LEARNING ESTABLISHED IN EGYPT ABOUT FIFTEEN HUNDRED B.C. DETAILED HISTORY OF ORDER REPORTEDLY SET FORTH IN ENCYCLOPEDIA BRITANNICA, FOURTEENTH EDITION (NEW STANDARD ENCYCLOPEDIA), AND IN BOOK ENTITLED "ROSICRUCIAN QUESTIONS AND ANSWERS WITH COMPLETE HISTORY OF THE ORDER," BY DR.
