DURING VISIT, ASSOCIATES NOTED HIS ADMIRATION OF NAZI DOCTRINES AND PROCLIVITY FOR ENDORSING COMMUNIST POLICIES. MEXICAN AUTHORITIES INDICATED HE WAS CONSIDERED A LEFTIST LEADER AT COLIMA. ON SEVEN ONE SIXTYSEVEN FEDERAL SECURITY POLICE IN MEXICO DETERMINED CURIEL HAD SENT FAKE MESSAGE TO HIMSELF FROM NONEXISTENT INDIVIDUAL M. OLYMPIC COLLEGE, BREMERTON, WASHINGTON, ADVISED THAT ON THE  
MORNING OF JUNE SIX LAST, WHILE HE AND STUDENTS OF OLYMPIC COLLEGE  
WERE IN A DISCUSSION WITH NOSAYAN, A STUDENT AT OLYMPIC COLLEGE,  
NOSAYAN RELATED THAT THE ASSASSIN OF KENNEDY WAS QUOTE JUSTIFIED  
IN DOING WHAT HE DID END QUOTE. NOSAYAN REPRESENTED THAT HE WAS  
PERSONALLY ACQUAINTED WITH SIRHAN BISHARA SIRHAN, HAVING MET HIM  
IN SAN FRANCISCO. NOSAYAN ADVISED QUOTE YOU MUST REMEMBER THAT  
THIS TOOK PLACE ONE YEAR FROM JUNE FIFTH. END QUOTE. ARMSTEAD  
OPINED THAT NOSAYAN WAS APPARENTLY WELL INFORMED CONCERNING  
STATEMENTS OF SENATOR ROBERT KENNEDY SUPPORTING THE SHIPMENT OF

ARMSTEAD ADVISED THAT IN PREVIOUS DISCUSSION NOSAYAN HAD INDICATED THAT HE DOES NOT HATE THE JEWS AS INDIVIDUALS BUT IS AGAINST THE AGGRESSION OF ISRAEL AND THAT HE HOLDS IT AGAINST THE U.S. AND BRITAIN FOR HELPING ISRAEL.

ACCORDING TO NOSAYAN'S REMARKS TO ARMSTEAD, NOSAYAN HAS SAID THAT NASSAR IS QUOTE A GREAT MAN END QUOTE AND QUOTE WE DON'T UNDERSTAND HIM. END QUOTE.

MCMANUS ADDED THAT AT TIME INDIVIDUAL WAS AT FREE BAR HE (MCMANUS) RECALLED SEEING A PAIR OF DARK BROWN (WHITH SHEEN) BUCKLE LOAFERS WITH HEAVY GRAIN LEATHER NOT WELL CARED FOR POSSIBLY WORN BY INDIVIDUAL.
