OWEN WAS FEARFUL OF SEEING SANDLIN SINCE HE HAD RECEIVED THREATENING CALLS AT HIS HOME AND WAS WORRIED OVER THE POSSIBILITY SOMEONE MIGHT DO HIM HARM.

BY TELEPHONE CALL JUNE TWENTY NINE LA ADVISED SANDLIN ASSIGNED THIS CASE ON LAPD. HAD PLANNED TO INTERVIEW OWEN AT NAPA BUT HAD DEFERRED INTERVIEW UNTIL OWEN RETURNED TO LA AREA. IT HAD BEEN DETERMINED THAT OWEN HAD HIRED AN ATTORNEY NAMED DAVIS WHO ONCE REPRESENTED CARYL CHESSEMAN AND THAT OWEN WAS TO BE INTERVIEWED BY THE PRESS WITH HIS HEAD COVERED BY A SACK. DAVIS HAD INFORMED THE LAPD OWEN WOULD RETURN TO LA EARLY IN THE COMING WEEK AND WOULD BE AVAILABLE FOR INTERVIEW.

ON JUNE TWENTY NINE SF CONTACTED MRS. JOSEPHINE HARDISTER, NAPA, CALIF., BY TELEPHONE. SHE ADVISED THAT OWEN WAS NOT THEN AT THE RANCH. SHE SAID SHE WOULD GET A MESSAGE TO HIM CONCERNING THE IDENTITY OF SANDLIN.

THE "SAN FRANCISCO EXAMINER" NEWSPAPER FOR JUNE THIRTY REPORTED INFORMATION CREDITED TO GEORGE T. DAVIS, SF ATTORNEY, CONCERNING AN UNIDENTIFIED SOUTHERN CALIFORNIA MINISTER WHO WAS HIDING IN THE SF AREA BECAUSE HE HAD EVIDENCE OF POSSIBLE CONSPIRATORS IN THE KENNEDY ASSASSINATION AND HAD RECEIVED THREATS AGAINST HIMSELF AND HIS FAMILY.

ACCORDING TO THIS STORY, ON JUNE THREE THE MINISTER PICKED UP TWO HITCHHIKERS IN LA AND AGREED TO SELL THE SMALLER OF THE TWO A PONY FOR USE AT A RACE TRACK. THIS INDIVIDUAL SAID HE WAS FROM JORDAN AND CAME TO THE U. S. AT AGE THIRTEEN.

ON THE NIGHT OF JUNE THREE THE MINISTER MET THE PROSPECTIVE BUYER ON SUNSET BLVD. HE WAS ACCOMPANIED BY TWO MEN AND A WOMAN. HE

SHOWED A ONE HUNDRED DOLLAR BILL AND SAID THE FULL AMOUNT OF THREE HUNDRED DOLLARS WOULD BE AVAILABLE AT EIGHT AM THE NEXT DAY. AT THAT TIME THE PURCHASER DID NOT APPEAR BUT HIS COMPANIONS OF THE PREVIOUS EVENING ADVISED THAT HE WOULD MEET THE MINISTER AT ELEVEN PM ON THAT DATE. THE MINISTER, HOWEVER, WAS UNABLE TO KEEP THE APPOINTMENT BECAUSE OF A PREVIOUS COMMITMENT.

ON THE NIGHT OF JUNE FOUR-JUNE FIVE MINISTER SAW TV ACCOUNT OF KENNEDY ASSASSINATION AND RECOGNIZED PHOTO OF SIRHAN AS THE SMALL MAN WHO WANTED TO BUY THE PONY. THE MINISTER IMMEDIATELY WENT TO THE LAPD WHERE HE WAS INTERVIEWED. ON THE SAME NIGHT HE RECEIVED AN ANONYMOUS CALL WARNING HIM TO KEEP HIS MOUTH SHUT IF HE KNEW WHAT WAS GOOD FOR HIM AND HIS FAMILY.

ON THE FOLLOWING DAY (APPARENTLY JUNE SIX) THE MINISTER WENT TO OAKLAND, CALIF. ON BUSINESS. HE RECEIVED A CALL AT HIS MOTEL FROM A MAN CLAIMING TO BE L. L. SANDLIN OF THE LAPD WHO WANTED TO TALK TO HIM AT THE HYATT HOUSE IN PALO ALTO. THE MINISTER THEN CONSULTED AN OLD FRIEND, BEN HARDISTER, WHO BELIEVED IT WOULD BE FOOLISH TO SEE THE UNKNOWN CALLER IN VIEW OF WHAT THE MINISTER KNEW. HARDISTER REPORTEDLY CALLED THE FBI AND WAS INFORMED THAT A CHECK WOULD BE MADE CONCERNING THE IDENTITY OF SANDLIN. THIS IS AN APPARENT REFERENCE TO THE CALL MADE BY GARDNER TO THE VALLEJO RESIDENT AGENCY.

DAVIS IN THIS RELEASE WAS CRITICAL OF THE LAPD AND SAID QUOTE LOS ANGELES AUTHORITIES HAVE TAKEN THE POSITION THAT THERE IS NO CONSPIRACY IN THIS CASE, SO THIS MAN'S STORY IS NOT IMPORTANT. UNQUOTE

THIS STORY ALSO REPORTED THAT THE MINISTER HAD NOT HEARD ANYTHING FROM THE FBI CONCERNING SANDLIN. THIS IS UNTRUE IN VIEW OF INFORMATION FURNISHED MRS. JOSEPHINE HARDISTER FOR HER GUEST ON JUNE TWENTY NINE.

BY MEANS OF TELEPHONE CALL TO LA JUNE THIRTY NO ADDITIONAL PERTINENT INFORMATION WAS OBTAINED EXCEPT THAT THE LAPD HAD DESCRIBED OWEN AS AN EXCITABLE TYPE.

IN VIEW OF THE ACTION PREVIOUSLY TAKEN BY THIS OFFICE IN THIS MATTER, AND, SINCE ARRANGEMENTS HAVE BEEN MADE BY THE LAPD FOR INTERVIEW OF OWEN UPON HIS RETURN TO SOUTHERN CALIFORNIA IN THE COMING WEEK, NO ADDITIONAL INQUIRY IS CONTEMPLATED.

REBUTEL JULY ONE LAST INSTRUCTING THAT JERRY OWEN BE INTERVIEWED IMMEDIATELY TO DETERMINE WHAT INFORMATION HE HAS PERTINENT TO THIS CASE.

ON JULY ONE, MRS. JOSEPH HARDISTER TELEPHONICALLY CONTACTED AT NAPA CALIFORNIA, BUT SHE ADVISED OWEN HAD DEPARTED FROM THEIR RANCH AND COULD BE CONTACTED THROUGH ATTORNEY GEROGE T. DAVIS, SF.

ATTORNEY GEORGE T. DAVIS TELEPHONICALLY CONTACTED AFTERNOON OF JULY ONE AND HE STATED WOULD HAVE OWEN APPEAR AT SF OFFICE OF FBI AT TEN AM, JULY TWO LAST. OWEN FAILED TO KEEP APPOINTMENT AND DAVIS AGAIN TELEPHONICALLY CONTACTED AT ONE PM, JULY TWO, WHEREUPON DAVIS APOLOGISTIC AND STATED HAD BEEN IN TELEPHONIC CONTACT WITH COP THOMAS REDDIN, LOS ANGELES, AND TEAM OF INVESTIGATIONS ENROUTE TO SF FOR PURPOSE OF INTERVIEWING OWEN FOR ALL INFORMATION IN HIS POSSESSION CONCERNING THIS MATTER. DAVIS PROMISED WOULD TELEPHONICALLY CONTACT OWEN AND THEREAFTER SF OFFICE WOULD BE ADVISED OF DEFINITE ARRANGEMENTS FOR INTERVIEW. DAVIS DID NOT RECONTACT SF OFFICE, AND AT TEN AM, JULY THREE, FURTHER EFFORT MADE TO CONTACT DAVIS TELEPHONICALLY HIS SECRETARY STATED HE WAS BUSY BUT THAT SHE HAD DISCUSSED MATTER WITH HIM. SHE RELATED DAVIS HAD APPOINTMENT FOR TEAM OF INVESTIGATORS

FROM "OFFICE OF DISTRICT ATTORNEY IN LOS ANGELES" TO INTERVIEW OWEN, AND THAT AFTER THIS CONFERENCE OWEN WOULD BE MADE AVAILABLE TO FBI FOR INTERVIEW.

TWO SUBSEQUENT CALLS RECEIVED FROM DAVIS'S SECRETARY ON JULY THREE. AT ELEVEN AM, SHE ADVISED INFORMATION HAD JUST BEEN RECEIVED THAT THE "TEAM OF INVESTIGATORS" HAD JUST ARRIVED AT SF AIRPORT AND WERE RUNNING LATE. (CONTACT WITH LOS ANGELES OFFICE AND WITH SECURITY OFFICE OF SF HILTON HOTEL DETERMINED THAT TWO REPRESENTATIVES OF LAPD CHECKED INTO THAT HOTEL DURING EVENING OF JULY TWO). AT TWO FIFTY FIVE PM, DAVIS' SECRETARY ADVISED THAT THE LA TEAM HAD BEEN WITH OWEN FOR APPROXIMATELY THREE HOURS AND HAD NOW DEPARTED FOR THE PURPOSE OF GIVING HIM A "LIE DETECTOR TEST". SHE RELATED THAT DAVIS WOULD INFORM THIS OFFICE WHEN OWEN WAS AVAILABLE FOR INTERVIEW AND PRIVATE SPACE WOULD BE MADE AVAILABLE IN DAVIS' OFFICE FOR INTERVIEW OF OWEN.

FOR INFO BUREAU AND LA, OWEN APPEARS IDENTICAL WITH OLIVER BRINDLEY OWEN, AKA, WSTA, SF FILE THIRTY ONE DASH THREE SIX ONE ONE, LA FILE THIRTY ONE DASH FIVE SEVEN TWO SEVEN, BUFILE THIRTY ONE DASH SEVEN ONE TWO EIGHT FIVE, PD OO, WHEREIN PROSECUTION DECLINED. OWEN ALLEGEDLY TRANSPORTED ONE JACQUELINE JANICE ROATH, AKA, FROM WASHINGTON TO OREGON FOR IMMORAL PURPOSES. OWEN ARRESTED AT PORTLAND, OREGON, FEBRUARY, FORTY FIVE, ON CHARGE DISORDELY CONDUCT AND SENTENCED TO THIRTY DAYS AND FIFTY DOLLAR FINE.

ATTORNEY GEORGE T. DAVIS HAS IN PAST ESTABLISHED REPUTATION AS OPPORTUNIST WHO TAKES ADVANTAGE OF ACHIEVING PUBLICITY BY DEFENDING INDIVIDUALS ACCUSED OF CRIMES HAVEING WIDESPREAD PUBLIC INTEREST. WAS SUBJECT OF INTENSIVE INVESTIGATION BY INS DURING FORTY SEVEN IN CONNECTION WITH OBTAINING FALSE BIRTY CERTIFICATES FOR CHINESE ALIENS. TRIED WITH TWO CHINESE ACCOMPLICES IN FIFTY. IN VIEW OF ABOVE BACKGROUND OF DAVIS AND OWEN AND THEIR FAILURE TO KEEP APPOINTMENTS WITH THIS OFFICE FOR INTERVIEW OF OWEN, IT RECOMMENDED THAT NO FURTHER ACTION BE TAKEN BY THIS OFFICE TO CONTACT OWEN. IF INTERVIEW STILL DESIRED, IT IS SUGGESTED SUCH ACTION BE WITHHELD UNTIL HE RETURNS TO THE SOUTHERN CALIFORNIA AREA WHERE HE WILL BE SEPARATED FROM ATTORNEY GEORGE T. DAVIS
