THE FATHER, BISHARA SALAMEH GHATTAS SIRHAN, BORN MARCH SEVENTEEN, THIRTEEN, AT TAIBEH, PALESTINE, FIVE FEET FIVE, ONE HUNDRED THIRTY TWO POUNDS, GRAY HAIR, BROWN EYES, OCCUPATION GARDENER AND GENERAL UTILITY MAN, ARRIVED IN U.S. JANUARY TWELVE, FIFTY SEVEN, WITH WIFE AND CHILDREN. HE DESERTED HIS FAMILY AND RETURNED TO JORDAN IN JULY RIFTY SEVEN. AFTER RETURNING TO JORDAN, HE ALLEGEDLY WROTE THREATENING LETTERS TO HIS WIFE DEMANDING THAT SHE AND HIS TWO YOUNGER CHILDREN RETURN TO HIM. LILLENAS, ONE NINE FOUR FIVE EAST MOUNTAIN, PASADENA,
CALIFORNIA. LILLENAS ADVISED INS IN AUGUST FIFTY SEVEN
THAT HE HAD OBTAINED SEVERAL WELL-PAYING JOBS FOR SIRHAN
BUT THAT HE WOULD NOT KEEP THEM AND HAD NOT LIVED UP TO
HIS PROMISES THAT HE MADE PRIOR TO IMMIGRATION. LILLENAS

OBTAINED AFTER SUCH AN ARRAIGNMENT AND APPOINTMENT
OF COUNSEL AND THAT DEFENSE LAWYER IS NOT PRESENT DURING THE
INTERVIEW SUCH EVIDENCE IS TAINTED AND CANNOT BE INTRODUCED
IN THE CASE IN EITHER FEDERAL OR STATE COURT. IN ADDITION
TO THAT THE POSSIBILITY EXISTS, ACCORDING TO BYRNE, THAT
OTHER EVIDENCE MAY BE TAINTED ALL THE WAY DOWN THE LINE AND

MR. BYRNE ALSO STATED THAT MR. A.L. WIRIN, THE PROMINENT CIVIL LIBERTIES UNION LAWYER, IS ATTEMPTING TO ENTER THIS CASE AS DEFENSE COUNSEL. MR. BYRNE FURTHER STATED THAT PROBABLY THE ONLY WAY THE FBI WILL BE ABLE TO GET ADMISSIBLE EVIDENCE INVOLVING A CONFESSION OR STATEMENTS AGAINST INTERESTS IS TO REQUEST THE DEFENSE LAWYER TO BE PRESENT AND ALLOW THE DEFENDANT TO BE INTERVIEWED. THE OTHER RECOURSE IS TO REQUEST THE DEFENDANT AS WELL AS HIS LAWYER TO WAIVE SUCH A RIGHT. IT IS DOUBTFUL THE DEFENSE LAWYER WILL PERMIT SUCH. ACCORDING TO MR. BYRNE, IT IS, HOWEVER, THE ONLY WAY TO GET AN ADMISSIBLE INTERVIEW AT THIS TIME. HE POINTED OUT THAT ANY STATEMENTS MADE UNDER CONDITIONS OTHER THAN THE ABOVE WOULD BE INADMISSIBLE. HE USED AS AN EXAMPLE THAT IF THE DEFENDANT STATES THERE WAS A CONSPIRACY

TO PRECLUDE ANY POSSIBLE CRITICISM OF THE FBI NOW OR AT ANY FUTURE DATE FROM ANY SOURCE, IT WOULD APPEAR THAT EVERY LEGAL STEP SHOULD BE TAKEN TO INTERVIEW THE SUBJECT EVEN THOUGH THE RESULTS MAY BE NEGATIVE.

THE BUREAU MAY DESIRE TO CONSIDER THE
AUTHORIZING OF THIS OFFICE TO CONTACT THE DISTRICT ATTORNEY'S
OFFICE AND IF AGREEABLE WITH THEM, THE DEFENSE COUNSEL IN AN
EFFORT TO SET UP SUCH AN INTERVIEW OF SUBJECT. THE REQUEST
COULD BE MADE FOR BOTH THE DEFENDANT AND HIS COUNSEL TO WAIVE
THE COUNSEL'S PRESENCE. WHEN THAT IS TURNED DOWN, IF IT IS,
