DOROTHY MC DANIEL, CHIEF DIETITIAN, GOOD SAMARITAN HOSPITAL, ADVISED THAT NADIA J. MORALES WAS POOR EMPLOYEE AND WOULD HAVE BEEN TERMINATED HAD SHE NOT RESIGNED ON APRIL FIRST LAST. MORALES INCOMPETENT IN HER WORK AND UNABLE TO GET ALONG WITH FELLOW EMPLOYEES. MC DANIEL ADVISED THAT IN HER OPINION MORALES WAS AN EMOTIONALLY MALADJUSTED PERSON.

JOYCE FREEMAN, DIETITIAN, GOOD SAMARITAN HOSPITAL, ADVISED THAT NADIA J. MORALES WORKED UNDER HER DIRECT SUPERVISION. MORALES WAS GROSSLY INCOMPETENT AND UNABLE TO PERFORM SIMPLE WORK IN AN ACCEPTABLE MANNER. MORALES <sup>Felt</sup>~~PLET~~ THAT THE OTHER KITCHEN HELP DID NOT CARE FOR HER AS SHE WAS OF ARAB EXTRACTION AND MOST OF THE OTHER KITCHEN HELP WAS OF SPANISH DESCENT. FREEMAN ADVISED THAT MORALES WAS SUCH AN INCOMPETENT EMPLOYEE THAT OTHER EMPLOYEES DID RESENT MORALES TO A DEGREE. MISS FREEMAN IS OF THE OPINION THAT MORALES MAY HAVE AN EMOTIONAL PROBLEM.

DOROTHY MC DANIEL MADE AVAILABLE A LETTER FROM MORALES POSTMARKED MAY TWENTY NINE LAST, AT MODESTO, CALIF., WHEREIN MORALES WRITES THAT, "THE OLD MAN THAT WEARS GLASSES HE WORKS IN THE BAKERY" HAD MADE HER BABY PERFORM AN ACT OR ORAL COPULATION.
