HE WAS FROM COLIMA, MEXICO. HE FURNISHED NAME OF AN INDIVIDUAL IN LOS ANGELES AND A NON-EXISTENT TELEPHONE NUMBER. AS A RESULT OF FOREGOING, [REDACTED] WAS COMMITTED BY JUVENILE COURT TO CUSTODY OF JUVENILE AUTHORITIES AND HIS FIRST COMMITMENT WAS TO JUVENILE HALL FACILITY IN LOS ANGELES. JUVENILE AUTHORITIES RECEIVED A LETTER FROM HIS FATHER, CRISPIN CURIEL ZAMORA, THREE FIVE THREE GENERAL NUNEZ, COLIMA, MEXICO DATED NOVEMBER NINETEEN LAST.
