Oh, dear God, is it possible that such tragic fate must keep befalling the most noble family of the 20th century, the Kennedys. Please follow the following instructions most faithfully, because a big gang has conderned you, too, to death.

- 1. Make no statements, not even among your friends or your family, because walls have ears too. Keep quiet.
- 2. Leave America without delay.
- 3. Do not get in touch with anyone, not even your own wife, until after the elections.
- 4. Three months after the elections, you may return to your wonderful and unhappy children.
- 5. You must take as your companion a hapless Serbian.
- 6. Do not engage in 1969 in any State affairs.
- 7. You, unhappy brother Ted, have been condemned to death by the same gang that killed your two brothers. They will kill you on the election day this year. I entreat you as God himself to leave America right away, as soon as you receive this letter.

- 12. Let them get me to America in some way. Your sister can do it. I was sick and because of my illness, I was turned down in 1966. My health has now improved, so let them call me for another physical. Your sister can do this for me.

- 13. To be frank, I am totally impoverished and without money. Now I clean streets. I should like to ask you, therefore, dear brother Ted, for \$1,000 help.
- 14. I will get in touch by mail with your sister, the wife of the Ambassador in Paris I'll use the same green pen and tell her who I am.

The youth of the entire world is grateful to John and Bob Kennedy. May they live in eternal glory, and may the black soil in which they rest forever be light to them.

Long live Ted Kennedy, the avenger of his brothers.

Official French police records reflect that STOKIC, Djura born 28 April 1931 at Dolovo, Yugoslavia is unmarried.

A Scrbian Nationalist, STOKIC claims to be supporter of the recetablishment of the monarchy in his homeland.

lanifectly obsessed with Yugoslav political problems, he often reads to his compatriots some letters which he is adressing to the high dignitaries of the actual Yugoslavian regime, even to the Yugoslavian Ambassador in Franco. In those letters, STOKIC, denounces with violence the "Regime Concentrationnaire de la Yougoslavie". These letters are oft-times incoherent with vague threats.

Concerning his private life, this foreigner is unfavourably noted in the Records of the Prefecture de Police. He is generally reported as unstable in his job, hot-headed and poses as a homosexual, He lives with a Russian citizen YARESKO, Michel, born 8 Oct, 1898 at Tchensockoff, a butler, well-known for his psculiar norales ("necurs speciales").

Your attention is directed to the fact that while this report bears no security classification its contents are of a personal nature and should be handled on a need-to-know basis and must be secured accordingly.

Djura STOKZU, born en April 26, 1931 at Dolovo, Yugoslavia, son of Zarco and Julijama ZTVANOV, Yugoslav national, is employed with the "Ear Cleaning" cotablishment, 18, Das Charsses d'Antin, Paris 9. He resides at 23, Rus Cuillance Toll, Paris 17.

STORIC entered France on January 21, 1963. He is considered to be of good repute by his circle of friends. He is the holder of a residence parally valid until 3-18-57 and of Political Refugio Card No. 1/2-460/5636.

STORIC is very well thought of by his employer; he is a hard worker, sober and honest.

However, following a demonstration, he was taken to the Psychiatric Institution of the Prefecture do la Seéne in May 1965 and was then transferred to the Psychiatric Ecopital of Perrey-Vaucluse, Seine et Olce, where he stayed for two menths.

STONIC shows temperary signs of absormmility, relating that his uncle is a minister; that his father was a superior officer in the National Yugoslav erry, but competrates from the same district confirm that he comes from an agricultural family. However, STONIC is widely knowledgeable. He can read but not write French. He appears to have a rather strong leaning towards writing to certain Heads of Foreign States.

He is in lotter contact with some of his compatricts and is said to correspond with Vindinia ZCCHEVION, 1913 W Schiller Street, Chicago 22, Illinois.

In general, Djura STOKIC is not cubject of bad information and despite his occasional mental deficiency, is not considered as a dangerous person.

Reference is made to your memorandum of July 24, 1963, enclosing a photograph and letter in the Serbo-Croatian language - Cyrillic script, received by the Embassy in Paris.

Due to the handwriting, a complete translation cannot be made; however, partions of the letter indicate subject to be possibly a mental case. The photograph attached to the letter is that of the subject. It is to be noted that the letter is dated January 22, 1968, at Paris, and signed "Long live Djuro Stokio, the Jaw."

The first sentence of the letter indicates that subject plans to get even with President Johnson by stealing his weelth. He also claims to have a list of names of 13 American millionaires, the first being President Johnson and the 13th Governor Nelson Rockefeller. Subject claims he has been forced to this action because Fresident Johnson is responsible for his being turned down a thousand times for a visa to enter the United States. Subject also claims that women and other people are always looking at him and following him. Subject states that, although he likes women, he loves money, "dollars," more.

Our Paris records contain no information identifiable with the subject.

In view of the threat against President Johnson, the original letter and photograph are being furnished to Mr. John M. Hanly, U. S. Secret Service, Paris.

A copy of the letter and photograph are also being furnished to the Visa Section in view of the statement by

By referenced letter, Paris was requested to attempt to identify the author of the above-mentioned letter.

For information of the Bureau and Los Angeles, the Paris Office recently received from CIA, Paris, a photograph and letter in the Serbo-Croatian language (Cyrillic script). A partial translation of this letter identified the writer as DJURO STOKIC. As the letter alluded to a threat to President JOHNSON, the original letter and the photograph were furnished to the Paris office of the Secret Service.

Enclosed for the information of the Bureau and Los Angeles is one copy each of Paris letter dated 8/7/68 to ALS (CIA), with copies to Secret Service and Visa Section, American Embassy, Paris. Enclosed for the Bureau is one copy of the Serbo-Croatian letter dated 1/22/68 at Paris, with photograph of DJURO STOKIC.

It is to be noted that there are numerous similarities between the letter written to Senator KENNEDY and the STOKIC communication. Both of these letters were written in the Cyrillic script of the Serbo-Croatian language and both enclosed photographs. Both letters alluded to the fact that

the writer had been refused a visa to immigrate to Chicago and both letters ended with the words "long live" (ziveo). In the letter to Senator KENNEDY, the author stated he had been born in the same year as the Senator. It is to be noted that Senator KENNEDY was born 2/22/32, while STOKIC, according to information contained in Paris Secret Service file, is listed as having been born 4/26/31 at Dolovo, Yugoslavia.

Enclosed for the information of the Bureau and Los Angeles is one copy each of Secret Service, Paris, report and American Embassy, Paris, Visa Section memorandum dated 5/26/66 pertaining to STOKIC. It is to be noted that the source of the Secret Service report is the Police Judiciaire (Criminal Police), Surete Nationale, Paris, and that it denotes that STOKIC had been placed in a psychiatric hospital in France in 1965. This same report also states that STOKIC appears to have very strong leanings toward writing letters to certain heads of foreign states.

STOKIC's visa file at the American Embassy, Paris, reveals that his application for an immigrant visa to the United States was rejected as he was found medically ineligible, class "A." According to the Visa Section, classification "A" is a classification given on the basis of mental or physical inability seldom overcome.

Based on the information set out in this letter, it is believed that the author of the letter to Senator KENNEDY may be possibly identical with DJURO STOKIC.

The Bureau is requested to have the FBI Laboratory make a comparison of the handwriting between the letter addressed to Senator KENNEDY, dated 6/11/68, with those written by STOKIC, dated 1/22/68, and the one STOKIC wrote in 1966 on the front and back of a World Council of Churches letter dated 5/24/66. Copies of these three letters are enclosed.

It is to be noted that the original STOKIC letter of 1/22/68 was furnished to the Paris office of the Secret Service on 8/7/68 and they have, in turn, forwarded this letter to their headquarters in Washington. The original STOKIC letter of 1966 is located in the American Embassy, Paris, visa file.

In addition to the Laboratory comparison, the Bureau is requested to determine from Secret Service headquarters in

Washington, D. C., if the photograph or picture enclosed with the letter to Senator KENNEDY (see page three, next to last line of translation letter) was that of the author. In the event this was the case, the Bureau is requested to compare the photograph of STOKIC with that contained in the letter to Senator KENNEDY.

A copy of the translation of the letter to Senator KENNEDY has been furnished to the Ambassador's office in view of information that the author plans to contact Mrs. SHRIVER in the future. Copies of this same communication were also furnished to the Secret Service, Security Office and the Visa Section of the American Embassy, Paris.

Since his arrival in France SUBJECT has worked from time to time in large concerns such as the Simea Automobile Works, with cleaning contractors, and even at the Prefecture de Police Snack Bar as dishwasher. However, it can be said that he las lived mostly from his wits, only keeping a regular job, during short periods when he could not do otherwise.

An ulta-Serbian nationalist, partisan of the re-establishment of the monarchy in Yugoslavia, he for that reason joined the Mouvement National Yougoslave RAVIN GORA, of monarchist trend, with premises at 123 Bld. Davout, Paris 20. He also is a member of the National Serbian Committee in Exile, an extremist organization with headquarters at Chicago, but which is forbidden to operate in France by Order of the Einister of the Interior dated August 2, 1962.

However, the violence of his speech, his continual threats and provocation toward many political personalities, has resulted in STOKIC being kept at a distance by most of his compatriots who fear the consequences of a too boisterous action. STOKIC in fact shows himself above all to be an exacerbated anticommunist to the point where he is considered not to be in his right mind.

He was interpollated by the police on the Champs Elysees, Paris, on April 24, 1965, when waving a placard representing de Gaulle, Petain, Goldwater, and Brigitte Eardot.

Examined by a psychiatrist, he was intermed as schizophrenic paranolae and politically delirious in an asylum at Vaucluse, near Epinay-sur-Orge. He came out of that asylum on April 16, 1966.

He then continued to send numerous letters to Chief of State and known international personalities.

During 1965 he adhered to the extreme right-wing movement called "Oscident" ("West"), which was created during 1964 and operated by Pierre SIDOS, ex-protagonist of "Le Jeune Nation" ("Young Nation") monvement.

Briefly, his violent anti-communist opinions, added to his unbalanced mental state, make this foreignifiable to a more or less outstanding hostile act at the time of international political events.

He is looked-upon most unfavorably in his private life. Well-known as a hemosexual, he 'cohabits' with a Russian refugee named Michel YARESKO, born on October 8, 1808 in Tehenscokoff, USSR, Maitre d'Hotel, also well-known to the Special (Morality) Section of the Paris Police.

STOLIC was interpollated on February 22, 1967 for public exposure (when exhibiting his sexual organs in a public place). Brought before the 24th Chamber of the Seine Tribunal, Faris, on February 23, 1967, he was sentenced to 3-months imprisonment.

An Expulsion Order was issued by the Ministry of the Interior on January 19, 1968. However, it appears that on intervention of the French Office for Refugees and Stateless Persons, Paris, a new Order was issued on May 13, 1968 revoking the previous Order.

On June 7, 1968 STOKIC was granted temporary permission to stay in France (four months) enabling him either to find work, to quiet down more normally, or to leave France.

On August 5, 1968 he applied for a visa to go either to the USA, to Japan or to Israel. When making that application he stated he was domiciled at 28 rue Guillaume Tell, Paris 17, where he shares a room with the above-mentioned Varesko.



The enclosed information has already been furnished to the Secret Service and the Visa Section, American Embassy, Paris, by the Security Office.



#### Result of examination:

It was found that the purported writing of DJURO STOKIC appearing on the submitted photocopies designated Kc23 and Kc24 is entirely too indistinct to permit a suitable comparison with the questioned writing on the two-page letter designated as Q33. Specimen Q33 is the original letter for the photocopy Qc33. Q33 and the envelope in which it was mailed, designated Q.32, are described in FBI Laboratory report dated 8/23/68, a copy of which was furnished to the Director, U.S. Secret Service, Washington, D.C. Photocopies of Q32 and Q33 were furnished with FBI Laboratory report of 8/23/68.

Due to the indistinctness of the writing on Kc23 and Kc24, a definite conclusion was not reached whether DJURO STOKIC wrote the questioned writing on Q32 and Q33. Certain handwriting characteristics were noted in the purported known writing of DJURO STOKIC on Kc23 and Kc24 which are consistent with handwriting characteristics in the letter designated as Q33. These consistences in handwriting characteristics indicate that Q33 may have been written by DJURO STOKIC.

The submitted material is being retained in the FBI files.

The Laboratory is conducting examination of the signature in order to determine if it was, in fact, that of Sharif Bishara Sirhan.

Inasmuch as the communication may constitute a possible violation of the Extortion Statute Los Angeles should initiate immediate investigation in order to determine whether it was in fact prepared by Sharif Sirhan. Consideration should be given to conducting an immediate interview of the suspect.

Expedite and advise Bureau of results.

SIRHAN family between SAIDALLAH and SHARIF SIRHAN, who are living apart from the family home, and the mother, MUNIR and ADEL SIRHAN. Pasadena police officers who have been guarding the house on Howard Street have reported that several days ago SAIDALLAH SIRHAN appeared at the house and was refused entrance by his mother. He allegedly threw a fit of temper, screaming at her and accusing her of having money and not dividing it with SHARIF and himself. Lieutenant WRIGHT indicated he has arranged some welfare payments to SAIDALLAH and SHARIF on the basis of their contention that they could not work under their present circumstances.

At the time of the interview of SHARIF SIRHAN on 11/7/68 it was noted that SAIDALLAH SIRHAN, who was present, had been drinking. Later the same evening, about 10:00 P.M., SAIDALLAH appeared at the Pasadena Police Department looking for his brother SHARIF. SA PHILIP J. REILLY spoke with SAIDALLAH on the telephone to assure him that his brother was not in FBI custody. SAIDALLAH appeared to be quite intercated at this time, and separate conversation with Sergeant CHARLES T. DUVALL of the Pasadena Police Department, who was interviewing SAIDALLAH at the time, confirmed this.

On October 28, 1968, representatives of Secret Service Headquarters furnished a copy of a communication addressed to Richard Nixon and Hubert Humphrey, National Headquarters, Willard Hotel, Washington, D. C. This communication was allegedly signed by Sharif Bishara Sirhan and was postmarked Pasadena, California, October 22, 1968. The return address was given as Sharif B. Sirhan, 696 East Howard Street, Pasadena, California, and the envelope was addressed to Nixon. A Xerox copy of the letter is attached.

On November 7, 1968, Sharif Bishara Sirhan was contacted at his residence, 1659 North Lake Avenue, Pasadena, California, by two Special Agents of the Federal Bureau of Investigation (FBI), Los Angeles, California. Also present at this time was his brother, Saidallah B. Sirhan, who shares a flat with him at this address, and Mr. Anthony Sherman, Jr., a representative of the United States Secret Service Agency, Los Angeles branch.

Sirhan was advised by the FBI Agents that the inquiry related to the authorship of a two-page written document addressed to President Elect Richard Nixon and Vice President Hubert Humphrey, bearing the signature Sharif B. Sirhan. Mr. Sirhan was then orally advised by the FBI Agents of his rights. He was then asked to read an Advice of Rights Form. Mr. Sirhan interrupted this to say, "Before I say anything, I want to see the letter." A copy of the above-mentioned letter was given to him to read. He read it slowly, line by line, his hands visibly shaking, although he showed no other signs of emotion.

Mr. Sirhan then said, "I did not write this. not mine." He then indicated he was certainly in agreement with some of the political statements contained in the letter and had himself expressed some of these ideas, but he would not

specify which of these points he was referring to. He stated he also disagreed with some of the points in the letter.

Mr. Sirhan said he had no knowledge as to who the author of the letter could be. He said he did not dictate the letter to anyone or cause it to be written in his name. He denied that the signature at the end of the letter was his and added that the signature appearing on the letter was not a good copy or facsimile of his own. In this connection, he said he sometimes signs himself Sharif B. Sirhan, sometimes Sharif Sirhan.

Mr. Sirhan declined to furnish a signed statement attesting that the letter and signature were not his. He refused to furnish any samples of his signature, stating, "You have my signature and you have your experts. See to it yourself!"

Mr. Sirhan said he did not have a typewriter in the flat but added that there was a typewriter in his mother's home in the room formerly occupied by his brother, Sirhan B. Sirhan. He said he did not know what kind of typewriter this was and described it by dimensions as being a standard size typewriter. He indicated that he did not use it.

Mr. Sirhan said he does not know about any such organization in the United States as "the Palestine Commandos" but was certain there were many of this type in his homeland.

Mr. Sirhan said the lines drawn at the bottom of page two of the letter beneath the signature have no significance to him as Arabic or any other type of symbol and could not comment on them.

Mr. Sirhan said "No" to the question as to whether he had any reason to believe the letter in question could have been written by another member of his family or anyone of his acquaintance.

Mr. Sirhan turned to the contents of the letter and said the thoughts expressed in the letter could be the thoughts

At this point Mr. Sirhan was reminded of the purpose of the interview and the reasons therefor, but he appeared upset and said he had nothing to add on this matter, and the interview was terminated.

I further more beg and ask again and again please do not make us believe in political assasinations. And as I mentioned above, I am willing to die for America as for Palestine: I nate to see America destroyed by Zionish and Communism. We think in America that we are above Communism and Zionism. The truth is not that, but we are lost in between.

We thank you for giving this matter the greatest consideration hoping that you will be against the agressors (Zionists) for the sake of justice and the world peace, thank you.
