LLOYD JOHN HAGER, Range Manager, San Gabriel Valley Gun Club, 4001 Fish Canyon Road, Duarte, California, provided the following information to Special Agents GEORGE M. KLING and ALDO A. GIANNECCHINI after identifying themselves as Special Agents of the FBI.

HAGER advised that he was on duty at the gun club on June 4, 1968. Upon being shown photographs of individuals including SIRHAN SIRHAN, he advised that he did not recognize the individual as being a shooter at the range on that day. However, HAGER advised, his records indicate that an individual signed in with the name SIRHAN SIRHAN on June 4, 1968. HAGER stated that he had notified the Los Angeles Police Department that SIRHAN's name appeared on these records and it was his understanding that police officials requested the record with the name SIRHAN SIRHAN be retained until they picked it up.

HAGER stated that they maintained two rosters of shooters at the gun club. One roster contained signatures of gun club members only who are shooting on any particular day and the other roster is for non-members. He noted that SIRHAN's name appeared on the non-member roster. In addition, he stated that everyone who shoots at the range is supposed to sign one roster or the other but often times this is not done.

GEORGE SALIM SOLAMEH was interviewed at one of his places of employment, the California Club, 538 South Flower, where he works as a waiter. He advised he lives with his wife, EDITH, at 11525 Calvert, North Hollywood, California, and is from Palestine. He works at this address from 11:00 a.m. to 2:00 p.m., and at Pikes Verdugo Oaks, Glendale, California, Restaurant, from 6:00 p.m. to midnight.

He advised he met SIRHAN SIRHAN at Pasadena City College (PCC) in 1963 when both were students. He advised he does not know him well, but that they talked some with each other and learned they are both from the same town in Palestine. They did not know each other in Palestine. He advised that he knows SIRHAN's brother, SHARIF, better than SIRHAN.

SOLAMEH stated he does not believe that SIRHAN is part of any conspiracy, that he probably was motivated "from his own head". SOLAMEH denies there is any Arab group that he is aware of that would have sponsored any attack such as the one on Senator KENNEDY. SOLAMEH stated he has not seen SIRHAN since 1963, but does hear of him often, is aware of SIRHAN's continued residence in Pasadena, knew about SIRHAN's horse racing jobs, and has heard that SIRHAN asks about him and his wife, EDITH, and their children.

SOLAMEH states that he knows that the night before the murder SIRHAN had dinner with "GAYOMAI D MISTRI", an Indian national who lives in Pasadena, is in the Electronic business and went to school in Inglewood. MISTRI uses 176 North Michigan, Pasadena, California, as a mailing address.

SOLAMEH continued he thinks SIRHAN might have been motivated by reports of continued raids by Israel on Jordan and that somehow SIRHAN reached a cracking point. SOLAMEH stated this aggressive action on the part of SIRHAN is to him unbelievable, that SIRHAN's personality was not one given to violence. Although SOLAMEH had not had personal contact with SIRHAN for some years, he did hear of him often enough to be ~~amazed at what has transpired.~~

MARGARET PECK was interviewed at her residence at 5849 Hayter Street, Lakewood, California, telephone number 633-5340. MARGARET PECK stated that she is the owner of Winchell's Donut Shop at 12000 Rosecrans Boulevard, Norwalk, California.

MARGARET PECK stated that DOROTHY MANNING started working at the Winchell's Donut Shop at 12000 Rosecrans Boulevard on Tuesday, June 4, 1968, and on that day worked from 1:00 a.m. until 9:00 a.m. in the morning. MARGARET PECK stated that she was with DOROTHY MANNING on that night and that DOROTHY MANNING arrived at work at approximately 12:45 a.m. on June 4, 1968, and she last saw DOROTHY MANNING when she left at approximately 8:00 a.m.

MARGARET PECK stated that DOROTHY MANNING also worked in the donut shop on June 5, 1968, from 1:00 a.m. until 9:00 a.m. in the morning. MARGARET PECK stated that she was also at the donut shop on that night and she stated DOROTHY MANNING arrived at work at approximately 1:00 a.m. on June 5, 1968, and she last saw her at approximately 8:00 a.m. when she, MARGARET PECK, went home.

MARGARET PECK stated that DOROTHY MANNING had also been at the donut shop on Monday, June 3, 1968, during the morning at approximately 10:00 a.m. with her daughter, DONNA JOHNSON, who lives at 3345 Glen Holly, Anaheim, California.

MARGARET PECK stated that when she was with DOROTHY MANNING on June 5, 1968, DOROTHY MANNING did not mention the shooting of Senator ROBERT F. KENNEDY and she seemed surprised when she heard the report of his shooting on the news broadcast. MARGARET PECK stated that DOROTHY MANNING did not act in an unusual manner on the morning of June 5, 1968.

On June 7, 1968, Mr. WENDELL T. PIERSON, 18454 Main Street, Huntington Beach, California, advised he is the owner of the Five Points Hardware Store located at that address. Mr. PIERSON stated that he did not make a statement to the effect that if KENNEDY wins the election, a couple of guys would kill him and that he knew four guys in the Veterans Administration Hospital, ex-G.I.s, who were going to kill KENNEDY. He stated he does have an employee JAMES JAYCOCKS, who usually works on the cash register who is a "big mouth" when it comes to talking about politics.

JAMES E. JAYCOCKS, an employee of the Five Points Hardware Store, was interviewed on June 7, 1968. Mr. JAYCOCKS stated that he resides at 7602 Taylor in Huntington Beach.

He said that about the middle of May, 1968, an occasional customer of the hardware store who has been in on approximately six occasions over the past two years started talking to Mr. JAYCOCKS about the upcoming elections. This person, whose name Mr. JAYCOCKS does not know, mentioned the fact that he had been to the Veterans Administration Hospital. He did not state which city but Mr. JAYCOCKS assumes that it was the Long Beach, California, installation and that the "fellows at the VA were hot at Senator KENNEDY because of the way in which he was aiding the enemy". He said that the Veterans Administration patients stated that Senator KENNEDY by his actions and speeches about Vietnam was aiding the enemy while they were over there giving their lives for their country. This person said that some of the patients at the hospital said that if KENNEDY were president, someone ought to shoot him.

Mr. JAYCOCKS said that he does not know the person's name who gave him the above information, that he does not know where he lives, nor what kind of car he drives. He described him as follows:

He said that this person said that he served in the Second World War and in the Korean War and Mr. JAYCOCKS assumes that he lives in the Huntington Beach area because of the fact that he has been in the hardware store on about six occasions.

Mr. JAYCOCKS denied making any statement indicating that he knew four individuals in the Veterans Administration Hospital who were going to shoot Senator KENNEDY and he said that he knows absolutely nothing about Senator KENNEDY's assassination.

Mr. JAYCOCKS said that he repeated the conversation he had with this ~~unknown~~ individual on three or four occasions with customers of the hardware store and also with his wife.

Mr. LES F. HORVATH, 9176 La Barca, Fountain Valley, California, telephone 962-5082, advised on June 7, 1968, that on June 5, 1968, he called the FBI Office in Los Angeles and related a conversation he had with the owner of a hardware store at the Five Points Shopping Center in Huntington Beach, California, on June 1, 1967.

Mr. HORVATH stated that on June 1, 1968, he went to the above hardware store to buy some paint and while he was there, one of the employees, whose name he does not know, but who fits the description of JAMES E. JAYCOCKS, asked him what he thought about the election and asked him who he thought would win. Mr. JAYCOCKS stated that as far as he was concerned, the only one acceptable would be Mr. HUMPHREY. Mr. HORVATH did not answer his questions directly but stated he liked President JOHN F. KENNEDY. Mr. JAYCOCKS stated that if Senator KENNEDY got elected president, in a couple of days they are going to shoot him. He said JAYCOCKS stated he knows four guys in the Veterans Administration Hospital who are going to shoot him. Mr. HORVATH stated that that was ridiculous and mentioned the fact that the assassination of President JOHN F. KENNEDY was stupid. JAYCOCKS replied "Well as far as I'm concerned it wasn't soon enough." Mr. HORVATH said that JAYCOCKS then stated "Maybe I shouldn't have said that. I ~~shouldn't~~ talk about the death".

Mr. HORVATH at the time felt that Mr. JAYCOCKS "just talks too much" but after Mr. HORVATH heard of the assassination of Senator KENNEDY and before he knew that the suspected assassin had been identified, he thought that he should contact the authorities with the above information so that the assassin's photograph could be shown at the Veterans Administration Hospital. Mr. HORVATH said that JAYCOCKS did not state which Veterans Administration Hospital he had reference to but he assumes it was the Long Beach, California, installation.

MARCIA PECK was interviewed at her place of employment, Winchell's Donut Shop, 12000 Rosecrans Boulevard, Norwalk, California. MARCIA PECK stated she resides with her parents at 5849 Hayter Street, Lakewood, California, telephone number 633-5340.

MARCIA PECK stated that DOROTHY MANNING is employed at the donut shop and works the 1:00 a.m. to 9:00 a.m. shift. MARCIA PECK stated that DOROTHY MANNING started working at the donut shop on Tuesday, June 4, 1968, working the 1:00 a.m. to 9:00 a.m. shift. MARCIA PECK stated that DOROTHY MANNING first came to the donut shop at approximately 7:00 a.m. on Monday, June 3, 1968, and talked to her mother, MARGARET PECK, about working at the donut shop. MARCIA PECK stated that her mother hired DOROTHY MANNING and then called her daughter, DONNA JOHNSON, who is a friend of DOROTHY MANNING's, to tell her about the fact that she had hired DOROTHY MANNING. MARCIA PECK stated that her sister, DONNA JOHNSON, arrived at the donut shop at approximately 8:00 a.m. on June 3, 1968; and shortly thereafter, her sister, DONNA JOHNSON, and DOROTHY MANNING went shopping.

MARCIA PECK stated that they came back to the donut shop at approximately 9:30 to 10:00 a.m. on June 3, 1968, and then they left to go to DOROTHY MANNING's residence to fix DONNA JOHNSON's hair.

MARCIA PECK stated that she next saw DOROTHY MANNING on the morning of June 4, 1968, when she came to work at approximately 7:00 a.m. MARCIA PECK stated that DOROTHY MANNING left work at approximately 9:00 a.m. on June 4, 1968, and she believed DOROTHY MANNING's boyfriend picked her up, but she does not know his name.

MARCIA PECK stated she next saw DOROTHY MANNING when she came to work on Wednesday morning, June 5, 1968, at

at approximately 7:00 a.m. MARCIA PECK stated on that morning DOROTHY MANNING left work at approximately 9:00 a.m. and she stated she again believes DOROTHY MANNING's boyfriend picked her up.

MARCIA PECK did not notice anything unusual in connection with her observations of DOROTHY MANNING on the morning of June 5, 1968.

CHESTER ADAM YASHUK was interviewed at his residence, 2450 White Street. His telephone number is 795-4895, and he is a student at Pasadena City College.

From March 1965, through December 1967, YASHUK was employed at the Jack Davies Richfield Service Station, 2529 East Foothill Boulevard, Pasadena, California. YASHUK stated that from March 1965 until November or December 1965, SIRHAN BISHARA SIRHAN was employed at this station. YASHUK advised that he worked on Friday and Saturday evenings from 5:00 p.m. until midnight and on Sunday from 9:00 a.m. until 4:00 p.m. SIRHAN would relieve him at work on Sunday at 4:00 p.m., and SIRHAN would spend his off evenings hanging around the service station. YASHUK stated he knew SIRHAN fairly well, had coffee with him a couple of times away from work, however, his association with SIRHAN was limited to contacts at the service station. He never spent any time with SIRHAN other than the two times he had coffee with him away from work. YASHUK described SIRHAN as being friendly and carefree, having a good personality and he added that SIRHAN got along well with all customers.

YASHUK recalled that in 1965 while SIRHAN was working at the station he would often point out his pink and white 1956 De Soto and would ask the question, "do I go well with this car?" And he would ask YASHUK, "do you think the car is too big for me?"

According to YASHUK, SIRHAN stated that he lived with his aunt and brother however the names and addresses were never stated. SIRHAN stated he had a sister who lived in Jerusalem, her name was not stated, and he wanted to bring her to the United States. SIRHAN also claimed to know several languages and indicated that he wanted to be an interpreter.

YASHUK stated that to his knowledge SIRHAN did not drink or use profane language and he does not know of SIRHAN having any friends. SIRHAN was never visited at the station by anyone. YASHUK advised that SIRHAN never expressed any political feelings or dislike for anyone.

YASHUK recalled that a CAROL LAMBRECHT managed the station in 1965. LAMBRECHT would often assign to SIRHAN the duties of cleaning out the restrooms. LAMBRECHT would inspect the restrooms for cleanliness and would often accuse SIRHAN of not cleaning the restrooms. SIRHAN would become excited and explain, "I did, you are lying to me."

YASHUK recalled that SIRHAN never borrowed money from any employees at the station and he appeared to spend his money on clothes. SIRHAN on one occasion mentioned that he had purchased two pair of pants which cost \$25.00 apiece. YASHUK cannot recall from what clothing store SIRHAN purchased the clothing. YASHUK advised that SIRHAN wore "continental style" clothes, and that he wore tight pants.

YASHUK recalled that in 1965 a security company named Hough Security Company provided evening security for the station. YASHUK stated around midnight the days' cash would be placed in the station safe and a security guard from the Hough Company would provide protection at the station when the money was placed in the safe. YASHUK advised that one guard in particular with this company was a very profane individual and on one occasion SIRHAN stated to this guard to tone down his profanity. The guard was upset by SIRHAN's statement and offered to fight SIRHAN, however, SIRHAN became very meek and would not fight this guard.

YASHUK advised that approximately one and one-half weeks ago on a Tuesday or Thursday afternoon, he was driving by the Davies Richfield Station and he observed SIRHAN's

1956 pink and white De Soto in the station. YASHUK stated that he stopped in the station and he observed SIRHAN working on his car. He said "hello" to SIRHAN and SIRHAN said "hi" and mentioned that he was having ignition trouble with his car. SIRHAN said nothing else to him and YASHUK did not say anything further to SIRHAN.

On June 16, 1968, HARRY BAUM, 238 South Alexandria, Apartment 7, Los Angeles, (383-2684), advised that he attended a political rally at the Ambassador Hotel on Sunday night, June 2, 1968. BAUM explained that he was "in the main ball-room" which was filled to a capacity crowd and noted that he was standing directly in front of the stage. He related that he moved back in order to allow Senator KENNEDY and singer, ANDY WILLIAMS to get on the stage.

BAUM explained that while he was standing in the crowd waiting the arrival of the Senator he observed a white female in a polka dot dress standing approximately ten feet from him. He stated that during the time the Senator spoke this woman sat beside him on the stage. BAUM noted that inasmuch as efforts have been made to locate a white female who wore a polka dot dress on the night of the assassination, he felt he should come forward with this information and furnished the following physical description:

BAUM was unable to furnish specific details concerning the type of polka dots on the above dress and pointed out that inasmuch as he did not take particular note of the woman at the time, he is unable to determine whether or not she was accompanied by any other persons. He noted that when the rally concluded, he did not see this woman again

RAY WILLIAMS, Agent, Thoroughbred Racing Protective Board (TRPB), Hollywood Park Race Track, advised that he had learned that SIRHAN BISHARA SIRHAN had worked for JOHN SHEAR, now the paddock gate guard who used to be assistant trainer for GORDON BOWSHER (phonetic), a trainer. WILLIAMS also learned that SIRHAN worked for LYNN WHEELER, a trainer, who has Box 211 in the track area.

WILLIAMS further advised that he had learned that SIRHAN was a friend of a race track "hot-walker" named MERLE MATTESON. Hot-walkers are the men who walk horses to cool them down after a race or a workout. It is, according to WILLIAMS, very low status work. The hot-walkers also clean stalls, et cetera. WILLIAMS said MATTESON is in his mid-50's, is constantly quoting the Holy Bible and has written anonymous anti-Semitic letters to the President of the United States, Secretary of Defense and other public officials. WILLIAMS said his source of information about SIRHAN and MATTESON is GEORGE WEINER, who is a former Los Angeles County Deputy Sheriff now with the California Horse Racing Board, at MA 0-4160 in Los Angeles. WILLIAMS advised that MATTESON lives in Tack Room Number Two, Barn Number Three, at Hollywood Park Track.

WILLIAMS made available the attached copy of a report on MATTESON dated May 23, 1968, relating to his letter writing. WILLIAMS believes that MATTESON is a mental case.

MERLE MARION MATTESON was interviewed outside of Tack Room Number Two at Barn Number Three, Hollywood Race Track, where he lives. He advised he is a white male, born October 14, 1913, in Canada, is 5' 8" tall, weighs 140 pounds, and has balding brown graying hair and blue eyes. He advised he is a groom and a hot walker. He has a married daughter and a son serving in Vietnam. He was shown photographs of SIRHAN BISHARA SIRHAN and stated he cannot recognize him as anyone he knew.

MATTESON continued that he had predicted President KENNEDY's assassination because President KENNEDY was once Commander of PT Boat 109 and there is a verse in the 109th Psalm which bears on this situation. MATTESON continued that there is a quote in the newspaper stories, especially editorials, which is influenced by Jews, that is a key to parts of the Bible that explained world problems.

KANAN ABDUL LATIF HAMZEH, 465 North El Molino, telephone number 799-5318, who is employed as a salesman at Robinsons Department Store, Pasadena, California, furnished the following information with respect to his knowledge of SIRHAN SIRHAN:

HAMZEH advised that he first met SIRHAN SIRHAN approximately three years ago when he (HAMZEH) was enrolled at Pasadena City College in electrical engineering. While at the college, he was president of "The Organization of Arab Students in the United States of America and Canada", with headquarters at 2929 Broadway, New York City, New York, 10025, telephone number MO 6-0300. This organization was formed in 1952 to assist Arab students in adjusting to academic life away from home.

SHARIF SIRHAN, who was a student at Pasadena City College and a member of the above organization, introduced SIRHAN SIRHAN to him, HAMZEH.

SIRHAN SIRHAN became a de facto member of this organization which although active, was not recognized as a formal organization by Pasadena City College since such organizations were prohibited to operate on the campus. It was also not recognized as a formal local organization by the mother organization in New York City due to the fact that the college did not authorize it to operate on the campus. In spite of the above technicalities, HAMZEH stated this organization operated like practically all organizations of its kind located on other campuses.

HAMZEH stated that he helped SIRHAN SIRHAN with some math problems that he was having. SIRHAN SIRHAN also visited his apartment for purposes of taping some Arabian music which he, HAMZEH, had. He recalls that in the company of SIRHAN SIRHAN was one of his brothers and his sister.

HAMZEH advised that in conversations with several of the SIRHAN brothers he learned that SIRHAN SIRHAN had constant arguments with them as well as with his mother. He was not told what the arguments were about, but he surmises they were strictly of a family nature. He recalls that SIRHAN SIRHAN along with one other brother SAID SIRHAN, were quite unhappy living in the United States. He thinks that both brothers were unable to adjust to the social and political atmosphere in the United States.

When he knew SIRHAN SIRHAN he did not think that he was capable of any major crime since school seemed to be foremost in his mind and not politics as such, which he did not seem too interested in.

While SIRHAN SIRHAN was a member of the organization of Arab students, he used to volunteer for some of the less desirous work of making the meetings which were held at the local YMCA, more successful. Some of the things he did were to set up the chairs, arrange for a tape recorder and arrange for various refreshments for the group.

He would consider SIRHAN SIRHAN to be easily influenced, however, for any Arab Nationalist cause since he had some intense feelings against the Israelis.

He does not know who SIRHAN SIRHAN's associates were. However, he considers that he was more forward than most Arabian students with respect to meeting female companions since he would often talk to them in the student lounge at Pasadena City College.

He does not know of any other interests which SIRHAN SIRHAN had, and he was surprised to read in the newspapers that SIRHAN SIRHAN seems to have an interest in philosophy. He stated that he must have greatly changed since he knew him three years ago, for at that time he considered SIRHAN SIRHAN to be just an ordinary young man.

Mr. RICE was shown photographs of SIRHAN BISHARA SIRHAN. Mr. RICE advised that he recalls having seen SIRHAN in the pool hall on infrequent occasions. He occasionally played pool there, and other times he would stand around and chat with other young people in the pool hall for a few minutes.

Mr. RICE last recalls having seen SIRHAN in the pool hall two or more weeks ago. He definitely does not recall having seen SIRHAN there at anytime during June 4, 1968.

Mr. RICE was working the afternoon and evening of June 4, 1968, and he recalls it as election day and the night Senator ROBERT F. KENNEDY was shot.

Although Mr. RICE has overheard some of the young men who frequent the pool hall mention that they knew SIRHAN SIRHAN to one degree or another; he has not overheard anyone mention having seen him on June 4, 1968. Mr. RICE advised that he will remain alert for any indication from any of the customers of the pool hall that they might have knowledge of any activity of SIRHAN SIRHAN, and he will immediately advise the FBI of any such information coming to his attention.

Mrs. LEE BROWN, Operations Officer, Crocker-Citizens National Bank, 80 South Lake Street, examined a xerox copy of a check issued by the Argonaut Insurance Company, dated April 5, 1968, drawn on the Crocker-Citizens National Bank, San Francisco, California, paid to the order of SIRHAN SIRHAN, 696 E. Howard, Pasadena, California. The check is made out in the amount of \$1,705.00 and is numbered 262013. Mrs. BROWN said this check was presented to her by an individual using the name and having the identification of SIRHAN SIRHAN. She explained that according to the information on the face of the check that the check was for an insurance claim. It is the policy and normal operational procedure for the bank branch that receives a check of this nature to forward it to the main office for payment authorization prior to payment. She said she explained this procedure to SIRHAN, and he seemed "put out" that there would be a delay in payment. Mrs. BROWN said that she requested that SIRHAN endorse the reverse side of the above described check. She said she observed him sign his name and address on the check. She then requested that he exhibit some form of identification. He displayed a California drivers license, and she wrote the initials "CDL" and the number [REDACTED] directly below SIRHAN's endorsement. Mrs. BROWN said the number she wrote down was the number of the drivers license that SIRHAN exhibited to her.

Mrs. BROWN said that the handwritten date, 4-8-68, that appears in the middle of the bank stamp on the reverse side of the previously described check would be the date that she received the check from SIRHAN.

She said after receiving this check she forwarded it to the Crocker-Citizens National Bank, 1 Montgomery Street, San Francisco, California. Several days later, authorization was received from that bank to pay \$1,705 00 to SIRHAN. He returned to the bank, and she prepared a Cashiers Check in the amount of \$1,705.00 and gave it to him.

This inquiry was made either on June 6 or 7, 1968, by persons connected with the insurance company. It was at that time that she and other persons at the bank learned that the individual who killed Senator ROBERT F. KENNEDY, and the person who received payment for the previously described checks were the same.

A photograph of SIRHAN SIRHAN, dated June 5, 1968, and another photograph, allegedly taken at the scene of his arrest on June 5, 1968, were exhibited to Mrs. BROWN, and she said that the person in the photographs resembled the individual who identified himself to her as SIRHAN SIRHAN.

She could not recall having conducted any other business with SIRHAN SIRHAN on any occasion other than noted above.

She said that one of her many duties consists of cashing Cashiers Check previously okayed by bank officials and presented for payment by customers. She said the above described Cashiers Check was brought back to her attention during the latter part of the week of June 3-7, 1968, by co-employees. She explained that she and her co-employees discussed the fact that the name of the individual that appears on the Cashiers Check and the person who was arrested by the Los Angeles Police Department for the murder of Senator ROBERT F. KENNEDY were one and the same.

Mrs. MC KENNA said she recalls making payment in the amount of \$1,705.00 to an individual who had the name SIRHAN SIRHAN. She said she could not recall the exact denomination of bills she gave to SIRHAN, but to the best of her recollection, she gave him \$1,500.00 in \$20.00 bills, a couple of \$100.00 bills, and one \$5.00 bill. She said she was out of \$100.00 bills that particular date, as a large payment had been made by her on the previous day, and she recalls the customer received all of her \$100.00 bills. She checked her cash sheet for April 12, 1968, and verified that she did not have many \$100.00 bills in her cash box on that date. She recalled the \$100.00 bills that she did give to SIRHAN were used and worn. They were not new or crisp.

JOYCE advised that she thought at various times that she had heard what sounded like gunshots in the neighborhood but never could be certain of this. ALLEN stated that she has been a member of the United American Arab Congress, Hollywood Boulevard, Los Angeles, and also the Asia Society, Hollywood, California, for approximately two years. ALLEN said that her main interest in life is to educate the people in the United States about foreign countries and especially the Arab countries. She stated that she felt that the American people were indirectly guilty for Senator KENNEDY's death because of our ignorance to the problems confronting other countries of the world, especially the Arab and Jewish world.

CAESER CHAVEZ, Director, United Farm Workers Organizing Committee, AFL - CIO, office address 102 Albany Street, Delano, California, mailing address, Post Office Box 130, Delano, California, was interviewed in Room number 6, of the Travelodge Motel, Indio, California, at which time he furnished the following information:

Mr. CHAVEZ last saw and personally talked with Senator ROBERT F. KENNEDY in March, 1968.

On the evening of June 4, 1968, Mr. CHAVEZ was going to see ROBERT F. KENNEDY and after the polls closed CHAVEZ left United Farm Workers Organizing Committee Headquarters, 806 Eastman, Los Angeles, California, with Father LUCE of the east side parish of the Episcopal Church. Mr. CHAVEZ arrived at the Ambassador Hotel with Father LUCE, 200 workers from his organization and a Mariachi Band.

Mr. CHAVEZ stayed at the Ambassador Hotel approximately one hour leaving at about 11:00 p.m. without seeing Senator ROBERT F. KENNEDY. He left as his wife had not been able to come to the affair and he was feeling tired due to a back injury. Prior to leaving, Mr. CHAVEZ told one of his associates RUDY AMADA to tell the others he had left.

Mr. CHAVEZ departed with Fathers LUCE and GARBER of the Episcopal Church and they took him by his home where they picked up Mrs. CHAVEZ and then proceeded to the eastside campaign headquarters for RICHARD CALDERON, a candidate for State Senate. CHAVEZ was there approximately ten or fifteen minutes when Senator ROBERT KENNEDY came on television and gave his victory speech. Mr. CHAVEZ watched this speech with his wife, HELEN CHAVEZ and the others at CALDERON's campaign headquarters.

CAESER CHAVEZ stated that he had seen photographs of SIRHAN SIRHAN in the newspaper and on television and did not know him. He did not see SIRHAN at the Ambassador Hotel. He stated he has had no argument with Senator ROBERT F. KENNEDY

Mr. CHAVEZ stated that on June 10, 1968, while stopping at his union headquarters in Los Angeles at 806 Eastman, one BILL CHANDLER commented that he (CHANDLER) knew SIRHAN SIRHAN or had gone to school with him in Pasadena, California. BILL CHANDLER is affiliated with CHAVEZ in his labor movement and was at the Ambassador Hotel on the night ROBERT F. KENNEDY was shot. Mrs. DONALD BOYKO, who said her nickname is "Tosti" was contacted at 1380 North Lake Avenue, where she is employed in the Health Foods Store owned by JOHN WEIDNER, which is known as Organic Pasadena Health Foods.

Mrs. BOYKO advised that on Sunday, June 9, 1968 she went to 1255 Morada Place in Altadena, California in an attempt to locate an Arab student named ABDUL MAJED DABASS. Mrs. BOYKO said she was accompanied on this trip by a Washington, D. C. reporter named GEORGE LARDNER, JR., whose credentials are unknown to her. LARDNER is staying at the Biltmore Hotel in Los Angeles, California.

On the day following the identification of SIRHAN BISHARA SIRHAN, LARDNER came to Mrs. BOYKO and asked for her assistance in locating some Arab students, who might know some background about SIRHAN. Mrs. BOYKO agreed to help him and thought she remembered an address for ABDUL DABASS, who some years ago lived at 1255 Morada Place. However, she did not know the address at the time and agreed to accompany LARDNER to pick out the house. In this connection, Mrs. BOYKO indicated she and her husband had met DABASS several years ago when he was a student at the University of Southern California School of Journalism. She believes that he is now married and not living in the Pasadena area, but thought she might get a lead on his present whereabouts by making a call to the Morada Place address. She was unable to obtain any information from Mrs. JOHNSON.

Mrs. BOYKO said she met SIRHAN SIRHAN at the time she went to work at WEIDNER's health food store in Pasadena, which was in December 1967 and was acquainted with him until his departure from the store as an employee in March 1968. She said she had no contacts with him outside of work, except on one or two occasions SIRHAN and his mother attended Mrs. BOYKO's church (7th Day Adventist Church in Pasadena) with the BOYKOs. stated that in her opinion SIRHAN seemed to be a quiet and intelligent boy and she would have had no reason to suspect he was capable of violence or murder.

Mrs. BOYKO said the name of MAJED GUSSOUS was not familiar to her.

Mrs. BOYKO stated that she does not know the present whereabouts of DABASS and indicated that it is possible that a Jordanian named SIMON (last name unknown) who owns a barber shop in Pasadena, might know the present whereabouts of DABASS. She said she had not mentioned this possibility to Mr. LARDNER.

Mrs. BOYKO concluded by stating she does not know the names of any other Arab nationals or Arab types, who might know SIRHAN and she stated that she has no knowledge of any personal friends or relatives of SIRHAN.

Mrs. SIRHAN was advised of the identities of the interviewing Agents, and she was told that the purpose of the interview was to obtain certain background information concerning herself and members of her family for use in the investigation of the assassination of late Senator ROBERT F. KENNEDY.

Mrs. SIRHAN was advised of her rights, which she orally waived after discussions with her sons SHARIF BISHARA SIRHAN, ADEL BISHARA SIRHAN, MUNIR BISHARA SIRHAN, and SAIDALLAH BISHARA SIRHAN.

Mrs. SIRHAN voluntarily submitted to being fingerprinted and photographed by Pasadena Police Department Identification Technician CLYDE HUBBELL.

Mrs. SIRHAN advised that she does not write in the English language except to sign her name. When something needs to be written in English, she has her sons write it, and she signs it.

Mrs. SIRHAN and her son, SHARIF BISHARA SIRHAN, discussed their knowledge of the assassination of King ABDULLAH of Jordan, the grandfather of King HUSSEIN. This occurred in probably the early 1950's. Their knowledge of the incident is based entirely on their recollection of news accounts of the incident at the time. It is their recollection that a man named MUSTAFA ESHOO (phonetic) shot the king as he knelt in prayer. They recall that probably the killer then turned the gun on himself and killed himself. Mr. SIRHAN has played pool with his brother, SIRHAN SIRHAN on infrequent occasions in 1967 and early 1968. He has also played pool occasionally when he was not with his brother. When he was with his brother they played at a pool hall across Colorado Boulevard from Pasadena City College (PCC), at a pool hall between PCC and Van de Kamps restaurant on Colorado Boulevard, and at a pool hall at the corner of Lake and Colorado, all in Pasadena.
