Mrs. MARGARET MC CARTHY, who resides at 4419 Stansbury, Sherman Oaks, California, advised that she was born in County Cork, Ireland, on June 1, 1900. She advised that she and other members of her family were very strong supporters of the late Senator ROBERT F. KENNEDY and that she and her daughters had been at the Ambassador Hotel on the night of June 4, 1968, and early morning of June 5, 1968, when Senator KENNEDY was shot. She stated that she and all of her family had been in the Ambassador Ballroom, which is located on the floor directly beneath the floor on which the Senator was shot.

She advised that she was in the crowded Ambassador Ballroom, along with many others, waiting for the arrival of Senator KENNEDY, who was supposedly going to come downstairs from the Embassy Room to speak to those who were waiting in the Ambassador Ballroom. She stated that she and a few of the other members of her family got up on the stage in the Ambassador Ballroom, along with the "Kennedy Girls", and they were all dancing and singing and waiting for "BOBBY" to come down. She stated that shortly after midnight the room became very close and stuffy so she and several others went to a small alcove to the left and rear of the Ambassador Ballroom, where they attempted to get a breath of fresh air. This alcove had a stairway leading up to the next floor where the Embassy Room was located; there was a door leading to the Wilshire Street parking lot with a fire escape leading upstairs directly outside this door.

Mrs. MC CARTHY advised that as they stepped out on to the landing of the fire escape sometime shortly after midnight, several individuals came down the stairs, both from the inside of the building and from the fire escape, exclaiming that Senator KENNEDY had been shot. She stated that she did not remember any one person in particular and that in the confusion she did not recall having seen anyone in a polkadot dress. She stated that she is quite certain that she did not hear anyone say "We've shot Senator KENNEDY".

Mr. LEONARD C. PERRY, who resides at 6268 North San Gabriel Boulevard, Altadens, California, phone No. 287-3241, was interviewed at Pasadena City College (PCC) where he is an instructor in the Speech and Communications Department.

PERRY advised that he has been an instructor at PCC for approximately eight years and that he holds the position of Associate Professor. He stated that he could remember the name SIRHAN BISHARA SIRHAN having been one of his students in 1963, but that he could remember nothing else about this individual and was sure that he would not recognize him if he were to see him on the street. He advised that with the number of classes and students in each class it was impossible for him to become too well acquainted with any of his students.

PERRY stated that the course SIRHAN took from him was called Basic Communication and was a course required for all Freshmen at PCC. He explained that it was basically an orientation to the college atmosphere with aptitude and other type tests furnished the students to help them discover their interests and determine their fields of study.

Mr. HAROLD J. BENSON, who resides at 3180 Crestford Drive, Altadena, California, phone No. 797-0628, was interviewed at Pasadena City College (PCC) where he is an instructor in the Physiology Department.

BENSON advised that he remembered having SIRHAN SIRHAN as a student in one of his classes while he was at PCC. He stated that SIRHAN sat at a table by himself in the classroom and that he did not appear to attempt to mix with the other students although he was always pleasant, and smiling and treated everyone with courtesy and respect. He advised that during the time SIRHAN was in his class he was not even aware of SIRHAN's nationality and that he did not ever have any discussion of politics or ideologies nor did he ever hear anyone else discussing these things with SIRHAN.

BENSON advised that SIRHAN was an average, or slightly above average student, who was very consistent in his work with perfect attendance and that he did not remember any type of disciplinary problem ever arising. He stated that he certainly would never have thought SIRHAN to be an individual of a violent nature as he always seemed to be even-tempered.

He advised that he did not know of any close association between SIRHAN and any of the other students in the classes and that he, BENSON, never saw him except in the classroom on a teacher-student basis. He stated further that he had no contact with SIRHAN after the semester in which SIRHAN was a student in his class.

NIXON, who resides at 435 South Hudson Street, Apartment 6, Pasadena, telephone number 792-1382, was interviewed at the Pasadena High School, 2925 East Sierra Madre Boulevard, Pasadena, California, and he advised that he had previously taught at the John Muir High School in Pasadena, at the time that SIRHAN B. SIRHAN had attended that school.

NIXON advised that he remembered having SIRHAN in a tenth grade geometry class but that he could remember very little else about SIRHAN. He stated that when he heard the name on television in connection with the assassination of Senator ROBERT F. KENNEDY, he remembered vaguely having had this individual as one of his students.

Mr. MARCUS LE GRAND YOUNG, who resides at 11062 East Andrews Street, South El Monte, California, was interviewed at the John Muir High School in Pasadena, California. Mr. YOUNG advised that he is a teacher in history at that high school and that he is also the Commander of the Cadet Corps. He explained that the Cadet Corps at John Muir High School is similar to a high school ROTC program, except that it is run and financed by the state instead of the Federal Government. He also stated that the Cadet Corps is under the direction of the California State Adjutant General and receives the money for equipment and uniforms and supplies through the State National Guard and Adjutant General's Office. He further stated that in this Cadet Corps, the boys receive basic military training in such fields as drill; including the Manual of Arms, military courtesy, first aid, camouflage, map reading and a brief explanation of firearm safety.

YOUNG advised that he could remember that SIRHAN B. SIRHAN had been a member of this Cadet Corps for the three years that he had attended John Muir High School, and he remembered him as a better than average cadet with a good attitude who accepted discipline well and showed potential and ability in administrative positions. He said that SIRHAN was probably a sergeant in the Cadet Corps at the time of his graduation. He stated that he remembered SIRHAN to be a serious individual but did not consider him to be sullen or moody and he certainly would not have thought him to be an individual of a violent nature. He said that he could not remember any display of temper on the part of SIRHAN towards any other student and, to his knowledge, SIRHAN got along well with his fellow corps members and other students and appeared to be a very nice person.

YOUNG advised that in connection with the Cadet Corps, some of the boys who were chosen to be on the Rifle Team were afforded the opportunity for training and practice with the .22 caliber rifle, however, he advised that SIRHAN



Miss GERALDINE AGNES MC CARTHY, who resides at 4419 Stansbury, Sherman Oaks, was interviewed at her place of employment, Security First National Bank, Studio City, California, during her lunch break. Miss MC CARTHY advised that she had been born in Birkenhead, Cheshire, England, on February 21, 1937. She stated that on the evening of June 4, 1968, she and other members of her family were in the Ambassador Hotel, where they were participating in the activities with the other KENNEDY supporters who were waiting for final election results and the victory speech by Senator ROBERT F. KENNEDY.

She advised that she and her family spent the evening at the Ambassador Hotel in the Ambassador Ballroom, which is located on the floor of the hotel immediately below the floor on which Senator KENNEDY was shot. She stated that they had been participating in the festivities and had been singing and dancing on the stage in the Ambassador Ballroom with the other celebrants and that shortly after midnight on June 4, 1968, she and several members of her family left the stage of the Ambassador Ballroom and went to a small alcove to the left of the stage and near the rear of the Ambassador Ballroom. This alcove had access to a stairway leading up to the Embassy Room and also had access to an outside door opening onto the Wilshire Street parking lot of the hotel. She stated that immediately outside this doorway to the parking lot there was a fire escape leading down from the floor above.

Miss MC CARTHY advised that as she and several members of her family were in this alcove attempting to get a breath of fresh air, several people came down the stairway from above and a girl in an orange dress stated "KENNEDY has been shot". Shortly after that a girl in a beige dress with black dots came down the outside fire escape and exclaimed,

"Oh my God, KENNEDY's been shot". Miss MC CARTHY stated at no time did she hear anyone make the statement, "We've shot KENNEDY". She stated that several more people came down the stairway of the fire escape and she asked them questions attempting to verify what they had heard and it became apparent to her that KENNEDY actually had been shot. She said that things became very confused and that within a short time the police began to request all those who were not directly involved to leave the building very quickly and calmly. She stated that at this time she and her family left the building and returned to their home in Sherman Oaks.

"I, JESSE CARDONA, 620 Hurstview Avenue, make the following voluntary statement to JOSEPH G. DAVIS, JR. and JAMES E. ROSS, who have identified themselves to me as Special Agents of the FBI.

"On 6/4/60, I was regularly engaged in delivering mail out of the Duarte Post Office. Part of my route takes me to the San Gabriel Valley Gun Club, Duarte, when I usually take my dailey break I arrived about 10:50 am and took the mail to LLOYD HAGER, the range master We were standing there talking and my neighbor, CHARLES MILLNER, and a friend RUSSFLL WEAVER came in They arrived at approximately 10:55 am I greeted them, they paid their fees, got their targets, and then we all walked to the pistol range

"There was only one person on the pistol range at that time He was on the far west end of the shooting line, down near where the small numbers begin. He was not then shooting, so MILLNER and WEAVER put up their targets, and returned to the firing line. MILLNER and WEAVER were at the opposite end of the pistol range, the east end.

"I did not talk to the person at the west end of the pistol range. As best I can recall, he was a white male, approximately age 25 to 30 years old. He was about 5 foot 3 inches tall, weighed about 150 pounds, and had dark, possibly black hair. He wore 'blue levis' pants and had on a 'pull over' sweater type shirt with short sleeves. He was a very mascular person. He had on shooters type 'ear muffs'. I do not know what

Based on my observations of this person, I do not think that he is identical with the person pictured in the photographs displayed to me by Special Agent DAVIS. I did recognize the photographs as being the person identified in the newspapers as SIRHAN SIRHAN I cannot recall observing SIRHAN on the pistol range while I was there or anyone resembling him.

"I left the range about 11:15 a.m. continuing on my mail route. At the time I left, only my two friends and the person at the west end of the pistol range previously mentioned were then at the pistol range. No other persons came during this time to the pistol range.

"To the best of my recollection, there were no female persons on the range, although there was several other male persons on the rifle range, whom I did not know.

I've read the above statement consisting of this page and three others. It is true and correct, in every respect.

The following signed statement was obtained from RUSSELL DOYLE WEAVER:

"Duarte, California 6/12/68

"I, RUSSELL DOYLE WEAVER, 2221 Broderick Avenue, make the following voluntary statement to JOSEPH G. DAVIS, JR. and JAMES E. ROSS, who have identified themselves to me as Special Agents of the FBI.

"On 6/4/63, I accompanied a friend CHARLES MILLNER, 626 Hurstview Avenue to the San Gabriel Valley Gun Club, Duarte, arriving there at approximately 11 AM On arrival, we went to the range master to check in and to get targets. We then went to the pistol range portion, which basically runs east and west. We took a position on the right hand side of the pistol range, that is, the last target position to the east side of the pistol range.

There was one other person on the bistol range at that time. He was at the target position to the far left of the pistol range, that is, about the last or next to last target position to the west side of the pistol range.

"The range master asked this person to cease firing in order that we could put up our targets down range.

"I would describe this person as follows: A heavy set muscular person weighing approximately 220 pounds. He was white, male, approximately 6 feet tall, 24 or 25 years of age, olive complexion, black "kinky" hair resembling that of a person of Italian descent. He was wearing a dark blue turtle neck shirt with short sleeves. He had on shooters

"type 'ear muffs', appearing to be of some type blue cloth with fur on it, of a commercial nature. was my impression only, that he might be a police officer, because he was orderly in handling his gun and amunition and he appeared to be an experienced shooter. This person had two guns. One was a .44 magnum automatic, the gun he was then shooting and holding in his right hand. The other gun was a smaller automatic, blue in color, and which may have been a .22 caliber. This smaller gun was lying in a black 'satchel' type of case, one side of which folded down opening up the 'satchel'. also had a small telescope which was mounted on a tripod resting on the bench. The scope was about a foot long and on the tripod, it stood about a foot tall.

"Approximately 10 minutes or so after our arrival, I went over to this person and asked that he cease shooting in order that we could go down and check our targets. It was at this time that I observed the small gun in his 'satchel' and the other details listed above. On one other occasion during the hour that we were there, I asked this person if he would again cease firing in order that we could check our targets.

"Based on my observations of this person, I can definitely say that he is not identical with the person pictured in the photographs displayed to my by Special Agent DAVIS. I did recognize the photographs as being the person identified in the newspapers as SIRHAN SIRHAN. I did not observe SIRHAN on the pistol range while I was there or anyone resembling him.

"While we were there, two male white persons arrived on the pistol range. They both spoke to the person at the west end of the pistol range and then took

"up a target position, approximately middle-ways between us, and about in the middle of the pistol range. I assume from their physical appearance that they were father and son. The younger individual was approximately 20 years of age and wearing an Army type fatigue hat, with civilian clothes. build was small and he weighed about 150 - 160 pounds. He was approximately 5 foot 6 inches tall. The older man was between 45 and 50 years of age and weighed approximately 175 pounds. He was wearing a jacket and pants. His hair was 'salt and pepper' graying. I did not observe these individuals sufficiently to furnish any additional description of them: nor did I know either, or observe their mode of arrival. I did not notice any conversations between these 2 persons and the man on the west end of the pistol range other than when they first arrived, as mentioned above, which conversation I could not hear.

About 20 minutes later, a white male and female arrived at the range.: I. noticed them because she was the only female on the range and both had to walk near me to enter the rifle range. They both went over on the rifle range, where there were also other males, unknown to me, also firing on the rifle range. I did not talk to either of them. The man was a heavy set male, 45 to 50 years of age, weighing 175 to 180 pounds. The woman was about 18 to 19 years of age, 5 foot 2 inches to 5 foot 3 inches tall, with a slender build, weighing approximately 100 pounds. She had blond hair and was wearing a scarf. She was shooting a .22 caliber rifle. She had on slacks. This is all I can recall of their description, Neither of these two persons ever came over to the pistol range. I cannot recall anyone from the pistol range ever going over to the rifle range to talk with them.

"While we were there, there were only five of us on the pistol range. We left about noon, going home. When we left, the man was still at the west end of the pistol range, and the other two individuals were still shooting at mid range. The man and woman who also arrived later were still at their position on the rifle range.

"I have read the above statement consisting of this and six other pages.

"It is a true and correct statement in every respect.

DOROTHY DIANE MANNING, also known as Dorothy Diane Sanford and Dorothy Diane Robertson, was interviewed in a Bureau car outside the residence of her mother, DOROTHY MANNING, 11820 Mapledale Avenue, Norwalk, California. She furnished the following information:

She was employed as a bar maid at the Golden Garter Bar, Alhambra, California, from May 10, 1968, to May 25 or 26, 1968, when she was discharged from her employment. She obtained this job through a friend named JIM WILSON who was a regular patron of the bar and knew the owners.

Photographs of SIRHAN BISHARA SIRHAN were exhibited to MANNING and she stated she did not know this man but he does resemble a friend of JIM WILSON's whose name is BOB (Last Name Unknown). BOB worked with JIM WILSON at a machine shop in Alhambra during part of May, 1968. He frequently came into the Golden Garter Bar with JIM WILSON during May, 1968.

She described BOB as a white male; age 28 or 29; 5' 8"; 170 pounds; good build with large shoulders; pitch black, curly hair; pockmarked face and swarthy complexion. He claimed to be an Italian.

MANNING was confined to the Los Angeles County Jail for ten days and released on May 9, 1968. Upon her release her girl friend, RHONDA GREEN, invited MANNING and her boy friend, EDWARD NESS, to reside with GREEN and WILSON in Apartment A, 2317 Main Street, Alhambra, California. The four of them resided there until approximately June 1, 1968, when MANNING moved to 11101 Ferina Street, Apartment 4, Norwalk, which is the residence of NESS' sister and brother-in-law, JUNE and CARL HANCOCK.

MANNING described NESS as 18 years of age, 5' 10", 130 - 135 pounds, slender build, brown hair. NESS was arrested on June 8, 1968, on traffic charges and confined to the Los Angeles County Jail with an additional charge of presenting false identification to a police officer.

ALBERT VALDIVIA, 826 Fedora, Los Ang les, California, advised he is employed as a runner and food carrier in the Lautrec Restaurant, Ambassador Hotel, Los Angeles. He works the 3:00 p.m. to 11:00 p.m. shift.

VALDIVIA advised he worked his normal shift on June 4, 1968, and went home shortly after 11:00 p.m. He was not a witness to the shooting of United States Senator ROBERT F. KENNEDY at the Ambassador that night, and was watching television at his residence when the shooting was announced. VALDIVIA advised he does not know SIRHAN SIRHAN other than observing him on television in connection with the shooting.

ROSENDO SOTO, 1420 Bonnie Brae, Los Angeles, California, advised he was employed as a kitchen laborer at the Ambassador Hotel, Los Angeles, from about June 1 to June 3, 1968. He worked the 4:30 p.m. to 2:00 a.m. shift.

SOTO advised his regular day off was Tuesday, June 4, 1968, so that he did not work on that day, and was not at the Ambassador Hotel when United States Senator ROBERT F. KENNEDY was shot. He had no information about the shooting other than what he had seen on television, and did not recognize a photograph of SIRHAN SIRHAN.

It is noted ROSENDO SOTO did not speak the English language so that he was interviewed in Spanish through the assistance of the apartment m.nager, Mrs. SANTILLAN.

RICHARD LEE WILSON, 115 Halladay Street, Apartment 7, Santa Ana, California, was interviewed in a Bureau car outside his residence since there were a number of people in his apartment at the time. WILSON is described as a male white, born January 1, 1944, in Long Beach, California, 5'10", 250 pounds, brown curly hair, and brown eyes. He is the brother of JAMES L. WILSON, who currently resides with him. He has previously been convicted of forgery and served two and one half years in the penitentiary.

WILSON advised he is currently unemployed but normally works as a machinist. His last employment was for Dodds Company, Beach and Stage Road, Buena Park, California, for whom he worked about one month and quit on May 29, 1968. His longest employment had been for a period of two years in 1962 and 1963 for the Kirkhill Rubber Company, Brea, California.

WILSON advised he had been living at 115
Halladay, Apartment 7, Santa Ana, since April 1968, with
his wife, ELAINE WILSON, and their son. His brother, JIM
WILSON, visited him at the Santa Ana apartment from time
to time while living in Alhambra in April and May 1968.
In the afternoon of May 30 or May 31, 1968, JIM WILSON and
RHONDA GREEN moved from the Alhambra apartment to the
Santa Ana address, along with their two children, and currently
reside with the RICHARD WILSON family. WILSON was not
certain of the date of the move, but recalled he spent the night
of May 29 or May 30, 1968, with JIM and RHONDA at the Alhambra
apartment after quitting his job.: He said his wife and
child remained in Santa Ana.

WILSON advised he had observed the television broadcasts of the assassination of Senator ROBERT F. KENNEDY and the arrest of the alleged killer, SIRHAN SIRHAN. He did

not recognize SIRHAN by name or photograph. He did not recognize the name BOB ANDRESE. Regarding BOB ALLEN, WILSON advised he had known him for about seven years and believed ALLEN currently lived in Paramount, California. Prior to May 1968, ALLEN lived with JIM WILSON, but they did not get along too well and split up.

WILSON advised his wife is currently employed as a barmaid at the Pour House Bar on First Street in Santa Ana, around the corner from his residence. She began this employment about June 4, 1968, and works the 5:00 p.m. to 2:00 a.m. shift. WILSON goes over to the bar at 2:00 a.m. to count the money and close the place. He spends about ten or fifteen minutes handling this matter and then returns to his apartment. He said JIM WILSON is generally asleep when he gets home since JIM gets up so early to go to work.

WILSON advised RHONDA GREEN has a 1964 gray Comet sedan, which is sometimes used by JIM WILSON since he does not own a car. The only other vehicle JIM WILSON is known to have driven recently was BOB ALLEN'S white Plymouth.

Regarding the move from Alhambra to Santa Ana on May 30 or May 31, 1963, WILSON believed the move had occurred about 6:00 p.m. He said JIM WILSON, RHONDA GREEN, the two children and he drove from Alhambra in RHONDA's Comet and moved into the Santa Ana apartment. All of them got drunk that night, which is a regular occurrence at the house. He said they drink frequently, but it is generally limited to beer. Most of the drinking occurs at home and they have not been frequenting bars in the Santa Ana area. Regarding the Golden Garter Bar in Alhambra, WILSON advised he did not believe he had ever been to that location.

WILSON advised the week end of June 1 and June 2, 1968, involved considerable drinking at the apartment by all of the adult members of the family so that his recollection is hazy about that time. He did recall that on June 4, 1968, which was election day, he and JIM WILSON had worked four hours for Quick Service, located near Second Street in Santa

Ana, about four blocks from his residence. He recalled they went there at 6:00 a.m., and obtained a job unloading a truck about 9:00 a.m. He and JIM worked until about 2:00 p.m., June 4, 1968, making \$1.65 an hour for their labors. He recalled there were elections that day since they were unable to cash the vouchers for their wages at a bar until S:00 p.m., since the bars were closed until that time. About 2:00 p.m., or shortly thereafter, he and JIM WILSON returned to the apartment from the employment and stayed around the house the rest of the afternoon. 8:00 p.m., he and JIM cashed their vouchers at the Spa Bar on South Main Street in Santa Ana. They took a taxi from the Spa Bar about one half mile to the Lasso Bar, where they had a pitcher of beer and walked home. He said the Lasso Bar is near the Pour House Bar and he assumed they got home at 9:30 or 10:00 p.m., but he was not certain. evening he and JIM watched television, along with RHONDA GREEN and ELAINE WILSON. The children were sleeping at the time. He recalled the election returnswere coming in and there was a movie which he watched, although he could not recall the name of it. He recalled seeing Senator ROBERT KENNEDY make his victory speech concerning the California election returns followed by reports of the shooting of Senator KENNEDY. He said he, JIM and the girls were all quite shocked about what happened but recalled no specific conversation about it. He said all of the people went to bed about 4:00 a.m.

WILSON advised he got up at about 3:00 or 9:00 a.m., on June 5, 1963, and observed that the other adults and children were still sleeping. He went back to bed and slept again until 10:00 a.m. or so, when he got up and found JIM WILSON was also up at that time. He recalled that during June 5, 1963, he, JIM and the girls watched television most of the day involving the investigation of the KENNEDY assassination. They were also all drinking quite heavily and he did not believe they left the residence to go anywhere.

WILSON advised upon further consideration, he believed it was on June 5, 1968, that he and JIM had also looked for some employment. He said JIM WILSON filled out an application for a job in the City of Orange, California, where he had previously worked or was known. He and JIM had driven to that location in RHONDA GREEN's car and were gone several hours before returning to the apartment. WILSON advised he did not enter the company from whom his brother was seeking employment, but rather remained in the car. After they returned to the apartment, he believed they stayed there the balance of the day.

Regarding Monday, June 3, 1963, WILSON advised he now has no particular recollection of what had occurred on that day.

EDWIN GERALD NESS, Inmate, Los Angeles County Jail, advised as follows:

During the month of May, 1968, he resided with DOROTHY MANNING, JAMES WILSON, and RHONDA GREEN at an apartment in Alhambra at 2317 Main Street. During that time, he was not employed and DOROTHY, whom he was living with, was employed as a barmaid at the Golden Garter in Alhambra. Also during this time, JAMES WILSON obtained employment at a company in Monterey Park, whose name he could not recall, but he thought it began with "S" and sounded something like "SCRABBLE." He believed that WILSON lasted at this employment approximately one week. WILSON did not own a car, and he was driven to and from work by an individual whom he (NESS) knew only as BOB. He believed BOB drove a 1962 Valiant and on several occasions stopped at the Golden Garter to have a drink with JAMES WILSON.

NESS was shown a photograph of STRHAN BISHARA STRHAN, and he said that this photograph resembled the individual whom he knew as BOB, with the exception that BOB combed his hair straight back and had a pockmarked face.

NESS was asked as to what type mail WIISON received during the period they shared the apartment on Main Street. He replied that the only mail WIISON received was "bills." He said that he has known WIISON for the past three years and has resided with him for the past one month, until they split up approximately the first of June, 1968. During that period, WIISON has never made known his political beliefs, and it is the opinion of NESS that he is not interested in politics.

Since their split up on June 1, 1968, NESS has had one contact with WILSON, that being on June 8, 1968, in Santa Ana. NESS said he believes that WILSON is residing in Santa Ana somewhere near Main Street on either First or Fourth Street. WILSON's brother, RICHARD, is the manager of a bar in Santa Ana, California, the "Poor House" or "Pussy Cat."

WILSON was known to frequent the Golden Garter and to the best of NESS's memory, BOB had accompanied WILSON to the bar on many occasions.

NESS advised that he was being held by the Los Angeles County Sheriff's Office on a charge of furnishing false identification to a police officer.

NESS was asked why DOROTHY was fired as a barmaid from the Golden Garter. He stated that she was fired because one of the owners tried unsuccessfully to have sexual intercourse with her.

The following description of NESS was obtained

through interview and observation:

HARRY PATZMAN, 2915 West Shorb, Alhambra, California, telephone 282-7637, advised he is employed at the Union 76 Service Station, Fremont and Valley Boulevard, Alhambra. He is a regular customer at the Golden Garter Bar, Alhambra, stopping there two or three times a month during the last six months. He also frequents the Interlude and Stardust Bars in Alhambra.

A group of photographs were shown to PATZMAN including photos of SIRHAN SIRHAN, ROBERT ANDRESE, EDWIN GERALD NESS, and JAMES LLOYD WILSON. PATZMAN did not recognize photos of WILSON or NESS. Regarding the photo of SIRHAN SIRHAN, PATZMAN identified him as appearing identical to a customer seen at the Golden Garter Bar three or four times during the last two months. PATZMAN recalled seeing him the first time about two months ago when PATZMAN went into the bar in the late afternoon. bar was crowded and PATZMAN sat next to this individual at the bar. He said the man had pimples on his face, looked like a "wetback", and was sloppily dressed. PATZMAN attempted to engage the man in conversation but the man did not even answer PATZMAN saw him two or three other times but was never introduced to him. He said the man was always alone and was not observed to associate with anyone else. PATZMAN could furnish no further information concerning this man.

Regarding ROBERT ANDRESE, PATZMAN identified a photograph of this individual as a man known to him only as "BOB", a customer at the Golden Garter Bar in the last two months. PATZMAN believed he had also observed "BOB" at the Interlude and Continental Bars in Alhambra. He knew no background concerning "BOB" such as his residence, employment, or vehicle. The only person ever seen with "BOB" was a young man, 6'2", long and very light blond hair, with a scar under his left eye. PATZMAN saw this man with "BOB" on one occasion at the Golden Garter Bar over a month ago.

Regarding JAMES LLOYD WILSON, PATZMAN was unable to identify him by name or photograph. PATZMAN recalled, however, meeting a man named "JIM" at the Golden Garter Bar, being introduced to him by the barmaid named "DOTTIE". PATZMAN believed "JIM" was "DOTTIE's" boy friend, and described him as a male, white, 20's, 6', 200 pounds, light brown hair, goatee, and wearing lace-up type of field boots. He saw "JIM" on only the one occasion and probably would not recognize him if seen again.

ELAINE M. WILSON, 115 South Halladay, Apartment 7, Santa Ana, California, advised that she is married to RICHARD WILSON and that JIM WILSON is her brother-in-law. She further advised that on May 30, 1968, JIM WILSON, RHONDA GREEN and her children moved into the apartment.


WILSON furnished the following information regarding JIM WILSON's activities from June 3 - 5, 1968:

On 6/3/68, JIM and RICHARD WILSON left the apartment at approximately 9:00 AM to seek employment and returned at approximately 11:30 AM. They stayed in the apartment the rest of the day drinking and talking.

On June 4, 1968, JIM and RICHARD WILSON got up about 6:00 AM and left the apartment to seek employment through the Qwik-Serv Employment Agency and were gone until approximately 3:15 PM. JIM stayed in the apartment until approximately 8:00 PM when the bars opened and, at that time, he and RICHARD went to the Spa Bar on Main Street to draw money for their employment. They returned at approximately 9:30 PM. JIM left at 10:00 PM to go to Sam's Bar and at approximately 10:30 PM, RHONDA went to the bar to get him and they returned approximately 20 minutes later. They all stayed in the apartment watching television until the early morning of June 5, 1968.

On June 5, 1968, JIM and RICHARD left the apartment at approximately 8:00 or 9:00 AM to seek employment and were gone for approximately two hours when they returned. During the early afternoon, they again left the apartment for job interviews and returned at approximately 3:00 PM, where they remained for the rest of the day.

RHONDA GREEN was interviewed at 115 South Halladay, Apartment 7, Santa Ana, California. After reviewing a photograph of BOB ANDRESE, she identified him as the individual who visited her in Commerce, California, with JIM WILSON, DOROTHY MANNING and EDDIE NESS.

GREEN furnished the following information as to the activities of JIM WILSON during the end of May and beginning of June 1968:

To her knowledge, JIM WILSON worked in Monterey Park until May 29, 1968, when he quit. He drove to Commerce accompanied by DOROTHY MANNING and EDDIE NESS and he was driving an old two door DeSoto (year not known but believed to be of the early 1950 vintage). WILSON wanted to borrow her car to move from Alhambra to Santa Ana, California. They all left Commerce about 8:00 PM and drove directly to the apartment in Alhambra.

She does not recall specifically what WILSON did from May 31, 1968, through June 3, 1968.

On June 4, 1968, the bars were not opened and JIM and RICHARD WILSON went to look for a job through the Qwik-Serv Employment Agency. They left the apartment at approximately 6:30 AM and did not return until approximately 3:00 PM. They sat around the apartment until 8:00 PM when the bars opened, at which time JIM and RICHARD went to a local bar. They returned at approximately 9:00 PM but JIM left at 10:00 PM and went to Sam's Bar. At approximately 10:30 PM, RHONDA went to Sam's Bar to get JIM and they returned to the apartment approximately 15 minutes later.

GREEN, JIM WILSON, ELAINE WILSON and RICHARD WILSON stayed in the apartment from approximately 10:45 PM, June 4, 1968, watching television until the morning of June 5, 1968.

JAMES LLOYD WILSON, JR., 115 South Halladay Street, Apartment 7, Santa Ana, California, was reinterviewed in a Bureau car near his residence.

WILSON identified a photograph of BOB ANDRESE as the individual he previously referred to as the BOB who worked with him in Monterey Park, California, and frequented the Golden Garter Bar, Alhambra, California.

WILSON pointed out that he did not see BOB on May 29, 1968, at the Golden Garter Bar as previously advised but feels he last saw him at the bar on the evening of May 28, 1968. He further pointed out he feels sure about this inasmuch as he, WILSON, quit his job at the Scanbe Manufacturing Corporation at noon on May 29, 1968. He left work and went directly to his apartment in Alhambra. He was driving a 1951 to 1953 DeSoto, gray or green in color, which belonged to ANGEL (Last Name Unknown)(LNU), an employee of Scanbe. He stayed at the apartment for approximately one or two hours and then drove to RHONDA GREEN's apartment in Commerce, California. He was accompanied by DOROTHY MANNING and EDDIE NESS. They stayed in Commerce until approximately 8:00 PM and then drove back to Alhambra. GREEN followed them in her automobile.

They all stayed in the apartment most of May 30, 1968. WILSON drove ANGEL's DeSoto back to the company area where he left it sometime during that day.

At approximately 8:00 PM, WILSON, accompanied by his brother, RICHARD, RHONDA GREEN and her two children, drove to RICHARD's apartment in Santa Ana, California, where he has resided since that time.

On June 3, 1968, he does not recall specifically what he did but believes he went to seek employment with his brother.

on June 4, 1968, he got up at approximately 5:30 AM and went with RICHARD to the Qwik-Serv Employment Agency on Spurgeon Street. They were at the agency from approximately 7:00 AM to 9:00 AM, when they were sent on a job, name and location not recalled. They worked four and one-fourth hours and finished up at approximately 2:00 PM. He was returned to the agency at approximately 3:00 PM and arrived back at the apartment at approximately 3:30 PM. He stayed in the apartment until the bars opened at 8:00 PM, when he and RICHARD walked to a bar on Main Street to cash their employment checks. After they cashed the checks, they took a taxi to Sam's Bar, which is near the apartment. He believes he stayed there until approximately 11:00 PM, when he returned to the apartment and remained there until the morning of June 5, 1968.

At approximately 7:00 or 8:00 AM on June 5, 1968, he went to Anaheim, California, with his brother in an attempt to obtain employment.

WIISON stated that he was in debt to one of the owners of the Golden Garter Bar in the amount of \$5 and recalls that this owner discussed the debt with him one evening a day or two before Memorial Day when he and BOB ANDRESE were sitting at a table in the bar.

FRED PARROTT, M.D., was interviewed at his office, 1704 West Manchester Avenue, Suite 210, and furnished the following information:

On June 4, 1968, he went to the Ambassador Hotel at approximately 11:30 PM to listen to the victory speech of Senator ROBERT F. KENNEDY. He found that the hotel was so crowded that he could not get into the Embassy Room, the room in which Senator KENNEDY was giving his speech.

Shortly after midnight, while standing near the door to the Embassy Room, he heard a great deal of shouting and screaming from the interior of the room. Shortly after, Dr. MARCUS MC BROOM, a Psychologist whom he knew, came out of the room and said that doctors were needed. Dr. PARROTT attempted to enter the Embassy Room; however, a guard at the door refused to allow him to enter. While he was trying to identify himself, Dr. ROSS MILLER slipped past the guard and went into the Embassy Room, apparently to see if he could render any aid.

With the tremendous crowd that had gathered in the Embassy Room, he never did reach the injured people and did not see SIRHAN BISHARA SIRHAN. However, while standing outside the door to the Embassy Room, a man came by carrying a rolled up newspaper under his arm. As the man pressed through the crowd, passing right next to Dr. PARROTT, he kept saying, "Excuse me, please". Dr. PARROTT noticed that he appeared to have glassy eyes, as though he were ill. Just after this man passed, several men, whom he assumed were from the KENNEDY Party, came through the crowd hollering, "Stop that man! Stop that man!", indicating the man who had been carrying the newspaper. He does not know if these men were successful in getting the man with the newspaper stopped, but the last time he observed them, they were going out the south door of the Ambassador Hotel. He described the name with the newspaper as a white male, dark complexion, dark hair, 25 to 27 years old, 5'7" tall, medium build. He said that he could furnish no description of the two or three

men who were attempting to stop the man with the newspaper, other than that they were white males.

The only other thing that he observed which seemed irregular to him under the circumstances was four men carrying a fifth man out of the hotel saying, "Let's get out of here". He did not know if the man they were carrying had been injured in the crowd.

A photograph of SIRHAN BISHARA SIRHAN was exhibited to Dr. PARROTT but he advised he did not recognize him as anyone he has ever seen. PARROTT stated that he went to the Ambassdor Hotel with his friend, SAMUEL STRAIN, and advised that STRAIN could be reached at telephone number AX 3-5327.

WILLIAM EVENSEN, Co-Chairman, Young Professionals for KENNEDY, was interviewed at the Graduate School of Business Administration, University of California, Los Angeles Campus. EVENSEN advised the Young Professionals for KENNEDY is made up of young working people who were not students. He furnished the applications made by all members of this organization and a roster listing the names and addresses of all members. This roster is being maintained in the Los Angeles file.

A review of the applications for the name JAMES TED revealed the name of JAMSHID TADJIKI, 1841 North New Hampshire, Number 9, Hollywood, California 90027, telephone number 665-3527. EVENSEN advised that he is not familiar with this name and cannot say whether this person was or was not identical with SIRHAN BISHARA SIRHAN.

EVENSEN said that he was on the stage of the Temple Isaiah, 10345 West Pico Boulevard, Los Angeles, California, when Senator ROBERT F. KENNEDY gave his speech about three weeks ago. He, however, does not recall seeing anyone resembling SIRHAN and further stated that there were between 50 and 75 people on the stage, so that if SIRHAN was there, it is unlikely that he would recollect seeing him. EVENSEN observed a photograph of SIRHAN and advised that he does not recognize him as anyone he has ever seen before.

He was not at the Ambassador Hotel on June 4, 1968, but observed the assassination of Senator KENNEDY by television in New York. He said that the following individuals are believed to have been at the Embassy Room at the approximate time of the assassination:

MARWAN MOHAMMED SABHA, apartment B, 415 North Third Street, Alhambra, California, telephone No. 284-0752, was contacted concerning his knowledge of SIRHAN BISHARA SIRHAN. SABHA advised that he is presently employed at the Lockeed Electronic Company, 6207 East Randolph, City of Commerce, California. SABHA advised that his wife, SIGRID SABHA, was contacted by Special Agents of the FBI on June 10, 1968 and that since the Agents contacted his wife, he and his wife have discussed the possibility of their having come into contact with SIRHAN. SABHA said that he and his wife have concluded that they have never seen nor talked with SIRHAN on any occasion and that he had never heard of SIRHAN until the assassination of Senator ROBERT KENNEDY, at which time he read the account of this assassination in the newspapers and observed photographs of SIRHAN in the newspapers as well as on television. SABHA stated that he is a Jordanian and knows several Jordanian Nationals in the Los Angeles area and that the only person that he can recall that even vaguely resembles SIRHAN is an acquaintance by the name of HAFEZ ARAFAT, who is a Jordanian friend of his.

SABHA said that ARAFAT is employed as a project engineer in the San Fernando Valley area for a company unknown to him. SABHA said that he does not know ARAFAT's address; however, he said ARAFAT lives in Canoga Park, California, and his telephone number is 884-8575. He said that ARAFAT resembles SIRHAN in his physical build, but that his facial features do not resemble any photographs that he has seen of SIRHAN.

On June 15, 1958, Mrs. LINCOLN (VIRGINIA) LYTTLE, 11703 Sampline Avenue, Downey, California, telephone number 852-1992, advised that she is employed part-time at the Nutriville Health Food Store, 7822 East Florence Avenue, Downey, California. Mrs. LYTTLE stated she is employed approximately 24 or 25 hours a week as a sales person.

Mrs. LYTTLE explained that about November or December 1957, while at work one day she was introduced to a person by the name of SAUL (Phonetic) by the Store Manager, LOIS PALMER. LYTTLE stated that SAUL made deliveries for the company from the Pasadena store to the store in Downey and on his return trip, he took merchandise and/or money to the Monterey and/or the Pasadena store for this company. Mrs. LYTTLE stated that subsequent, she saw SAUL in the store almost everyday that she worked, which was about two or three times a week. Mrs. LYTTLE stated that some times she would not see SAUL because he had already been at the store before she arrived for work or he did not come to the store at all on some particular days.

Mrs. LYTTLE stated that she had very little conversation with him. She stated that it consisted primarily of hello and how are you? Mrs. LYTTLE stated that she had no extended conversation with SAUL and would be unable to furnish anything concerning his ideas, as she does not know his ideas or opinion about anything. Mrs. LYTTLE stated that all she could say was that he was a nice looking person, with a pleasing personality.

Mrs. LYTTLE stated that the first she knew that SAUL was identical with a person named SIRHAN SIRHAN, who was alleged to have assassinated Senator ROBERT KENNEDY was on the Thursday after KENNEDY's death, when Mrs. WEIDENER, the wife of the owner of the store, telephonically advised the store manager, LOIS PALMER, that the person who was arrested for shooting Senator ROBERT KENNEDY was SIRHAN SIRHAN, who is the same person as SAUL who made deliveries to the Nutriville Health Food Store. Mrs. LYTTLE stated that after LOIS PALMER
