He further pointed out that BOB tried to talk about politics all the time, which WILSON was not interested in, therefore, never paid much attention to the conversation. He did recall on one occasion while they were in the bar, BOB was talking about politics and was becoming a little excited so he told him to "cool it". WILSON said the last time he saw BOB was on the evening of May 29, 1968, at the bar where the aforementioned incident occurred.

ANWAR MUSA SAYEGH, 2497 Ridgeway Road, telephone number 793-0763, advised he was born [REDACTED] at Mafraq, Jordan, and that he came to the United States by boat in 1957. SAYEGH advised he currently is a student at Pasadena City College and that his only employment is a Saturday job at Bennett's Rose Bowl Restaurant. SAYEGH advised that the above residence is owned by Mr. and Mrs. MORRIS and that they room and board foreign students in return for a few hours labor around their house and pool by these students. SAYEGH advised his father and mother are MUSA and RAFGH SAYEGH who currently live at 39 St. Joseph Avenue, Yonkers, New York. SAYEGH advised he is the President of the International Club at Pasadena City College. (It is noted that SAYEGH was observed this date to be driving a Pontiac convertible with black top and red body bearing California license VSB 639).

SAYEGH continued he generally drinks coffee at the cafeteria at Pasadena City College (PCC), both before his class in the morning and in the evening on Tuesdays and Thursdays. He was first introduced to one of the SIRHAN brothers about two or three weeks ago during the morning coffee. It is not known which SIRHAN brother he met, ADEL or SIRHAN BISHARA SIRHAN. He had no conversation with this individual on that occasion. SAYEGH advised the second and last meeting with this individual was between 6:30 and 7:00 p.m. Tuesday, June 4, 1968, which lasted about ten minutes. This meeting occurred in the presence of several other persons at the table, their names not recalled. On this occasion, he and this individual conversed. SAYEGH advised he asked this individual if he were Moslem, and he answered that he was not. SAYEGH advised he then asked him if he were Catholic, and he answered that he was not. SAYEGH then asked him when he had come to the United States and he answered in 1957 on the boat "Christopher Columbus." SAYEGH then advised he then left for his class and that was the last time he saw this individual. SAYEGH recalled that at this meeting, this individual had introduced a friend of his, name not recalled, to the group. This person appeared to be quite hunchback, and he regularly frequents Bob's Restaurant

and lives somewhere near PCC and is believed to be from India.

SAYEGH advised that on that occasion, this individual appeared to be very calm and pleasant and neatly dressed, further description unknown. SAYEGH advised later when he learned Senator KENNEDY had been shot, he turned on his television set where he observed the person being held in custody for the shooting. SAYEGH advised he could not identify this person as the individual previously mentioned. SAYEGH advised he later learned the name of this person was SIRHAN BISHARA SIRHAN and made inquiry with his school friends asking if he was the same SIRHAN with whom they had coffee. SAYEGH advised he learned that two of his acquaintances were close friends of SIRHAN BISHARA SIRHAN. One of the acquaintances was identified as IVAN (LNU), a student at PCC who lives on North Hill Avenue, Pasadena, and who is employed daily after 4:00 p.m. at Allied Auto Parts on Colorado Boulevard, Pasadena. The other acquaintance was identified as JOE (LNU) also a student at PCC. They said they were going to go by ADEL SIRHAN's home and invited SAYEGH to come with them. SAYEGH advised he had to take a psychology test at that time and was unable to accompany them. He advised later that JOE (LNU) told him they did not go to ADEL's so as to not add to the confusion. SAYEGH advised he told JOE that he should contact the appropriate authorities in view of his long friendship with SIRHAN BISHARA SIRHAN, but JOE told him that he was not going to contact anyone but would tell everything he knew about SIRHAN BISHARA SIRHAN if the authorities came to him.

ROLEN advised that she is presently employed as sales personnel for one of JOHN H. WEIDNER's health food stores, located at 7822 East Florence Avenue, Downey, California.

She said the only thing she could recall regarding SIRHAN BISHARA SIRHAN is that he made deliveries to her store from their main store approximately three times a week and would remain in their store for approximately ten to fifteen minutes on each delivery. She believed he first started making deliveries around Christmas 1967 until about February or March 1968.

During these deliveries, she recalled SIRHAN to be a very polite, cooperative young man. She said he seemed to be very nice and could not think of anything derogatory regarding his conduct. She knew of nothing regarding his personal life or beliefs and actually she did not know his full name. She recalled when she first saw him that she and her co-worker, LOIS PALMER, asked him his name. He replied, "Call me SAUL".

She concluded that she was very shocked by the incident involving SIRHAN and if there is any further information concerning this matter, she would be more than willing to furnish the same.

Mrs. ROLEN is leaving the city for a visit at a relative's home in San Bernardino, California and will be on vacation for approximately two weeks.

Mrs. CLAUSSINE GRAY advised that she is temporarily living at 843 North Las Palmas, Los Angeles, California, until June 22, 1968. After that she will be at her permanent home address, 2972 Whitby Drive, Doraville, Georgia, telephone Number 938-5320.

She stated that on June 4, 1968, at approximately 10:00 a.m., she and her husband, H. E. GRAY, entered the waiting room at the Atlanta, Georgia, Municipal Airport to board Delta Flight 885, nonstop to Los Angeles. They sat down in the waiting room and seated across from her was a white female who was talking in a very loud voice. She recalls this female saying the approximate words, "Wouldn't it be thrilling to be hit by the same (or a) bullet that hit (or was fired at) Kennedy." This female did not appear to be talking to anyone in particular but just talking to everyone around her. Mrs. GRAY does not recall hearing any of this female's prior conversation leading up to this statement. Her conversation seemed jovial in nature.

Mrs. GRAY next heard the same female say something to the effect that finally her luck is changing or has changed, which Mrs. GRAY felt was in connection with her catching this particular flight to Los Angeles. The female did not appear to be with anyone except that when she was standing in line waiting to board the plane, an older female in her early fifties, 5' 2" tall, and with gray hair, was standing next to her and they were talking. Mrs. GRAY paid no attention to any further conversation from this female.

Mrs. GRAY advised that she did not further notice this female after she had boarded the plane but believes that she sat in the first class section. She did not see the female after they arrived in Los Angeles at approximately twelve midnight, same date.

Mrs. GRAY pointed out that the female was talking so loud that there were bound to be other persons who would have heard the same remarks. She did not notice this female carrying

ALBERT RICHARD LE BEAU, 712 East Princeton Street, Ontario, California, was interviewed on June 7, 1968, by SA JOHN R. KELLISON and furnished the following signed statement:

"June 7, 1968
Pomona, Calif.

"I, Albert Richard LeBeau, furnish the following information to John R. Kellison who had identified himself to me as a Special Agent of the F.B.I.

"I was born [REDACTED] at Schenectady, N.Y. I reside at present at 1712 E. Princeton St., Ontario, Calif.

"I am employed as night manager at Robbie's Restaurant located at 390 Pomona Mall East in Pomona.

"During the day of Wednesday, June 5, 1968, I observed a photograph in the Progress Bulletin newspaper of the person who had been arrested in connection with the shooting of Senator Robert Kennedy.

"This photograph closely resembled a man I had seen previously at the restaurant on the occasion of a visit by Senator Kennedy to Pomona. On that occasion which took place on Monday, May 20, 1968, a luncheon for Senator Kennedy was held at the restaurant. This luncheon took place from about 12:20 p.m. to about 1:30 p.m.

"I was stationed generally during this period at the foot of the stairs on the first floor of the restaurant for the purpose of taking up tickets from those persons attending the

"luncheon. After all persons were seated and Senator Kennedy had entered the restaurant and gone upstairs I then allowed the standing room crowd to go upstairs. Tickets were required from these persons also.

"Prior to allowing the standing room crowd up the stairs I was told not to let anyone up the stairs until Senator Kennedy cleared the stairs and the luncheon room upstairs. After he did so, I was then told to allow the people up.

"I recall letting one older man up the stairs after taking his ticket. A moment or so later I allowed a few other persons with tickets through.

"I recalled then hearing a noise of someone apparently hitting their foot on the stair behind me. I looked around and saw a young woman on the stairs behind me about two steps up. She had to climb over the stair rail from a booth and a brick flower casing against the stairs in order to get behind me. I saw a man coming over the rail and dropping onto the stairs behind the girl.

"I stepped up on the next stair and grabbed the girl with my right arm to prevent her from moving up the stairs. She was facing up the stairs at the time. In grabbing her with my right arm I recall ending up with my right hand on her left breast accidentally.

"I asked the question of both the girl and the man, "Do you have tickets".

"The girl answered "We are part of the Senator's party".

"I asked again "But do you have tickets?"

"She answered "We are a part of the Senator's party. He just waved to us to come upstairs."

"During this brief encounter the man said nothing but he was continuously pushing on her back.

"I then let the two of them go and returned to the bottom of the stairs.

"Following this I let the remainder of the ticket holders go up the stairs.

"During the address made by Senator Kennedy at the luncheon at approximately 1 PM I was upstairs for the purpose of locating a runner for one of the newsmen present and I recalled having seen the same man and woman standing against the south wall of the room where Kennedy was making his address.

The podium from which Kennedy spoke was set against the east wall of the room.

"On seeing the couple, it occurred to me that they were not a part of the Senator's party in view of their location.

"After finding the runner I was seeking in the vicinity of the south wall, the two of us turned to leave the luncheon room, I bumped accidentally into the man who was with the girl mentioned previously.

"I recalled saying, "Pardon me".

"He said "Why should I?"

"I ignored his remark and left the room.

"I did not observe further the man or the woman.

"While the man was standing against the wall I noted that he was still carrying a coat of some kind draped over his right arm. This was the same manner in which he had carried the coat when I encountered the man initially on the stairs.

Officer DAVE HANELINE, Pomona Police Department, advised that on the day of the reception held for Senator KENNEDY at Robbie's Restaurant on the Pomona Mall, Pomona, he was stationed inside the restaurant during the noon luncheon reception held for KENNEDY. He stated that he was stationed near the stairs leading to the second floor luncheon area. During the entire time of the luncheon, while inside, he said that he had no recollection of any incident on the stairs leading the second floor of a couple having been detained momentarily on the stairs because of their not having tickets for the luncheon.

HANELINE related, after viewing photographs of SIRHAN BISHARA SIRHAN, that he has no recollection as having seen anyone in the crowd inside the restaurant who would have resembled SIRHAN.

Officer CARL F. JACKSON, Pomona, California Police Department, advised that on May 20, 1968, when a reception was held for Senator KENNEDY at Robbie's Restaurant on the Pomona Mall during the noon hour, that he was stationed inside the restaurant on the first floor in the vicinity of the stairs leading to the second area where the luncheon reception was held.

He recalled that when Senator KENNEDY and his party started up the stairs to the second floor that Senator KENNEDY stopped momentarily on the stairs and pointed a finger to Officer SCHNEID who was holding back a crowd away from the foot of the stairs and saying to Officer SCHNEID "Let them through". JACKSON related that this remark apparently referred to a couple in the crowd being held back by SCHNEID who he believed to have been part of the KENNEDY party. To the best of his recollection one of these persons would have probably been STEVE SMITH, brother-in-law of Senator KENNEDY, or someone resembling SMITH.

It was his recollection that this person then made his way to the area of the foot of the stairs and got onto the stairs themselves by being forced to climb over the north rail of the stairs because of the crowd at the base of the stairs.

JACKSON recalled also that there was a girl standing by the kitchen door adjacent to Officer SCHNEID and apparently Officer SCHNEID had had some words with this girl. He recalled that a moment or so later this same girl was observed by him as being on the stairs and apparently having been detained by one of the persons taking up tickets at the foot of the stairs, however, JACKSON said he had no recollection of any man being with this girl.

He related that he saw no one in the crowd around the stairs who resembled photographs of SIRHAN BISHARA SIRHAN.

Officer VERN ALLEN MILLER, Pomona, California Police Department, advised that during the noon hour on May 20, 1968 on the occasion of a reception-luncheon held for Senator KENNEDY at Robbie's Restaurant on the Pomona Mall, he was stationed on the stairs inside the restaurant leading to the second floor luncheon area.

After Senator ROBERT KENNEDY and his party went up the stairs to the luncheon area, he recalled that there might have been an incident of two women having been detained momentarily as though they were being checked for tickets.

It was his recollection that they did not have tickets to the luncheon but were allowed up the stairs anyway. These persons were an older heavy set female caucasian and a younger woman who might have been the first woman's daughter.

MILLER advised that he had no recollection of a young couple having been detained on the staircase and that he has no recollection of having seen anyone in the crowd resembling the photograph of SIRHAN BISHARA SIRHAN.

Officer WILLIAM H. SCHNEID, Pomona, California Police Department, advised that on May 20, 1968, he was stationed inside Robbie's Restaurant located on the Pomona Mall during the noon hour. On this date and at this time there was a reception held for Senator KENNEDY in the upstairs portion of the restaurant.

He stated that he was stationed in uniform in the aisle leading to the rear door at the southeast end of the building holding back the crowd away from the stairs leading to the second floor luncheon area.

Just prior to Senator KENNEDY and his party moved up the stairs to the second floor, he recalled having noticed a girl in her mid 20's standing by the kitchen door on the west side of the corridor. It was his recollection that this girl apparently was trying to get into the kitchen. SCHNEID said he told her that she could not go in there. He recalled her asking him which way Senator KENNEDY was coming in and was told he would probably go up the stairs to the second floor.

SCHNEID related that when the KENNEDY party did go up the stairs that Senator KENNEDY stopped midway and pointed at him and said to him "Officer, Let them through". SCHNEID related that KENNEDY was referring to the people in the aisle that he was trying to hold back. As soon as Senator KENNEDY said this, SCHNEID said that the crowd serged toward the foot of the stairs and that he was forced to step aside.

At this time, SCHNEID recalled that the girl mentioned previously by him bolted toward the area at the foot of the stairs and moved into the booth area on the north side of the staircase instead of trying to get up the stairs herself. It was his impression that she was trying to get to someone she might have recognized in that area.

Within possibly a minute later, SCHNEID recalled seeing the same girl on the stairs themself. He said that it was his impression that someone might have helped her over the brick facade adjacent to the stairs and over the stair railing behind

After observing photographs of SIRHAN BISHARA SIRHAN, SCHNEID said that the man observed by him in the company of the woman did bear some resemblance to SIRHAN or at least to the photograph taken of SIRHAN at the Ambassador Hotel, which photograph also contains a portion of the face of Mr. UNRUH.

SCHNEID advised that he might recognize both the girl and the man observed by him if he were to see them in person. He did not feel that the man observed by him on the stairs would have been SIRHAN SIRHAN.

SCHNEID furnished the following description of the man observed by him:

Both were linguists, consequently, their association became quite close. They did not have any classes together, however, they were frequent associates and, after leaving PCC, SIRHAN was a frequent guest at the residence of STRATHMANN and his wife.

SIRHAN was considered an ideal guest and initially seemed lonely and quiet and was considered very kind and considerate.

SIRHAN was considered by STRATHMANN to be quite passive politically and did not tend to discuss American politics. SIRHAN did, on one occasion, express admiration for ADOLF HITLER and, although he disapproved of his tactics, did greatly admire him in the success that he achieved. SIRHAN criticized the United States because of existing poverty and the difficulty in achieving rapid advancement. SIRHAN seemed to be obsessed with a desire to achieve instant wealth and success. SIRHAN was very emotional in discussing the recent Arab - Israeli conflict and was critical of United States policy supporting Israel. SIRHAN did not discuss personalities in connection with United States politics. STRATHMANN recalled that on one occasion, a Jewish friend of his, not known to SIRHAN, expressed to him a disapproval of the Israeli treatment of Arab refugees. This STRATHMANN related to SIRHAN and SIRHAN understood him to say that his friend admired the Israeli treatment of Arab refugees, and SIRHAN, in an emotional outburst, stated, "He had better not say that to me".

After SIRHAN fell from a horse in 1966, he seemed to change considerably. His eyes appeared to be different to the effect that he had difficulty seeing out of one eye

and it seemed glassy and bloodshot. SIRHAN rubbed it frequently and since the accident seemed very impatient, nervous, more emotional, and always in a hurry.

After the accident, SIRHAN also became interested in mystical bodies, the power of mind over others. SIRHAN had indicated that he was studying mysticism with an individual named PAUL, who was unknown to STRATHMANN. SIRHAN gave STRATHMANN a book on mysticism, which he has misplaced.

Prior to the accident, STRATHMANN considered SIRHAN a very intense person and a perfectionist and, subsequent to the accident, SIRHAN seemed to have lost an intensity which had been characteristic of him previously.

STRATHMANN, about six months ago, gave SIRHAN a text book on Chinese grammar, in which SIRHAN had expressed an interest. He does not believe that SIRHAN studied the book and did not return it to STRATHMANN.

STRATHMANN's last conversation with SIRHAN was in mid April 1968.

She did not have any classes with SIRHAN but knew of him.

She also attended one semester at Pasadena City College (PCC) in 1963.

It was not until after her marriage to JOHN H. STRATHMANN in 1964 that she became well acquainted with SIRHAN.

She last saw SIRHAN approximately four or five months ago when he had dinner with her and her husband and, after dinner, he invited her and her husband over to his house on Howard Street in Pasadena.

She does not know any other close associates of SIRHAN's, except perhaps an individual whose last name is CROWE who had been a classmate of SIRHAN's at PCC and who SIRHAN had helped with the Arabic language.

SIRHAN was very pro-Arabia and the only time he became emotional was when discussing the Israeli-Arab conflict. He criticized the United States due to its support of Israel in the conflict and expressed a feeling of appreciation to Russia for its assistance to the Arabs.

When SIRHAN was a horse exercise boy in Corona, California, he expressed a profound interest in becoming a jockey and seemed to change considerably following his fall from a horse in 1966. After the fall, he seemed to brood and remarked that due to the damage to his eyes, he could no longer be a jockey.

He subsequently became interested in mysticism and expressed a desire to be able to control a person's mind through extra sensory perception. He told Mrs. STRATHMANN of one occasion when he conducted an experiment on his mother. He was home late at night studying a book on mysticism and his mother was sleeping in the next room. He related to Mrs. STRATHMANN that through concentration, he attempted to transfer thoughts to his mother to force her to get out of bed and go to the bathroom. He stated that shortly after he began this concentration of thought, his mother did get up and go to the bathroom.

Other than SIRHAN's emotional feelings regarding the Arab - Israeli conflict, Mrs. STRATHMANN considered him a friendly, kind and generous person.

FLEMING advised that he became acquainted with SIRHAN at Pasadena City College (PCC) in 1963 and 1964 when both were students. He did not have any classes with SIRHAN but came to know him namely through his friendship with the STRATHMANNs.

While at PCC, SIRHAN took part in informal discussions, however, he did not discuss politics, except that he was very pro-Arab and was critical of American foreign policy because of United States support of Israel. He felt that SIRHAN liked the United States and did not consider him a revolutionist.

SIRHAN was a member of a foreign student organization at PCC and a member of an Arab student organization.

SIRHAN impressed FLEMING as desiring to rapidly get ahead in life and to acquire wealth. While a student at PCC, SIRHAN was employed for a while at a Richfield Station on the corner of Santa Anita and Foothill Boulevard, Pasadena, California.

Since 1964, FLEMING saw SIRHAN only once, that being in February 1967, when he spoke to him briefly after meeting him on the street in Pasadena.

INAYAT'KHAN stated he first met an individual known to him as SIRHAN SIRHAN in the Fall of 1966 at a private residence rented by OMAR RAMZI, which is located at 2345 Lilydale Street, Los Angeles, California. He was shown a photograph of SIRHAN SIRHAN dated June 5, 1968, and he stated this individual resembled the individual he knew as SIRHAN. He further advised that the only other individual he can recall being at the residence of RAMZI was an individual known to him as FAIZULLAH KHAN. He advised that a small group of students met several times at the above residence and discussed general topics and also various political situations in the United States and Jordan, Israel, etc. In this regard, he indicated that SIRHAN and others in this group were supporters of the Bath Party, a mid-East political party that is composed of members that support any government that is pro-Jordan, Syrian, etc., in philosophy and ideology.

He advised that FAIZULLAH KHAN, residence address unknown, was a native of Afghanistan; a graduate student majoring in political science when he met him in the Fall of 1966. He further advised that it was his understanding that KHAN was the President of the Student Association at California State College at Los Angeles and it was his further understanding that KHAN's brother is the Prime Minister of Afghanistan.

INAYAT'KHAN advised that his impression of SIRHAN was that he was a very impressionable individual. In this regard, he related how during one group discussion at the previously mentioned residence, the topic of conversation centered around various committees of the United States Senate and the United States House of Representatives and the key positions certain members had in influencing policies, appropriations in such areas as foreign aid, etc. He stated that SIRHAN became quite agitated during this discussion and indicated how unfair and undemocratic the committee system of our form of government is and can be if the wrong people control the power.

He advised that SIRHAN and others were pro-Jordanian, Syrian, in philosophy but they also do not believe the rulers in their native lands were fighting with enough determination to regain their rightful land from the Israeli people.

He advised that on numerous occasions, SIRHAN and the others in this group went to a beer tavern known as Garfanos, 5468 East Valley Boulevard, Los Angeles, California.

INAYAT'KHAN further advised in late 1966 or early 1967, the Arab Students Association held a bazaar at an Armenian Church in the City of Los Angeles, the exact location not recalled, and approximately 200 students, girl friends, etc., attended.

INAYAT'KHAN concluded by stating he did not know SIRHAN SIRHAN very well but he would describe him as a young immature individual that was very impressionable.

Mrs. PALMER knew SIRHAN SIRHAN as SOL SIRHAN who was employed by Mr. WEIDNER as a delivery boy for about six to seven weeks during February and March of 1968. SIRHAN came to Nutri-Ville about four times each week remaining no more than ten minutes on each occasion. He delivered stock to the store, picked up stock from the store and picked up money from her for delivery to Mr. WEIDNER.

According to Mrs. PALMER, SIRHAN was always very respectful. He appeared to be very intelligent and once, when she asked him if he went to college, he replied, "No, but I read a hell of a lot". However, he did not explain precisely what he read.

She also learned from him that he rode horses. Moreover, he told her that he and his brothers went to Santa Anita Race Track on week ends.

Mrs. PALMER stated she knows nothing of SIRHAN's background or his associates.

Miss CAROLINE MARY PETTINATO, Room 208, Hope Hotel, 700 Hope Street, Los Angeles, furnished the following information:

She was a volunteer campaign worker for Senator ROBERT KENNEDY; and, to help publicize his campaign, she rode a bicycle from San Antonio, Texas, to Los Angeles, arriving in Los Angeles on May 26, 1968. She was present at Senator KENNEDY's victory celebration on the night of June 4, 1968, at the Ambassador Hotel. She heard about four pops in quick succession shortly after Senator KENNEDY left the Embassy Room; but she did not realize at the time that they were shots. She was at the Ambassador Hotel from around 8:00 PM on June 4, 1968, until the time of the shooting, but at no time did she see the man who has been identified as SIRHAN SIRHAN.

On June 9, 1968, Mr. HOLDER, the Desk Clerk at the Hope Hotel, told her that a man by the name of JOHN WRIGHT had said that he was a witness to the shooting and that he knew something about it. She told HOLDER that she would like to talk to WRIGHT; and HOLDER called WRIGHT at the Milner Hotel and had him come to the Hope Hotel. Throughout the course of the afternoon and evening, WRIGHT told PETTINATO the following story:

He was employed as a "kitchen reporter" at the Ambassador Hotel; and he was on duty from 10:00 PM on June 4, 1968, to 8:00 AM on June 5, 1968. He first noticed the man identified in the newspaper as SIRHAN SIRHAN at about 11:00 PM on June 4, 1968. SIRHAN came into the kitchen at that time, and he hung around in there drinking coffee. He noticed SIRHAN because he was dressed differently from the kitchen employees. He saw somebody shake KENNEDY's hand in the kitchen. He saw SIRHAN facing KENNEDY and pointing the gun at him; and he saw KENNEDY fall, but he was watching SIRHAN and he never saw SIRHAN pull the trigger of the gun. WRIGHT observed this from the main kitchen by the refrigerator, and he saw SIRHAN standing directly behind the steam table.

Seven men were involved.

PETTINATO advised that WRIGHT seemed to know the cashier at Jerry's Restaurant, Seventh and Hope, who was on duty at 5:30 PM on June 9, 1968.
