

Mrs+MARGUETITE SWEENEY, Volunteer Coordinator of the KENNEDY for President Committee of Southern California, 20055 Wells Drive, Woodland Hills, California, telephone 347-9910, advised as follows by telephone.

Mrs. SWEENEY, who had been previously interviewed by SA LESLIE F. WARREN on June 7, 1968, and by SA RICHARD P. DOUCETTE on June 8, 1968, was questioned whether she had any knowledge of any photographers who reportedly were shooting a movie film at the KENNEDY Campaign Headquarters 5615 Wilshire Bouleward, Los Angeles, California on the late afternoon of June 4, 1968. She said that there were a number of people taking shots of the interior of the headquarters on this and other dates, and that she had heard reference made to some Swiss group, but had not made any arrangements for them to shoot. She had also heard some reference made to a group known as Educational Films and knew nothing about such a firm or who may have authorized them to film in the headquarters She did recall there was a crew of four or five people shooting a film in the headquarters and she recalled that it was on June 4, 1968 in the mid-afternoon.

The news department at the KENNEDY headquarters headed by DICK KLEIN would in all probability know whether a specific arrangement had been made for anyone to bring a crew of photographers on that or other dates. She did not have the address or telephone number for DICK KLEIN, but was of the opinion that this information would be available at the KENNEDY Headquarters, which she felt was currently open on an intermittent basis. Mr. ART SELTZER, who had been in charge of the overall campaign in Los Angeles, may have some knowledge of any photographic groups at the headquarters.



Mr. CHARACH said that he was a freelance communications (voice man) who worked with some of the freelance recorders and photographers including JEFF BRENT of Continental Recordings. Concerning himself as a potential witness, Mr. CHARACH said that during the actual shooting he was in the Embassy Room and did not see the shooting nor did he see SIRHAN BISHARA SIRHAN.

Immediately after the shooting, Mr. CHARACH secured several names of persons in the crowd who claimed to have seen the shooting. They are as follows:

JIM LOWE, phone number 296-3506

KADAR was a witness to the KENNEDY shooting according to the statements he made at the scene when being interviewed rather extensively by TV newsmen.

Mr. CHARACH said that automobile bumper stickers pertaining to a conspiracy to kill JOHN F. KENNEDY were being distributed in the parking lot and around the Ambassador Hotel during the Senator ROBERT F. KENNEDY's campaign party by persons not known to CHARACH. The latter obtained one of these bumper stickers which was taken away from him by MORT GOODMAN of the Mort Goodman Company, a public relations firm which handled the Ambassador Hotel account. GOODMAN was in the press room at the KENNEDY party at the time and was protesting against the circulization of the bumper stickers.

There has been some hearsay statements around town according to Mr. CHARACH that SIRHAN BISHARA SIRHAN and some of his associates had about a year ago appeared on a Joe Pyne TV Show on Channel 11, Los Angeles, this show at the time being produced by MARVE GRAY. This was about the time of the outbreak of war in the Middle East.

Mr. JACK HEEGER, formerly of the United Press International and now associated with CARL BYOIR and associates, 900 Wilshire Boulevard, telephone MA7-6421, phoned on July 9, 1968, following attempts to contact him, and advised the following:

Mr. HEEGER stated that he had arrived at the Embassy Room of the Ambassador Hotel on the early morning or June 5, 1963, about twenty minutes after Senator ROBERT F. KENNEDY had been shot. Consequently he was not a witness to the shooting. He made certain notes of potential witnesses among persons he encountered during the immediate aftermath of the shooting.

Among the names of potential witnesses HEEGER had gathered the following included:



On the morning of June 5, 1968, at the time Senator ROBERT F. KENNEDY was assassinated, Mr. KEVIN was on duty for his company in the press section in the Embassy Room of the Ambassador Hotel in Los Angeles. He was not in a position to see the shooting or any immediate aftermath.

Photographs of SIRHAN SIRHAN and his brothers were exhibited to Mr. KEVIN. He said he had no recollection of seeing any of these persons and had never heard of them prior to the assassination.

He had no other information which, in his opinion, would have a bearing on the matter at this time. He said he would remain alert in the future and advise the FBI should anything come to his attention.



Concerning the identity of a group of singers consisting of one female and two male Caucasians and a male Negro, each in their late teens or early 20's, who had approached KLINE on the podium in the Embassy Room at the Ambassador Hotel, Los Angeles, during the KENNEDY campaign party on June 4, 1968, she stated the following:

KLINE recalled the group of singers, who had asked her if it was alright to sing from the podium. She did not know who they were and it appeared to be a bunch of kids, a pick-up group from the kids who hang around rallies seeking to capitalize on them by singing.

She had informed the group that they would not be allowed to sing from the podium but there was no objection to the group standing on the floor in front of the podium and singing. No name or names were used in connection with the group during their request of KLINE. The latter had no knowledge of who they were or where they could be contacted. She had not seen them before and did not know if they were, in fact, an organized group.



SANDRA METTETAL, Reporter, City Newspaper Service, 417 South Hill Street, Los Angeles, advised the following by phone on July 3, 1968:

With respect to details on a group of singers, who SANDRA had observed in the Embassy Room during the Senator ROBERT F. KENNEDY campaign party, SANDRA described them as being in their late teens or early 20's. The group, consisting of one female and two white male Caucasians and one male Negro, had approached SANDRA, who was standing on the podium in the Embassy Room where Senator KENNEDY was to speak. The group did not appear to have a name but asked SANDRA if it would be okay to get upon the podium and sing. SANDRA said she would not have the authority to authorize the request and referred them to someone on the KENNEDY staff nearby. These singers were dressed in white sweaters and orange trousers. When last observed the group was talking to KAREN KLINE of the KENNEDY campaign staff. KLINE is currently working at the former Senator KENNEDY Campaign Headquarters at 5616 Wilshire Boulevard, Los Angeles. The work is presently devoted to gun control.

SANDRA continued that she had no information as to the identity to the group of singers or where they may be located. Further, she did not know whether they would be potential witnesses or not.

A person observed on the podium during the KENNEDY campaign party in the Embassy Room was a male Caucasian in his early 20's, who was employed by Continental Recordings. He had recording equipment and was believed to have a press pass. His name is not known to SANDRA but he had been observed driving a large white automobile with large blue lettering "Continental Recordings."

Mr. SIMS said that he was in the Embassy Room of the Ambassador Hotel, Los Angeles, at the time that Senator KENNEDY was shot and that he did not see the shooting nor did he see SIRHAN SIRHAN at any time.

Mr. SIMS had traveled with the Senator ROBERT KENNEDY Campaign Party in Indiana, Oregon, Northern California and the Los Angeles area and he had no recollection of having ever seen any person who he thought might be SIRHAN SIRHAN.

Mr. SIMS said that he was a co-operator of two corporations in New York City, "Simthing" Company and Fortune Cookie Films, 630 9th Avenue, Suite 411, New York City, New York. If it was ever desired to contact him, he could be reached either at a call service telephone No. in New York City, JU 6-6490 who would know his whereabouts at all times, or at his above residence phone. SIMS claimed to do contract work for the Columbia Broadcasting System.

Mr. CLETE ROBERTS, Newscaster and co-owner of USTV News, Suite 217, 6922 Hollywood Boulevard, Los Angeles, California, telephone number 469-7789, advised the following:

With respect to the matter of the name CLETE ROBERTS appearing in a notebook found among the possessions of SIRHAN SIRHAN by the Los Angeles Police Department (LAPD), Mr. ROBERTS said that he was aware of this fact.

Mayor SAMUEL YORTY had, in a telecast, mentioned that CLETE ROBERTS' name had been in a notebook which resulted in YORTY being further interviewed at Sacramento, California, by newsman ROBERT SIMMONS; YORTY being asked to further comment on exactly what had appeared in the notebook with respect to the name CLETE ROBERTS.

All that Mr. ROBERTS had been able to ascertain was that his name and some mention of the City of Eilot had appeared in the book. He mentioned that Eilot, in Israel, was the sister city of Los Angeles, California.

Mr. ROBERTS said that he had visited the Middle East on several occasions. In 1951 and 1956, he had done television and radio shows in Israel. Previously as a war correspondent for the American Broadcasting Company in 1945 he had been in this area.

Mr. ROBERTS was of the opinion that the basis for his name appearing in the notebook in question was a television special aired over Columbia Broadcasing System in this country, which he did on the Middle East war in June, 1967, from Israel. This broadcast had portrayed the position of Israel in the war with the Arab nations. Mr. ROBERTS said that he had not been able to get any information from the Arabian countries which would have stated their position in the war. This was in spite of his attempts to interview certain officials of the Arabian countries involved in the war at that time.

Mr. ROBERTS said that he had not received any threats as a result of his broadcasts on the Middle East war in June, 1967. He said on two occasions he had been approached while eating in restaurants by persons believed to be of Arabian descent who had remarked to him that they did not like the broadcasts he made in June, 1967, as it was one-sided in favor of Israel.

Upon examination of photographs of SIRHAN SIRHAN and his brothers, Mr. ROBERTS said that he had no recollection of ever seeing any of these individuals at any time and had not heard of them until the shooting of Senator ROBERT F. KENNEDY.

Mrs. SWEENEY said that she had been in charge of the office work at the Campaign Headquarters of Senator ROBERT F. KENNEDY, 5615 Wilshire Boulevard, Los Angeles, from the time it opened in March 1968, until the evening of June 4, 1968. She said that during this period she had no recollection of observing any volunteer worker or any person at all who, in her opinion, resembled the photographs of SIRHAN SIRHAN that had been published and who had been arrested in connection with the shooting of Senator KENNEDY.

Photographs of SIRHAN SIRHAN taken by the Los Angeles Police Department on June 5, 1968, were exhibited to Mrs. SWEENEY, who further confirmed her opinion that she had no recollection of seeing SIRHAN SIRHAN at any time other than pictured on television and in the newspapers.

Mrs. SWEENEY related that three volunteer workers at the Headquarters had reported that they had thought that they had seen a person closely resembling SIRHAN SIRHAN at the Headquarters within the past few days. They were ELLENORE SEVERSON, who worked on the information desk; who was an office assistant, and WILLIAM HENEBRY, who had worked in the department correlating telephone calls and transportation.

Following the announcement that SIRHAN was of Jordanian descent, there was speculation among some of the volunteer workers that a Mr. KHAIBER KHAN may have known SIRHAN. Mr. KAHN, as well as a number of young persons of student age, whom he brought in for volunteer work, appeared to be of Middle East extraction. They were dark and had features common to the Arabian and adjoining countries.

Mr. KHAN, age 50 to 55 years, claimed birth in Persia. He had a dark complexion, a large head, strong facial features dark graying hair, heavy shoulders, and a stocky build. He is about 518" in height.


She said Mr. KHAN broutht in a number of persons who reportedly were students who worked as volunteer workers in the campaign. There were usually six or seven at a time and they had been given telephoning assignments. Mr. KHAN did not handle any specific assignment but more or less correlated the activities of the persons that he brought in.

Mrs. SWEENEY recalled that Mr. KHAN had brought in one girl he claimed to be a relative. She was on crutches, and Mr. KHAN had a splint or cast on his arm. All volunteer workers were registered and in all probability a record of the workers brought in by Mr. KHAN would be among those retained by the KENNEDY Headquarters. Sone of the registrations for volunteer workers had been placed on cards; others had registered on long sheets of paper. JUNE ISACKSON, who lives on Malcom Street in West Los Angeles and has telephone Number 474-5239, had access to the records at the KENNEDY Headquarters, now closed, and should be contacted if it is desired that these records be examined.

Mrs. SWEENEY continued that Mr. KHAN had related during some of their limited conversations with her that he was acquainted with Senator KENNEDY and that he was known for his support of Senator KENNEDY's policies. This resulted in some objection to his support of Senator KENNEDY by the Shah of Iran but no elaboration was made on this statement.

The only address that Mrs. SWEENEY ever had on Mr. KHAN was $10554\frac{1}{h}$ Wilshire Boulevard. He furnished a telephone Number of 475-1849. He also mentioned that he was known as "GOODEY" and his friends called him "GOODEY". She said that she understood that the volunteer workers brought in by Mr. KHAN had also used this Wilshire Boulevard address on the records.

Mrs. SWEENEY commented, after examining a photograph of SHARIF BISHARA SIRHAN, taken December 18, 1963, and of ADEL SIRHAN, taken June 5, 1968, both brothers of SIRHAN SIRHAN, that she had no recollection of seeing at any time the individuals in these photographs.

Mrs. ELLENORE SEVERSON, also known as Mrs. Bertol Charles Severson, housewife, 12409 Helena Street, Los Angeles, telephone number GR 6-2909, related the following:

Mrs. SEVERSON said that she, a member of the California State Central Committee of the Democratic Party, had been active in the Senator ROBERT F. KENNEDY Campaign Headquarters at 5615 Wilshire Boulevard, Los Angeles, during the past two weeks. She served on the information desk at the headquarters which was located opposite the front entrance.

On June 2, 1968, she noticed one of the volunteer workers who showed up at the headquarters and who furnished the name of KHAIBAR KHAN, 10554½ Wilshire Boulevard, Los Angeles, appeared to be of Middle East descent. KHAN was in and out of the headquarters until closing time on June 4, 1968. It was noted that he, during this period at different intervals, brought in a number of young persons of student or immediately post-student age to do volunteer work at the headquarters. The majority of them worked in the telephone department. All of these persons brought in by Mr. KHAN appeared to be of Middle East descent.

Mr. KHAN, in registering these various individual volunteer workers had them furnish the address of $10554\frac{1}{2}$ Wilshire Boulevard. There must have been approximately 20 of these workers who Mr. KHAN brought in.

On Sunday, June 2, 1968, at about 2:00 p.m., Mrs. SEVERSON noticed a young man standing just inside the entrance to the headquarters and Mr. KHAN was talking to Mrs. SEVERSON at the information desk. One of the volunteer workers, several asked the young man if he could help him, whereupon the young man standing by the door reportedly told that "I'm with him" pointing towards Mr. KHAN.

Mrs. SEVERSON said that she had seen pictures of SIRHAN SIRHAN, who had been arrested for the shooting of Senator KENNEDY, and she was of the opinion that the young man she had seen in the office near the front door on Sunday afternoon, June 2, 1968, was in fact SIRHAN SIRHAN.

Photographs of SIRHAN SIRHAN which were taken by the Los Angeles Police Department on June 5, 1968, were exhibited to Mrs. SEVERSON who stated in her opinion that the photographs exhibited to her very closely resembled the young man mentioned above and in her opinion, "It was him". She did not recall seeing this young man in question at any other time during her work at the headquarters.

Mrs. SEVERSON suggested that BILL HENEBRY, a volunteer worker who spoke Arabic and appeared to converse with Mr. KHAN at the headquarters, and Mrs. MARGUERITE SWEENEY who was in charge of the headquarters, be interviewed.

Mrs. SEVERSON said that the only other thing that she could recall which might have a bearing on the matter was that on June 2, 1968, she had an itinerary for Senator KENNEDY for that date lying on her desk. Shortly after the young man and Mr. KHAN were in her area, this itinerary was missing and she never did recover it after making considerable inquiry among other volunteer workers. This itinerary sheet was a mimeograph form, was not issued to the public, there were very few copies, and it was restricted to field personnel at the headquarters. A new itinerary for Senator KENNEDY was issued each day.

Mrs. SEVERSON described Mr. KHAN as being a male Caucasian of Middle East descent, dark complexion, about five feet eight inches to five feet nine inches, stocky build, age in 40s or early 50s. He had dark hair, slightly graying, which he combed straight back. His nose was slightly semitic and of medium size, slightly aquiline. He was muscular, had an athletic build, and claimed to have had a large group of sport supply stores and specialized in golfing. He had a splint on one arm which he claimed to have broken during a fall playing

tennis. He spoke with a heavy accent although claimed to have studied English in England. He reportedly had been born in Istanbul and was an Iranian by birth. He claimed to have a daughter going to high school in the United States and to have come out from New York City to aid Senator KENNEDY's campaign in the Los Angeles area.

Mrs. SEVERSON recalled that in one instance, a young girl approximately 23 years of age, dark hair, fair complexion, attractive, well built, of apparent Middle East extraction, appeared with Mr. KHAN at the headquarters. She was dressed in a stylish manner and was on crutches. One leg was held up although not in a cast or splint. When this young girl and Mr. KHAN appeared, on exact date not recalled, the young girl signed a name and address at which point Mr. KHAN stated, "Don't use that address. Use the 10554 Wilshire Boulevard address". The original address was crossed out and the latter Mrs. SEVERSON said that Mr. KHAN had on address submitted. occasion been bringing the young volunteer workers to the information desk to register and had asked Mrs. SEVERSON to print the names for him as he was unable to write. She recalled that all of the names were of names usually associated with people who live in the Middle East section of the world.

Later Mrs. SEVERSON telephoned the Los Angeles Office of the FBI and stated that she had, on this date at 12:27 p.m., been watching CBS news over KNXT, Channel 2, Los Angeles, on television and during a pan shot of the crowd at the Los Angeles International Airport at the time Senator KENNEDY's body was being taken to New York, she observed in this television shot a man wearing a white shirt she believed to have been one of the persons who Mr. KHAN had brought into the Senator KENNEDY headquarters.

Mr. KHAIBAR KHAN, who was previously interviewed in this matter, phoned the Los Angeles Office of the FBI July 5, 1968, and asked he be contacted by SA LESLIE F. WARREN at telephone number 474-4561 extension 242.

Upon returning Mr. KHAN's call, he advised the following:

Mr. KHAN said he wanted to report that he had been arrested by the Immigration and Naturalization Service (INS) Los Angeles, on June 27, 1968, and was being held for a deportation proceedings. He was in jail several days and is currently out on \$4,000 bail. A deportation hearing is scheduled at INS, Los Angeles, July 19, 1968. DAVID CARLINER, 901 Warner Building, Washington D.C., was the attorney representing Mr. KHAN in the proceedings.

Mr. KHAN said he had also been interviewed by two detectives from the Los Angeles Police Department (LAPD) on June 27, 1968, as a potential witness in the shooting of Senator KENNEDY. Mr. KHAN stated he furnished the information to the police detectives about his working as a volunteer worker in the Senator KENNEDY campaign headquarters of Los Angeles, June 1 through June 4, 1968, and had thought he had seen SIRHAN SIRHAN.at these headquarters on June 4, 1968, his opinion being based on a photographic identification.

The LAPD, according to KHAN, wanted him to take a lie detector test and also wanted to arrange for Mr. KHAN to personally observe SIRHAN SIRHAN at the Los Angeles County Jail in an attempt to confirm that he had seen SIRHAN SIRHAN at the KENNEDY headquarters. Mr. KHAN declined to take the test or go to the jail advising the police that he wished to consult with his attorney before taking such action.


PHILLIPE KHAN, Assistant to the manager, Culver Theatre, 9820 West Washington Boulevard, Los Angeles, phone 838-3124, was contacted by phone when agent was at the apartment of his mother, Mrs. TALAT KHAN, 10554½ Wilshire Boulevard, Los Angeles, California, in an attempt to locate his father, KHAIBAR KHAN.

PHILLIPE was advised his father was reportedly working in the Los Angeles headquarters of Senator ROBERT F. KENNEDY during the period SIRHAN SIRHAN, charged with shooting Senator KENNEDY, reportedly had been seen in the headquarters. It was desired to show photographs of SIRHAN to KHAIBAR KHAN. Further, Mrs. KHAN had said PHILLIPE had been in the campaign headquarters within the past few days as a volunteer worker.

PHILLIPE was asked if he knew where his father could be reached as it had been ascertained from his mother that his parents were divorced and Mr. KHAN did not live with PHILLIPE's mother. He claimed his father did not disclose his address but called his mother at number 475-1849 frequently and a message could be left for the father at her place.

PHILLIPE said he had been in the KENNEDY campaign headquarters as a volunteer worker in Los Angeles, June 4, 1968, and he had seen photographs of SIRHAN on television and in the press. He had no recollection of ever seeing SIRHAN in the headquarters or elsewhere and had never heard of SIRHAN before he was charged with shooting Senator KENNEDY.

said that for several days before the Mr. California Primary Elections on June 4, 1968, he had been a volunteer worker at Senator KENNEDY's Campaign Headquarters at 5615 Wilshire Boulevard, Los Angeles. He said that he had seen a young man at the KENNEDY Headquarters who he possibly believed to be SIRHAN SIRHAN who had been arrested for shooting Senator KENNEDY. He claimed that he had seen this young man on June 2, 1968, at about 2:00 p.m. and that this person had come into the headquarters and was standing by the front door at the same time a Mr. KHAIBAR KHAN, who had been doing some voluntary work at the KENNEDY Headquarters, was standing at the information desk which is located near the front door at the headquarters. Mr. KHAN had been bringing in a number of young people as volunteer workers, all of whom appeared to be descendants of people who resided in the Arabian countries of the Middle East. Mr. KHAN, himself, appeared that he may have been from the Middle East and reportedly was from Iran.

Mr. continued that he had asked the young man in question who was standing by the door on June 2, 1968 if he, could help him, whereupon the young man replied, "No thank you. I'm with him" and pointed towards Mr. KHAN.

Mr. Mr. said that this young man was possibly around headquarters that afternoon but that this was the only time that he could recall seeing him.

Mr. Methods said that he had, since the shooting of Senator KENNEDY, discussed the possibility of SIRHAN SIRHAN having been in the KENNEDY Headquarters, with Mrs. ELLENORE SEVERSON who had been on the information desk at the headquarters at the time and they both had been of the opinion that there was a strong possibility that SIRHAN SIRHAN had been in the headquarters and that he might possibly be known to Mr. KHAN.

Mr. Mreason related that he had learned from Mrs. SEVERSON that an itinerary sheet for Senator KENNEDY for June 2, 1968 had turned up missing. There was suspicion that maybe Mr. KHAN had taken it as he was known to have been standing near her desk just before it had been missed.

Mr. Mr. KHAN said that all of the voluntary workers brought in by Mr. KHAN reportedly furnished the same address as Mr. KHAN but he could not identify them. He was of the opinion that their names would be on the registrations of volunteer workers in the KENNEDY Headquarters.

Mr. Merce examined a photograph of SHARIF BISHARA SIRHAN, taken December 18, 1963, and of ADEL SIRHAN, taken June 5, 1968, both brothers of SIRHAN SIRHAN. Mr. Merce said he had no knowledge of seeing anyone resembling either of these brothers around the Senator KENNEDY Campaign Headquarters or elsewhere.


Mr. FLOOD said he was calling in response to SA LESLIE F. WARREN's attempt to contact JERRY LEWIS, actor and head of Jerry Lewis Films, who was currently out of the country and was expected back sometime the coming week. FLOOD said he was present when JERRY LEWIS had, on June 5, 1968, telephoned the Los Angeles FBI Office concerning a call which LEWIS had received from one FRANK CULLEN. The latter, who claimed to be a security guard at the Sportsman's Lodge, had called LEWIS and requested that LEWIS pass information, furnished by him, to PETER LAWFORD, actor, who is currently associated with JERRY LEWIS in a film. In substance, FRANK CULLEN had claimed that he had seen the suspect, identified in the papers and on television as SIRHAN SIRHAN, on an elevator with Senator KENNEDY sometime during the latter's campaign in California. No further details were given by CULLEN to LEWIS, further that LEWIS had remarked he did not know FRANK CULLEN or vouch for the veracity of CULLEN's story.

FLOOD said that it was hisopinion that CULLEN was probably referring to a fund raising dinner and cocktail party at \$250 per plate, which was held at the Sportsman's Lodge, during the latter part of March 1968, attended by Senator ROBERT F. KENNEDY. FLOOD said he was not acquainted with anyone by the name of FRANK CULLEN, but the latter may have been a security guard with the KENNEDY party or known to them, if not known at the Sportsman's Lodge.

Mr. JOSEPH GARSON, Night Auditor, Sportsmen's Lodge Hotel, 12825 Ventura Boulevard, North Hollywood, California, telephone number 769-4700, residence 203 South Bushnell Street, Alhambra, California, telephone number 576-1976, advised the following:

Mr. GARSON said he recalled the evening of March 24, 1968, during an appearance of Senator ROBERT F. KENNEDY at the Sportsmen's Lodge Hotel to give a campaign speech. Mr. KENNEDY had arrived at the hotel around 7:00 P.M. on March 24, 1968, and had been assigned Room 508. Mr. GARSON, at the time, was working on the front desk in the hotel lobby.

Mr. GARSON had, shortly after Mr. KENNEDY's arrival, been asked to aid a Mr. FRANK CULLEN to act as a security guard outside the room of Senator KENNEDY on the fifth floor. Mr. GARSON's attention was called to a young man who appeared on the fifth floor and wanted to take a photograph of Senator KENNEDY, and when advised that he would be unable to, he became very persistent.

Following attempts by Mr. CULLEN and Mr. GARSON to get the young man to leave the fifth floor, Mr. GARSON asked the young man if he were a guest at the hotel. When the young man said no, Mr. GARSON advised him that if he did not leave, the police would be called. The young man then left the corridor, but was observed riding up and down the elevator periodically, apparently checking to see if Mr. KENNEDY was available for photographing. The last time Mr. GARSON saw the young man in question was approximately one half hour later after first seeing him. The young man at this time was standing in the lobby of the hotel near the elevator and appeared to be with a young girl. They were standing together and away from a crowd of people who had gathered in the lobby waiting for Mr. KENNEDY to appear.

Mr. MARK HARLIG, Manager of Sportman's Lodge Hotel, 12833 Ventura Boulevard, North Hollywood, California, telephone 769-4700, advised as follows:

Mr. HARLIG said that during a fund raising dinner and cocktail party on March 24, 1968, held at the Sportman's Lodge, which featured an appearance by Senator ROBERT F. KENNEDY, no security guards had been hired by the hotel or the lodge. He had no knowledge of a security guard being hired by the KENNEDY party. He also had no knowledge of any individual by the name of FRANK CULLEN, reportedly a security guard at the Sportsman's Lodge. He mentioned that the lodge and hotel did not have a security squad staff and rarely did they hire one. Frequently organizations who have conventions or affairs at the hotel and lodge hire their own security guards.

During the aforementioned KENNEDY party, a large number of people apparently got word of it and showed up at the hotel and lodge in an apparent attempt to observe Senator KENNEDY. They were all over the hotel and grounds.

Photographs of SIRHAN BISHARA SIRHAN and his brothers, ADEL, SHARIF and MUNIR were shown to HARLIG, who commented he had no recollection of seeing these individuals around the hotel or lodge during the KENNEDY party on March 24, 1968 or any other time. The other logical employee to whom the photographs should be shown is Bellman BOB LOCHRIE, who was on duty and was in a position to see anyone hanging around the hotel when Senator KENNEDY was there on March 24, 1968.

Concerning persons in the KENNEDY party, who may have hired a security officer or otherwise, know who may have observed persons around the hotel at the time, they could probably be identified through JERRY BRUNO, who was an advanceman for the KENNEDY party about a year ago and may still be connected with them. No specific address was available for JERRY BRUNO according to Mr. HARLIG.

Mrs. JACKIE LAWRENCE, Manager of Banquet Department, Sportman's Lodge, 12833 Venture Boulevard, North Hollywood, California, Telephone TR 7-9846, advised as follows:

She was unable to identify anyone by the name of FRANK CULLEN, reportedly a Security Guard at the Sportman's Lodge She mentioned that this lodge did not employ a security guard as such There were numerous security guards employed at the lodge from time to time by organizations who utilize the facilities of the Sportman's Lodge Hotel and Restaurant. The specific organization would have to be identified, together with the date, to establish who may have been hired.

With respect to the fund raising dinner and cocktail party, at \$250 a plate, attended by Senator ROBERT F. KENNEDY, it was held on the evening of March 24, 1968 at the lodge, from approximately 8:00 p.m until 11:30 p.m. Mr. PIERRE SALINGER had made the original contact and reservations for the lodge for this affair. Senator KENNEDY had stayed in the adjoining hotel and had arrived at the party at approximately 9:30 p.m or 10:00 p.m. He came in through the kitchen to the dining area where he ate dinner and subsequently went into the cocktail party area, which was behind a glass partition. Approximately 300 people, who were not invited to this affiar, which was rather confidential and attended by a group of prominent supporters of Senator KENNEDY, had gathered around the hotel and, in the lodge for the purpose of observing Senator KENNEDY. ' When Senator KENNEDY observed this crowd of people standing outside the glass partition, he ordered the partition be opened and invited all the people into the party, much to the surprise of those present.

As far as the Sportsman's Lodge and Hotel were concerned, they did not hire any security guards for this occasion and as far as she knew the KENNEDY party had not hired any outside guards, at least she had not been so advised.

They found that by going through a kitchen area, off this room, they could enter the Embassy Room without being challenged. There were only three people in the kitchen when she and her husband entered. They were all dark complected men, two of whom appeared to be kitchen workers as they were moving about. One was tall and the other short. The third man, slight of build, was just standing against the wall in about the middle of the kitchen. She did not note details of his dress but did note this third man did not appear to be a kitchen worker.

Mrs. RUBIN and her husband went on into the Embassy Room just as Senator ROBERT KENNEDY was finishing his speech. They had arrived at a point a few feet from the podium where Senator KENNEDY was standing when he made some remark about Mayor SAM YORTY of Los Angeles, which ended his speech. Senator KENNEDY then started for the kitchen. Mr. and Mrs. RUBIN followed him. They were separated by the pressure of the crowd near the kitchen door and Mrs. RUBIN followed the KENNEDY party into the kitchen. Mr. RUBIN got trapped and did not get into the kitchen.

Mr. PAUL SCHRADE was right behind Senator KENNEDY and Mrs. RUBIN was behind Mr. SCHRADE when she suddenly heard three shots followed by five quick shots. She realized someone was shooting in her direction but she could not see who it was, as Mr. SCHRADE was taller than she. She, at this point, "hit the floor" along with a young blonde woman, and kept her head down until she felt the shooting had stopped. She saw people go down on the floor and briefly saw Mr. KENNEDY on the floor. When she

got up she ran out of the kitchen to join her husband. She hid behind things until she found her way out as she did not know whether or not there might be more shooting.

The Los Angeles Police Department had questioned Mrs. RUBIN briefly after the shooting, asking her if she had seen the shooting. She replied "no" and was not questioned further.

Mrs. RUBIN had appeared on television but was not interviewed. She was standing near the door of the Embassy Room when the television news cameras picked up an interview being conducted of a Negro doctor who had been at the scene. There had been some comment in news programs and in the press of a couple being sought for interview, exact source not recalled. She was of the opinion the descriptions furnished of the couple being sought and apparently seen in the kitchen area before the shooting generally fit that of her and her husband.

Mrs. RUBIN described herself as a white female, 33 years of age, 5' 5", wearing two-inch heels, olive complexion, 135 - 140 pounds, dark shoulder length hair worn bouffant style, dark eyes. She was wearing a white dress with red belt sash and a bright red and white checkered jacket. She, at times, carried the jacket.

She described Mr. RUBIN as a white male, 6', 185 pounds, 35 years of age, broad shoulders. He was wearing a navy blue blazer and gray slacks.

Mrs. RUBIN furnished a photograph of herself taken in March 1968, which she said could be used for further identificatio. if desired. The photograph need not be returned.

Following examination of photographs of SIRHAN SIRHAN and his brothers, Mrs. RUBIN was of the opinion that the photograp of SIRHAN SIRHAN resembled the person she had seen in the kitchen

standing against the wall about five to seven minutes before Senator KENNEDY finished his speech. She had not noted the man in question in the kitchen closely enough to make a positive identification. She had no recollection of seeing any of the brothers of SIRHAN SIRHAN at any time.

Mr. DALE ROBERTSON, television and film actor, 10801 Winnetka Avenue, Chatsworth, California, furnished the following information:


In connection with his breeding of horses, Mr. ROBERTSON said that he had, in the past, stabled some of his horses at the Corona Breeding Farm at Corona, California, owned by actor DESI ARNAZ. ROBERTSON has also stabled horses at the Futura Farms, which is located near Lake View, California, which is between Riverside and Hemet.

Mr. ROBERTSON had not employed any exercise boy and had no recollection of ever seeing SIRHAN SIRHAN, who had been charged with shooting Senator ROBERT F. KENNEDY. He mentioned he had been contacted by a representative of "Life" magazine on June 10, 1968, who claimed to be doing a story on SIRHAN SIRHAN. Further, the latter alleged that SIRHAN SIRHAN had approached DALE ROBERTSON one time during a public horse sale and had asked ROBERTSON for a job.

Mr. ROBERTSON claimed that he had no recollection whatspever of SIRHAN SIRHAN asking him for a job; in fact, only one young man, SHAWN CORBETT, had asked him for a job under similar circumstances and he had hired this young man who was still in his employ. He mentioned that in stabling his horses at the aforementioned farm he paid a flat fee and did not have anything to do with the hiring of any personnel who may have been employed at those farms.

Mr. FRANCIS D. CULLEN, also known as Frank Cullen, 4558 Laurel Canyon Drive, North Hollywood, California, telephone 761-2637, furnished the following information:

Mr. CULLEN said that he was 62 years of age and a motion picture grip by occupation, having worked at various motion picture studios in the past, and was currently unemployed due to health.

During the 1954 presidential campaign of JOHN F. KENNEDY, CULLEN worked on behalf of KENNEDY in the Los Angeles area.

On or about March 22 or March 23, 1968, CULLEN read an article in the "Herald Examiner" that Senator ROBERT F. KENNEDY was to make a campaign appearance at the Sportsmen's Lodge Hotel, 12825 Ventura Boulevard, North Hollywood, California. This being close to CULLEN's home, the latter went to the Sportsmen's Lodge on March 24, 1968, at approximately 7:00 p.m., to greet Senator ROBERT F. KENNEDY, who CULLEN had met during the 1964 KENNEDY presidential campaign.

Upon arrival of the Senator KENNEDY party at the Sportsmen's Lodge Hotel, Senator KENNEDY recognized FRANK CULLEN asking the latter to direct him to the hotel room where KENNEDY was to stay. CULLEN accompanied Senator KENNEDY to the room assigned him on the fifth floor, possibly room 508. When Senator KENNEDY got to his room the question of a security guard came up and PIERRE SALINGER and a man named BRUNO with the KENNEDY party, asked CULLEN to stand by outside of the KENNEDY room on the fifth floor and act as a security guard. CULLEN agreed and one of the secretaries of Senator KENNEDY took CULLEN's name and address.

Approximately 15 to 20 minutes after CULLEN became an active security guard, which would have been between 7:00 and 8:00 p.m., a young man came up to the fifth floor on the elevator carrying what appeared to be a camera on a strap over his shoulder. He said to CULLEN that he wanted to take a picture of Senator KENNEDY. The object, thought to be a camera, was about five inches by eight inches wide and three to four inches high. It was encased in a dark brown leather-type case. When advised that Mr. KENNEDY was not available and that the fifth floor had been restricted, the young man was instructed to leave whereupon he declined and sat down on a chest in the hallway The Senator stepped out of his room to make an inquiry about the whereabouts of a certain pair of cufflinks. The young man was still in the hallway at this time.

Mr. JOSEPH GARSON, who was one of the managers of the Sportsmen's Lodge Hotel, was present and asked CULLEN if he did not think that the young man wanted more than a picture of KENNEDY. Consequently, CULLEN asked the young man to get up from the chest and get on the elevator which he reluctantly did. CULLEN noted that this young man stayed in the elevator approximately 15 minutes going up and down and controlling the elevator.

CULLEN finally, after certain protests from the young man who claimed that CULLEN had no right to remove him from the hotel hallway, got the young man out of the elevator and completely out of the hotel and into the parking lot. This was the last time CULLEN observed the young man and did not observe anyone else with the young man, nor did CULLEN ascertain the name of the young man or whether or not he had an automobile.

The young man was described by CULLEN as being a male white, 5'8", 20 to 24 years of age, dark complexion, dark eyes, clean shaven, dark kinky curly hair, and not well groomed.

Following the assassination of Senator ROBERT F. KENNEDY, Mr. CULLEN observed a picture of SIRHAN SIRHAN in the newspaper and noted a resemblance between the photograph and the young man who attempted to take a photograph of Senator KENNEDY at the Sportsmen's Lodge Hotel on the evening of March 24, 1968.

Mr. CULLEN said that he attempted to relay the information regarding the young man observed on March 24, 1963, to PETER LAWFORD, actor and former brother-in-law of Senator KENNEDY. LAWFORD, at the time, was associated with actor - producer JERRY LEWIS making a film at Columbia Pictures Studio in Hollywood. The call to this studio disclosed that PETER LAWFORD was not available and the information was given by telephone to JERRY LEWIS by Mr. CULLEN to be passed on to PETER LAWFORD .

A group of photographs containing photographs of SIRHAN SIRHAN, his brothers, ADEL, SHARIF, MUNIR, and SAIDALLAH, were exhibited to FRANK CULLEN, without identifying the photographs by first or last names. Mr. CULLEN examined the photographs carefully and selected the photograph of SHARIF SIRHAN as very closely resembling the young man who had attempted to photograph Senator ROBERT F. KENNEDY at the Sportsmen's Lodge Hotel on March 24, 1968.

It was noted at the time that CULLEN selected the photograph of SHARIF SIRHAN he was unable to talk, started to perspire and appeared to be visibly shaken. A lapse of approximately one and a half minutes followed before Mr. CULLEN acknowledged that he had become emotionally upset at seeing the photograph of SHARIF and believing that it was a photograph of the young man whom CULLEN had encountered on March 24, 1968. CULLEN noted that the hair on the young man in question at the Sportsmen's Lodge Hotel, as he recalled, looked more like the hair of SIRHAN SIRHAN as depicted in the photograph exhibited to him, which photograph was taken by the Los Angeles Police Department on June 5, 1968. Upon further examination of the photographs, CULLEN said he was still of the opinion that the photograph of SHARIF more closely resembled the man in question at the Sportsmen's Lodge Hotel.

Mr. CULLEN was of the opinion that Mr. JOSEPH GARSON should have some opinion in the matter as he had called GARSON following the assassination of Senator KENNEDY and they both agreed that the young man at the Sportsmen's Lodge Hotel on March 24, 1968, attempting to photograph Senator KENNEDY, closely resembled the photographs of SIRHAN SIRHAN which had appeared in the newspapers on June 5, 1968.

She may remain in the Los Angeles area for a while longer and if so she can be reached at 22548 Pacific Coast Highway, Apartment 111, Malibu, California.

Miss VAUGHN, who had been doing some free lance photography in New York and recently had a contract to do work for the "New Yorker" magazine, had more recently been traveling with the Senator ROBERT F. KENNEDY campaign party. She was present in the Embassy Room at the Ambassador Hotel, Los Angeles, California, on the early morning of June 5, 1968. She did not see the shooting or the immediate aftermath. She, at the time, Was in the press area overlooking the Embassy Room. She collected a number of photographs of the party in the Embassy Room which she sent to STEVE SHAPIRO in New York City, New York. He markets photographs and can be contacted through Black Star, 450 Park Avenue South, New York, New York.

The film still shots are in black and white. She expected to have copies of the film in two or three weeks. She will make the film available to the FBI if it is desired to examine it.

Following examination of photographs of SIRHAN SIRHAN and his brothers, Miss VAUGHN said she had no recollection of having ever seen any of these persons at any time.

BETTY BARRY, wife of GENE BARRY, actor, 809 Whittier Drive, Beverly Hills, California, said she and her husband had attended the Senator ROBERT F. KENNEDY campaign party at the Ambassador Hotel, Los Angeles, California, on the evening of June 4, 1968, and the early morning of June 5, 1968. They had been in the Embassy Room at the hotel at the time of the shooting of Senator KENNEDY and consequently had not observed it or the immediate aftermath.

During a period about half an hour before Senator KENNEDY arrived for his speech in the Embassy Room, she was separated from her husband. She, at that time, observed a young man who resembled the photographs of SIRHAN SIRHAN. He was standing at the foot of some stairs which led from the Embassy Room to an area below where a number of Mexican Americans had assembled to welcome Senator KENNEDY. When standing in front of the podium from which Senator KENNEDY spoke, this stair would be to the left rear of the podium and in the rear corner of the room.

Following examination of photographs of SIRHAN SIRHAN and his brothers, she was of the opinion that the man she saw just standing at the foot of the stairs could have been SIRHAN SIRHAN. She could not say for sure. He had dark curly hair, was of swarthy complexion, and slight of stature.

The only thing she observed of possible note was a young man who had earlier been trying to gain entrance to the Embassy Room at the main entrance. No one else was allowed in as the room was over crowded. He was white, age about 19 years, small, dark, and thin with curly hair. He was carrying what appeared to be campaign posters or literature. His dress was casual, detail not recalled. The Negro uniformed policeman on the door would not let him in. He asked Mrs. BARRY if she would help get him in. When she declined, he said when she went back to the KENNEDY group to tell Mr. KLINE that WAYNE was there and that KLINE would get him in. Mrs. BARRY located a Mr. KLINE, white, age in forties, wearing a white shirt, who had something to do with publicity for Mr. KENNEDY, and told him about WAYNE. Mr. KLINE said he did not know a WAYNE and took no action to aid WAYNE. The latter was not further observed by Mrs. BARRY.

PHILLIPE KHAN, a student and part-time employee of the Culver Theater in Culver City, California, who can be contacted through 10554¹/₂ Wilshire Boulevard, Los Angeles, California, telephone 475-1849, advised the following:

Mr. KHAN had been contacted by telephone on June 7, 1968, from the apartment of his mother, TALAT KHAN, at the above address. He, at the time, advised that he had no knowledge of SIRHAN SIRHAN and had no recollection of ever seeing him around the Los Angeles Campaign Headquarters of Senator ROBERT F. KENNEDY. Mr. KHAN had worked briefly as a volunteer worker at this headquarters at 5615 Wilshire Boulevard, Los Angeles, on June 4, 1968. He had been assigned to the Telephone Room and had worked there from approximately 11:30 AM to 2:30 PM on that date.

Mr. KHAN was shown photographs of SIRHAN SIRHAN and his brothers, MUNIR SIRHAN, ADEL SIRHAN and SHARIF SIRHAN. He said that he had no recollection of ever seeing any of the individuals in these photographs around the Senator KENNEDY Campaign Headquarters in Los Angeles or elsewhere. Futher, he had never heard of any of these individuals prior to their recent publicity.

Mr. KHAN, who is of Iranian descent and who was noted to generally resemble the physical appearance of the current movie star OMAR SHARIF, was asked if anyone had ever told him whether or not he did resemble this actor. He replied yes, that a number of people had remarked to the similarity of their appearance. He said at the time he. was working at the campaign headquarters, he was wearing a black and white stripe sport shirt and a white tennis sweater and tennis shoes.

Mr. KHAN said that he did not attend the Senator KENNEDY Campaign Party at the Ambassador Hotel on the evening of June 4, 1968, and the morning of June 5, 1968.

With respect to the identity of the persons who Mr. KHAN was responsible for their appearance as volunteer workers at the Los Angeles Campaign Headquarters of Senator ROBERT F. KENNEDY on June 1, 1968, and June 4, 1968, he advised as follows:

The persons who actually worked there at his request were his half-sister, MARYAM KOUSHAN, his **a second** a high school student, his **a second** a high school student, and his son, PHILLIPE KHAN, a college student. Another son, J. C. KHAN, did not work at the headquarters but did, on June 3, 1968, drive MARYAM to the headquarters where she was doing volunteer work.

Mr. KHAN explained that he had brought the above individuals with him at the time of interview and would have them available for any questions the Agents desired to ask them in his presence. Consequently, the above individuals were interviewed and shown photographs of SIRHAN SIRHAN and his brothers, ADEL, MUNIR and SHARIF, the results of which were reported separately.

On the late afternoon of June 4, 1968, Mr. KHAN had furnished a list of names of individuals to the KENNEDY Campaign Headquarters in Los Angeles who he said would be available as volunteer workers in the November campaign of Senator KENNEDY. The address of these various individuals had been furnished as care of The Khaibar Khan, telephone telephone This is the address of his divorced wife, TALAT KHAN, and This is the address of his divorced wife, TALAT KHAN, and This is the address are not in the Los Angeles area and some of them are not even in the United States but were expected to be here to do volunteer work for Senator ROBERT F. Of the persons whose names were furnished as November volunteer workers for KENNEDY who live in the Los Angeles area were as follows:

TALAT KHAN, mentioned above

M. DAJHM, a cousin

Mr. KHAN said that none of the persons whose names were furnished on June 4, 1968, as November volunteer workers had done any work at the KENNEDY Campaign Headquarters in Los Angeles during the June Primary Election.

It was pointed out by Mr. KHAN that he was a leader of the opposition to the Shah of Iran among Iranian nationals in the United States and that the persons that he recommended as volunteer workers were of Iranian background and that he did not desire to furnish their specific addresses for security reasons.

He was afraid of possible politically motivated reprisals against him and his associates due to the opposition to the policies of the Shah.

Mr. KHAN said that he did not desire to get mixed up in an affair involving the Arabian countries and the Jewish State as a result of the KENNEDY assassination, however, in the interest of justice, he was willing to cooperate with the FBI. Concerning any further thought he may have had on the possibility of SIRHAN SIRHAN conspiring with anyone in the shooting of Senator KENNEDY, he replied the only possibility concerned the person, LILLIAN LAWRENCE, whom he had referred to in his initial interview by the FBI in the presence of his attorney in Los Angeles on June 10, 1968. He had just learned from sources he did not disclose that LILLIAN LAWRENCE had recently been on a trip to the Middle East. This, coupled with the previously furnished information regarding the mention of the name ĬA 56-156

of LILLY LAWRENCE by a man in the blue Volkswagen with a young girl near KENNEDY Campaign Headquarters on June 3, 1968, looked familiar to him. Further, that this young man, unidentified, he felt quite sure he had seen before in New York and possibly in association with LILLIAN LAWRENCE and her husband. Further, that the young girl seen in the Volkswagen had on the late evening of June 4, 1968, been observed in the KENNEDY Campaign Headquarters standing very near to the individual who he thought to be SIRHAN SIRHAN, the details of which he had previously related. Also, that this young girl, when last seen on June 4, 1968, was wearing a dress, the upper portion of which, as best he could observe, was light in color and contained dark, either blue or black, dots on it.

He continued that though this was speculation, it might be significant if there was any actual connection between LILLIAN LAWRENCE, the Iranian national married to an American in New York, the young man he observed with the young girl in a blue Volkswagen outside the KENNEDY Headquarters and this same girl who was in the Volkswagen who was, the following day, seen at the KENNEDY Headquarters near the person thought to be SIRHAN SIRHAN.

Mr. KHAN reiterated that he did not actually see the young girl in question talking to the person thought to be SIRHAN at the headquarters but the two were standing face to face about two feet apart, the man thought to be SIRHAN near the water cooler and the girl by the coffee urn.

Mr. KHAN re-examined the photographs of SIRHAN SIRHAN and his brothers, ADEL, MUNIR and SHARIF, including a current photograph of the latter, and reached the conclusion he had never seen any of the individuals previously with the possible exception that he felt that he had seen SIRHAN SIRHAN as related above.

It was mentioned by Mr. KHAN that if anything ever developed from the information he furnished, he would

not be willing to testify in a court of law with respect to SIRHAN without personally observing SIRHAN. With respect to the unknown girl in the Volkswagen, he would also have to see any girl thought to be the same person before he could make any more positive identfication.
