FIBUS advised that he is employed as a custodian at the Van Nuys Division, Los Angeles Police Department, Van Nuys, California. He stated that his home telephone number is 782-8379.

FIBUS advised that he has little information pertaining to SIRHAN B. SIRHAN. He stated that he had been watching television on the morning of June 5, 1968, when he saw photographs of the person who had been arrested by the Los Angeles Police for the shooting of Senator ROBERT F. KENNEDY. FIBUS stated that he recognized the photograph as being a photograph of SIRHAN SIRHAN and that he and SIRHAN SIRHAN had been in the Ninth Grade in school together. FIBUS stated he knew nothing about SIRHAN and his only involvement in this matter was when he telephoned the police and told them of SIRHAN's identification.

On June 26, 1968, MICHAEL HAGGERTY, Room 110, Taylor Hotel, 64 West Colorado Boulevard, Pasadena, California, advised that he saw SIRHAN B. SIRHAN in the Denny's Restaurant, Colorado Boulevard, Pasadena, on May 23, 1968, in the company of five other persons not known to him. HAGGERTY stated the other five persons seemed to be of Arab extraction. HAGGERTY stated that he knew SIRHAN B. SIRHAN from school attendance together. He advised that both he and SIRHAN attended John Muir High School in Pasadena and Pasadena City College, in Pasadena, California. HAGGERTY stated that he did not know SIRHAN very well but both of them had been active in student government at Pasadena City College, and he remembers SIRHAN as being bitter over United States support of Israel and that Palestine would still belong to the Arabs if it were not for England and the United States. HAGGERTY advised that SIRHAN had the ambition to become a jockey and felt there was a lot of money in horse racing. He advised he thought it strange when he saw SIRHAN ignore him at Denny's on May 23, 1968. He stated that when he approached SIRHAN's table SIRHAN switched the conversation to Arabic and SIRHAN and his friends left the restaurant without ordering anything to eat.

HAGGERTY was shown photographs of ADEL B. SIRHAN, SHARIF B. SIRHAN, SAIDALLAH B. SIRHAN, and MUNIR B. SIRHAN, but he was unable to identify any of them as being the persons who were with SIRHAN B. SIRHAN in Denny's. HAGGERTY advised he would be unable to describe or recognize the persons seen with SIRHAN.

LORENA KURTZ, 4110 Monroe Street, was interviewed at her residence.

KURTZ stated she called FBI Headquarters, Washington, D. C., on June 7, 1968. At the time of her call to Washington she added she was very distressed over the death of Senator KENNEDY. She continued she is presently under a doctor's care for treatment of nervous spasms. She added she has no information to furnish that her next door neighbor is a friend of an individual who conspired with SIRHAN SIRHAN. KURTZ said this is a false statement. KURTZ agreed that she made such a statement, however, she repeated she was very upset when she made this statement.

KURTZ continued that until June 9, 1968, she had neighbors residing at 4108 Monroe Street, who were of Arabic nationality. This family consisted of a man and wife and two children; a girl age 10 and a boy age eight years. She does not know the name of this family. She was exhibited a photograph of SIRHAN and advised she has never observed SIRHAN at the residence at 4108 Monroe Street and she has no reason to believe that this family is acquainted with SIRHAN or is acquainted with an individual who conspired with SIRHAN to kill Senator KENNEDY.

Mr. FRANCIS MC CREERY, Associate Professor, Supervisor Distributive Education and Placement, Pasadena City College, who resides at 255 West La Verne Avenue, Pomona, California, advised that JEANNE HERRICK, one of his office interviewers, had brought to his attention an incident which had occurred with SIRHAN SIRHAN in July of 1967. MC CREERY stated that he had just taken over his duties in Distributive Education at that time and that Dr. LEWIS, Administrative Dean for Student Personnel Services, had been in charge just prior. MC CREERY stated that SIRHAN had come to the office apparently seeking a specific job that had been listed on the placement bulletin board. MC CREERY advised that a receptionist had guided SIRHAN to Mrs. JEANNE HERRICK who interviews persons seeking full time employment.

MC CREERY stated that he came in contact with SIRHAN when he apparently would not give information to Mrs. HERRICK that is required to finish the application form. MC CREERY stated that SIRHAN was then brought to his office and the situation was then explained to him. MC CREERY stated that SIRHAN told him that Mrs. HERRICK would not tell him where a specific job was and that she did not want to give him a job because he was a "damn" foreigner. MC CREERY stated that SIRHAN did not give him an opportunity to explain the problem involved and that after making his statement SIRHAN left the office.

MC CREERY stated that he then conferred with Mrs. HERRICK and she had explained to him that SIRHAN had come into the office seeking a job offered by Safeway Stores for a management trainee. MC CREERY advised that Mrs. HERRICK then requested that SIRHAN fill out an application form but that SIRHAN only put down a minimum of information. MC CREERY stated that according to Mrs. HERRICK, SIRHAN became very adamant and demanded to know about the job. MC CREERY further stated that according to Mrs. HERRICK, SIRHAN then wanted the employment card back but was refused by her. MC CREERY stated that it is the office policy that all records are kept

MC CREERY stated that when SIRHAN returned from Dr. LEWIS's office and then requested the information card it was given to SIRHAN to avoid any further incident particularly since it appeared that SIRHAN would not go to the job.

JIM DOANE, 65 North Catalina, Apartment 6, Pasadena, was interviewed at the Mentor Cafe, 40 North Mentor. DOANE stated that he had known SIRHAN SIRHAN while he was in attendance at Pasadena City College. DOANE stated that he knew SIRHAN by sight, but had no real association with him. DOANE advised that BOB COMFORT had known SIRHAN and that COMFORT was going to publish a story about SIRHAN in COMFORT's magazine, "Small Comfort", which is a rather general local publication featuring various writers. DOANE stated that COMFORT worked as bar manager at the Ice House on North Mentor in Pasadena and that he publishes the "Small Comfort" at 18 North Mentor.

ROBERT G. COMFORT, who resides at 95 North Holliston, Pasadena, California, was interviewed at 18 North Mentor and advised that he was the publisher and editor of a periodical called "Small Comfort" and worked as bar manager at the Ice House located on North Mentor in Pasadena. COMFORT advised he had attended Pasadena City College in the spring of 1964 through 1965. He stated that during this time he had been acquainted with SIRHAN SIRHAN. COMFORT advised that on occasion SIRHAN would have coffee with a group of students and they would engage in a general conversation. COMFORT advised that during these conversations numerous topics would come up and that he could not specifically recall exact statements of SIRHAN. COMFORT advised that he did remember that SIRHAN had stated a contempt for the idea of Israel but not toward the Jewish people. COMFORT advised that he remembered a Jewish boy being a regular in this group and that SIRHAN never voiced opposition or disdain for this individual. COMFORT stated that it was his impression that SIRHAN did not hold the rich in contempt and that SIRHAN had respect for the idea that persons with ability could acquire material possessions and live better than persons with lesser ability.

COMFORT advised that generally SIRHAN was usually withdrawn and that it appeared that SIRHAN desired to be accepted. COMFORT stated that SIRHAN was not at a loss to express his belief in Arab Nationalism and if the topic came up he would participate. COMFORT stated that on occasion the group would bait SIRHAN because his views on the subject were known by the more frequent members of the coffee group.

COMFORT further advised that SIRHAN did not like the idea of the establishment and the relegation of the individual to being no more than a number. COMFORT further advised that it was his impression that SIRHAN sought to be accepted by this group even to the extent that SIRHAN would sometimes buy coffee for everyone.

COMFORT advised that his only other contact with SIRHAN was when SIRHAN worked for a Richfield Service Station

in Pasadena and he (COMFORT) would have his car serviced or just stop by to get some free work done.

COMFORT advised that SIRHAN would not probably consider him a friend because their contact was infrequent.

COMFORT advised that in the July 2, 1968, issue of his magazine, "Small Comfort", he intended to print a story about his impressions of SIRHAN SIRHAN and the KENNEDY assassination. COMFORT stated that he had no profound insights to offer and that his purpose in writing was to point out the need for every individual to get involved in current matters so that in the future protests will not take the form of assassins bullets.

COMFORT furnished a copy of his article. COMFORT advised that the following paragraph is the only part which reflects his factual knowledge of SIRHAN:

"I went to school with SIRHAN. We weren't fast friends, but I remember him. We shared no classes, but he often sat at our table during breaks. I sometimes went to the service station where he worked evenings; to scrounge cans of STP for my sickly car, and to talk with him. He was a little guy with the top button on his shirt undone so the hair on his chest stuck out. He was friendly. Eager enough for acceptance that he'd buy coffee for everybody at the table. Maybe not so much for acceptance as the indication of a generous nature--I don't know. He was articulate without being pushy. The only time he raised his voice were the times the Middle East situation was the topic of discussion. He was from a refugee background and was, therefore, considered unfit company by the rest of the Arab students; most of whom were the offspring of monied middle-east establishment parents. He disliked them for their smugness; they

"rejected him. In our group there was no one who didn't like SIRHAN, but no one who liked him well enough to be his friend. He asked a few girls for dates, but none accepted. 'He's a nice guy,' they'd say when he was gone, 'but I'd feel so funny if I went out with him.' They'd make a small face then or laugh. That's all I knew about him. He thought NASSER was a great man. He hated the ideas of Isreal-- but not the Jew who sat at our table. SIRHAN SIRHAN. He was tiny. He wanted very much to be liked. He was lonely."

Dr. IRVIN G. LEWIS, Administrative Dean for Student Personnel Services, Pasadena City College advised that he recalled the incident in July 1967 involving SIRHAN SIRHAN attempting to apply for a job which was offered through the Distributive Education and Placement Service at the college. Dr. LEWIS stated that he had not remembered the matter during prior interviews because of the number of students with whom he deals. Dr. LEWIS stated that he first became involved when SIRHAN went to the office of the President at the college to make a complaint, but that SIRHAN was referred to his office because the Placement Service had been placed under his supervision about a month earlier. Dr. LEWIS stated that he could not really remember the particulars of the meeting but that he did have SIRHAN fill out a second application card and then sent SIRHAN back to the employment office. Dr. LEWIS stated that he believed he had telephoned the office suggesting that they give SIRHAN the job information SIRHAN requested, even though SIRHAN did not meet the requirements for educational background or physical requirements.

Dr. LEWIS stated that he kept a journal from day to day noting matters out of the ordinary which arise. Dr. LEWIS referred to this journal, where under the date July 24, 1967, was the notation:

"saw SIRHAN - noted job 604, Retail Management Trainee, Permanent Resident Visa, Dr. LEWIS okay to Re apply for job-113C".

Dr. LEWIS stated that each job opening is given a number, which is probably reflected by "job 604." He further stated that "Permanent Resident Visa" is probably a reference to the fact that when foreign students apply for positions the number of hours they can work are limited by their type of visa and therefore SIRHAN would have had to been asked what his status was for this reason.

Mrs. JEANNE S. HERRICK, Employment Interviewer, Pasadena City College, who resides at 1160 Coronet Street, Pasadena, California, advised that in late July of 1967, SIRHAN SIRHAN had come to the Employment Center at Pasadena City College inquiring about a specific employment opening which had been listed on the bulletin board at the employment center. Mrs. HERRICK stated she told SIRHAN that he had to fill out an information card and return the following day for an interview. Mrs. HERRICK stated that SIRHAN then stated he would not fill out the information card but that she should just tell him where the job was and he would go apply. She advised that she was able to get SIRHAN to fill out one or two blanks on the card and had inquired as to his immigration status to determine whether he would need a work permit. Mrs. HERRICK advised that SIRHAN then stated that he would talk to the college president about this matter and left the office. Mrs. HERRICK stated that SIRHAN later returned with a completed information card. Mrs. HERRICK stated that Dr. IRVIN LEWIS told her that he had talked to SIRHAN and told her to give SIRHAN the job information to avoid any other disturbance. Mrs. HERRICK stated that on her second meeting with SIRHAN, he was more cooperative and gave her further information.

Mrs. HERRICK stated that SIRHAN had been interested in a management trainee job with Safeway Stores, Incorporated but that their requirements called for a four-year college degree and a minimum height of 5'8" and a minimum weight which she could not recall, but that SIRHAN obviously did not fit. Mrs. HERRICK stated that SIRHAN had told her he was a jockey and when asked why he was changing jobs he stated that he had had an accident and wanted another type of work.

She stated she gave SIRHAN the address of Safeway Stores, Incorporated and thought he was going to leave. She stated that SIRHAN then demanded that the information card be given to him or destroyed. She advised that this was against school policy and asked Mr. FRANCIS MC CREERY, her supervisor, what she should do. She stated that MC CREERY told her to give him the card and let him be on his way. She stated that she then gave SIRHAN the card at which time he tore it up into many small pieces and threw it in the waste basket. She stated SIRHAN then told her, "This will teach you to never under estimate a jockey." She advised that SIRHAN then left.

Mrs. HERRICK stated that the card SIRHAN tore up was the second card, which he had filled out completely. She stated that she later wrote on the first card, which was incomplete, some of the information she could recall so she would have a record of the incident.

Mrs. HERRICK advised that she had remembered the incident after she saw SIRHAN's picture and name in the newspaper.

He purchased a .22 caliber gun at the Pasadena Gun Shop on Green Street in Pasadena, California. He purchased the gun shortly after the Watts riots of 1965. He does not recall the make or serial number of the gun. He only possessed the gun for two or three months, and then his wife gave the gun to their daughter, DANA WESTLAKE, who lives at 349 Redwood Drive, Woodacre, California. WESTLAKE told him that she gave the gun to CHICK ERHARD, her next door neighbor.

HERTZ was shown a photograph of SIRHAN SIRHAN and he stated that he had never seen the man.

GEORGE BEILICKE, 112 Harkness Avenue, Pasadena, furnished the following information:

Since last being interviewed, he has not been able to recall the last name of the person known to him as PAUL, who might have been a friend of SIRHAN SIRHAN. He reiterated that he has not seen PAUL since the Fall of 1966 and that he has not seen PAUL and SIRHAN SIRHAN talking together since prior to last seeing PAUL.

BEILICKE has been attempting to recall information regarding PAUL's employment and friends or acquaintances but, because they met rather haphazardly and infrequently almost two years ago, BEILICKE has not been able to recall any additional information regarding PAUL.

BEILICKE stated that he does not specifically recall ever mentioning to anybody that SIRHAN SIRHAN had been involved in a fight or argument at Denny's Restaurant in Pasadena a week or two prior to the shooting of Senator ROBERT F. KENNEDY. According to BEILICKE, he does not have any knowledge of such a fight or argument.

PAUL KHOURY, 175 North Sierra Bonita, Pasadena, California, was contacted at his place of employment, Shell Service Station, Avenue 26 and Figueroa Street, Highland Park, and he furnished the following information:

He has been in California on a student visa since 1963, and has been enrolled at Pasadena City College (PCC) since his entry from Jordan.

During 1965, he resided at 128 North Sierra Bonita, Pasadena, and he became acquainted with SHARIF SIRHAN who was residing across the street. From SHARIF he learned that SIRHAN SIRHAN, SHARIF's brother, was attending PCC, but KHOURY did not meet SIRHAN SIRHAN until sometime in 1966 when he was introduced to SIRHAN SIRHAN in the PCC cafeteria. KHOURY could not recall who introduced them but it was a rather brief and informal meeting and KHOURY and SIRHAN SIRHAN did not talk together for any length of time. KHOURY did not see SIRHAN SIRHAN again for quite sometime when again they met in the PCC cafeteria. This meeting, too, was very brief and consisted of little more than saying hello.

The next time KHOURY saw SIRHAN SIRHAN was in February or March 1968, at Santa Anita Race Track. At that time, KHOURY was leaving the track and saw SIRHAN SIRHAN and GHABEL BADRAN in the crowd. KHOURY said hello to them, they acknowledged his greeting and KHOURY continued out of the track.

These three occasions were the only times KHOURY saw or spoke with SIRHAN SIRHAN and he could not provide any other information regarding SIRHAN SIRHAN or any friends or acquaintances SIRHAN SIRHAN might have had. KHOURY never saw SIRHAN SIRHAN in Denny's Restaurant, Colorado Boulevard, Pasadena, and he never visited the Lock, Stock and Barrel Gun Shop, San Gabriel, California, with SIRHAN.

He has been employed at Shaps Bar for approximately the past four years, however, he had never seen the person pictured in the tavern. GIBBONS works two days and three nights a week behind the bar and always works the weekend nights.

GIBBONS could not provide any pertinent information regarding friends or acquaintances of SIRHAN SIRHAN.

According to GIBBONS, the manager of Shaps, EDWARD WARD, and another bartender, GARY MEZA, also work behind the bar but GIBBONS had not heard them mention ever seeing SIRHAN SIRHAN in Shaps.

She observed a photograph of SIRHAN SIRHAN and advised she is not acquainted with him nor is she aware that SIRHAN SIRHAN was ever a customer of the restaurant she manages. She did not have any knowledge of an argument or quarrel at Denny's in which SIRHAN SIRHAN may have participated and she had not received any information from any other Denny's employee about such an argument.

He is not acquainted with SIRHAN SIRHAN, however, he does know ADEL SIRHAN, the brother of SIRHAN SIRHAN, inasmuch as ADEL would stop by the trucking business SIMANN briefly operated in Pasadena during 1961. This was shortly after SIMANN arrived in this country from Jordan and he and ADEL have maintained a casual acquaintanceship to this day.

SIMANN recalls seeing ADEL SIRHAN in the Fez Restaurant, Hollywood, approximately five days before the shooting of Senator ROBERT F. KENNEDY. At that time, ADEL SIRHAN was dining in the company of four or five other Arabs, none of whom were known by SIMANN, and SIMANN overheard ADEL bitterly complaining about the support for Israel Senator KENNEDY had expressed during the Oregon primary. ADEL was upset that Senator KENNEDY was cultivating the Jewish vote in the United States, however, SIMANN did not hear ADEL SIRHAN threaten Senator KENNEDY in any manner.

SIMANN is of the opinion that ADEL was exasperated with Senator KENNEDY and may have passed some of this bitterness to his younger brother, SIRHAN SIRHAN.

JOSEPH SHEEHAN, Professor of Psychology, University of California at Los Angeles (UCLA), was contacted at his residence 371 20th Street, Santa Monica, and he furnished the following information:

On the night of May 24, 1968, he and his wife, MARGARET, attended a rally for Senator ROBERT F. KENNEDY at the Sports Arena, Los Angeles. This rally ended around 10:30 p.m. and SHEEHAN and his wife made their way out of the Arena to a position where they could get a look at Senator KENNEDY as he was leaving the Arena. SHEEHAN was waiting about a half hour for Senator KENNEDY and a large crowd, in excess of 200 people, had also gathered to wait for the Senator.

About that time SHEEHAN noticed that the man who had moved in front of him, was completely out of character in the crowd. This man appeared very intense and sinister, and did not participate at all in the carnival atmosphere that pervaded the crowd. This man appeared to SHEEHAN to be alone, inasmuch as he did not talk with anyone in the crowd and after two or three minutes he moved away and was lost by SHEEHAN in the crowd. However, as this man moved away, SHEEHAN remarked to his wife as to the sinister demeanor of this man. His wife agreed. SHEEHAN reiterated that he lost this individual in the crowd and did not see him again that evening.

Two days after the assassination of Senator KENNEDY, SHEEHAN saw a photograph of SIRHAN SIRHAN in the Los Angeles Times and he identified the photograph in the newspaper as being the picture of the sinister individual who had been in front of him outside the Los Angeles Sports Arena on May 24, 1968. SHEEHAN showed this picture to his wife without any explanatory statements and she too, without prompting, identified the photograph of SIRHAN SIRHAN as being the picture of the man in front of them in the Sports Arena.

SHEEHAN observed a photograph of SIRHAN SIRHAN taken by the Los Angeles Police Department on June 5, 1968, and he identified the person pictured as being the person who was in front of him in the crowd outside the Sports Arena on May 24, 1968.

Approximately half an hour after SHEEHAN lost SIRHAN SIRHAN in the crowd, Senator KENNEDY left the Sports Arena in the company of ROOSEVELT GRIER and RAFAEL JOHNSON, and other unknown members of the KENNEDY entourage. While the entourage was attempting to clear a path to Senator KENNEDY's awaiting automobile, which SHEEHAN observed was parked on Exposition Boulevard, SHEEHAN noted that a group of four men were concertedly attempting either to impede the progress of the entourage by not giving ground before it, or were simply attempting to withstand the crowd in order to get a better view of the Senator. In any event the KENNEDY entourage was momentarily halted by the bottleneck of people before GRIER and JOHNSON moved in the direction of least resistance and took Senator KENNEDY to the awaiting automobile. SHEEHAN could not recall the four men other than that they all appeared to be white Americans and to be well dressed. SHEEHAN did not see SIRHAN SIRHAN in the company of these men, nor does SHEEHAN have any reason to associate SIRHAN SIRHAN with these men.

SHEEHAN commented that he did not know any person in the crowd outside the Sports Arena on the night of May 24, 1968, other than his wife.

SHEEHAN concluded that on the night of June 4, 1968, he and his wife were at the Ambassador Hotel arriving there about 8:30 p.m. They spent the entire evening in the Grand Ballroom, leaving about 11:30 p.m., and he did not see SIRHAN SIRHAN or Senator KENNEDY that night.

Mrs. MARGARET SHEEHAN, 371 20th Street, Santa Monica, furnished the following information:

On the night of May 24, 1968, she and her husband, JOSEPH SHEEHAN, attended a rally for Senator ROBERT F. KENNEDY at the Los Angeles Sports Arena. After this rally concluded, she and her husband went outside the Arena in hopes of seeing Senator KENNEDY as he left the Arena. She and her husband had been waiting in a crowd of over 200 people for approximately 20 to 30 minutes, when her husband commented to her that the man, who had been standing in front of him and who was now making his way off into the crowd, appeared to be extremely sinister. Mrs. SHEEHAN observed this man, agreed with her husband, and watched this sinister looking individual as he moved through the crowd in the direction of the automobile that was awaiting the departure of Senator KENNEDY. She observed this man only momentarily before losing him in the crowd, and she did not see him again that evening.

Two days after the assassination of Senator KENNEDY, her husband showed her a picture of SIRHAN SIRHAN and she identified the picture as being that of the sinister looking individual they had observed in the Sports Arena crowd on May 24, 1968.

Mrs. SHEEHAN observed a photograph of SIRHAN SIRHAN taken by the Los Angeles Police Department on June 5, 1968, and she identified the person pictured as being the person who was in front of her and her husband in the crowd outside the Sports Arena on May 24, 1968.

Mrs. SHEEHAN concluded that on the night of June 4, 1968, she and her husband were at the Ambassador Hotel, arriving there about 8:30 p.m. They spent the entire evening in the Grand Ballroom, leaving about 11:30 p.m., and she did not see SIRHAN SIRHAN or Senator KENNEDY that night.

JOHN H. AHRNDT, Area Chairman, KENNEDY for President Committee, was interviewed at his residence, 15124 Garfield and he furnished the following information:

At about 10:00 p.m. on June 4, 1968, he went with CHERYL MOORE to the Ambassador, 3400 Wilshire Boulevard, Los Angeles, California, where he was to meet Dr. ROSS MILLER. At approximately 10:30 p.m. he met Dr. MILLER at the entrance to the Cocoanut Grove and together they went to the room which had been set up as a press room. They watched Senator ROBERT F. KENNEDY's victory speech on television.

After the speech they were to get together with some of the members of the KENNEDY party, who had worked with him in the Compton area, and go out for something to eat. As they were standing outside the door to the press room, a girl came by saying that someone had been shot. At this point Dr. MILLER left to see if he could render aid to the injured party. He and Miss MOORE remained in the area of the press room and did not realize that the injured party was Senator KENNEDY until someone in an effort to quiet the crowd said, "You can't help the Senator by screaming".

He and Miss MOORE stayed at the Ambassador Hotel until about 3:30 a.m., when they went to the Central Receiving Hospital to see if they could find Dr. MILLER or any of the people that were to meet them for dinner. When they could find no one at Central Receiving Hospital, they returned to their homes.

AHRNDT advised that he recalls seeing nothing irregular at the Ambassador Hotel prior to the shooting. He observed a photograph of SIRHAN BISHARA SIRHAN and advised he does not recall seeing this man at the Ambassador Hotel. However, he stated that sometime between May 12 and 18, 1968, while at KENNEDY Headquarters in Downtown Los Angeles, he is quite certain he saw SIRHAN. President Committee so that areas for distributing literature could be assigned. He was assigned one of the areas and is quite certain while picking up literature he observed SIRHAN. At that time he was accompanied by VICTORIA NELSON. He is not certain if she saw SIRHAN. AHRNDT stated that LES GUTHMAN, Los Angeles Area Chairman, Students for KENNEDY, was in charge of the meeting at KENNEDY Headquarters and may have additional information concerning who was at the meeting.

While at the Ambassador Hotel on June 4-5, 1968, AHRNDT observed the following individuals: DENNIS LOPEZ, TERRY DRINKWATER (CBS newsman) and GENE BERRY. AHRNDT further advised that CARLTON HAYES has told him that he was at the Ambassador Hotel on June 4, 1968.

ANN FERGUSON was interviewed at her place of employment, 7250 West Beverly Boulevard, at which time she furnished the following information:

She was a volunteer for Senator ROBERT F. KENNEDY and at approximately 6:15 pm, on June 4, 1968, she and BILL COX went to the Ambassador Hotel to await the results of the California primary. Upon arriving at the hotel, both she and COX went directly to the Embassy Room where they remained until about 10:30, or 11:00 pm, when she went to the Ballroom to get a drink.

After getting the drink in the Ballroom, the guard at the door to the Embassy Room would not allow her to re-enter the room. She then went to the Press Room, where the guard allowed her to enter the kitchen, and by passing through the kitchen, she returned to the Embassy Room. At the time of passing through the kitchen, she noticed no one, but in an area adjacent to the kitchen, she found a small room full of men she had not seen before and whom she assumed were members of the press.

She was in the Embassy Room during Senator KENNEDY's victory speech standing near the back of the crowd. After Senator KENNEDY had finished his speech, ERWIN STROLL, who was standing near the kitchen door, beckoned to her to follow him out of the kitchen. At this point, Senator KENNEDY had left the podium and was passing through the kitchen. The reason STROLL had attempted to have her follow him was because he, STROLL, had a gift which he was going to present to Senator KENNEDY, and she was supposed to be present when the gift was received.

As she was attempting to get to this door, STROLL went through the door and disappeared into the crowd. Just a few moments after he disappeared she heard several bangs which sounded like breaking balloons. After these bangs,

STROLL comes back through the door and says to her, "My God, ANN, I'm shot." At first she did not believe STROLL and thought that he was just joking again, but she then noticed the blood on his leg. She then called for BILL COX to help ERWIN. COX came to ERWIN and along with DAVID ESQUITH helped STROLL out of the Embassy Room.

About this time a man said that BOBBY KENNEDY has been shot and she called out for a doctor. At the same time, as she was calling for a doctor, a woman aided by a man came out of the same door that STROLL had come from. This woman had blood on her face, but she was walking. By now several people were shouting for doctors, and someone was requesting that the crowd stand back. Still later someone asked for ice.

At this point, BILL COX returned to the Embassy Room and asked her if she was okay. Then she and BILL left the Embassy Room and met Mrs. TIFFANY JONAS, who was crying and saying that they should be with ERWIN since he has been hurt. Mrs. FERGUSON then drove herself, TIFFANY JONAS, and BILL COX to the Central Receiving Hospital, where they stayed until ERWIN STROLL's parents arrived at the hospital.

After STROLL's parents arrived at the hospital, she returned to the Ambassador Hotel with DAVID ESQUITH. ESQUITH picked up his car and they both returned to their homes.

FERGUSON observed a photograph of SIRHAN BISHARA SIRHAN and advised that she does not recall seeing him at the Ambassador Hotel on June 4, 1968, but recalls seeing someone resembling him at the Kennedy For President Headquarters, Wilshire Boulevard, on Tuesday, June 3, 1968. She said that she could not positively identify this man as being SIRHAN, but thought that there was a close resemblance. The man she saw at the headquarters had on a white shirt and tan trousers. She does not recall what this man was doing at the headquarters.

DAVID SAUL BARRETT was interviewed at his place of employment, the Yamano Beauty College, 5553 Wilshire Boulevard. He advised that he resides at 1525 North Hayward, Los Angeles, California, and was formerly employed as an exercise boy at the race track. He does not recall ever seeing SIRHAN BISHARA SIRHAN at the race track or anywhere else. BARRETT stated he was at the Ambassador Hotel on the night of June 5, 1968, with his wife. However, she could furnish no information which he did not know and he would prefer that she not be interviewed because of the traumatic effect KENNEDY's assassination has had on her.

BARRETT furnished the following signed statement:

"Los Angeles, California
June 13, 1968

"I, David Saul Barrett, make the following statement to Richard P. Doucette who has identified himself to me as a Special Agent of the Federal Bureau of Investigation. No threats or promises have been made to me and I make this statement of my own free will.

"I am 24 years old having been born on [REDACTED] in New York City, New York.

"I was a volunteer on the Kennedy for president committee and on June 5, 1968, at about 8:30 p.m. I went to the Ambassador Hotel to wait for the results of the election. A little before midnight Senator Robert F. Kennedy came to the Embassy room of the Hotel to give his victory speech. During the speech I was directly in front of the Senator, about 2 feet away from him.

"After the speech was over Senator Kennedy left the podium and disappeared from

"my sight. A few seconds after he was gone. I heard a loud pop, it sounded just like a breaking balloon, there was a short pause and then three more pops in rapid succession. Shortly a young boy, standing on a chair, yells that Senator Kennedy has been shot.

"I pushed my way through the crowd toward the area where the pops came from but the crowd was too tight and I could not get through. I got down near the floor and by looking between peoples legs I could see, some distance away, the foot of someone on the floor. I could not tell if it was Senator Kennedy.

"About 15 minutes later Steve Smith asked everyone to leave the Embassy room. I left the room, went down stairs to the ballroom, and watched television until about 3:30 a.m. when I went home. Later I went to the hospital.

"I have read this statement of two pages and now sign it because it is correct best of my knowledge.

At the end of Senator KENNEDY's speech, she observed the Senator leave the podium and head toward the kitchen area.

Shortly after KENNEDY left the podium, she heard three loud bangs which sounded like breaking balloons. At this point there was a considerable amount of yelling and screaming and she went back to the area of the television cameras. Prior to the shouting, she had been attempting to leave the Embassy Room.

From the area of the television cameras, she observed ERWIN STROLL being carried from the Embassy Room. Shortly after STROLL was taken from the room, someone requested that the people leave the Embassy Room and at this point she left the room and went downstairs to watch television. At approximately 2:00 am, she left the Ambassador Hotel and returned to her home.

Miss BRYAN observed a photograph of SIRHAN BISHARA SIRHAN and she advised that she does not recall seeing this man at the Ambassador Hotel on June 4, 1968, or June 5, 1968. She further stated that other than having seen SIRHAN's photograph in the newspaper she does not recall ever seeing this individual.

He was a volunteer for Senator ROBERT F. KENNEDY and at 7:30 PM on June 4, 1968, he went to the Ambassador Hotel to await the results of the California primary election. On arrival at the Ambassador Hotel, he went immediately to the Embassy Room and remained there the entire evening.

He was in the Embassy Room at the time of Senator KENNEDY's victory speech and shortly after KENNEDY left the podium he heard several loud bangs which he assumed were breaking balloons. There was a great deal of shouting and pushing by the crowd, but at first he assumed this was just part of the victory celebration. As he was attempting to leave the Embassy Room, ANN FERGUSON asked him to help ERWIN STROLL because STROLL had been shot in the leg. At first he thought FERGUSON was joking, but then he saw STROLL's leg had blood on it.

He, along with DAVID ESQUITH and another white male, unknown to him, helped carry STROLL from the Embassy Room to the entrance of the Ambassador Hotel where they placed him in a taxicab. DAVID ESQUITH accompanied STROLL to the Central Receiving Hospital while he attempted to return to the Embassy Room.

While attempting to reenter the Embassy Room, he met Mrs. TIFFANY JONAS and ANN FERGUSON. Mrs. JONAS suggested that they go to the Central Receiving Hospital and stay with ERWIN STROLL until STROLL's parents could be contacted. All three of them then went to the Central Receiving Hospital in ANN FERGUSON's car and waited for the arrival of STROLL's parents. After STROLL's parents arrived at the receiving hospital, he and ANN FERGUSON returned to the Ambassador Hotel for a few minutes and then went home.

DAVID ESQUITH picked her and her mother up at approximately 6:30 pm and they went to the Embassy Room of the Ambassador Hotel, where they met ERWIN STROLL. At about 10:15 pm, JIM LOWE asked STROLL to watch the entrance to the kitchen, which was next to the podium.

At about midnight, Senator KENNEDY came to the podium to give his victory speech. At this point, Miss CUCCIA's mother became ill because of the stuffiness of the Embassy Room, and it was necessary for her to leave the hotel. Miss CUCCIA accompanied her mother to the elevator outside of the Embassy Room. After getting her mother on the elevator, Miss CUCCIA went to the Ballroom where she met TIFFANY JONAS. After meeting Mrs. JONAS, they both attempted to return to the Embassy Room, but were stopped in the area of the press room by the security guard. Just after arriving at the door to the press room, she heard a pop, which sounded like a bag was being broken. Immediately after the pop, there was a great deal of pushing and shouting. Some members of the press attempted to get into the press room and there was altercation between the security guard and one of the press men. As this is going on, a woman passed by who said that Senator KENNEDY has been shot.

At this point, she observed ERWIN STROLL being helped from the Embassy Room by three men and realized that he had been shot. Upon realizing that STROLL had been shot, she became very emotional and it was necessary for STEVE WAGNER to bring her home. Prior to leaving the Ambassador Hotel with WAGNER, she did observe SIRHAN BISHARA SIRHAN being taken from the hotel by the police.

At the time she and TIFFANY JONAS attempted to return to the Embassy Room, she did look into the kitchen, but does not recall seeing anyone identical to SIRHAN BISHARA SIRHAN. She recalls seeing only four men, all of them in suits, and all appearing to be members of the press.

Miss CUCCIA observed a photograph of SIRHAN BISHARA SIRHAN and advised that on June 3, 1968, she was working at Kennedy Headquarters on Wilshire Boulevard answering phone calls. Sometime during the morning of the third, she recalls seeing a man who resembled SIRHAN BISHARA SIRHAN come into the headquarters office, go to a table which had literature on it concerning Senator KENNEDY and look at this literature for a short time. CUCCIA stated that she could not positively identify this man as being SIRHAN, and simply said that there was a close resemblance.

Mrs. TIFFANY JONAS, 914 Beverly Glen Boulevard, was interviewed at her residence and furnished the following information:

She worked on the KENNEDY Campaign Committee for Los Angeles and was at the Ambassador Hotel on the morning Senator ROBERT F. KENNEDY was assassinated.

At approximately 10:30 PM on June 4, 1968, she accompanied by her husband, DAVID JONAS, arrived at the Ambassador Hotel where they intended to go to the Embassy Room to await Senator ROBERT F. KENNEDY's victory speech. They made several attempts to enter the Embassy Room, but it was so crowded it was impossible to get in. In an effort to get into the room, they attempted to pass through the kitchen area, but were stopped by Security Guards.

After spending some time in the Press Room, adjacent to the kitchen, she and her husband went to the Ballroom for cocktails. While drinking in the Ballroom, she became separated from her husband who returned after about half an hour and said he was going home because of the large crowd. After her husband left, she again attempted to get into the Embassy Room and was standing near the doors which go into the Press Room, kitchen and the Embassy Room, when she heard what she thought was the breaking of balloons. Shortly after the loud popping sounds, there was screaming and a great deal of pushing by the crowd. The entire area, where there were three doors, became very crowded and after asking several people what was going on, she was informed Senator KENNEDY had been shot. By this time, she was standing near the Press Room door holding on to a Security Guard.

While standing near the Security Guard, a man carrying a large television camera attempted to get into the Press Room door, and the Security Guard attempted to stop him. A great deal of shoving and scuffling occurred and the man carrying the camera ended up on the floor along with the Security Officer. At this time, VICKIE CUCCIA came by and

said that ERWIN STROLL had been shot and was being taken to the Central Receiving Hospital.

Mrs. JONAS said she was a good friend of STROLL and upon learning that he had been shot and was being taken to the hospital, went to Central Receiving Hospital to see if he was seriously hurt. At approximately 12:40 she arrived at Central Receiving Hospital and after telling the Security Guards that she was the mother of STROLL, she was allowed to go into the hospital and talk to the nurse. The nurse advised that STROLL was being taken care of and was being sent to Midway Hospital for an operation to remove the bullet from his leg. She then went to Midway Hospital staying there until STROLL's parents arrived.

She stated that while at the Ambassador Hotel, she observed nothing irregular and upon observing a photograph of SIRHAN BISHARA SIRHAN, she advised that she does not recall ever seeing him in her life.

NELSON RISING was interviewed at his place of employment, 433 South Spring Street, at which time he furnished the following information:

He was a volunteer for Senator ROBERT F. KENNEDY, and on June 4, 1968, he and his wife, SHARON, went to the Ambassador Hotel to await the results of the California primary. He arrived at the hotel at approximately 7:30 pm, and went immediately to the Embassy Room of the hotel. On several occasions he left the Embassy Room to get drinks and cigarettes, but was in the room when Senator KENNEDY gave his victory speech.

At the time of the victory speech he was approximately 30 feet away from Senator KENNEDY and as KENNEDY left the podium after the speech, RISING and his wife, SHARON, began to move towards the door of the Embassy Room in an effort to leave the hotel. As they were moving, at the rear of the crowd he heard shouting and screaming from the area of the door leading to the kitchen. At first he thought Senator KENNEDY had decided to leave the Embassy Room through the crowd, but later people began saying that there had been a shooting and someone began asking for a doctor. About this time, STEVE SMITH asked the people to leave the Embassy Room. RISING and his wife then went into the lobby of the Ambassador Hotel. While in the lobby rumors again spread that KENNEDY had not been shot, but one of the aides had been shot. Still later a man wearing a sweater came out of the Embassy Room and said that KENNEDY had been shot. The sweater the man was wearing had blood on it and RISING stated that he was the man in the newspaper photograph shown fanning KENNEDY. When this man came into the lobby and stated that KENNEDY had been shot, another individual, unknown to RISING, became excited and started to fight with him. After breaking up this fight, RISING next recalls seeing the police taking SIRHAN BISHARA SIRHAN from the Ambassador Hotel. This was the first time RISING can recall ever seeing SIRHAN BISHARA SIRHAN.

While awaiting in the lobby to see what was happening, RISING recalls talking to someone who stated that they had seen SIRHAN BISHARA SIRHAN earlier in the evening trying to get into the Embassy Room by claiming that he was with the press. This person was also supposed to have seen SIRHAN BISHARA SIRHAN trying to get into a better position near the stage when Senator KENNEDY was giving his victory speech. RISING is not certain who this person was, but he believes it was either JERRY DODDERMAN, or a friend of DODDERMAN's. RISING was not sure of the spelling of DODDERMAN and thought that perhaps it could have been DODDERSON. In any case, DODDERMAN handled the sound equipment for KENNEDY, was formerly employed by a newspaper in Tulsa, Oklahoma, and should be able to be contacted through TED KENNEDY's Office in Washington D. C. RISING further described this man as being a white male, approximately 23 years old, blond curly hair, six feet tall.

At about 2:00 am, RISING and his wife, SHARON, left the Ambassador Hotel and went to the home of BOB THOMPSON, later returning, at about 4:00 am, to the Ambassador Hotel, where he picked up his car and returned to his own home.

MARGUERITE SWEENEY, Volunteer Coordinator, KENNEDY For President Committee, Southern California, 20055 Wells Drive, Woodland Hills, California, phone No. 347-9910, was interviewed at the KENNEDY for President Campaign Headquarters, 5615 Wilshire Boulevard, Los Angeles, California, and she furnished the following items, which are being retained in the Los Angeles file for evidentiary purposes:

1. One manila folder containing three legal pads, the following notation having been made on the manila folder, "Persons who Carried Nominating Positions". The legal pads contain the names and addresses of persons who worked on petitions for the KENNEDY for President Committee.
2. One manila folder containing miscellaneous papers which were found in the area in which associates of KHAIBAR KHAN were working.
3. One manila envelope containing lists of persons who signed up in advance to work on election day.
A notation was inscribed on this envelope by Mrs. SWEENEY that most of these individuals had worked throughout the campaign.
4. One manila envelope containing lists of volunteers during the last three days prior to the election. Mrs. SWEENEY explained that index cards were not made up on these individuals.
5. Five 11 X 15 inch sheets of heavy manila paper with names, addresses, and phone numbers. Mrs. SWEENEY explained that these were election day signing sheets, which had been done by Mrs. HELEN STOUT. Mrs. SWEENEY attempted to have all the people who worked on election day sign in on these records; however, since the KHAN group did not sign on these sheets, they

are obviously incomplete due to the confusion and tension of the election day rush.

7. Nine cardboard boxes and one metal box which contained 3 X 5 index cards which show the names and addresses of volunteers who worked on the KENNEDY for President Campaign in the Los Angeles area.

On about May 31, 1968, a man who identified himself as THE KHAIBAR KHAN, came to the Campaign Headquarters and offered the services of himself and several of his friends to aid Senator KENNEDY's campaign. KHAN appeared to be from the Middle East, she believes Iran, as were his friends. After they had been registered as volunteers, they were used to make telephone contacts of voters. At the time of registration, they filled out 3 X 5 index cards, all of them giving their address care of the address given by THE KHAIBAR KHAN. This address was 10554 $\frac{1}{2}$ Wilshire Boulevard, phone No. 475-1849. Mrs. SWEENEY furnished these 3 X 5 index cards.
