She stated Monday, 6-3-68, between 3PM/4:30PM, she went to her vehicle, that was parked on Melrose, North curb, headed West; approx. 100 ft. East of St. Andrews Pl. She proceeded WB to St. Andrews Place, in the curb lane and had to stop for a vehicle at the curb, by a mailbox. She described the vehicle and suspects as follows:

VEH: 60/64 Ford, 2DR, Baby blue, large dent in rear above license plate; No '68 license tag on Calif. plate.
1) DRIVER: M C 25/28, lt brn hair, lt. goatee, approx. 7 days old, Very thick eyebrows, deep sounding voice, wearing a suit jacket, dark blue or black; sport shirt unknown color.

2) PASSENGER: M C 24, Short Dk brn hair, wearing Dk. Jkt.; Possibly brown; it had a white 4" round emblem sewed on left sleeve, midway between the elbow and shoulder.

3) STANDING OUTSIDE RIGHT DOOR OF VEHICLE, LEANING IN: M Possible Latin descent, 27/31, 5'5", to 5'6", Very slender, thick dark bushy hair, long jaw,

high cheekbones, white dress shirt, tie around neck-not tied; Dark suit pants, had what appeared to be

a small gun in waistband; spoke with an accent. She stated she pulled to the left of the above vehicle, and stopped alongside of it, approx. a minute and a-half. All of the

windows of the vehicle were rolled down and so was the passenger window of her vegicle. She overheard the driver (#1)say to person on the outside (#3), "Get your ass in the car", and "We have to get him tonight". She heard #3 say "I don't want to, I'm afraid". She said #3 spoke with a foreigh accent. She heard <u>Kennedy's name</u> mentioned and also heard <u>Wilshire</u> mentioned. She could not say who mentioned the above names as she started forward to make a right turn NB on St. Andrews Place. While stopped alongside the vehicle she saw about 8" of a riflebarrel, protruding from a green blanket in the rear seat of the vehicle. There was a large bundle of clothing in the rear seat. She was shown a picture of Sirhan Sirhan, and said he was the same person #3, she saw standing alongside the vehicle. She said this was definately the same person."
