THE REMAINDER OF THE AFTERNOON SESSION WAS UTILIZED WITH DEFENSE ATTORNEY COOPER READING THE PAGES OF SIRHAN'S NOTEBOOK. SIRHAN WAS UNABLE TO RECALL HAVING WRITTEN MOST OF THE MATERIAL APPEARING THEREIN, BUT DID ACKNOWLEDGE THAT IT WAS HIS HAND-WRITING AND THAT HE OBVIOUSLY HAD WRITTEN IT. SIRHAN INDICATED THAT SEVERAL EFFORTS IN RELATION TO THE ARAB ISRAELI SITUATION SO ANGERED HIM THAT AT THOSE MOMENTS HE COULD HAVE KILLED THE PERSON RESPONSIBLE.
