AFTER NOON RECESSES, DEFENSE DEVELOPED FURTHER INFORMATION FROM SIRHAN REGARDING HIS READING CONCERNING THE ROSICRUCIAN AND VARIOUS MENTAL EXPERIMENTS THAT HE LEARNED IN THIS STUDY.

FOLLOWING THIS DEFENSE DEVELOPED THROUGH QUESTIONING SIRHAN'S PURCHASE OF THE GUN USED IN MURDER OF KENNEDY AND HIS ACTIVITIES ON THE IMMEDIATE DAYS PRECEDING THE NIGHT OF JUNE FOUR WHEN SIRHAN WENT TO THE AMBASSADOR HOTEL. SIRHAN TESTIFIED TO HIS ATTENDANCE AT ROSICRUCIAN MEETING NIGHT OF MAY TWENTY EIGHT, SIXTY EIGHT, HIS FIRING PISTOL AT CORONA PD RANGE ON JUNE ONE, SIXTY EIGHT, HIS ATTENDANCE AT RALLY FOR SENATOR KENNEDY AT AMBASSADOR HOTEL ON JUNE TWO, SIXTY EIGHT, AND HIS ACTIONS ON JUNE FOUR, SIXTY EIGHT.

IN RELATION TO HIS SEEING KENNEDY AT AMBASSADOR ON JUNE TWO, SIXTY EIGHT, SIRHAN TESTIFIED THAT AT THAT POINT HE LOOKED UPON KENNEDY AS A "SAINT". AT END OF COURT SESSION, SIRHAN HAD TESTIFIED TO THE POINT OF ENTERING HOTEL ON NIGHT OF JUNE FOUR, SIXTY EIGHT. SIRHAN WILL CONTINUE TESTIMONY TOMMORROW. AT CLOSE OF SESSION, DEFENSE ATTORNEY COOPER REQUESTED TO SEE JUDGE IN CHAMBERS. ALL PROSECUTION AND DEFENSE ATTORNEYS AND INVESTIGATORS WENT INTO JUDGES CHAMBER. SIRHAN VAGUELY RECALLS GOING TO POLICE STATION AND TALKING TO SEVERAL PEOPLE, LATER APPEARING BEFORE A "LADY JUDGE." CLAIMS HE DID NOT KNOW HE HAD SHOT KENNEDY UNTIL VISIT FROM AMERICAN CIVIL LIBERTIES UNION (ACLU) ATTORNEY AL WIRIN ON MORNING OF SHOOTING.

AFTER MORNING RECESS, PROSECUTION ATTORNEY LYNN COMPTON BEGAN CROSS EXAMINATION CONCERNING RECOLLECTIONS OF SIRHAN OF HIS EARLY LIFE, HIS NOTEBOOKS AND HIS POLITICAL FEELINGS.

CROSS EXAMINATION CONTINUED AFTER THE NOON RECESS. EXAMINATION CENTERED ON RECOUNTING OF EVIDENCE AT GUN RANGE AT AMBASSADOR HOTEL NIGHT OF JUNE FOUR SIXTY EIGHT AND TIME SIRHAN WAS IN POLICE CUSTODY. CROSS EXAMINATION ENDED WITH PROSECUTING ATTORNEY REPEATING STATEMENTS SIRHAN MADE ON FEBRUARY TWENTY EIGHT LAST, WHEN JURY WAS ABSENT, THAT HE SIRHAN, KILLED SENATOR KENNEDY. THIS FOLLOWED STATEMENT BY SIRHAN ON CROSS EXAMINATION THAT HE NOW WAS NOT SURE HE HAD KILLED SENATOR KENNEDY.

DEFENSE ATTORNEY, AFTER BOTH PROSECUTION AND DEFENSE ATTORNEY CONFERRED WITH JUDGE, THEN READ ENTIRE TRANSCRIPT OF EVENTS THAT OCCURRED DURING SIRHAN'S OUTBURST AT COURT SESSION ON FEBRUARY TWENTY EIGHT LAST, DURING WHICH PERIOD JURY WAS EXCUSED. SIRHAN WAS THEN EXCUSED AS WITNESS.

AT CONCLUSION OF DIRECT EXAMINATION DEFENSE ATTEMPTED TO PUT HYPOTHETICAL QUESTION TO WITNESS AS TO WHETHER A PERSON SUCH AS SIRHAN HAD THE MENTAL CAPACITY TO GOVERN HIS ACTS OR TO ACT WITH WILLFUL MALICE ON THE NIGHT OF JUNE FOUR LAST IN SHOOTING KENNEDY. PROSECUTION OBJECTED TO QUALIFICATION OF WITNESS TO ANSWER QUESTION. THIS OBJECTION OVERRULED. PROSECUTION ALSO OBJECTED TO PHRASING OF HYPOTHETICAL QUESTION WHICH WAS SUSTAINED.
