

He worked on June 4, 1968, from 3:45 p.m. to 11:45 p.m., and he went home right after he got off work. BROOKS advised that he left the hotel before the shooting of Senator KENNEDY occurred. BROOKS was shown a photograph of SIRHAN SIRHAN and he stated that he had never seen the man.

On June 12, 1968, Mrs. BARBARA BROWN, 8920 Orion Street, Apartment 25, Los Angeles, California, advised that she was born in Long Beach, California, on April 9, 1947, and she has been employed as a cocktail waitress in "The Cave" bar of the Ambassador Hotel, 3400 Wilshire Boulevard, Los Angeles, for the past three weeks.

Mrs. BROWN stated that she was working during the early morning hours of June 5, 1968, when Senator ROBERT F. KENNEDY was shot in the Ambassador Hotel. Mrs. BROWN stated that she was working the bar at the time of the shooting and she learned of the shooting when she heard people running through the hotel yelling that Senator KENNEDY had been shot. She stated that she did not see Senator KENNEDY before or after the shooting.

Mrs. BROWN was shown three photographs of SIRHAN B. SIRHAN and she advised that she recognized the photographs of SIRHAN as being the same person she has seen photographs of in the newspapers since the shooting. She stated that she observed the police removing some person from the hotel following the shooting but she could not see him clearly. Mrs. BROWN advised that to the best of her knowledge, she has never seen or waited on SIRHAN.

LILLIAN MARY BUTLER, Telephone Operator, Ambassador Hotel, 3400 Wilshire Boulevard, Los Angeles, California, was interviewed at her place of employment and advised that she had been on duty from 6:00 PM, June 4, 1968, until 2:15 AM, June 5, 1968. She was in the Switchboard Room the entire evening and never near the Embassy Ballroom. BUTLER advised that at approximately 12:15 AM, June 5, 1968, she received a telephone call and the unidentified male voice stated, "Call the police. Someone has been shot in the Embassy Room". On receiving this, she called the Los Angeles Police Department (LAPD) and reported this prior conversation. BUTLER stated that at approximately the same time, fellow operator RUBY FORD had received a call from within the hotel indicating Senator KENNEDY had been shot and requesting an ambulance. FORD complied with this request. stated that she heard nothing resembling gun fire during the evening. A photograph of SIRHAN BISHARA SIRHAN was displayed to BUTLER and she stated that she had never seen this individual in or about the hotel.

He has been an employee of the hotel for approximately $2\frac{1}{2}$ years. His Social Security Number is born at Santa Barbara, California.

On June 4, 1968, he worked the 3 PM to 11 PM shift in the kitchen at the Ambassador Hotel. He left the hotel at approximately 11 PM on June 4, 1968, and he did not return to the hotel until just before 3 PM on June 5, 1968.

He heard of the shooting of Senator ROBERT F. KENNEDY at approximately 2 AM on June 5, 1968. He heard of this while watching television.

He has seen photographs in the newspapers of SIRHAN BISHARA SIRHAN and has also observed this individual on television. Prior to seeing SIRHAN's photograph in the newspapers, he did not at any time observe this individual. He was shown a photograph of SIRHAN.

Concerning the information received by the FBI that one of the waiters in the Venetian Room received a \$20.00 tip from SIRHAN B. SIRHAN, CAPELS was unable to furnish the name of the waiter nor did she have any knowledge that any of the waiters had received a \$20.00 tip.

He was working at the Ambassador Hotel from 5:00 p.m. on June 4, 1968, until 1:00 a.m. on June 5, 1968, as a room service waiter. Sometime after midnight while he was in the area where the waiters put in their orders for room service, he heard four to five pops which he thought were balloons popping. He later learned that these were shots. He was not a witkess to any of the incidents surrounding the shooting of Senator KENNEDY. CARDENAS was shown a photograph of SIRHAN SIRHAN and advised that he had never seen the man.



HENRY ESTRADA CARRILLO, Room Service Manager, Ambassador Hotel, 3400 Wilshire Boulevard, Los Angeles, California, advised he resides at 2967 West San Marino Street, Los Angeles, and has home telephone number 383-7575.

CARRILLO advised at about 12:20 a.m., on the morning of June 5, 1968, he was sitting at his desk in the Room Service Office, when he heard what sounded like a gun shot from the Embassy Room Service Pantry. About one second later he heard a second shot and after about a two second delay, a series of about six shots. Immediately after hearing the series of shots, he ran through the kitchen employees' dining area and as he approached the entrance way into the Embassy Room Service Pantry, he observed one JUAN ROMERO, a hotel employee, holding Senator ROBERT F. KENNEDY in his arms. He recalled that Senator KENNEDY was lying on his back; however, he was unable to furnish any other details concerning that immediate area.

CARRILLO started back toward his office to call an ambulance, at which time he observed a tall heavy Negro man, whom he later learned was ROOSEVELT GRIER, leaning against a steam table with his hands against his head saying, "Oh no, oh no", several times. About six feet away from GRIER were three or four persons wrestling with an unidentified person. All CARRILLO could see was this unidentified person's arm waving a pistol with the surrounding persons attempting to grab the gun. At this time, many people began to converge on the area from the main lobby of the hotel and the Embassy Room.

CARRILLO finally ran back to his office, and as he arrived there someone was using his telephone. Therefore, he ran back to the Embassy Room Service Pantry

and observed several individuals, including KARL UECKER, Maitre d', EDDIE MANASIAN Assistant Maitre d', and ROOSEVELT GRIER attempting to protect the individual who was waving the pistol several minutes before. stated that he attempted to get a look at the individual but could not due to the crowd of people around him.

At this time, NIWA YOSHIO, cook at the hotel, told CARRILLO that he should go get some rope in order that the above individual could be tied up. He ran to his office and obtained a segment of rubber extension cord and returned to the pantry. An unidentified person took the cord from him, then due to the fact that he was very nervous, CARRILLO returned to his office.

About three to five minutes later, he returned to the pantry and observed three uniformed Los Angeles Police Department officers escort the individual CARRILLO observed waving the pistol in the Embassy Room Service Pantry out of the pantry and into the Colonial Room located adjacent to the east end of the pantry.

CARRILLO furnished the following description of this individual:

CARRILLO observed a photograph of SIRHAN BISHARA SIRHAN and stated it very closely resembled the individual he saw escorted from the Embassy Room Service Pantry after Senator KENNEDY was shot; however, he could not positively state that the above described person was SIRHAN BISHARA SIRHAN.

She advised that on June 4, 1968, she was working in the room service area at the hotel taking telephone orders and acting as cashier. At approximately midnight, Senator ROBERT F. KENNEDY, his wife and group of about eight people, came to the kitchen area enroute to the Embassy Room. She recalled that a television cameraman was taking films of KENNEDY as they passed through the kitchen. She stated Senator KENNEDY stopped at her area and shook hands with JEAN ABSTON, CHARLES SIEBERT and herself and continued on to the Embassy Room. She stated that approximately one half hour later she heard what sounded what sounded like four shots, although the noise was not too loud. She next noticed EDDIE MANASIAN the banquet captain, run in the direction of the Embassy Room. Mrs. CASE advised she followed MANASTAN and as she neared the chef's office, she noticed a large crowd gathered in the service kitchen area and heard someone say, "They shot him".

She advised she saw Senator KENNEDY lying on the floor, but only observed him from the waist down, as he was surrounded by a large group of people. She stated she never did see the man who shot Senator KENNEDY and after a few minutes, returned to the room service area.

She advised that the police officers and ambulance arrived about that time and she observed them take Senator KENNEDY along with another man and woman on stretchers past her area and put them on the freight elevator. She was unable to furnish any additional information concerning the shooting.



He advised he was present in the Embassy Room on several occasions, but when displayed a photograph of SIRHAN BISHARA SIRHAN, he advised he had never seen this individual in or about the hotel.

LUIS ALBERTO DEL MORAL, 3184 West Eighth Street, Los Angeles, California, no telephone, was interviewed at the Ambassador Hotel where he has been employed as a banquet houseman for approximately ten years. He furnished the following information:
His Social Security Number is He was born at Cabezas, Nicaragua.
On June 4, 1968, he began work at the hotel at approximately 3 PM and continued to work at the hotel until approximately 1 AM on June 5, 1968.
He was working with JUAN M. ANGUIANO in the Regency Room of the hotel at approximately 12:15 to 12:30 AM on June 5, 1968.
Just before 12:30 AM, a man came running into the Regency Room and asked them where he could find a public telephone so that he could make an emergency call. This individual was carrying KENNEDY hand-out materials in his hand and was very upset and excited. DEL MORAL told this man that there was no phone in the Regency Room and he would probably find one in the lobby. A few moments later, he observed that this same individual was being held by the arm by one of the uniformed security officers employed by the hotel. He advised that the security officer was a Negro male and he believes that he had an Ace Guard Company uniform. He described the individual who came in looking for a phone as being a White male, 21 to 23 years, dark wavy hair, olive or tan complexion, wearing sweater (color not recalled), gray pants, and a white or blue shirt.
Shortly after this incident, he heard that Senator ROBERT F. KENNEDY had been shot near the Embassy Room.
He was shown a photograph of SIRHAN BISHARA SIRHAN and

he advised that he has seen SIRHAN's photograph in the newspaper as well as having seen SIRHAN on television. He stated that he does not recall ever having seen SIRHAN at any time prior to

PEDRO DIAZ, waiter, Cocoanut Grove, Ambassador Hotel, residence address 875 West 23rd Street, Los Angeles, telephone 747-4965, advised that he was on duty from 5:00 p.m., June 4, 1968, until 1:00 a.m., June 5, 1968, and said at no time during the evening did he have occasion to visit the Embassy Room.

DIAZ recalled that a busboy informed him at approximately 12:20 a.m., that a shooting had occurred in the Embassy Room, but made no mention of the fact that one of the victims of the shooting was Senator ROBERT F. KENNEDY. He stated that he left the hotel at approximately 2:30 a.m., and did not stop in the kitchen area prior to departing.

DIAZ was thereafter displayed a photograph of the subject, SIRHAN BISHARA SIRHAN, after which he advised that he had never seen this individual in his life.
