"June 11, 1968 "Los Angeles, California

"I, Rogelio Diaz, give the following free and voluntary statement to Robert E. Sage, who has identified himself to me as a Special Agent of the F. B. I. I have been advised that I do not have to make a statement and any statement I do make can be used in a court of law. No promises or threats have been made to induce me to make this statement.

"I am 37 years of age, having been born June 10, 1931, at Mexico City, Mexico. I reside at 3315 Andrita Street, Los Angeles, California, with my wife MARIA, and three children. I am employed as a bus boy at the Ambassador Hotel, 3400 Wilshire Boulevard, Los Angeles, and have been so employed for the past ten years. I can read and write the English language.

"On June 4, 1968, I came to work at 5:00 p.m., and was working out of the kitchen covering primarily the Embassy Room and the Colonial Room. About midnight on June 4, 1968, I was standing between the pantry and the kitchen when I observed Senator Robert F. Kennedy, accompanied by his wife and a number of other people walk through the kitchen area and go into the Embassy Room where Senator Kennedy gave a speech.

"About twenty to twenty-five minutes after entering the Embassy Room, Senator Kennedy came back out of the Embassy Room into the pantry

> I was standing between the pantry and the kitchen, about ten to fifteen feet from Senator Kennedy when I heard several loud noises which sounded like shots. At that time Senator Kennedy was shaking hands with the two cooks and I saw him double up and fall backwards to the floor. A large crowd of people immediately gathered around him and then I saw three or four men wrestling with a man who had a gun in his right hand. The man with the gun was standing about eight or ten feet from Senator Kennedy and was a young man about twenty or twenty five years of age. He was wearing a blue sports coat. just got a glimpse of the side of the man's face and could not identify him from that quick glance other than to say he was a young man. also noticed the man had a lot of black hair which appeared uncombed. The only man I recognized who was wrestling with the man was Carl Yucker, the banquet captain. I recall seeing the same man about twenty minutes prior to that time as he was walking into the Colonial Room. was alone and I only saw him from the rear, but I recognized him because of the same blue sport coat.

"The men who were wrestling the man with the gun were near the steam tables and they finally got the man on the steam table and held him down. My attention was then directed again to Senator Kennedy who was lying on the floor. I saw blood on his stomach and on the right side of his head. Then the crowd of people moved in around Senator Kennedy and I didn't see him anymore. I then returned to the kitchen area and did not see either Senator Kennedy or the man with the gun again.

"I have seen a photograph of Sirhan Sirhan and I do not know him. Further, I can not positively say he was the same man I observed with the gun the night Senator Kennedy was shot. I do not recall ever seeing anyone resembling Sirhan Sirhan in or around the hotel

ANDREW DIVYAK, Chief Steward, Ambassador Hotel, 3400 Wilshire Boulevard, Los Angeles, California, was interviewed at his place of employment and furnished the following signed statement:

"Los Angeles, California 6/13/68

"I, Andrew Divyak, Chief Steward, Ambassador Hotel, 3400 Wilshire Boulevard, Los Angeles, California, voluntarily furnish the following signed statement to Special Agent of the Federal Bureau of Investigation, JC Fishbeck, Jr., who has identified himself by display of his credentials.

"I reside at 758 South Ardmore Street, Apartment 602, Los Angeles, California, and have no home telephone. I am single and have never been married. I have been employed by the Ambassador Hotel since 1950, except for a short period of time from late 1965 until April, 1966. From 1950, until late 1965, I was employed as Purchasing Agent, and since April, 1966, I have been Chief Steward at the Ambassador Hotel.

"I was born January 30, 1918, in Hibbing, Minnesota and have resided in Los Angeles, California since 1943. I am five feet eleven inches tall, weigh 170 pounds, and have been issued Social Security Number

"I recall the following events that occurred in the Ambassador Hotel during the late evening hours of June 4, 1968, and the early morning hours of June 5, 1968:

"Shortly before twelve o'clock midnight on June 4, 1968, I was sitting in the kitchen employees' dining room adjacent to the Embassy Room Service Pantry. I was sitting with Jesus Perez, hotel employee, and a hotel security guard whose name I do not recall. As we sat at the table, I saw Senator Robert F. Kennedy and other persons walk through the dining room and proceed to the Embassy Room.

"I remained at the dining table figuring my work schedule when at about 12:15 a.m., June 5, 1968, I heard what sounded like three firecracker explosions. About two seconds later, I heard a burst of about six more firecracker explosions. As best I can recall, there was about one second delay between the first and second explosion, and about the same length of time between the second explosion and series of about six bursts. I looked up to see what made these noises and saw small lines of smoke coming from the Embassy Room Service Pantry.

"Immediately I arose from the table, ran into the pantry, and stood next to a metal tray stand across from a row of chrome steam tables. I saw two white male Caucasians wearing Kennedy campaign sportcoats and top hats standing on each side of a slender built male who appeared to be of Cuban descent standing against the steam tables. This person waved a pistol with his right hand, thus I yelled out to the effect, let's get him. The two men in the Kennedy campaign clothes grabbed the person waving the pistol before I did, and in the confusion, someone jumped ahead of me before I could reach him. However, I was able to observe his face and the pistol he held in his hand.

"By this time, several persons had shoved the above person against the steam tables, and had him sprawled over the table; but he was still waving

the pistol. I ran around to the other side of the steam tables in attempt to get the gun but too many people blocked my path. As I turned, I observed Senator Robert F. Kennedy lying on the floor of the Embassy Room Service Pantry. I ran to the Room Service desk to call for an ambulance; however, the phone was being used. I then ran to the Room Clerk's Office in the main lobby, but his telephone was also in use. Unable to locate an unused telephone, I ran back to the Embassy Room Service Pantry.

"Senator Kennedy was still lying on the floor; however, the person waving the gun had been moved down to the east end of the Service Pantry and was being held against the steam tables. I walked down toward where the individual was being held and saw Karl Eucher, Maitre D'Hotel, and Eddie, last name unknown, Assistant Maitre D', along with a tall heavy Negro in a maroon sportcoat, holding this individual against the steam tables.

"Eddie asked me to go get some rope in order that they could tie this individual up. I turned to go find some rope, however, I saw some Los Angeles Police Department officers enter the pantry. From that point, I assisted the police department and ambulance crews load the wounded indivudals (total of four including Senator Kennedy), onto the service elevator and out of the hotel.

"I did not observe the police officers take the above individual who waved the pistol from the Embassy Room Service Pantry; however, as stated, I did observe him when I ran into the Pantry after hearing the above described explosions. The following is a physical description of that person:

"After assisting the police and ambulance crew with the last person to be taken to the hospital, I secured my work schedule and waited until about 1:50 a.m., at which time I gave a Los Angeles Police Department officer my name and address for future reference.

"I have been shown a photograph of Sirhan B. Sirhan and positively identify it as that of the above described person whom I saw waving a pistol in the Embassy Room Service Pantry about 12:15 a.m., on June 5, 1968, and who I attempted to apprehend together with several other persons in the room. have seen Sirhan B. Sirhan's photograph in the newspapers and it is also the same person I have previously described on page five of this statement.

"I have read the above six page statement and it is true to the best of my knowledge.




