А б And I'd like to direct your attention, if Q 6 7 I may, to the election, June 4th, 1968; did you have occasion to work or go to the Ambassador? 8 I had occasion to go to the hotel. A 9 Did your father call you up? 10 Q Yes, he did. A 11 Did he tell you, in effect, that the 12 Q 13 Senator was there? But then finally, when the Senator came, he asked if I would help hold the people back, and I, you know, I helped them do that.

Q How did the Senator come in to the platform for his -- we will call it his acceptance speech?

A He came from -- when I saw him, I saw him from here. I had moved over to about here.

Q Will you put D-2 to where you went to? A To here (indicating). There was very many people in this area, and I would say thirty, forty people in that area.

Q You know the employees. These were other than employees?

A Yes, these were other than employees, just people that were there at the time.

When I saw him coming from here, I moved back to my stationary position.

A 1 Q About how long did that last 2 As near as I can figure, between ten and A 3 fifteen minutes. 4 Q You stayed in the general area of the pantry. 5 at S-1? 6 7 I stayed at S-1 the whole time of the speech. A What happened when the Senator completed his Q 8 talk? 9 Mr. Minasian was down there, and at the last A 10 moment he decided -- or I don't know who decided, actually 11 but he told me that they were going to take him behind the 12 stage into the Conference Room -- they wanted to hold a 13 press meeting -- instead of bringing him directly down-14 stairs. 15 Q What happened? 16 They proceeded to take him from the podium A 17 behind through the stage room, through this door -- there 18 is actually no door -- it's just an opening. 19 Were there curtains there, do you recall? 20 Q I don't recall. 21 A He went into the hall and down this incline. 22 There is a ramp there? 23 Q Well, it's just a little bit of an incline, 24 A and he walked through here. 25 At that moment I walked from the door to the 26

Senator's side. 1 That's Senator Kennedy s side? Q 2 Yes. 3 A And I got as close as I could possibly get, which was maybe three feet, and I walked with him up to 5 6 here, up to the S-2, up to the swinging doors ... 7 Right. 8 This door at the time was pushed open.
