Would you Q 7 put "R.F.K."? 8 (Whereupon the witness complied with the 9 request of Mr. Howard.) 10 Q· We are keeping you with the color red so if 11 we have other colors, you will be red. 12 Right. 13 A How close did -- we will call him the 14 0 suspect -- get to the Senator? 15 It couldn't have been more than six feet. 16 17 It was impossible to be more than six feet away from him because Mr. Uecker was almost right next to him. He was 18 19 pushing the crowd back. How close to the Senator was the suspect 20 Q 21 when this gun started firing? Four feet -- four to six feet. 22 A. 23 Q What did he do? He kind of went around Mr. Uecker, and he 24 Α from here -- he looked like -- though he pulled his hand 25 out from here and came around. 26

And when he stuck the gun, he looked like 1 he was on his tiptoes because he wasn't that tall. 2 Mr. Uecker is quite huge, and he tried to 3 get Mr. Uecker out of the way, and he shot him. 4 Q How close to the Senator were you at the 5 time of the first shot? 6 7 The same amount of distance, five feet. Q And how many shots were fired? 8 9 A I heard five distinct shots. I could swear to five, but --10 Could there have been more? 11 12 There could have been. I don't know if the A 13 confusion -- I was standing behind there -- the next thing I knew, I had blood all over my face and my glasses. 14 15 And then the man that got shot in the head 16 fell in my arms. 17 And then the other boy that got shot in the thigh, he fell on top of me, and they pushed me down, they 18 fell on top of me. 19 Did you see what happened to the Senator before 20 Q 21 you went down? He was on his way, falling -- he was falling 22 Α 23 down. The first shot, he kind of reared back very, $\mathbf{24}$ very sharply. 25 Did you see any movement of the Senator's Q 26

Do 0 15 you know that person by name? 16 No. sir. According to the papers, the 17 Α first name is Paul. I don't know his last name. 18 You wouldn't know it? Would you describe 19 Q him by size? Did he appear to be quite large? 20 Yes, sir, he was, and --21 A 22 MR. HOWARD: May I approach the witness --THE FOREMAN: Go right ahead. 23 MR. HOWARD: -- Mr. Foreman? May we mark, with the 24 Foreman's permission, as Grand Jury Exhibit 9, a 25 photograph of a patient in the hospital? 26

96 THE FOREMAN: Permission granted. 1 Q BY MR. HOWARD: I'd like to show you Grand 2 3 Jury Exhibit 9, if I can. Are you familiar with the person depicted 4 5 in that photograph? Yes. It looks like --6 A 7 Does this appear to be the person that you Q have identified by a first name and as a heavy set 8 individual, to your knowledge, shot in the head --9 10 Yes, sir. A 11 Q -- and fell upon you? 12 Will you return to your seat, please? 13 (Whereupon the witness complied with the 14 request of Mr. Howard.) 15 As near as you can, will you recall for Q 16 the Jury the events immediately after the shooting? What 17 happened? How did the crowd react, what you saw, and 18 with particular reference to the person identified as in 19 3-A and 3-B? 20 Well, the suspect turned almost immediately; 21 Α and after all the shots were fired, he was trying to 22 23 escape. He was trying to escape. He tried very, 24 very hard to get away. 25 But Mr. Rafer Johnson -- and by this time 26

Mr. Grier and Mr. Uecker vere all holding him against the 1 heater. It's the stainless steel table. 2 And people were trying -- were hitting him 3 and cursing at him, and it was utter confusion. I mear. 4 5 everyone was trying to kill him. There were very few -- at that time there 7 were only four of us around the Senator. There was -- the 8 busboy was holding his head, another gentleman with glasses, and myself, and two other people on the other 9 10 side of him. 11 And we were trying to, you know, see if 12 we could help him in any possible way. 13 But all we could do was unbutton his shirt and see -- try to get the people back. 14 At that time Mr. Unruh pushed me out of the 15 way, and at that time I tried to help keep the suspect 16 subdued, but it was, you know -- wasn't really worth it 17 because everyone else grabbed him already and were beating 18 19 up on him. But he was apprehended at this time? Q 20 Yes, almost instantly. А 21 Did some police officers arrive? Q 22 Yes, they did, but at the time involved, Α 23 I have no idea. 24 The passage of time? 25 Q The passage of time, I have no idea. A 26

MR. HOWARD: With the Foreman's permission, may we 22 mark and envelope and content, the revolver, as Grand 23 $\mathbf{24}$ Jury Exhibit 7? Permission granted. 25THE FOREMAN: MR. HOWARD: We have just gone through it, Mr. 26

He A 7 tried to stop me. And then one of the waiters recognized me 8 and he said, "It's all right. He is with the hotel." 9 10 So there was some type of control? Q 11 Yes, sir, there was. A 12 Internal? Q 13 Yes. A But from your observation, was it effective? 14 Q Was the area kept clear of people? 15 It was congested with people. 16 А No. 17 MR. HOWARD: That's all we have. 18 THE FOREMAN: Any further questions? HOWARD: 10 11 Q Can you hear me all right, Mr. Goldstein? 12 А Yes. 13 Q If you get in any distress or pain, will you te 1 us? 14 15 A No, I feel fine. 16 Will you tell us your age? Q .17 А I am nineteen and a half. 18 Q Your business or occupation? 19 Α I am a news reporter for Continental News. 20 Q May I direct your attention to election 21 evening and the early morning of July 5th. That would be 22 Tuesday night -- I'm sorry -- June 4th and June 5th. 23 Were you at the Ambassador Hotel? 24 A Yes, I was. 25 Were you there at the -- we will call it Q the Kennedy celebration? 26

Yes. Α 1 And did the Senator arrive? I looked at my watch. 7 Are we talking about the area of the Embassy Q 8 Room, is that correct? 9 Α Yes. This was the podium that was set up 10 for his television broadcast. 11 And he arrived and did address his following Q 12 there, is that correct -- a correct statement? 13 Yes, right. Α 14 Where were you at the time of the address? Q 15 At the time of the address, I was walking A 16 around, looking at a monitor. I stood on a table for a few 17 minutes, trying to see if I could see him. 18 And then someone mentioned that there was 19 sandwiches in the kitchen for the press, so I hadn't had 20 dinner, so I walked into the kitchen to see if I could 21· find them. $\mathbf{22}$ I walked to the end of the kitchen and 23 I didn't see anything. 24 In fact, I didn't even see this man here 25 (indicating). 26

A 8 Did you perhaps do something at this time Q 9 or attempt to go up and shake his hand? 10 Well, we were walking by him. This young Α 11 lady I was with, she shaked his hand. The Senator's 12 eyebrows kind of raised when he saw her. 13 I was about to shake his hand, but he was 14 moving too fast, so he just passed by. 15 He passed by? You were going in opposite 16 0 17 directions? We were walking towards each other. 18 А 19 Q And you passed him? 20 Α Yes. What occurred next? 21 Q Well, about five or ten seconds after I 22 A passed him, I started hearing gunshots. 23 At first, I thought they were balloons just 24 There were a lot of balloons around. 25 popping. About the second or third shot, I realized 26

A 21 And did you receive medical treatment for Q 22 that? 23 Yes, I did. Α $\mathbf{24}$ Before we go into that, how many explosions 0 25 or shots or sounds did you hear? 26

А A minimum of five. I can't ---1 Q Could there have been more? 2 Yes, I know there were more. A 3 Q But you can recall at least ---I can recall at least five. What happened to him?" 2 And this woman walked by, and she said to 3 me, "How dare you talk about my husband that way," and 4 she slapped me across the face. 5 And I said, "I am sorry, lady, but I was 6 I'd like to know how the Senator was -- " or shot, too. 7 " -- is." 8 And she said, "Oh, I am sorry, Honey," 9 This was Mrs. Ethel Kennedy. and kissed me. 10 At that time she was not in tears. A 15 Did you see some police officers arrive?
