Mr. GIIMAN KRAFT in response to attempts to contact him personally, December 12, 1968, phoned on December 13, 1968, and advised the following:

Mr. KRAFT is associated with, "Performing Arts", a theatrical program publication, 1915 Beverly Boulevard, Los Angeles, telephone 386-8791. He resides at 401 St. Cloud Road, Bel Air, California, telephone 467-4755.

Mr. KRAFT said at the time of the assassination of Senator ROBERT F. KENNEDY, he was in the lobby outside the Embassy Room at the Ambassador Hotel in Los Angeles and had not observed the shooting of Senator KENNEDY or any of the immediate aftermath in the vicinity of the shooting. Mr. KRAFT first became aware that something unusual had occurred when he observed persons who appeared to be excited and distraught running into the lobby from the Embassy Room. His attention was particularly drawn to a young man who was running and who hurdled a couch. This person was a male caucasian in his early 20s, about 6'2" in height, long blond hair and fair complexion, dressed in a casual shirt and slacks. Mr. KRAFT said he had reported this observation to the Los Angeles Police Department at the time. After learning what had occurred with respect to the assassination of Senator KENNEDY, Mr. KRAFT said that he had no reason to believe that the young man who he had seen running in the lobby, described above, had anything to do with the assassination. The young man who appeared to be distraught and excited was not known to Mr. KRAFT and the latter said that he would be unable to identify this young man at this point.

Mr. KRAFT said he had no recollection of ever seeing SIRHAN SIRHAN and had never heard of him until he was charged with the shooting of Senator ROBERT F. KENNEDY.

Mrs. MURIEL LEE, 1100 South Bradshaw Street, Monterey Park, California, was interviewed at her place of business, Constitutional Rights Foundation, 609 South Grand Avenue, Los Angeles.

Mrs. LEE advised that she was present at the Ambassador Hotel, 3400 West Wilshire Boulevard, Los Angeles, on the night of June 4, 1968. Mrs. LEE stated she spent some of the evening in or near the kitchen area of the hotel. She stated that she was in the Embassy Room of the hotel during Senator KENNEDY'S speech, but she left the room just prior to the end of the Senator's speech in order to get a drink of water.

Mrs. LEE advised that she as returning to the Embassy Room by way of the kitchen when she heard shots. She stated that she knew PAUL SCHRADE and she saw him fall as the shots rang out. Mrs. LEE advised that she saw a group of people taking a gun from the hand of a person later identified as SIRHAN B. SIRHAN. She stated that as SIRHAN was being escorted from the area she attempted to strike him with her purse.

Mrs. LEE advised she could positively identify SIRHAN B. SIRHAN as being the person from whom a gun was taken soon after the shots were fired.

Mrs. LEE stated she was close enough to the shooting to observe Senator KENNEDY on the floor, and she thought that the Senator was dead.

SIRHAN at any time prior to when she saw him being led away by police after the murder.

KENNEDY's Presidential campaign in the Indiana, Oregon and California primaries. He advised he was in the Embassy Room of the Ambassador Hotel, Los Angeles, Calif., on the evening of the assassination and heard Senator KENNEDY's talk. He advised he remained in the Embassy Room after Senator KENNEDY and his pafty departed and a short time later, heard a commotion toward the rear of the room and heard someone say that Senator KENNEDY had been shot. He stated he did get back to the area sometime later and saw the person believed to be SIRHAN SIRHAN being escorted away. 



On November 27, 1968, KATHY TAYLOR, 26 S.E. 71st Street, Portland, Oregon, stated that she was with the Scnator ROBERT F. KENNEDY Campaign as a "Kennedy Girl," and is now employed by Meior and Frank Company in Portland.

She said she joined the campaign in April of 1968, when the Senator came to Oregon with his campaign, and almost constant companion with her during the campaign was CECI DOUCET, Martha Washington Apartments, 1802 S.W. 10th, Portland, Oregon. She and CECI remained with the campaign until the day after Senator KENNEDY was assassinated, they then returned to Portland, Oregon.

She said she did not know SIRHAN BISHARA SIRHAN, and did not see him at the hotel on the night of June 4, 1968. She was not aware of a conspiracy uponther life of Senator ROBERT F. KENNEDY and has not heard of one since the assassination took place.

She said the afternoon before the assassination she was filling balloons with helium in the Embassy Room of the hotel, and placing them around the speaker's podium in preparation for the speech that night. It was during this time that she had occasion to notice any strange activity at all. She said a dark skinned man, not SIRHAN, who was about 5'7" tall, stocky build, dark brown hair, wearing a white hat similar to a chef's hat, and a white waiter's style coat, made several trips into the Embassy Room. She felt this man was employed by the hotel. This man did not say a word while in the room even though she spoke a greeting to him on at least two occasions. Since he did not return her greeting she assumed that he did not speak English. She saw this can only in the afternoon and could not furnish a better description. The man seemed very inquisitive during his trips into the room even though he did not speak.

She said she was in the Embassy Roon when Senator ROBERT F. KENNEDY was shot in the corridor outside. When



It is noted that the Mr. AOYAMA interviewed subsequently has the first name of AKIRA, but since he is obviously the individual referred to above as M. AOYAMA, apparently there was a mistake made by the individual registering him at s the hotel initially.

A United States intelligence agency which conducts investigations abroad advised that on October 10, 1968, AKIRA AOYAMA, Chief, Planning Division, Misshin Hodo KK, #3, 2-chome, Nihonbashi-Kaomi-cho, Chuo-ku, Tokyo, Japan, was interviewed and stated that he, along with MORINAGA and HIRANO, arrived at the Ambassador Hotel, Los Angeles, California, at approximately 2340 hours on June 4, 1968. They checked in at the front desk and went directly to their separate rooms. He AOYAMA) stayed in his room for only a few minutes and went to HIRANO's room where the three (HIRANO, MORINAGA and AOYAMA) met to discuss their plans for the following day. After that discussion, interviewee returned to his room where he stayed for a few minutes, then went downstairs to the lobby. There he found everything in a state of confusion. He did not understand what was taking place because he did not understand English. The next day Mr. MORINAGA, who understands English, told him what had happened, and said that he (MORINAGA) had watched television in his room after the aforementioned meeting had been completed and the others had departed.

AOYAMA was unable to provide any information regarding the assassination of Senator KENNEDY. AOYAMA denied that he had ever seen SIRHAN and said he knew nothing about him. AOYAMA advised that Mr. HIRANO recently had an eye operation and was recovering in the Hagiwara Hospital, Tokyo, Japan.

The source advised that on October 14, 1968, HIROSHI HIRANO, Vice President, Nisshin Hodo KK, was interviewed and related substantially the same information as that provided by AOYAMA. HIRANO said he did not know SIRHAN and denied that he had ever seen him. He was unable to provide any information pertinent to the assassination of Senator Robert F. Kennedy.

The source advised that on October 24, 1968, TAMETAKA MORINAGA, Chief, President's Office Staff, Nisshinseito XK, was interviewed and related substantially the same information as that provided by AOYAMA and HIRANO. He said that he did not know SIRHAN and denied that he had ever seen him. MORINAGA was unable to provide any information pertinent to the assassination of Senator Kennedy.

Date December 2, 1968

Mrs. Pear's Baggs, 1114 East 34th Street, Brooklyn, New York, stated that in June, 1968 she was on a train tour of the West and that on the night of June 4-5, 1968 she was registered at the Ambassador Hotel, Los Angeles, California. Her room was in a cottage in back of the hotel.

On the night of the shooting of Senator Robert Kennedy, Mrs. Baggs went to bed pror to the shooting and knew nothing of it until the next morning when she went to breakfast.

Mrs. Baggs does not know Sirhan Sirhan.

STEMART BLOCK was interviewed at his office at United Methodist Church, 100 Maryland Avenue, N. E., Washington, D. C., concerning the assassination of Senator ROBERT F. KENNEDY, and stated the following information:

He was present in the Rebassy Ballroom June 5, 1969, at the time of KERNEDY'S assassination, in connection with the United Methodist Church's Vietnem Education Project. Standing in the antoroom watching the television monitor, he beard three gun shots which sounded like breaking glass. Soon after hearing the shots he was approached by a heavy-set, middleaged wale who told him that KERNEDY had been shot. FLOCK thought this was peculiar since the man appeared to be calm and had a smile on his face, while others in the ballroom were confused or hysterical. The man quickly departed the ballroom through the back door which led into a lot containing television equipment. He described the heavy-set man as follows:

Dr. PHILLIP D. BONNET, Professor in the School of Hygiene and Health, Johns Hopkins University (JHU), Baltimore, Maryland, advised that on June 4, 1958 at approximately 8:30 P.M., Los Angeles time, he registered at the Ambassador Hotel in Los Angeles. He stated that this reservation was made by the American College of Hospital Administration, San Francisco, California and that he had gone to Los Angeles to attend a seminar on a hospital administration which began on June 3, 1968 and continued through June 6, 1968. Upon arrival at the Ambassador Hotel, he discovered that in addition to the seminar on hospital administration there were several other conventions and political meetings being held.

After checking into the hotel, Dr. BONNET had his dinner in the hotel and went to his room where he retired at approximately 10:30 P.M. Around 12:30 or 1 A.M. on June 5, 1958 he was awakened by someone knocking at his door and upon checking, found out that it was someone who had the wrong room. He stated that he then went back to sleep and when he awakened the next morning, he heard over his television that Senator ROBERT KENNEDY had been assassinated in the hotel. He stated that he did not see Senator KENNEDY upon his arrival at the hotel and upon viewing the photograph of SIRHAN SIRHAN he stated that he did not see anyone who resembled this picture.

Dr. BONNET stated that he has no information regarding the shooting of Senator KENNEDY and that it was quite a shock to him when he heard of it on the morning of June 5, 1968. He further stated that he had no information concerning any possible conspiracy in the shooting of Senator KENNEDY.

JAMES E. CHAPMAN, interviewed at International Business Machines Corporation (IBM), 11 South Broadway, White Plains, New York, advised that he is employed by this company as an Airlines Program Administrator and resides at 43 Old Wagon Road, Wilton, Connecticut. He furnished the information set forth below.

He was in Los Angeles, California, on IBM company business in June, 1963, and stayed at the Ambassador Hotel. When returning to the hotel by car after midnight, June 5, 1963, via Wilshire Boulevard, he was stopped by police of the Los Angeles Police Department as he drove into the hotel parking lot. While he was waiting to enter the parking lot, an ambulance left, and he later learned that Senator ROBERT F. KENMEDY had been shot and was being taken to the hospital in that ambulance. This was his first knowledge of the shooting. He observed nothing unusual on his way back to the hotel or in the vicinity of the hotel before or after the shooting.

He never heard the name, STRHAN SIRHAN, until it was mentioned by news media after the shooting as the name of the person suspected of shooting Senator KENNEDY.

Mrs. C. CLEVA, 10 Avenue Georges Mandel, Paris 16, France, advised on January 12, 1969, that P. A. CLEVA was her son.

P. A. CLEVA advised on January 12, 1969, that he and his wife had been registered at the Ambassador Hotel, Los Angeles, California, on the night of June 4-5, 1968. CLEVA further advised that both he and his wife were not at the Ambassador Hotel at the time Senator ROBERT F. KENNEDY had been shot. He stated that he and his wife had returned to the hotel some 15 to 20 minutes after the shooting had occurred. CLEVA further stated that neither he nor his wife had any information of value to furnish regarding the assassination. RICHARD ALLEN COHEN advised that he resides with his family at #3 Oak Park Court in Creve Coeur, St. Louis County, Missouri. He is a 19 year old white, male, and a junior student at the Washington University in St. Louis.

Mr. COHEN recalled his activities on June 4 and June 5, 1968, while in Los Angeles, California. He had accompanied his sister-in-law to San Diego, California, for the purpose of visiting his brother, who is in the military service and who was stationed there. Upon arriving at San Diego, California, on June 4, 1968, he decided to go on to Los Angeles bécause he had learned that former Senator ROBERT F. KENNEDY was going to make a speech there. COHEN had previously been active in campaigning for Mr. KENNEDY in St. Louis. He arrived at the Ambassador Hotel in Los Angeles on June 4, 1968, and registered for a room there at about 8:00 a.m. He remained at the hotel until 6:00 a.m. on June 5, 1968, when he returned to San Diego, California, by air and continued his visit with his brother and sister-in-law until June 10, 1968, when he returned to St. Louis, Missouri. He had remained at the Ambassador Hotel alone and his decision to go to Los Angeles had not been the result of any prearranged plan. Upon arriving in Los Angeles he contacted the headquarters of Senator KENNEDY and volunteered to work campaigning or doing anything else that he could assist in. He was given assignments to work in the Los Angeles community campaigning for KENNEDY which he did until about 1:00 on Thereafter, he reported to the Ambassador June 4, 1968. Hotel where he assisted in arranging and decorating two ballrooms at which Mr. KENNEDY was to appear. The main ballroom was located on the second floor of the hotel which also houses the main hotel lobby. A second ballroom was located on the next lower floor. During the course of the afternoon Mr. COHEN had several occasions to go into the kitchen area adjoining the ballroom for the purpose of obtaining streamers and other supplies. On these occasions he has a recollection of having seen a number of the hotel employees, who he described as "Italian-Americans' and whom he believed to be kitchen help, waiters and busboys.

Thereafter, he returned to the second floor ballroom at about 7:00 p.m. and waited there mutil Mr. KENNEDY appeared and made his speech. He recalled seeing Senator KENNEDY leave the ballroom by exiting through a door at the back of the Having worked in the ballroom during the afterstage area. noon COHEN realized that this door would probably lead through a rear exit way and down to the ballroom one flight below where Mr. KENNEDY was supposed to appear and speak to the young people and students who were working for him. Annediately after Mr. KENNEDY left the room Mr. COHEY along with the crowd exited from the ballroom through the main door into the lobby and just as he stepped through the door two men rushed out of a double swinging door tohis left leading into the kitchen area and shouted "no one is allowed in here, no one is allowed in here." They immediately took positions guarding the doors to keep anyone from entering. Mr. COMEN thought nothing about this except that he believed that Mr. KERNEDY was passing through that area of the hotel and did not want to be delayed by a crowd of people rushing in there. DENNIS, Dean of Medical Services, University of Oklahoma Medical School, Oklahoma City, Oklahoma, advised he attended a seminar on hospital administration held at the Ambassador Hotel, Los Angeles, California, June 3-6, He was a guest speaker at the seminar and upon checking 1968. into the hotel became aware for the first time that Senator ROBERT F. KENNEDY was at the hotel in connection with his campaign for the Democratic nomination for President of the United States. He stated he became aware due to the large number of people, mostly youth, in the lobby of the Hotel when he checked in. Dr. DENNIS said after dinner on the evening of June 4, 1968, he went to the lobby to watch the enthusiastic. activities of those connected with Senator KENNEDY's camp. About 11 PM he retired to his room and turned on the television to watch the results of the primary voting in California and there, for the first time, learned that Senator KENNEDY had been shot.

The next day they were informed that they would not be permitted to leave the hotel until information had been obtained from them by the Los Angeles Police Department. Since the seminarwas continuing, this necessitated no change in his plans, and a day or two later when the seminar was over, he checked out of the hotel, leaving his forwarding address.

During the time he was in the hotel, Dr. DENNIS said he did not see SIRHAN BISHARA SIRHAN and had no previous acquaintance with him. He said he had absolutely no information of any sort of any possible conspiracy in the shooting of Senator KENNEDY, and had no more connection with the tragic event than he would have had, had he been home in Oklahoma watching the proceedings on television.

He stated he had no further information concerning the event.

Krs. SAM DIEMER, 815 Walnut Street, Fairmont, W. Va., advised that it is possible that she and her husband were registered at the Anbassador Hotel, Los Angeles, California, on June 4, 1968, however, she and her husband did not arrive at that hotel on that date.

Mrs. DIEMER explained that she and her husband were on a tour conducted by the Berry Tour Srvice, which originated in Chicago, Illinois, approximately a week prior They departed Chicago via train and visited to that date. a number of places en route to San Francisco, California, where they arrived on June 1, 1968. While en route across to Arizona, some difficulty arose in the air conditioning system which allowed a considerable amount of dust to enter the train. Mr. DEMER is an asthmatic and this affected him considerably. He required the attention of a doctor while on the train and was attended by a physician for the three days that he was in a hotel in San Francisco. Because of his condition, the remainder of the tour was cancelled and Mrs. IFIER advised that she and her husband departed from San Francisco, California, on June 3, 1988, flying to Pittsburgh, Pa., and then returned to their home in Fairmont, W. Va.

MRS DIEMER advised that she and her husband knew nothing about the happenings at the Ambassador Hotel on June 5, 1968, except what they have read in the newspapers and heard on television.
