12	and the gentleman here is John Fahey, F-a-h-e-y; the
13	stenographer, John, for your information is Mr. Ron Horlacher;
14	and he's going to take this statement verbatim. Now, what
15	we're trying to do here, John, is to determine the truth
16	concerning statements made by you to members of the FBI and
17	to other members of the Los Angeles Police Department. And
18	I hope you'll be truthful with me at this time.
19	Q BY LT. HERNANDEZ: Now, on June 4, 1968, did
20	you meet a young woman at the Ambassador Hotel?
21	A Yes, sir.
22	Q Was there anything during your association with
23	that woman that led you to believe that she was in any way
24	connected with the assassination of Senator Kennedy?
25	A No, sir.
26	Q Did you tell anyone, either the FBI or other

SUBJECT: POLYGRAPH EXAMINATION OF JOHN FAHEY

#### POLYGRAPH EXAMINATION

This report covers the investigation made from September 6, 1968, to <u>September 2071968 Inclusive</u> and pertains only to the Medical Back ground and the Conspinacy potentials of the case

On June 4, 1968, John Fahey was employed as a salesman for "Cal Tek Industries," 1833 North Eastern Avenue, Los Angeles.

On June 6, 1968, Fahey was interviewed by agents of the F.B.I. and he related to them a story about a foreign-looking woman that he allegedly met at the Ambassador Hotel on the morning of June 4, 1968. Fahey's story contained many strong inferences and allegations concerning a possible conspiracy to assassinate Senator Kennedy. Fahey's statements indicated that Sirhan Sirhan, Munir Sirhan, the woman he had met, plus other unknown people were involved in this conspiracy.

Subsequent to the interview of June 6th, Fahey was interviewed by investigating officers from S.U.S. Upon completion of the second interview, it was noted that Fahey's statements were inconsistent with each other and that there were a number of discrepancies in his stories.

Investigators determined that Fahey's allegations demanded additional investigation.

On September 5, 1968, Fahey was informed that due to the many discrepancies in his statements Refeated by Reagh 4 Fx amination would be necessary in order to attempt to verify that his statements were truthful.

Fahey was asked if he would agree to take a Polygraph Test but he stated that he had already been given a Lie Detector Test by Mr. Chris Gugas, a private Polygraph Examiner. He stated that Fernando Faura had taken him to Mr. Gugas for the examination, and that the results had proven that he was telling the truth.

Fahey was again asked if he would submit to the Polygraph Examination and he consented.

Prior to the instrumental testing, Mr. Fahey was explained to regarding the functions of the instruments and the procedures that would be followed during the course of the examination. He was given an opportunity to ask questions during any phase of the test. The questions that were to be asked were reviewed with Fahey before any instrumental testing began.

## Conclusion'

During the course of the examination, physiological tracings at points where crucial key questions were asked, strongly indicate that Mr. Fahey was not being completely truthful.

Two Peak of Tension tests were administered and, in addition, two General Series tests were administered. Each of these . examinations contained a series of questions relative to the major key issues. It is this examiner's opinion that Mr. Fahrens answers with respect to the following questions are clearly indicative of deception and that his answers were untruthful.

- (Q) Is there anything concerning the story you have told the FBI that you honestly know is not true?(A) "No."
- (Q) Since Senator Kennedy was assassinated, have you lied to any police officer?
- (A) "No."
- (Q) Have you ever seen Sirhan Sirhan in person?
- (A) "Yes."
- (Q) Did you lie to the FBI about what happened on June 4, 1968?
- (A) "No."
- (Q) Other than pictures of Sirhan, have you ever seen him in person?
- (A) "Yes."
- (Q) Did any woman tell you of a plan to assassinate Senator Kennedy on June 4, 1968?
- (A) "Yes."

(Note: Fahey answered truthfully when asked the following relevent questions: (1) Do you honestly believe that you have ever seen Sirhan Sirhan in person? Answer: "No." (2) Do you honestly believe that you have ever seen Munir Sirhan in person? Answer: "No.")

Upon conclusion of the Polygraph Examination, Fahey was informed that his responses to certain questions indicate that he was purpose of going over all his previous statements and correcting those areas which were wrong.

Fahey's complete statements at the time of the Polygraph Examination on September 5, 1968, are contained in tape #29593 and are in file at S.U.S.

During the preliminary phase of this interrogation, Fahey continued to be untruthful with investigators and was being evasive in his manner of answering questions which were being asked. Ultimately, however, Fahey did admit that he had been mislead by Fernando Faura and others, and he stated that he had not been completely truthful in his first reports to the FBI and the Los Angeles Police Department. He stated that he knew that many portions of his previous statements were not truthful.

Fahey explained that in his mind, he had been "romanticized" by Fernando Faura. He stated that he knew he had never seen Sirhan Sirhan or Munir Sirhan in person. He explained that when he was shown the photographs by the FBI, he knew then that at that time he told the FBI that the persons looked very much like Sirhan and Munir Sirhan, but he did so knowing that the persons he saw at the Ambassador Hotel on the morning of June 4, 1968, were not the Sirhan brothers.

Fahey related that as a matter of fact, nothing had happened during his association with the unknown woman that lead him to believe that she was in any way connected with the assassination of Senator Kennedy. He indicated that at the time he was first interviewed, he could have erroneously misled the FBI because at the time he was excited and had a fear inside him due to the events that took place. He said that when the girl made statements to him reflecting her bad taste towards Senator Kennedy, it was ordinary political conversation and that there was really nothing that she said that would lead any reasonable person to form a belief that she was connected with Kennedy's assassination.

He stated that he did go riding with the girl in his car and that when he stopped along side the highway, a blue Volkswagon pulled behind his car but the driver said nothing to him or did anything to him in a threatening manner. He described the female that was with him on that day as a "nutty" person that could have been a Hippy. When asked if there was anything that happened to him on June 4, 1968, that in his mind might have even the slightest connection with the assassination of Senator Kennedy, Fahey answered, "No sir, nothing happened."

He said that when he first went to see Fernando Faura he explained the story about being with a lady. He related that Faura took him to the San Fernando Police Station and that he was actually lead to believe that Faura was part of the police department. Faura interrogated him at great length and Fahey stated that as a result of these interrogations and statements made to him by Faura, he was lead to believe that the girl that he had been with was the polka dot dress girl, and was the girl the police were looking for. He said that he became excited and became afraid and appalled about the situation. Faura, at a late date, again took him back to the San Fernando Police station and introduced him to a Lt. Stein. Stein and Faura used an Identi Kit and put together a description of the girl. They then took the composite to a Hippy artist who drew the girl in color. Later, snap shots were made of this girl and Fahey states that Faura has been showing these snap shots to different witnesses ever since. Fahey also related that he was taken to a hypnotist by the name of Dr. LaScola, who was supposed to have hypnotized him.

We stated that Faura also told him that a Maitre'd' by the name of DiPierro had identified the snap shot of the girl as being the polka dot girl. Fahey stated that all these different transactions continued to strengthen his belief that he actually met the girl in the polka dot dress. He said that towards the end, Faura kept saying to him that the girl he had been with was the polka dot girl and kept telling him that additional witnesses had identified her picture. Fahey further stated that Faura had also taken him to a private polygraph examiner by the name Chris Gugas, who had given him a polygraph test. Upon the completion of the test, Mr. Gugas told Fahey that he was telling the truth. The following Sunday, Faura called Fahey at home and informed him that he had passed the polygraph test like a champion.

Fahey was asked by investigating officers whether he had answered all the questions truthfully. He said there were two questions he remembered lying about. 1. When he was asked if he had told the truth to the FBI, and answered "Yes." 2. When he was asked did you tell the truth to the Los Angeles Police Department, and deliberately attempting to deceive the examiner. He was told that he could not honestly say he had ever seen Sirhan Sirhan or Munir Sirhan in person.

Further, Fahey was advised that his answer to questions concerning being told of a plan to assassinate Senator Kennedy clearly showed that he was also being untruthful in this respect.

Mr. Fahey claimed that he had never told anyone that he had actually seen Sirhan or Munir in person. He claimed that he told the FBI that the men he had seen at the Ambassador Hotel on the morning of June 4, 1968, had a strong resemblance to the photographs which were shown to him.

Examiner informed Fahey that regardless of who he thought the people at the Ambassador looked like, he knew that they were not Sirhan or Munir and should have told the FBI at the time. Fahey answered, "Yes, sir, you're right."

Investigating officers interviewed Paul Woo at his place of business, "Ken Aire Inc.," 7965 San Fernando Road, Sun Valley, on September 16, 1968 at 10 A.M. Mr. Woo is the purchasing agent for his company and stated that he recalled meeting John Fahey on at least two and possibly three occasions.

Woo states that on April 16, 1968, he met John Fahey, who introduced himself as a salesman for "Cal-Tek Industries" at 1833 North Eastern Avenue, Los Angeles, California.

Woo recalls purchasing some chemicals from Fahey on April 16 and remembers that on April 18, Fahey returned to his office. Woo recalls that he introduced Fahey to someone from the store's department of his company who purchased some rust preventatives and other miscellaneous merchandise from Fahey on that day.

Woo states that the last time he remembers seeing John Fahey was on or about May 15, 1968. He recalls that when he looked up from his desk, he observed Fahey standing in the doorway leading into his office.

Fahey had come to the office with another man whom Fahey introduced to Woo as Fernando Faura, a stocky man wearing a gray jacket and glasses. Fahey told Woo that his friend wanted to write a story on the "China Airlines" and Woo stated that he became curious about why Faura wanted to write this story, and he asked Faura who he worked for.

He recalls asking for Faura's credentials and that Faura produced an identification card with the words "Police Press" written on it.

Woo informed Faura that he knew nothing concerning the China Airlines and shortly thereafter Fahey and Faura left together.

This interview is in regards to the John Fahey conspiracy. Fahey alleged to have gone to the hotel on June 2, 1963 between the hours of 11:45 A.M. and 12:10 P.M. He later changed his statement, saying he had not been there on that date at all.

Mrs. Ricketts is the manager of the Burbank Motel and also resides at that location. She recalls that Fahoy was at the hotel on June 4, 1966 around noon time. She was quite busy at the time and told Fahey to come back some other time. He asked if he could return the next day, that being a Modnesday. Ricketts declined, stating she had Mednesdays off. Fahey did return at a later date with a second representative, but Ricketts did not purchase any meychandise.

Ricketts was asked why she rocalls the June 4, 1968 so well. She related that her birthday is on June 3, and the assassination was on June 5, 1968. Duo to these important dates, she recalled numerous incidents that occurred to her in that three-day period.

On September 5, 1968, a polygraph examination was administered to Mr. John H. Fahey at the polygraph facilities of the Scientific Investigation Division.

This examination was requested by S.U.S. Investigators in order to try and determine the truthfulness in Mr. Fahey's statements as given originally to the FBI and later to investigating officers of this unit. It was noted that these two separate interviews of Fahey contained many statements which are inconsistent with each other and that Mr. Fahey's allegations demanded additional investigation.

On June 6, 1968, Mr. Fahey alleged to agents of the FBI that on the -. morning of June 4, 1968 at approximately 9 AM he met a young female caucasian whom he described as approximately 28 years of age at the coffee shop of the Ambassador Hotel in Los Angeles. During the time that they were together, the girl informed Fahey that she and some other people were going to take care of Senator Kennedy on that evening during the winning reception for Kennedy at the Ambassador Hotel, Fahey alleges that while they were eating breakfast in the coffee shop the girl told him that she could not give him any more details about Kennedy because she couldn't trust him. She further stated that she was afraid and had to be careful because they were being watched. She indicated that two men whom Fahey described as foreign looking were in the Hotel watching them and that they were part of the group that were going to take care of Kennedy. (Fahey later examined some photographs and identified the two man as being #1 Sirhan Sirhan, \$2 Munir Sirhan.)

Fahey stated that after eating breakfast, he invited the girl to go with him for a ride. Initially, he mentioned to the FBI that he had told the girl that he had some business calls to make in the vicinity of Oxnard and Ventura, California, but later he changed his story. During the pre-test interview, he stated that he had asked the girl to go cruising with him and that he had not mentioned anything relative to business calls or calls that he was planning to make anywhere. He stated that he did not mention anything about Ventura or Oxnard until much later on that day (6-4-68).

Fahey told the FBI that after leaving the Ambassa r Hotel he drove northbound on the Pacific Coast Highway 101 and that while driving in the area of Malibu Beach north, he observed a blue Volkswagon following his car. Later when he was interviewed on the 7th of June, he changed this statement and said that initially he observed a dark blue Ford following his vehicle and that later the blue Ford disappeared and the blue Volkswagon took over the tailing of his car.

Another area wherein there is conflicting testimony in Fahey's statements is where, at the time of the initial interview on 6-6-68, Fahey stated to the FBI that when he realized he was being followed by the blue Volkswagon he pulled off the roadway and drove to a location along side a large boulder. He did this in order to convince himself as to whether or not he was in fact being followed. According to Fahey, the Volkswagon pulled up behind his vehicle, the driver alighted from the Volkswagon and according to Fahey stared at him and the girl in a very peculiar and threatening manner.

On June 7, during the second interview, he stated that he had stopped at the beach and remained there with the girl for approximately 10 minutes to 15 minutes and that it was after this time that he drove to the boulder area and while driving to that location he discovered that he was being followed.

There was a question as to whether the driving into the area of the boulders was conducted first or whether if had stopped somewhere in the area of Malibu Beach first. He was questioned about these various conflicts in his statements, and Fahey related that he had first stopped by the beach and that he had carried the young woman in question to a deserted life guard station where they had remained for approximately 10 minutes. During the pre-test interview, he stated that it was after this beach sight seeing stop that he first observed the blue Volkswagon following his car.

An additional discrepancy arises when Fahey reportedly told his employer, Mr. Ron Smith, that at the time that he stopped along side the boulders, the driver of the Volkswagon got out of the car and according to Fahey pulled out and was holding a gun in his hand. Fahey told Smith that he became so afraid that the incident almost scared him to death. He stated that he practically had to crawl back to his car due to his fright and that his chest hurt. (It should be noted that to all other persons to whom he related this incident, he at no time mentioned ever getting out of his vehicle or of having seen any person with a gun on that day.)

During the pre-test interview, the examiner questioned Fahey further regarding his conduct at the scene of the boulder area and specifically asked him why he had not gotten out of his car and talked to the man that was following him. Fahey answered, "Because when I started to get out of the car, I saw the girl looking rather strangely at my car keys". "I assumed she was going to take my car if I got out". Examiner then posed the question, why didn't you remove your keys from the ignition and then get out and check? Mr. Fahey replied, "Because I was still very much afraid of the man behind me". Fahey was then asked, were you also afraid of the young girl in the caroind he said, "Yes, I was afraid of her also, that is the reason that I decided to drive towards the direction of Oxnard hoping that I could see a police car or go to one of my accounts and obtain help. Fahey related that at this time he formed the idea of driving towards the Oxnard area. He stated that he pulled out and turned left on the highway and continued his travel toward Oxnard to seek help. While driving towards Oxnard, Fahey stated he continued looking in his rear view mirror and could see that he was no longer being followed. He said that after arriving in the area of Ventura, he made a variety of right and left turns and after realizing that he was, in fact, no longer being followed, he

Examining officer again asked Mr. Fahey if he had stopped and informed the police of the situation that he had found himself in and Fahey replied that after he realized that he was no longer being followed, he felt that he no longer needed any help. Again he was asked whether he was not any longer in fear of the girl companion in his car, and he said that he was still afraid of her; however, he felt his obligation as a gentleman was to return her to the location where he had first picked her up. While enroute to Los Angeles, he reportedly stopped at Trancas Restaurant and both he and the young girl went to the restroom and later ate a sandwich. He indicated that the girl wanted him to buy her a cocktail, but he stated that he refused to buy her any drinks (note: Fahey earlier had stated to the FBI that this female had, in his words, a large amount of money which he had observed in her purse). After eating, they again continued their trip towards Los Angeles. Somewhere between Trancas Restaurant and Los Angeles, Fahey states that his vehicle had a flat tire. He states that with the assistance of a friendly truck driver who stopped and offered help, he replaced the flat tire and continued driving to Los Angeles. Fahey states that he dropped the girl off at the Ambassador Hotel at approximately 7:30 PM. He claims that the girl was insistant throughout the day and she kept inviting him to attend the winning celebration for Kennedy at the Ambassador Hotel. Fahey refused every invitation and again refused just prior to leaving the girl at the Ambassador, he drove directly home and arrived at his house approximately 35 hours later than normal. He states that normally he picks up his wife at work at 4:30 PM every day and then drives her home. On this particular Tuesday, 6-4-68, he was 31 hours late and his wife wanted to know where he had been. He told her that he had a flat tire on the road from Oxnard, but related nothing else to her regarding Kennedy or the girl with whom he had been riding. The examiner asked Mr. Fahey why he hadn't informed his wife about his experiences during that day and he stated that at the time he didn't feel it was important. He stated that he wanted to prepare his wife's attitude so that she would not misunderstand him when he told her the story about the woman.

The following morning; 6-5-68, Fahey states that he drove his wife to work and then proceeded towards his own place of employment. He worked all day, returned to his wife's place of employment, picked her up and drove home. Fahey again was asked whether on the morning of 6-5-68 or at any time during the working day he had told his wife or any of his fellow employees about the incident; concerning the girl or any of the statements about Kennedy, or whether he had told anyone that his car had been followed. Far answered no, that on 6- 8 he had not told his wife or anyone about what had happened during the previous day. He said that he did not think it was important at the time. He was asked whether he knew the fact that Kennedy had been assassinated at the time that he was driving his wife to work on the morning of 6-5-68 and he said that he had heard the news about Kennedy on the radio, but that he still didn't connect anything to the girl. He was specifically asked when it was that he believed that there might be some connection by his experiences with the girl and the death of Senator Kennedy. He stated that upon arriving home after work on 6-5-68 that the girl whom he had been with on the previous day had called his house on the telephone. He stated that he recognized her voice on the telephone. He said that the woman called again later and that when his wife talked with her, he decided to explain to his wife what had

Fahey was asked what, in his mind, was the objective of the girl and the people that were following him, he stated, "I thought they were trying to steal my car".

He was then asked if he didn't feel that this was an unusual and delaying method of stealing anyone's vehicle and he answered, "Yes, I guess so". When asked, Fahey described the girl that he had been with as "nutty". He said that she was not very attractive, that she did not have a good figure, that in fact she had a bad body odor. (note: to the FBI he had earlier described this female as having a very good build and a very attractive figure.) He was then asked if he thought the girl was a Hippy. He answered, "She could have been, but I don't know". When asked if he had sexual intercourse or tried to have sexual intercourse with the girl, he answered, "Definitely not". He was then asked if he kissed or tried to kiss the girl and he said, "No, she was very cold". He was asked how he determined that the girl was cold, and he replied that, "You can tell by the way that they talk to you", and specifically mentioned that she kept saying, "I cannot trust you" and thus he assumed she was a cold person.

The foregoing is the substance of the pre-test interview with Fahey and upon its conclusion Mr. Fahey was informed that due to the many discrepancies and conflicts in his statements, a polygraph examination would be desireable in order to attempt to verify whether he truthfully believes that the story he had related was true in its entirety.

Fahey stated that he had already been given a lie detector test by a private polygraph examiner to whom he had been taken by Mr. Fernando Faura. He stated that he had passed the test and that Mr. Faura, after checking with the polygraph examiner informed Fahey that he had passed the test like a champ. He stated that everything that he had related was true.

Prior to instrumental testing, Mr. Fahey was explained the instrument and its functions and he was explained the theory and the procedures that would be followed during the course of the examination. Fahey was given an opportunity to ask questions concerning any phase of the examination. The questions that were to be asked instrumentally were reviewed with him before any instrumental testing began.

Two separate control tests were administered to Fahey and two polygrams were obtained which determined that John Fahey was a suitable subject, capable of responding to stimuli and capable of producing polygrams adequate for evaluation.

During the course of the examination, physiological tracings at points where crucial key questions were asked, strongly indicate that Mr. Fahey was not being completely truthful.

Two Peak of Tension tests were administered and, in addition two General Series tests were administered. Each of these examinations contained a series of questions relative to the major key issues.

It is this examiner's opinion that Mr. Fahey's answers with respect to the following questions are clearly indicative of deception and that his answers were untruthful.

- (Q) Is there anything concerning the story you have told the FBI that you honestly know is not true?
- (A) "No"
- (Q) Since Senator Kennedy was assassinated, have you lied to any police officer?
- (A) "No" ·

(Q) Have you ever seen Sirhan Sirhan in person?

(A) "Yes"

(Q) Did you lie to the FBI about what happened on June 4, 1968?

(A) "No"

(Q) Other than pictures of Sirhan, have you ever seen him in person?

- (A) "Yes"
- (Q) Did any woman tell you of a plan to assassinate Senator Kennedy on June 4, 1968?
- (A) "Yes"

(Note: Fahey answered truthfully when asked the following relevent questions: (1) Do you honestly believe that you have ever seen Sirhan Sirhan in person? Ans: "No" (2) Do you honestly believe that you have ever seen Munir Sirhan in person? Ans: "No"

Upon conclusion of the polygraph examination Fahey was informed that his responses to certain questions indicate that he was deliberately attempting to deceive the examiner. He was told that he could not honestly say he had ever seen Sirhan Sirhan or Munir Sirhan in person.

Further, Fahey was advised that his answer to questions concerning being told of a plan to assassinate Senator Kennedy clearly showed that he was also being untruthful in this respect.

Mr. Fahey claimed that he had mover told anyone that he had actually seen Sirhan or Munir in person. He claimed that he told the FBI that the men he had seen at the Ambassador Hotel on the morning of June 4, 1968, had a strong resemblance to the photographs which were shown to him.

Examiner informed Fahey that regardless of who he thought the people at the Ambassador looked like, he knew that they were not Sirhan or Munir and should have told the FBI at the time. Fahey answered, "Yes, sir, you're right."

Fahey was asked if he was deliberately trying to mislead the authorities, he answered, "No".

Mr. Fahey was told that his previous statements would have to be changed and corrected with the truth. He was told that he would be given to opportunity to correct his statements himself, or that the examiner would correct his prior statements by furnishing a report on the findings and conclusions of the polygraph examination.

Woo states that on April 16, 1968 he met John Fahey, who introduced himself as a salesman for "Cal-Tek Industries" at 1833 N. Eastern Ave. Los Angeles, Calif. Woo recalls purchasing some chemicals from Fahey on April 16 and remembers that on April 18, 1968 Fahey returned to his office. Woo recalls that he introduced Fahey to someone from the store's department of his company who purchased some rust preventatives and other misc. merchandise from Fahey on that day. Woo states that the last time he remembers seeing John Fahey was on or about May 15, 1968. He recalls that when he looked up from his desk, he observed Fahey standing on the door way leading into his office. Fahey had come to the office with another man whom Fahey introduced to Woo as Fernando Faura, a stocky man wearing a gray jacket and glasses. Fahey told Woo that his friend wanted to write a story on the "China Airlines" and Woo stated that he became curious about why Faura wanted to write this story, and he asked Faura, whom he worked for. He recalls asking for Faura's credentials and that Faura produced an identification card with the words "Police Press" written on it. Woo informed Faura that he knew nothing concerning the China Airlines and shortly thereafter Fahey and Faura left together. Mr. Woo was told that John Fahey had submitted a report to his employer alleging that Fahey had been to Woo's place of business on June 4, 1968 and seen him. 

At no time did Mr. Dirks make any connection between the two young men and the woman.

After the hypnotic session ended, a general discussion ensued. Dr. La Scola searched his memory for the details of that conversation.

He recalled that when Mr. Dirks was describing the woman, Mr. Fahey became very agitated and interested, nodding assent as each physical detail was brought out. Fahey later stated he was sure the woman seen by Mr. Dirks was the samewoman he had spent the day with.

Mr. Fahey discussed being with a woman all day on 6-4-68. He stated the woman told him on five separate occasions that Kennedy was going to be assassinated. According to the context of the conversation, she used the words shot, shooting, or assassination. Fahey recalled the woman showed him a picture of her child. Fahey stated he had taken the woman to a motel somewhere in the valley area.

Mr. Fahey kept referring to Mr. McCarthy throughout his entire conversation. He appeared to be frightened that Mr. McCarthy would discover that he was participating in the hypnotic sessions. Dr. LaScola thought Fahey was referring to Senator McCarthy in an attempt to impress the Dr. (It is the opinion of this investigator that Fahey was referring to Spec. Agent McCarthy of the FBI who was investigating Fahey's story.)

At the conclusion of the conversation, Fahey complained of a headache. Dr. LaScola then hypnotized Fahey and 2 red his headache. An appointment was then made, for the following Tuesday, to hypnotize Fahey for the purpose of refreshing his memory. This appointment was not kept and Dr. LaScola has never had Fahey under hypnosis for the purpose of examining his story.

Dr. LaScola was asked for his impression of Fahey. He volunteered that he did not consider Fahey emotionally stable. He did not believe Fahey was the type of person who would become involved in intrigue. He did not think Fahey was dynamic enough to have withstood the pressure which would have been generated if his story were true. His subjective evaluation of Fahey's personality type was that Fahey was an uncultured person who would enjoy the notoriety attached to being involved in an intrigueing situation and was not above fabricating a story to enhance his own image.

Dr. LaScola stated that a person is perfectly able to lie while under hypnosis. As a matter of fact, the person due to the added concentration powers gained while under hypnosis, could lie better and more convincingly than under normal circumstances.

Mr. Gugas is a licensed polygraph examiner. He was interviewed at his office.
Mr. Gugas was contacted by Fernando Faura and agreed to administer a polygraph examination on John Fahey.
On Aug. 30, 1968 Mr. Fahey was brought to Mr. Gugas' office, accompanied by Fernando Faura and Mr. Jordan Bonfante, Bureau Chief of Time-Life Magazine in L.A.
Mr. Faura gave Mr. Gugas a transcript of a conversation between Faura and Fahey. The transcript described Fahey's experiences on 6-4-68 in 'the company of an unknown woman.
Mr. Gugas studied the transcript and based a polygraph exam on its contents. The guestions asked and the answers received are as follows:
<ul> <li>(A) Is the statement you have made to the FBI and Faura true? Yes.</li> <li>(B) Is the statement you have made to the LAPD true? Yes.</li> <li>(C) Did the woman say something to the effect that "they were going to get Kennedy tonight?" Prior to the polygraph examination and following the examination Mr. Gugas had a conversation with MR. Fahey. Mr. Gugas recalled as much of the conversation as he presently remembers.

Mr. Fahey felt that the FBI and LAPD Investigators did not believe his story.

Fahey admitted his reason for picking up the woman was motivated by sexual desire.

Fahey told Gugas that he told his wife of his experience before going to the FBI.

He also stated that the waitress at the Trancas Restaurant had remembered him.

He claimed to have been hypnotized by Dr. LaScola and as a result had remembered additional details, i.e. The woman had told him of having a husband on Guam or Taiwan and a daughter in school in the Eastern U.S.

He admitted he never saw Sirhan at the Ambassador Hotel on 6-4-68.

He denied having sexual relations with the woman.

Mr. Gugas was questioned regarding his professional evaluation of the polygraph exam. He stated that he was not immediately impressed with Mr. Fahey but as a result of their conversation had altered his opinion and was now of the opinion that Fahey was an intelligent person. He cross-examined Fahey extensively and Fahey had total recall of the events contained in the transcript. He was impressed by Mr. Fahey's account of the woman's knowledge of a method of obtaining a passport. He felt that Fahey could not have possibly imagined that.

Mr. Gugas evaluated his polygraph charts and came to the conclusion that Fahey was truthful on the questions asked. He was of the opinion that no person could tell such a convincing story and be such a good polygraph subject unless he was telling a truthful story. He admitted that his tests had not contained sufficient questions to fully evaluate Fahey's truthfulness and expressed a desire to re-examine Fahey.

When pressed, Mr. Gugas stated he felt definitely that Mr. Fahey was truthful about having picked up a woman at the Ambassador Hotel and having spent the day with the woman. He explained the reaction obtained on the question, "Were you followed on 6-4-68?-- Yes" as possibly being due to Fahey having imagined that this occurred. He had no explanation for the extreme response to the question, "Do you feel that your life was in danger on 6-4-68?"

When Mr. Gugas pressed Fahey on this point, Fahey mumbled something to the effect that he thought the man following him in the V.W. was going to shoot him.

Mr. Gugas stated that he has called Fahey in an attempt to re-interview him and that Fahey has become un-cooperative. Fahey will not discuss the matter further and told Gugas that he has resolved the matter with the Los Angeles Police Department.

Mr. Gugas' interview was concluded by with the statements that he has not examined any other person in connection with the Kennedy case and that Time-Life Magazine was paying for his services.

Subject stated that Fernando Faura contacted him and made him believe that this girl was involved in the shooting. Subject thought that Faura was working for San Fernando Police Depart-Faura took subject to a hypnotist, Dr. La Scola, who was ment. supposed to hypnotize subject and help him recall the girl's name. Subject does not believe he was hypnotized. Faura then took subject to a polygraph examination where Chris Gugas administered a polygraph examination. Gugas told subject that he was telling the truth when he stated he thought this girl was connected with the shooting. Faura took subject to a Lt. Stein of San Fernando Police Department, made a composite of the girl in question with an Ident-a-kit. Faura then told subject that a witness named Chuck identified the picture as being the girl involved. Faura also, told subject that the hotel maitre d', Di Pierro identified the picture as the girl involved in the shooting. Subject stated that Faura cold him things which subject came to believe actually happened or were connected. On tape and transcript is subject's admission that this person is not to his knowledge connected in any way with the shooting; that this girl is just a gril he picked up for a "date."
