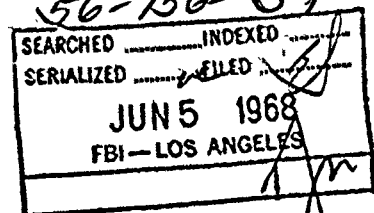

SENATOR ROBERT F. KENNEDY  
6/4/68

At approximately 8:40 a.m., 6/5/68, Mr. LESTER CLARK, 217 1/2 East Florence, Los Angeles, telephone 751-0779, telephonically advised he observed the individual who allegedly shot Senator KENNEDY on television and he believes him to be an individual that he knew in Saint Peter, Minnesota, in 1961.

CLARK stated he was employed as a part-time guard at the Saint Peter State Insane Asylum, Saint Peter, Minnesota, in May, June, and July, 1961. He stated the person he saw on television as having shot Senator KENNEDY was identical to an inmate by the name of JOE MENDEZ (phonetic). He stated MENDEZ was at the asylum for criminally assaulting a young child and was in the criminal ward of the hospital. He claimed MENDEZ escaped in July, 1961, and as far as he knows was never located.

CLARK stated MENDEZ has a small scar on his right forearm located about the middle of the forearm. He stated it appears to have probably been made by a cigarette burn.

CLARK stated he was not positive of the identity but felt reasonably sure it is the individual he knew as JOE MENDEZ. CLARK stated he could be reached at this telephone number any time during the day.

C advised that he was formerly with Mutual Broadcasting Co., in Washington, D. C., and also Madison, Wisconsin. He said that he has investigated the W.E.B. DuBois Clubs in Wisconsin, and testified before a U. S. Senate Internal Security Committee some years ago. He says that he is a close person friend of Inspector TOM BISHOP, Inspector-in-Charge, Crime Records Division.

C wanted to call our attention to the fact that NBC Newsman SANDER VAN OKER had interviewed a person at the Ambassador hotel early this morning, and that the girl had said that she was just outside the hotel at the time of the shooting; the girl said that a caucasian girl came running down the steps saying "We shot Kennedy! We shot Kennedy", and seemed quite pleased. This girl then allegedly met a Mexican-American and both left together. C said that VANOKER seemed stunned and did not realize the possible importance of this matter. C advised that the FBI should obtain the TV tapes and check this out.

Warren telephoned that this morning he had received <sup>during</sup> two communications through the mail:  One envelope was addressed to Director, NAACP, Watts Section, Los Angeles, Calif. It was postmarked 5-31-68, Pittsburg, Penn. and bore no return address. Inside was a whole sheet, color white, bearing yellow printing reading, "Kindly see that your people keep a respectable distance from Senator Kennedy" There was no additional printing on the sheet and the message was in the form of a note. It bore no signature nor date. The message appeared to be regular printing or a mimeograph job- not hand-printing.  The other communication was in an envelope bearing the address of NAACP, Watts Section, Los Angeles, Calif. The postmark is June (illeg.) 1968. (Possibly June 2), Bellevue, Pennsylvania. This envelope also contained a note which read: "Kennedy as an Attorney-General did nothing for you. Kennedy as a Senator did nothing for you. As President, what would he do for you? The same thing - NOTHING." The note was not signed and no further information appeared on the sheet which appeared to be cut down from regular size and cut in crooked fashion. The paper was white and unlined. In this instance the note was typewritten.  Warren advised that both communication were sent airmail; that one envelope appeared to be a business type envelope while the other was of a personal type. He has both letters in his possession. He advised that he has no knowledge who is the sender of these and knows of no others of this type.

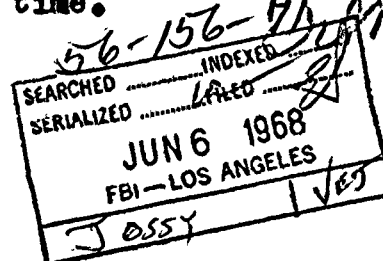

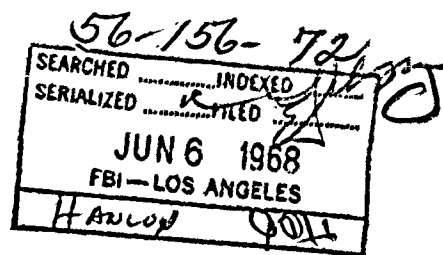

On 6/5/68, Special Agent JAMES W. CLARK, Bureau of Criminal Identification and Investigation (CII), Department of Justice, State of California, Room 406, State Building, 217 West First Street, Los Angeles, California, advised that he was offering the following information with a view to possible assistance concerning captioned matter. Special Agent CLARK appeared personally at the office and was interviewed by the writer.

CII, Sacramento, received an applicant print on 12/16/65, from California Horse Racing Board, 107 South Broadway, Los Angeles, concerning SIRHAN BISHARA SIRHAN and the print showed SIRHAN was an applicant for a license as an Exercise Boy. SIRHAN was described as a male white, born Jerusalem, 3/19/44, 5'2", 115 pounds, black hair, brown eyes. There is no CII or FBI Number for SIRHAN.

In checking further concerning SIRHAN, Agent CLARK determined that California Driver's License M238847 was issued to above SIRHAN in 1964, at which time his residence was shown as 696 East Howard Street, Pasadena, California. Agent CLARK additionally advised that on 3/9/66, in Pasadena Municipal Court, SIRHAN was convicted of violation of Section 22350 Vehicle Code (VC), and paid a \$5.00 fine plus penalty.

On 11/28/66, in El Monte, California Municipal Court, he was charged with violation of Section 21453 VC and forfeited \$13.00 bail. In connection with this charge, it was shown that he was driving vehicle with license plate JWS 093. DMV shows a 1968 California registration for the above license plate, registered to a 1956 De Soto two door, serial number 62050J11. The sole owner was shown as SIRHAN B. SIRHAN, 696 East Howard Street, Pasadena.

Agent CLARK said the following information in CII files in Sacramento may possibly pertain to a brother of the above SIRHAN, under CII Number 2473675 and FBI Number 802 378 E: SHARIEFF BISHARA SIRHAN, aka Sharieff Bishara Sirhan, born Jerusalem, 6/7/33, male, white, 5'3", 115 pounds, black hair, brown eyes. He was arrested on 12/18/63, Pasadena Police Department, their number 57226, for investigation of violation Section 217 Penal Code (PC), attempted murder. On 3/31/64, above charge reduced to violation Section 10852 VC on four counts, and on 3/31/64, proceedings were suspended and SIRHAN placed on one year's probation due to expire 3/30/65. On 3/4/64, a print was received from the Los Angeles Sheriff's Office (IASO), but pertained to a Pasadena arrest on the individual who was charged with breaking or removal of vehicle parts. No disposition was shown. On 2/1/65, a print received from the IASO charging breaking or removal of vehicle parts. Disposition - sentenced to two days.

It is noted that in connection with the arrest of this individual on 12/18/63 (supra), his residence was shown as 1711 Corson Street, Pasadena. His occupation was given as bookkeeper.

Agent CLARK advised that CII presently has a flag in the CII folder on this individual reflecting he is on probation; however, this may pertain to the above 3/31/64 arrest and CII was not notified upon the expiration of the probation. Additional information with regard to this probation may be available in the Los Angeles County Probation Department, their file number X289999.

Another notation in CII folder regarding this individual indicates that he may be the same individual as the subject mentioned in Pasadena Police Department Criminal Report Number 393322 dated 12/24/63. The notation was made in the folder by CII's Sex Crimes Unit. The complete record at CII concerning this matter is not readily available since it is stored in the archives,

but it can be obtained if necessary. This particular record possibly is readily available at the Pasadena Police Department. Photographs of this individual are available if necessary through LASO, under the 1964 arrest number C071362, and the 1965 arrest number C192299.

Agent CLARK further advised that from CII records in Sacramento the following information may pertain to another brother of suspect in captioned matter: MUNIR BISHARA SALAMEH SIRHAN, aka Joe/Munir, born Jerusalem, 7/15/47, male white, 5'6", 120 pounds, black hair, brown eyes, CII Number 3044067, FBI Number 866 039 F. He was arrested 6/10/66, Pasadena Police Department for investigation violation Section 11531, Health and Safety Code, for sale of marijuana, and Section 11530 of same code, for possession of marijuana. Pasadena Police Department Number 62470. Disposition 12/1/66, proceedings suspended, placed on five years probation under condition he serve the first year in County Jail. The only residence shown for this individual was Pasadena, California.

Agent CLARK furnished the following information concerning an emergency APB (teletype) received by CII, Sacramento, from the Los Angeles Police Department (LAPD), dated 6/5/68. He said this APB could be identified by 1 RAM. He said this was actually received from Rampart Detectives, LAPD, Lt. HUGHES. Agent CLARK said that he did not have the verbatim text of the APB at this time; however, it does mention a possible female companion of the suspect in captioned matter. This female was described as white, age 23 to 27, 5'6", wearing white voile dress with three-quarter length sleeves. There was no additional information available at this time in this regard.

Agent CLARK was thanked for his cooperation in this matter and he advised that should it be necessary to contact him on an emergency basis, he could be reached through his residence telephone in Temple City, 444-8493.

At 2:15 p.m., 6/5/68, Sgt. BALDWIN, San Luis Obispo Police Department, telephonically contacted the Rampart Division, Los Angeles Police Department (LAPD) and advised an unidentified ex-con called the San Luis Obispo Police Department long distance and indicated he wanted to talk about a conspiracy to kill KENNEDY. Sgt. BALDWIN informed the unidentified informant that he would contact the LAPD and obtain the name of the appropriate official who would take the informant's information.

At 2:30 p.m. the unidentified informant telephonically contacted Lt. HEGGE, Rampart Division, LAPD, and indicated he wanted to talk about a conspiracy, however, he wanted complete amnesty before he did any talking. The unidentified informant refused to give his name and telephone number and stated he would call again at 3:00 p.m.

At 3:00 p.m. the unidentified informant telephonically contacted Lt. HEGGE and stated that one of the persons involved in the conspiracy was one "ROMAN", who is an attorney in Miami, Florida, with telephone No. 271-6248. Informant claims "RAMON" was to pick up the assassin and take him to "the island".

Informant indicated that "RAMON" had accontact in the Los Angeles area. Informant also indicated another person by the name of "ART" was also involved and resided Sunset Island, with telephone No. 531-9711.

Informant again refused to identify himself or furnish the telephone number where he might be contacted and stated he would call again on 6/6/68. He indicated he might have additional information at that time.

On 6/5/68, Detective Sergeant CHARLES BALDWIN, San Luis Obispo Police Department (SLOPD) furnished the writer the following information:

On the morning of 6/5/68, he received a telephonic communication from a source of his named HAROLD TOWE, who resides at 1834 East Floral Avenue, Fresno, California, telephone 209-834-2885. TOWE advised Sergeant BALDWIN that he had been approached "to do a high political job" inferring it had something to do with killing Senator ROBERT F. KENNEDY. TOWE remarked he refused the offer, told the people involved he did not want any part of it and if it was tried he would "blow the whistle on them". TOWE stated to Sergeant BALDWIN that he wanted a guarantee in writing that he will be immune from prosecution pertaining to this or any action he had been involved in that is discovered as a result of investigation into this matter. Prior to his furnishing details on the identity of the persons and offer made to him in this regard.

Sergeant BALDWIN advised that since he was unaware of the details in the matter and in no position to guarantee TOWE immunity, he put TOWE in telephonic contact with Lieutenant A. S. HEGGE, LAPD, and TOWE later contacted Lieutenant HEGGE, who indicated to TOWE that he would guarantee no prosecution of TOWE for information that TOWE could furnish.

Sergeant BALDWIN advised he has had contact with TOWE over a period of years and TOWE has provided information which has proved to be reliable. BALDWIN stated that TOWE is an ex-convict who has done time for armed robbery and his most recent arrest involved assault on a police officer. Sergeant BALDWIN
