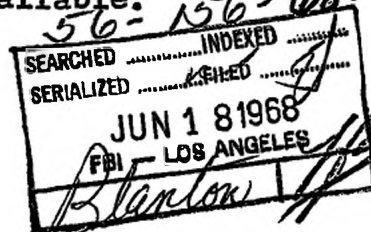

SUBJECT: KENSALT

On 6/5/68, HUMPHREY OTTO CORDERO and ENRIQUE RABAGO voluntarily appeared at the Los Angeles Office of the FBI and furnished signed statements concerning conversations they had with SIRHAN BISHARA SIRHAN at the Ambassador Hotel on the evening of 6/4/68.

In addition to making statements derogatory to Senator ROBERT KENNEDY, SIRHAN allegedly told the above individuals of an incident involving himself and some unknown female "hostess" at the RAFFERTY for Senator Room at the Ambassador Hotel. According to SIRHAN, he allegedly paid for a drink and left a \$20 tip for the hostess in an effort to show the individuals present that he was "not dirt".

On 6/11/68, RICHARD S. MC GEE, Campaign Coordinator, RAFFERTY for Senator, advised that there were no hostesses as such working in the RAFFERTY Room on the evening in question. He did state, however, that the following females were present in a voluntary status on the evening in question:

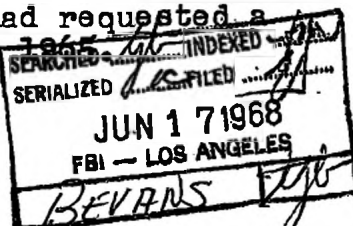

In connection with attempts to identify the woman in the polka-dot dress who was allegedly with SIRHAN at the Ambassador Hotel, Mrs. ALICE ALLEN, secretary to Dr. IRVIN G. LEWIS, Administrative Dean of Students Personnel Services, Pasadena City College, stated there was an Iranian student who attended PCC in 1961 and 1962 who was extremely attractive in figure, being quite petite. She had no idea whether or not SIRHAN knew this girl, but furnished the following information concerning her:

Mrs. ALLEN stated the girl always seemed to have lots of money, and appeared to be an opportunist. The record reflected Woodbury College, Los Angeles, had requested a transcript of her record from PCC in June, 1965.

TERRY MICKEY WELCH, 25173 Farmbrook, Southfield, advised that he recognized SIRHAN BISHARA SIRHAN from photographs on telecast concerning the attempt on the life of Senator ROBERT F. KENNEDY. WELCH then called WWJ Television, Detroit, Michigan, and made them aware of the fact that he knew SIRHAN and he was subsequently interviewed on that station.

WELCH stated that he first met SIRHAN approximately three years ago when both were employed as exercise boys at Granja Vista Del Rio, a thoroughbred horse farm located at Corona, California, and owned by BURT ALTAFISH (phonetic). From that time until May, 1967, WELCH was closely associated with SIRHAN and considered him to be his closest friend. He said that approximately 1½ years ago, probably between September, 1966 and December, 1966, SIRHAN suffered a very bad fall from a horse at Granja Vista Del Rio and was admitted to the hospital at Corona, where he remained in critical condition for several weeks. He suffered head and back injuries which resulted in his being partially blind in his left eye and since the time of the accident, he has suffered from severe headaches. WELCH stated that SIRHAN was supposed to get a settlement as a result of this accident and was angry because he did not get as much as he thought he should.

WELCH advised that SIRHAN underwent a complete personality change after the above-described accident. He stated that prior to that time, SIRHAN had been good natured and easy to get along with. He was popular with other employees at the horse farm and with horse owners who kept race horses at this farm. WELCH listed DESI ARNEZ, BUDDY EASON, and DALE ROBERTSON, prominent television personalities, as horse owners who were well acquainted with SIRHAN. He described SIRHAN prior to the accident as well mannered, neat, clean, intelligent, and a gentlemen in every way. He said that while SIRHAN was thrifty and would sometimes save his checks for three or four weeks before cashing them, he was also generous in providing money to friends who were temporarily in need, and in addition stated that although SIRHAN did not drink himself, he accompanied WELCH and other employees to local bars and would often purchase drinks for everyone present.

Following his fall from the horse in 1966, SIRHAN became a "loner" who was resentful toward anyone who had wealth. He, at this time, became unpredictable and unreliable in that he would make plans to do things or go places with WELCH and then for no apparent reason would change his mind.

After he was released from the hospital at Corona, SIRHAN obtained a job with ROBERT WHEELER, an owner and trainer at the Santa Anita Race Track. He remained on this job for 3 to 5 weeks and when he found that he did not know enough about the job, he quit and went back to Granja Vista Del Rio to learn more about handling horses. WELCH said SIRHAN had a great desire to be a good rider and although he was frightened after the accident, he refused to quit riding even after being repeatedly thrown from horses.

TERRY WELCH advised that SIRHAN was also known as Sol by race track acquaintances and fellow employees. He said that inasmuch as persons of all nationalities frequent race tracks and horse farms, he and SIRHAN worked with Mexicans, Negroes, Irish, Greeks, Italians, Jews, and Hungarians, and SIRHAN never gave any indication to him of prejudice toward any nationality. He said that before the accident SIRHAN was curious and was always attempting to learn and improve himself. He would visit dairy and poultry farms for example during his off-duty hours, and could talk intelligently on almost any subject. He spoke excellent English with little or no accent. He was an avid reader, particularly with regard to law and frequently discussed cases which he had read about. SIRHAN did not appear to be particularly interested in politics and WELCH does not recall any pertinent discussions of political issues.

SIRHAN appeared to be devoted to his mother and told WELCH he visited his mother in Pasadena, California every other weekend when he was not working. WELCH said he never went with SIRHAN to visit his mother and does not know the names of any of SIRHAN's relatives, but recalls SIRHAN stated his mother's name was MARY. His father was overseas, according to SIRHAN, and supposedly wealthy.

WELCH believes that the Reverend LEO HILL, Circle City Baptist Church, Ninth and Sheridan, Corona, would possibly know SIRHAN inasmuch as SIRHAN gave WELCH a card for this church and suggested that he see Reverend HILL when he was having personal problems.

SIRHAN told WELCH on one occasion that he had been expelled from a college in Los Angeles, California as a result of trouble with a girl. This incident supposedly occurred before WELCH and SIRHAN became acquainted.

SIRHAN also stated that at one time he had worked for a gun or skeet club in the Corona or Los Angeles area. WELCH believed that BURT ALTAFIGH would possibly have more information concerning this.

TERRY WELCH said that when he first learned about SIRHAN's connection with the assault on Senator KENNEDY, he could not believe that SIRHAN had shot KENNEDY because he had previously been such a "nice guy". He has not seen or had contact with SIRHAN since May, 1967. He does not believe that SIRHAN would have committed this assault for money, nor would he have been involved in a conspiracy. With regard to the money allegedly in SIRHAN's possession when he was captured, WELCH said it would not be unusual for SIRHAN to carry large sums of money in his pocket inasmuch as he was a thrifty individual and when he and WELCH were closely associated, SIRHAN habitually kept his wallet in the glove compartment of his car, which WELCH described as a 1950 or 1951 DeSoto. WELCH said it was common practice for race track employees to keep their wallets in the glove compartments of cars to prevent theft from their persons.

In conversations with fellow employees who were refugees from Communist countries, such as Cuba and Hungary, SIRHAN always gave WELCH the impression that he was very much opposed to Communism. He indicated a liking for the United States and never exhibited any particular loyalty or feeling toward the country of his birth, Jordan. WELCH said he does not recall having ever heard SIRHAN mention being or living in any state other than California in the United States.

WELCH concluded by stating that he feels that the personality change which took place in SIRHAN BISHARA SIRHAN after his accident must have gotten worse in the past year since WELCH has had contact with him, and that he "went out of his mind, or that something was preying on his mind."

WELCH said that SIRHAN was particularly friendly with FRANK DONORAMA, one of the bosses or supervisors at Granja Vista Del Rio. He added that prior to SIRHAN's accident, BURT ALTAFFISH had been so impressed with SIRHAN's potential that he offered SIRHAN a good administrative job at Granja Vista Del Rio. SIRHAN declined this offer inasmuch as he preferred to work directly with the horses and become a good rider.

SMITH advised that although he was not at the Ambassadors Hotel when SENATOR KENNEDY was shot, as soon as he heard that the SENATOR had been shot, he went to the AMBASSADOR HOTEL to the PRESIDENTIAL SUITE. Enclosed for Los Angeles is one copy of photograph of (FNU) SERHARD (Phonetic) mentioned in referenced teletype and photo of "HAPPY WACK" and girlfriend "CANDY". Enclosed for Cleveland is one copy of referenced Cincinnati teletype.

For the information of Cleveland, enclosed teletype contains sufficient background data for coverage of leads in Cleveland Division.

ROBERT LEE DRIGGS was incarcerated at the Lima State Hospital, Lima, Ohio, in 1966 by Ross County, Ohio, apparently for observation.

For information of Los Angeles, DRIGGS has been reinterviewed as requested in referenced Bureau airtel. DRIGGS was unable to provide identities of persons attending party at SERHARD's home in Pasadena, California, on 7/4/65, with the exception of JOHN HAIG (phonetic) who owned the coffee shop at #7 Dudley Street, Venice, California, where the N.E.B. Du Bois Club members met. DRIGGS described HAIG as the main organizer of the Venice Du Bois Club. DRIGGS states there was a beach party at the end of Dudley Street about May, 1965. Most of the

people at this party were members of the Du Bois Club at Venice. This party was broken up by the police and the majority of the persons present arrested. DRIGGS states the names of persons present were in a local paper with photos of the party and that about 1/3 of the people at the beach party were also present at the party at SERHARND's home on 7/4/65.

DRIGGS stated he has lived in California off and on since 1961 doing "day work" and living with friends and sleeping on the beach. DRIGGS has been unable to locate other photos he took at the party at SERHARND's home and believes they have been destroyed. DRIGGS described the Communist literature in SERHARND's home as approximately 90% dealing with Communist aims and objectives in Latin America. The other literature dealt with alleged American atrocities in Vietnam and the alleged use of chemical warfare by the United States in Vietnam.

DRIGGS stated he could only describe one pamphlet specifically and this concerned with chemical warfare. DRIGGS stated he does not remember the size of the pamphlet however, the cover bore a photo of an alleged American airplane spraying something. DRIGGS stated that it looked almost like a cropduster to him. DRIGGS stated this literature was spread on a table at SERHARND's home during the party.

For further information of Los Angeles, a separate case has been opened at Cincinnati captioned, ROBERT LEE DRIGGS, SM - C, Cincinnati file 100-17655. Any information concerning KENSALT resulting from information furnished by DRIGGS or information concerning DRIGGS' activities developed by Los Angeles should be furnished to the referenced file as well as KENSALT.

For the information of WFO, DRIGGS did not go to Washington as planned, however, he now tentatively plans to leave for Washington, D. C. on 6/15/68 or 6/16/68, and to arrive at Washington by 6/19/68, to participate in the demonstration scheduled for that date.

On 6/12/68 MR. MARVIN H. STEWART, General Electric Tempo Project, Santa Barbara, advised that he and a fellow worker, SID FRANK, had attended an afternoon rally in the Santa Barbara County Courthouse Sunken Gardens on Tuesday, 5/28/68, which featured an appearance and talk by Senator ROBERT F. KENNEDY. FRANK had a camera and took a series of photos of the Senator and the crowd around him before, during and after the talk. MR. STEWART advised that in viewing these color transparencies on 6/12/68 he noted in one of the photos a person in the foreground of the crowd who bore a strong resemblance to SIRHAN SIRHAN. The photo in question was a long shot of KENNEDY as he was preparing to depart by auto on Anacapa Street.

The writer viewed this frame on 6/12/68 through the assistance of MR. STEWART and noted that the individual in question bore a slight resemblance to SIRHAN in coloring and facial features, but he was noted to have a moustache and a larger nose than SIRHAN's newspaper photo. He was dressed in a blue striped shirt and was carrying what appeared to be a placard under his right arm.

STEWART made the original frame available to the FBI but advised that since it is the original and only copy, he ~~would~~ desired that it be returned to him immediately after it had been viewed by witnesses in the Los Angeles area and was no longer needed by the FBI.

The frame is attached and should be returned to the writer for return to STEWART.

On June 7, 1968, authorities of the Oklahoma State Penitentiary, Mc Alester, Oklahoma made available to the FBI the following letter addressed to the FBI, Tulsa, Oklahoma:

"Dear Sir. I have just heard of the attempt on Mr. Robert Kenneky's life. I have myself at one time been suspicioned of such dire happening. You can find my name in Secret Service files. I would like strongly to suggest in the course of your investigation you question Max Stross, Jr., 3545 Oakridge Drive, Woodland Hills, California, and Micky Belfort. I am unaware of his address, although it is in the Santa Ana Hills section of Orange County. I have definite reasons of belief of knowledge by these people of the events of the past twentyfour hours. Signed, Most Sincerely, David Eugene Kates, OSP number 75728."

Kates was interviewed by Special Agents of the FBI on June 7, 1968 and advised that he became associated with Stross and Belfort while a student at Orange High School, Orange, California in 1962.

Stross and Belfort persuaded Kates to hand out Nazi propaganda. Kates states that Stross and Belfort associated with individual at Orange, California who appears to be identical with photograph in newspapers of Sirhan Beshara Sirhan. This individual was not a student at Orange High School, but attended school functions there and had a girlfriend, Gloria Gonzales, a student at Santa Ana, California, High School. Kates has not seen Stross or Belfort since 1963 when he moved from California. He did

not recall the name of the individual who appeared to be identical with Sirhan.

Kates thinks that Stross and Belfort were arrested during riots in Los Angeles in 1962. He described Stross as a white American male, early twenties, five feet seven inches tall, one hundred and ninety pounds, heavy build, sandy brown hair, medium complexion and an only child.

He described Belfort as a white American male, five feet ten inches tall, one hundred and seventy pounds, early twenties, black hair, dark eyes, dark complexion, medium build, two older brothers.

Kates was received at Oklahoma State Penitentiary on July, 17, 1967 from Oklahoma County for robbery with firearms and unauthorized use of a motor vehicle: sentenced to nine years. He is described as a white American male, five feet eleven inches and one-half, slender build, ruddy complexion, black hair, brown eyes, born June 29, 1946 at San Diego, California, FBI number 789042E.

During the interview, Kates admitted that while he was an inmate at Federal Correctional Institution, Englewood, Colorado, in 1964, he wrote two letters threatening to kill President Johnson. He was then transferred on December 17, 1964 to the Medical Center for Federal Prisoners, Springfield, Missouri. He was discharged October 11, 1966. On October 12, 1966, Kates was arrested by Secret Service, Tulsa, Oklahoma, and charged with oral threat against the President. On October 20, 1966, he was admitted as a patient, Eastern State Hospital, Vinita, Oklahoma. He claims to have been released November 13, 1966. On November 16, 1966, he was arrested by the Sheriff's Office, Oklahoma City, for unauthorized use of a motor vehicle and claims to have been incarcerated since that time. Kates had no information to tie Stross and Belfort to Kennedy's death.

Kates while in the Federal Correctional Institution, Englewood, Colorado, attempted to poison a fellow inmate. Kates allegedly had recruited his victim into the American Nazi Party and the poison incident was over the victim's defection. Prison records at Englewood, Colorado showed an interview by prison officials with Kates wherein he claimed to have been in contact with George Lincoln Rockwell, deceased leader of the American Nazi Party, while in California. Colorado prison records further showed Kates "had definite paranoid and schizoid tendencies and could easily become fanatic..." Kates remains in custody at the Oklahoma State Penitentiary, McAlester, Oklahoma, and SHOULD BE CONSIDERED EXTREMELY DANGEROUS.

STEELE advised that his office had extensive records concerning KATES and as a matter of fact, had arrested KATES in 1966 for making oral threats against President LYNDON B. JOHNSON. STEELE said he considered KATES to be a very dangerous and extremely unstable, and anything he said would be of questionable value.

On 6/12/68, an individual identifying himself as NORMAN WEXLER, residence--963 Lexington Ave., NY, NY, telephone #LO4-3250, called the NYO of the FBI, and stated that he is a free-lance playwright and also that he is free lance in advertising. He stated that he was a classmate of Senator ROBERT KENNEDY at Harvard in 1948; that he had gone to California on a voluntary basis to help with the KENNEDY campaign a few days prior to Senator KENNEDY's assassination; and that he was in the Ambassador Hotel on the night of the assassination.

WEXLER stated that there was no security at the Ambassador Hotel and that when the police came in, they acted as though they were "morons". WEXLER stated that he was in a room near the shooting and that he did not see the shooting nor hear the shots. WEXLER went on to state that he had the theory that SIRHAN SIRHAN was a member of Communist International.

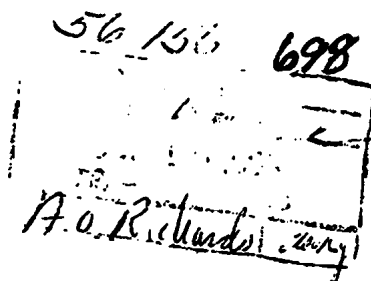

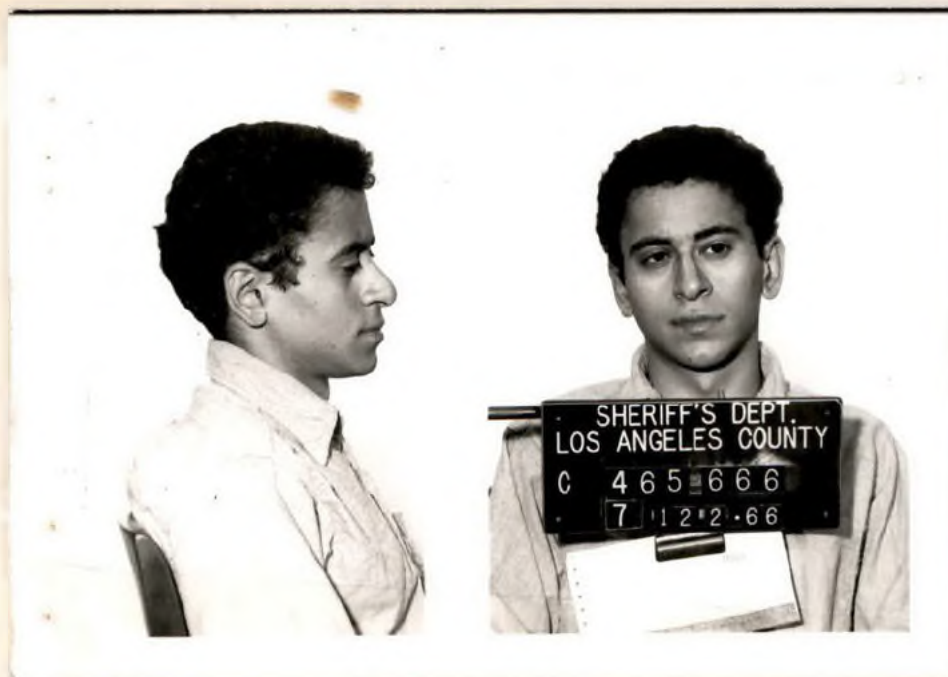



On 6/12/68, HAROLD F. ZIMMERMAN residence-413 Braeburn Road, Hohokus, New Jersey, Business - 7333 Woodhaven Boulevard, Queens, New York, unlisted telephone number 212-897-9094 called the New York Office.

He stated that in 1944 in Seattle, Washington, he qualified as a ballistic expert in a murder trial in which a 22 long rifle was used.

Much of the case centered on his testimony (for the defense) and the defendant was acquitted.

The defendant was an Army Corporal, Technician Fifth Grade ROSS M. EVANSTEAD. The deceased was JOHN BRANGERT. BRANGERT was murdered in 1944 in Bothell, Washington, just outside of Seattle.

ZIMMERMAN stated that murder trials involving 22 long rifles are rare and that the Government may desire to review the Seattle case as to ballistic testimony.

ZIMMERMAN added that the defense for SIRHAN SIRHAN will probably look into prior cases involving 22 long

On 6/14/68, LORENA KURTZ, 4110 Monroe Street, Los Angeles, was interviewed by SA's THOMAS G. MANSFIELD and JAMES E. WHITE.

KURTZ stated she called FBI Headquarters, Washington, D. C., on 6/7/68. At the time of her call to Washington she added she was very distressed over the death of Senator KENNEDY. She continued she is presently under a doctor's care for treatment of nervous spasms. She added she has no information to furnish that her next door neighbor is a friend of an individual who conspired with SIRHAN. KURTZ said this is a false statement. KURTZ agreed that she made such a statement, however, she repeated she was very upset when she made this statement.

KURTZ continued that until 6/9/68, she had neighbors residing at 4108 Monroe Street who were of Arabic nationality. This family consisted of a man and wife and two children; a girl age 10 and a boy age eight years. She does not know the names of this family. She was exhibited a photograph of SIRHAN and advised she has never observed SIRHAN at the residence at 4108 Monroe Street and she has no reason to believe that this family is acquainted with SIRHAN or is acquainted with an individual who conspired with SIRHAN to kill Senator KENNEDY.
