



MAAS, FELECIA (MRS.)

Mrs. Maas has owned Robbie's Restaurant for approximately five years. On May 16, 1968, she was contacted by a man who identified himself as J. Hernandez, head of the Pomona group for Kennedy. He requested that she provide the facilities of her upstairs banquet hall for a political luncheon at which Senator Kennedy was to appear as speaker. Arrangements were made for 300 sitdown luncheon guests and for 100 standees. The standees were to be admitted just before Kennedy was to begin speaking as Kennedy was not lunching.

After the arrangements had been made, she heard nothing more from Hernandez, or any member of the local Kennedy party. She waited until the morning of May 20, and then contacted a member of the Pomona Police Department. She was informed that the Police Department had no advance knowledge of the luncheon and, therefore, no arrangements had been made for crowd control.

By 11 a.m., she estimated there were approximately two to three thousand people outside her restaurant and the restaurant inside was full. Just before Kennedy arrived, the Police Department assigned ten to fourteen uniform officers to assist in controlling the crowd both inside and outside the restaurant. She observed the young couple who had just been involved in an incident with Albert R. Le Beau ascend the staircase and pass by her but paid no attention and could not identify them.

MAC DONALD, HUGH

Mac Donald was Assistant Press Secretary to Senator Kennedy. During the Senator's speech, Mac Donald was in the Colonial Room (Press Room) waiting for Senator Kennedy's arrival. He heard a commotion in the kitchen, proceeded through the door, and observed a group of people holding Sirhan. He jumped onto a metal table, observed Senator Kennedy on the floor and went to his assistance. Mac Donald removed his coat and placed it beside the Senator's head. He could offer no further assistance, therefore, he assisted in holding back the crowd until the ambulance arrived.

MAC EWEN, DONALD

Mr. Mac Ewen, stated that Mary Vaughn gave him a nap sack which she found at the Ambassador Hotel. He submitted this nap sack to the police.

MAC KAY, RODERICK LYNN

Mr. Mac Kay, is a writer and researcher for magazine publications. On June 6, 1968, he gave investigators some draft

counselor lists which showed the names of Jo Ann, Joe Handy and the address of Sirhan B. Sirhan. He gathered these sheets while doing research on the anti-draft movement. Subject attended several meetings of the W. E. B. Du Bois Club, and obtained lists and addresses of Draft Counselors. Subject stated to investigators that after the assassination he remembered that he had seen the address of 696 East Howard.

Mac Kay was reinterviewed and gave evasive answers to questions regarding the material. Mac Kay was asked why some entries were in pencil and others in ink. Mac Kay stated he could not recall, he explained that the material had been gathered over a long period of time which could explain the difference.

MADDOX, ARTHUR H.

Mr. Maddox was employed as a security guard by the Ambassador Hotel. He stated he was engaged in crowd control duties at the Colonial Room entrance at the time of the shooting. He heard a noise like balloons popping a short time after the crowd began leaving the Embassy Room.

MADSON, JOHN

Mr. Madson reported the manager of the Original Barbeque at 8th and Vermont had advised him that Sirhan attempted to cash a check in his cafe the Saturday prior to the shooting. Sirhan reportedly had been in the cafe several times.

NOTE: This person was identified as Peter Paul Andrews.

MAGDALENO, CELELIA

Magdaleno is the Aunt of Sandra Serrano. She was present during the interview held prior to Serrano's polygraph examination.

MAHANA, MATTHEW

Mr. Mahana reported that during a speech the night before the election, he heard the Senator refer to a woman in a polka dot dress. He remembered a group of twelve to fifteen people lined up in the Lautrec Room at one time.

MAHER, GERALD F.

Mr. Maher was publicity man on Senator Kenendy's staff. He arrived at the hotel June 4, 1968, 8 p.m., was in the Embassy Ballroom during the early evening, but spent most of the night in Jesse Unruh's room on the fifth floor. He watched the

election returns on television and was not aware of the shooting until it was described on television. Later that night he picked up Jesse Unruh at Good Samaritan Hospital and transported him to the Ambassador Hotel.

MALIAN, VARTAN

Mr. Malian stated that Sirhan used to come into his liquor store at 2547 East Foothill Boulevard, when he worked at the Richfield Service Station. He added that he did not conduct any type of conversation with Sirhan.

MALKI, ABDO JABRA

Mr. Malki reported that he saw Sirhan at the Pasadena City College Cafeteria at 6:50 p.m., on June 4, 1968. He stated that Sirhan approached his table with another person and was talking about how he arrived in the United States. That was the only time Malki saw Sirhan and he stated that he recalled that Sirhan was smiling and appeared quite normal. Malki stated that he noticed nothing odd about Sirhan.

MALLARD, AUGUSTUS

Mr. Mallard was employed as a security guard by the Ambassador Hotel on June 4, 1968. He was stationed at the door of the West Venetian Room at the time of the shooting. He stated that he observed Michael Wayne running across the lobby and heard someone say that Senator Kennedy had been shot. He took Wayne into custody and escorted him to the hotel security office. Wayne was not armed but was carrying a roll of campaign posters.

MANKIEWICZ, FRANK

Mr. Mankiewicz was a member of the Kennedy staff. He was present in the pantry at the time of the assassination and his activities are recorded in the portion of this report dealing with Senator Kennedy's activities.

MANN, JOHN R.

Mr. Mann was the Personnel Manager of Microdot Incorporated in Pasadena. He stated that Khalid Iqbal was employed by his company from September 1967, to August 1968. He stated that Iqbal was the person referred to in the Life Magazine photograph of January 17, 1969.

MANNING, DOROTHY DIANE

Miss Manning was employed at the Golden Garter Inn from May 13, 1968, until May 28, 1968. During this time Miss Manning met Robert Andrese and James Wilson. Joseph Martigani, who is the owner of the Golden Garter Inn, stated he observed Wilson sitting at a table with Sirhan B. Sirhan sometime in May. Miss Manning remembers the incident, and states it was Robert Andrese whom Martigani observed.

MANNING, LLOYD

Mr. Manning stated he stopped for coffee at a catering truck at 3160 San Fernando Road, Glendale and overheard a female driver state that her daughter had dated Sirhan.

MANON, PIERRE

Mr. Manon has a travel agency in the Belmont Shores area, Long Beach. The Long Beach Police Department received an anonymous letter indicating that Mr. Manon was an accomplice in the assassination of Senator Kennedy, President Kennedy, and that Edward Kennedy was to be next. The letter also accused him of being a narcotic peddler and an abortionist. He denied any knowledge of the assassination. On June 2, 1968, he left for Europe on a business trip and did not return to the United States until June 10, 1968. He also recalls that when President Kennedy was shot, he was in his office at 5265 Second Street, Long Beach.

NOTE: His office, which consists of his travel agency office, a vacant office, one incomplete office space, and a garage, was searched with his permission. No evidence was found to substantiate the allegations in the anonymous letter.

MANOOCHERI, ABDOOLAH ABBY

Mr. Manoocheri stated he was born in Iran and came to the United States in 1960. He was a great admirer of the Kennedy family, and spent six months painting a portrait of President and Mrs. Kennedy. He was working on a portrait of Robert Kennedy. He does not know, and has never seen Sirhan B. Sirhan.

MANSOUR, MAROUN

Mr. Mansour was acquainted with Adel Sirhan through associates at the Fez Restaurant and Shaker's Oasis. He met Sirhan Sirhan in a Hollywood market on one occasion.

MARCHMAN, EARA

Marchman, a Kennedy Girl, arrived at the Ambassador Hotel on June 4, 1968, 8:30 p.m. She met some other Kennedy Girls, and they walked up the stairs to the Embassy Room and through the kitchen area. While walking through the kitchen, she saw four men dressed as waiters. She attempted to get on the stage in the Embassy Room but was prevented due to the large crowd. She then walked out toward the kitchen area and saw a man in a blue coat, dark complexioned, talking or possibly arguing with a -uniformed guard at the swinging kitchen doors. She returned to the Embassy Room and remained until 11 p.m. She then went straight home and learned of the shooting on television. She cannot be certain that the person seen with the guard was Sirhan.

MARCOVECCHIO, JOSEPH

Mr. Marcovecchio stated that he met Sirhan for the first time in 1966, at a billiard parlor on Colorado Boulevard in Pasadena. He met him again the same year and this time Sirhan was in the company of a mutual friend, Ivan Garcia. Marcovecchio stated he last saw Sirhan in a bar approximately two months prior to the shooting and he was with Ivan Garcia. He stated Sirhan was exuberant on that occasion, having just obtained a \$2,000 cash settlement on an injury claim. Marcovecchio stated he was an acquaintance of Sirhan and never engaged in any serious conver-Sirhan preferred to talk about horses and his own sation. ambition to become a jockey. He did not have a girl friend but was interested in girls, although, Marcovecchio stated, he never saw Sirhan with a girl. He stated he had never met any other member of the Sirhan family and never visited the Sirhan home.

MARCUS, DAVID C.

Mr. Marcus stated that he was the attorney representing Saidallah and Munir Sirhan in their citizenship and deportation cases. He stated that he believes Sirhan Sirhan came to his office on one occasion, with one of his brothers, and attempted to tell Marcus how to handle the case. He added that he was unaware of the Sirhan family's political beliefs.

MARDER, GARY

Mr. Marder was a Kennedy worker at the Wilshire Headquarters. He arrived at the Ambassador Hotel on June 4, 1968, at 9 p.m., and worked at the Anchor Desk prior to the Senator's speech. During the victory speech, he stood on the left side of the podium. As the Senator concluded his speech and exited the stage, Marder crossed in front of the podium and entered the anteroom. He walked into the kitchen and saw Senator Kennedy,

William Barry, Rafer Johnson, Roosevelt Grier, and Richard Aubrey ahead of him. He heard three shots then some additional shots. A scuffle ensued then stopped as Barry, Johnson, and Aubrey walked Sirhan out of the kitchen and up the ramp behind the stage. Marder could not see Sirhan as they passed.

NOTE: Facts disclosed during the investigation have shown Marder's statements incorrect.

MARGOLIS, GEORGE HENRY

Margolis contacted officers and stated he had a photograph of Kennedy and a girl wearing a polka dot dress. Personal friends of Margolis have called him a "kook". They feel Margolis is looking for publicity.

MARKOT, TED

Officer Markot worked for the Alhambra Police Department. He stated that he recalled seeing Sirhan playing pool in the Golden Garter Inn, 2605 West Valley Boulevard, Alhambra. He stated he recalled seeing a 1959 De Soto or Chrysler in the bar parking lot.

NOTE: The person referred to was determined to be Robert Andrese.

MARKS, WILLIAM H.

Officer Marks, Corona Police Department, stated that he saw two men at the Corona Police Department Range on June 1, 1968. He identified one of the men as Sirhan.

NOTE: Mark's description and identification was apparently confused, due to his description of Sirhan as 6' to 6'2", 215/225.

MARLOW, VELMA

Marlow was a teacher at John Muir High School in 1960. She stated that the name Sirhan Sirhan was vaguely familiar and that he may have been in a tenth grade Algebra class. She cannot recall anything specific about him.

MARRO, BERNARD

Mr. Marro, Bureau of Criminal Investigation, New York State Police, stated that he had received information from Leslie and Shirley Putnam that Mark Chamberlain, Shirley's alcoholic

half-brother, had telephoned several times prior to and on June 8, 1968, with various complaints. He told Shirley that he was involved in the assassination of Senator Robert Kennedy and claimed to know Sirhan. He claimed to know that the assassination would be attempted but had nothing to do with it. He additionally claimed that he and Sirhan were members of the same group.

MARSHALL, CHRIS

Mr. Marshall accompanied his wife, Winnie Marshall, to the Ambassador Hotel, on June 4, 1968, 9:30 p.m. He went to the Ambassador Room and remained until 11:50 p.m. At that time he left the Ambassador Room and walked outside onto a fire escape. While standing outside, a female Mexican-American came down the fire escape and said, "Kennedy's been shot." He went back inside the Ambassador Room and informed his wife.

MARSHALL, WINNIE T. (MRS.)

Mrs. Marshall was a volunteer worker and went to the Ambassador Hotel on June 4, 1968, 9:30 p.m. She was accompanied by her husband, Chris Marshall, and friends. She entered the Ambassador. Room and entertained the crowd by performing on the stage. She remained on the stage the entire evening and did not learn about the shooting until her husband informed her.

MARTIGANI, ANDY

Mr. Martigani, co-owner of the Golden Garter Inn in Alhambra, stated that Sirhan was observed in his bar prior to the shooting. The resulting investigation is reported in the section of this report dealing with alleged conspiracies.

MARTIGANI, CARL M.

Mr. Martigani, co-owner of the Golden Garter Inn in Alhambra, stated that Sirhan was observed in his bar prior to the assassination. The resulting investigation is reported in the section of this report dealing with alleged conspiracies.

MARTIN, ANDREW

Mr. Martin is the assistant manager of the Los Angeles Biltmore Hotel. Martin had no statement regarding the investigation but merely assisted investigators in locating documents and interviewing hotel employees.

MARTIN, JACK S., SR.

Mr. Martin was interviewed by the F.B.I. concerning a letter he sent to Charles D. Winters, Teamster Representative in New Orleans, wherein Martin asked, "Why did Hoffa once put out a contract on both of the Kennedy boys?" He said he had no firsthand information that any "contract" was put out, and that he merely made such a statement as a means of irritating Winters. He emphatically denied having any information regarding a "contract."

MARTIN, RAYMOND P.

Mr. Martin was assigned to the Public Assemblage Unit, Los Angeles Fire Department. He was stationed at the main entrance of the Embassy Room when he learned of the shooting. He was unable to keep everyone inside the room so he entered the ballroom and assisted with crowd control.

MARTIN, RHODA E. (MRS.)

Mrs. Martin, Librarian in charge of the Theosophical Society in Walnut Creek, California, said that Tom Rathke was a member of the Society and had attended meetings at their lodge. Sometime in June 1968, Rathke spoke at one of the meetings. At that time he told the group that he formerly worked with Sirhan B. Sirhan. Rathke further commented taht he had received a letter from Sirhan, but made no further comment.

MARTINEZ, FRANK

Mr. Martinez, attended a pro-Castro meeting at 3800 Amesbury Road, on May 21, 1968, with Jose Duarte and several other Cubans. During the meeting Duarte began making anti-Castro statements and was interrupted by a man in the audience who asked Duarte if he was from the C.I.A. Duarte responded by asking the man if he was from Nasser and the man replied, "No, I am a revolutionary." Martinez saw a picture of Sirhan on television and recognized him as the man involved in the argument with Duarte. He was shown photographs of Sirhan and Reza Jalalipour and stated, "It looks like the same person." He then identified the picture of Sirhan as the man who argued with Duarte at the meeting.

MARTINEZ, GILBERTO LOPEZ

Mr. Martinez stated he is a waiter at the Ambassador Hotel and was on duty the evening of June 4, 1968, and early morning on June 5, 1968. He advised shortly after midnight on June 5, 1968, he was working in the Embassy Room and heard what sounded

like four or five shots being fired, in rapid succession. He was approximately seventy yards away when the shooting occurred. Martinez stated it took him a few minutes to reach the scene of the shooting and observe Kennedy on the floor. He did not see Sirhan.

MARTINEZ, JOY

Miss Martinez, ticket agent for Golden West Airlines, stated that she was at her desk in the Ontario Office on June 7, 1968, when she heard threats against Sirhan being voiced over an inter-office radio-telephone. She did not know the origin of the broadcast.

MARTINEZ, RICHARD

Mr. Martinez arrived at the Ambassador Hotel on June 4, 1968, at 11:15 p.m., and went directly to the Ambassador Ballroom. He learned of the shooting while in the Ambassador Ballroom and heard a young lady, whom he later identified as Sandy Serrano, ask an older woman, "Who did they shoot? Did they shoot Kennedy?" The woman shouted to Serrano, "Don't start rumors like that, you'll start a riot." He noted that Serrano was becoming hysterical as she talked. He was sure the girl he later saw on television was Serrano.

MARWICK, GEORGE B.

Mr. Marwick reported a conversation on June 8, 1968, with Leonard L. Edwards. They were discussing the death of Robert Kennedy and Edwards stated, "When we don't like them in California, we kill them." Later, Edward Kennedy's name was mentioned and Edwards stated, "We'll kill that son of a bitch, too, if he runs." Marwick stated he did not know if Edwards was in Los Angeles the night of the assassination.

MASSOUGH, FARIED

Mr. Massough gave background information on John Antoine Khoury. He advised that Khoury was his next door neighbor in Beirut, Lebanon from 1960 to 1962. Khoury moved to the United States between September and November of 1962. He recalls the Khoury family were Egyptian. He recalls that Khoury was in Chicago for approximately two months in 1964, and that he has not seen Khoury since that time. Massough stated that Khoury had a very high regard for President John F. Kennedy. He remembers Khoury's family having financial problems and could never figure out how Khoury owned a new Chrysler, numerous new suits and would always go to the best places.

MATAS, GEORGE A.

Mr. Matas was Business Administrator for the Southern California Baptist Convention. He stated that Sirhan Sirhan had never been associated with the convention. Sharif Sirhan was employed as an accountant for one and a half years terminating in 1963. He stated that he had been aware that Sharif had a younger brother named Sirhan but had never met him.

MATSUI, KIMI (MRS.)

Mrs. Matsui stated she was not acquainted with Gilderdine Oppenheimer.

MATSUYOSHI, NANCY (MRS.)

Mrs. Matsuyoshi stated she was not acquainted with Gilderdine Oppenheimer.

MATTESON, MERLE

Mr. Matteson lives at Barn #3, Hollywood Race Track, where he is a groom and a hot walker. When shown photographs of Sirhan, he could not identify him as anyone he knew.

MAYTAG, BOB

Mr. Maytag, was a Kennedy staff member assigned to the San Fernando Valley Headquarters. On June 4, 1968, 9:30 p.m., he left his room at the Ambassador Hotel and went to the Embassy Room. He was at the west side of the stage near the anteroom when the shooting occurred.

MC ALLISTER, WILMA (MRS.)

Mrs. Mc Allister is a registered nurse and was so employed on June 5, 1968, at 12:30 a.m. At this time she observed the ambulance attendents taking the Senator into the hospital. She observed a fight between a photographer and another person. After making several telephone calls she returned to her duty station in the Police and Fire Ward.

MC BRIDE, JAMES

Mr. Mc Bride stated that Adel Sirhan is listed in the commercial credit clearance files. He stated that Adel's credit applications showed he worked as an entertainer at the Fez Restaurant, gave the name of Mike Siam as a personal reference and had a savings account at Altadena Savings and Loan.

MC BROOM, MARCUS, DR.

pr. Mc Broom, stated that he observed Sirhan in the pantry at 10:40 p.m., on June 4, 1968. He stated that Sirhan looked, "out of place", because of his clothing. Mc Broom was on stage at the time of the shooting, but was entering the pantry at the time Sirhan was being removed. He stated that he heard Jesse Unruh say, "Do you know what you have done?" Sirhan replied, "I did it for my country." "I can explain everything."

NOTE: All additional statements made by Mc Broom were later retracted and are not reported here.

MC CARTHY, GERALDINE

Miss Mc Carthy was a supporter of the Senator and arrived at the Ambassador Hotel June 4, 1968, after 9 p.m. Denied admittance to the Embassy Room, she went to the Ambassador Room. While cooling off on the fire escape outside the Ambassador Room she heard a woman yell, "There is a man up there with a gun." She saw another woman wearing a polka dot dress and a Kennedy campaign hat, shouting, "My God, Kennedy has been shot!" She could not identify the woman.

MC CARTHY, JOHN

Mr. Mc Carthy was conducting an investigation on Clifford D. Gresham for the State on an industrial claim. On May 29, 1968, he heard Gresham state that if Kennedy became president he would be shot. Gresham also stated that he would not be able to do some work on June 5, 1968, because of a very important appointment. On June 9, 1968, Gresham stated that it would probably happen again in Chicago.

MC CARTHY, JOHN FRANCIS (MRS.)

Mrs. Mc Carthy was the wife of John Mc Carthy who allegedly knew about the assassination of Senator Kennedy prior to the occurrence. She recalled that her husband had mentioned that he met a man who stated that if Kennedy were to become president or even before that, he would be killed. Her husband appeared very nervous after he heard an announcement of the assassination, especially in connection with a reported diary which had been found. The diary belonged to Sirhan and her husband thought a name was mentioned which might have had a connection with the conversation he had heard.

MC CARTHY, JUSTIN J.

Mr. Mc Carthy was registered at the Ambassador Hotel, Room 363,

attending a sales meeting for the Bulova Watch Company. He was one of the thirty-five employees attending the meeting. On June 4, 1968, at 10:30 p.m., he retired for the evening in his room. He was asleep during the incident and could offer no information.

MC CAUGHEY, WILLIAM

Mr. Mc Caughey stated on May 27 or 28, 1968, 5 p.m., he was in the Poddle Steak and Tavern in Pasadena. He and a friend were playing pool when Sirhan joined them and desired to play eightball for \$1.00 per game. Mc Caughey summarized that the bet was too expensive and guit playing. Sirhan was drinking beer and, "was feeling pretty good." He has not seen Sirhan previous to or following this incident. He was shown twenty-five photographs of male Latins and without hesitation selected Sirhan's photo.

MC CHESNEY, GROVE

Mr. Mc Chesney stated that he arrived at the San Gabriel Valley Gun Club at 8:30 a.m., June 4, 1968, and went to the rifle range. He found approximately twelve men on the range. He did not see any women at the club and did not go to the pistol range. He stated that he did not observe Sirhan at the range.

MC CONNELL, SHIRLEY (MRS.)

Mrs. Mc Connell stated that her daughter Susie was associated with the Jacobs family at 2149 North El Molino Street, Altadena. The Jacobs family had made statements that they knew Sirhan and were deeply shocked at what had happened.

MC CORMICK, JOHN

Mr. Mc Cormick contacted S.U.S. Unit and advised them his daughter Miss Sally C. Cherry had been receiving letters from Puerto Rico and stated the letters were threatening to Kennedy.

MC COY, ERMA V.

Mc Coy was asked if she saw Munir Sirhan at Nash's Department Store on June 1, 1968. Mc Coy stated that she observed Munir at the employees exit at 5 p.m., and invited him to a barbeque at her home on June 2, 1968.

MC CRACKEN, W. CHAVE

Mr. Mc Cracken was a member of Brownell Tour #216, and was

visiting the Holy Land on May 16, 1968. He stated the group lunched at the Semadar Hotel in Caesarea at approximately 1:30 p.m. He overheard a rumor that an attempt had been made on the life of Senator Kennedy in Milwaukee, Wisconsin. The rumor further indicated the Senator was alive but in critical condition. Mc Cracken stated he heard the news from his tour guide, Jacob Henigman, and that Henigman stated he heard the news on the air. Mc Cracken stated Henigman indicated the news was broadcast in Hebrew. Mc Cracken stated he attempted to confirm the rumor but nothing appeared in Israeli papers concerning the matter and he assumed the rumor to be false.

MC CREERY, FRANCIS

Mr. Mc Creery, Associate Professor and Supervisor of Distributive Education and Placement at Pasadena City College, related an incident concerning Sirhan B. Sirhan that occurred in July of 1967. Mc Creery stated that Sirhan came to the placement office seeking a job that had been listed on the placement bulletin board. Mrs. Jeanne Herrick was assigned to interview Sirhan regarding the job. Sirhan then came back to the office and told him that Mrs. Herrick would not tell him where the specific job was and that she did not want to give him a job because he was a "damn" foreigner. After making this statement, Sirhan left the office. Mrs. Herrick explained to him that Sirhan filled out the application form with only a minimum of information. Sirhan became adamant and demanded to know about the job. Sirhan then wanted his employment card returned, but was refused. After leaving the office, Sirhan requested the information card and it was given to him to avoid any further incident.

MC DANIEL, SIDNEY

Mr. Mc Daniel first met Sirhan in 1965 when he started working for Jack Davies at the Richfield Station in Pasadena. He knew Sirhan on a conversational level, but never new him socially. Sirhan seemed to have a fine personality and was a good worker but appeared to be a loner. He never met any of Sirhan's family and felt that Sirhan was a foreigner. Sirhan once mentioned to him that he liked to play the horses and that his ambition was to become a jockey. He was aware that Sirhan had fallen from a horse and was injured but does not recall where the incident occurred or the exact date.

MC ELROY, LEO

Mr. Mc Elroy contacted investigators and stated that the owner of a photo shop in the United Building at 7th and Broadway was in possession of a recent photograph of Sirhan with another person and was afraid to call the police.

NOTE: Investigators were unable to locate the alledged photo in the studio at that location.

MC EVOY, JAMES, III

Mr. Mc Evoy is a PhD employed by the University of California, Davis, California, in the Department of Psychology. Kennedy was scheduled to address the students and faculty at the college on May 16, 1968. Prior to Kennedy's arrival, Mc Evoy instructed a campus patrolman to order a young man out of a hallway behind the stage where Senator Kennedy was to speak as no one was permitted to be in that area. He described the young man as being of Middle Eastern extraction with a slight hesitation in his speech as if he were unfamiliar with the English language.

On June 26, 1968, he viewed photographs of Sirhan Sirhan taken by news photographers at the time he was being led away from the scene of the shooting. He also viewed photographs of Sirhan taken by the Los Angeles Police Department, as well as the photograph appearing on Sirhan's California driver's license dated March 18, 1964. The fullface newspaper photographs as well as the one taken by the Los Angeles Police Department did not resemble the person he observed in the hallway. He did note some similarity with the profile newspaper photograph of Sirhan as well as some resemblance in the photograph on Sirhan's California driver's license. He could not, however, identify the individual he had seen at the Davis Campus as Sirhan.

MC FARLANE, JOHN

Mr. Mc Farlane is a counselor at Pasadena City College and was previously employed in the same capacity at Muir High School. He vaguely recalled Sirhan as a pupil at Muir High School about 1960, through 1961; but could not recall anything specific.

MC GINLEY, PEGGY

An anonymous caller advised investigators that a teacher at Belmont High School, named Peggy, graduated from John Muir High School about the same time as Sirhan. The caller stated that she had radical ideas, and was wearing a polka dot dress on the day of the assassination. She was reported to live at the Los Feliz Arms.

Miss Mc Ginley stated that she was a teacher at Belmont High and lived at the Los Feliz Arms, but did not know Sirhan and was not at the Ambassador Hotel at the time of the shooting. She stated that she owned a polka dot dress but had not worn it for some time.

MC GINTY, BILLY

Mr. Mc Ginty first met Sirhan at The First Nazarene Church of pasadena, approximately two weeks prior to the shooting. Before entering church and again upon leaving, he observed a man standing in the parking lot. Mc Ginty's brother, Daniel, took him over to this man, introduced him and said, "Bill, I want you to meet Sirhan Sirhan; he's from Jordan." On June 3, 1968, Mc Ginty, a telephone repairman, answered a call directly across the street from the Sirhan residence at 696 East Howard. He was on a telephone pole when a car that he described as a possible MG with a hard top and badly oxidized, parked in front of the house. The car parked away from the curb and remained running for two to four minutes while the occupants talked.

After Senator Kennedy was shot, Mc Ginty, out of curiosity, drove by the Sirhan residence on Thursday, June 6. He said he saw a grey Mercedes parked in front of the house with a girl sitting in the car that appeared to be the same girl he had seen on June 3. The Mercedes had U. S. Counsel Service license plates.

MC GINTY, DANIEL

Mr. Mc Ginty first met the Sirhan family in 1958 or 1959 through his church. He vaguely remembered calling upon them when they lived on Mentor Street ten years ago. He claimed he did not remember introducing his brother, Bill, to Sirhan. When he was advised of his brother's statement, he said he could recall a like circumstance that occurred approximately six months prior to the shooting. He had observed a man standing in the foyer of his church and had introduced himself to the man. He recalled that when the man told him his name, the first and last names were identical. He viewed photographs of the Sirhan brothers and the look-alikes, but was unable to make an identification.

MC HALL, JOHN F.

Mr. Mc Hall was one of Sirhan's teachers at Eliot Junior High. He was Sirhan's physical education instructor and stated he was a good student and good in physical education. He recalls Sirhan got along well with the other students and was friendly toward everyone.

MC INTIRE, TIMOTHY

Mr. Mc Intire first met Sirhan when they were attending the First Baptist Church in Pasadena. At that time they were high school age and their activities were limited to meeting at church or church functions. He reported that he had not seen or talked with Sirhan since 1964.

MC KAY, KEITH

Mr. Mc Kay taught Sirhan Social Science at John Munir High School. Sirhan was registered in his 10th grade class but during an interview on June 24, 1968, he stated he could not recall having Sirhan in his class and had no personal knowledge of him.

Mr. Mc Kay was reinterviewed on August 1, 1968. At that time he changed his story stating he remembered Sirhan's being different because he was from a foreign country. He stated Sirhan had a good command of the English language for the short time he had been in the United States. It appeared Sirhan enjoyed wearing his California Cadet Corps Uniform to class. He stated Sirhan was polite and was willing to recite and discuss issues in class. Mr. Mc Kay recalled the class discussed world affairs at some length and Sirhan appeared interested. He observed no particular leanings against Israel at that time, although Sirhan had a nationalistic interest due to the fact that he was of Arabic background. He could recall no apparent anti-American feelings on the part of Sirhan although Sirhan did voice a scholarly disapproval of the United States policy of supporting Israel.

NOTE: This sudden recollection of details by Mr. Mc Kay is difficult to explain under normal circumstances. In light of the publicity and interest surrounding this case, investigators question the veracity of Mr. Mc Kay's second statement with the distinct possibility the entire context is a figment of his imagination.

MC KENNA, PATRICIA (MRS.)

Mrs. Mc Kenna is chief teller at the Crocker Citizens National Bank in Pasadena. She examined cashiers check number 174775 dated April 12, 1968, and paid to the order of Sirhan Sirhan. This check was brought to her attention by co-employees because the name of the person arrested for the murder of Kennedy and the name on the check were the same. She recalls making payment to an individual who had the name Sirhan Sirhan but does not recall the exact denomination of bills. She also recalls that she gave Sirhan \$100 bills that were in a used and worn condition. She was shown a photograph of Sirhan and recognized the person in the photograph as resembling the individual who identified himself to her as Sirhan. She did not recognize him as a regular customer. She checked the bank savings and checking account signature cards and was unable to locate a signature card.

MC LAUGHIN, JUANITA (MRS.)

Mrs. Mc Laughin was present on the Brownell Tour of the Holy Land on May 16, 1968. She stated that she did not hear any comments or statements made by anyone relative to Senator Kennedy being shot.

MEDINA, ROBERT

Mr. Medina was the manager of the film processing counter at Lucky Discount Store. He stated that he searched his records and could find no record of film being deposited by anyone named Sirhan. Medina viewed photographs of the Sirhan's, including Sirhan Sirhan, and made no identification.

MEGOWN, RICHARD

Mr. Megown stated that he disliked the Kennedy family and had made derogatory statements, but denied making the statement that he would kill one of the Kennedy's. He stated he did not know Sirhan Sirhan and had never seen any of the Kennedy's

MEJIA, ALICE (MRS.)

Mrs. Mejia was on duty as a nurse at Central Receiving Hospital on June 5, 1968, at approximately 12:45 a.m. At that time two other nurses removed the clothing from Senator Kennedy and gave them to her to wrap. After partially wrapping the clothing, she gave them to Mrs. Tolbert.

When the Senator was first taken into Treatment Room #2, she assisted in getting him on the treatment table. The oxygen tank fell to the floor due to Dr. Bazilauskas' eagerness to get the Senator on the table. Dr. Bazilauskas started artificial respiration until the resuscitator was placed and started. The airway was placed in the Senator's mouth to facilitate breathing. When the doctor saw that the Senator was breathing on his own, the resuscitator was removed and oxygen was again administered. Dr. Bazilauskas handed Ethel Kennedy the stethoscope so that she could hear the heart beat.

MELICHER, JOANNA MAY (MRS.)

Mrs. Melicher is employed at Nash's Department Store in Pasadena. She was questioned about seeing Munir Sirhan, who also works at Nash's, on Saturday, June 1, 1968. Mrs. Melicher stated she observed Munir Sirhan walk through the basement stockroom at approximately 4:45 p.m. This was the only time she saw Munir Sirhan on Saturday, June 1, 1968.

MEMONN, PHILIPPE

Mr. Memonn signed a registration card and listed Khaibar Khan's address. Khan stated he did not know Memonn and the investigator was unable to locate him.

MEREDITH, DAVID DONALD

Mn. Meredith was the third of three customers listed in the "lay away" receipt book of the Lock, Stock 'N Barrel Gun Shop. He was in the shop on June 1, 1968, between 12 noon and 3 p.m. He has seen Sirhan's picture but does not recall him as having been in the store.

MERKEL, LAWRENCE

Mr. Merkel is a member of the branch of the Theosophical Society which is located at 643 East Mariposa Street, Altadena. He manages the University Press which produces the literature and other publications for the Theosophical Society. He has no personal knowledge of Sirhan or Walter Thomas Rathke and was unable to find any records to the contrary. He said there are three separate and distinct branches of the Theosophical Society in the Los Angeles County area. Each local branch is under the auspices of the national headquarters in Wheaton, Illinois. He said he was aware that Sirhan had requested certain publications published by the Society, one being the "The Secret Doctrine" written by Madame H. P. Blavatsky. His branch of the Society does not hold meetings.

MERRIMAN, TRULA

Miss Merriman was a stenographer employed by the California Horse Racing Board. She stated the application for a "Hot Walker's" license was probably executed by Sirhan and the actual license was issued January 1, 1966, at the Santa Anita Race Track.

MERRITT, JACK J.

Mr. Merritt was a security guard at the Ambassador Hotel on June 5, 1968. He was assigned to the main doors of the Embassy Room when a woman ran out of the serving pantry and yelled, "My God, we need a doctor, Kennedy's been killed." Merritt stated that he drew his gun and ran into the pantry in time to see two men struggling with Sirhan. He phoned the police and for an ambulance. He stated that when he first entered the pantry, he observed two men and a woman walking away from him and out of the kitchen. They seemed to be smiling. He added that the woman was wearing a polka dot dress.

MERSON, RUBY (MRS.)

Mrs. Merson is the owner and manager of Denny's Restaurant on Colorado Boulevard in Pasadena and has never known Sirhan to frequent this restaurant. she further stated she was not aware of any quarrel at the restaurant in which Sirhan may have partic/pated.

MEW, DOUGLAS KIN

Mr. Mew is the son of Sang Mew, owner of the Sang Inn in Pasadena and worked at his fathers restaurant until 1965. He stated he does not remember meeting Sirhan and cannot recall Sirhan being in the restaurant.

MEW, RAYMOND

Mr. Mew is the son of Sang Mew, the owner of Sangs Inn, Pasadena. Mr. Mew stated he never met Sirhan and to the best of his knowledge, Sirhan never visited his father's restaurant.

MEW, SANG

Mr. Mew is the owner and operator of Sang Inn in Pasadena. He stated he is not acquainted with Sirhan and to the best of his knowledge Sirhan never visited his restaurant.

MEW, VICTOR

Mr. Mew, is the son of Mr. Sang Mew, the owner and operator of Sangs Inn in Pasadena. Mr. Mew stated he is not acquainted with Sirhan Sirhan.

MEWBORNE, LEO

Mr. Mewborne is assistant manager of the United States National Bank, 1255 North Lake Avenue, Pasadena. Mr. Mewborne stated he checked the bank records and was unable to find any transaction as described by Evelyn Fin and Beatrice Moore.

MEYERS, WILLIAM

Mr. Meyers reported hearing three Arabs in a "conspiracy-type conversation" at the Ambassador Hotel. Myers stated that he was working as a telephone operator at the Ambassador Hotel and observed three Arabs talking in the hotel. He stated that a co-employee, W. J. Wood, heard the conversation and determined the men were speaking Arabic, and one of them had stated, "If we can't catch him today, we'll catch him tonight."

NOTE: This allegation was proven to be false; and after a confrontation between the two reporting parties, it was determined they reported this alleged occurrence for publicity.

MEZA, GARY

Mr. Meza was the bartender at the Shaps Bar, 2565 East Colorado Boulevard, Pasadena. He could not identify any photographs of the Sirhan brothers.

MICHAUD, DENNIS

Mr. Michaud was the State Chairman for Students for Kennedy. He arrived at the Ambassador Hotel with his wife, Thora, at 6 p.m., and went to the Presidential Suite and remained there until 12 a.m. When the Senator walked downstairs to deliver his speech, he followed. After the shooting he attempted to enter the kitchen but was unable due to the crowd. He then left and went to the Ambassador Ballroom. He returned to the Presidential Suite and remained there until 4:30 a.m.

MIDBY, GLEN H.

Mr. Midby arrived at the hotel at approximately 10:30 p.m., June 4, 1968. During Senator Kennedy's speech, he stayed in the Colonial Room and watched the proceedings on television. At the conclusion of the speech, he waited by the double doors leading to the kitchen because a woman had informed him earlier that the Senator would enter at this point and make a brief statement. As he waited he heard five shots fired rapidly. He went approximately ten feet into the kitchen, jumped over some tables, and saw Sirhan holding a gun. Several people had Sirhan's arm down on the table. Someone knocked him away, so he walked over to a man on the floor who had been shot in the head. He turned and observed Kennedy on the floor. He did not hear Sirhan make any statements.

MIDDOUGH, BRUCE

Officer Middough stated that Mr. Kenneth Frey took several pictures at Long Beach Airport on May 20, 1968, at 6:30 p.m., and Frey thought one picture was that of Sirhan. Mr. Frey later identified the person and it was not Sirhan.

MIKHAEL, AZIZ TEWFIC AZIZ

Mr. Mikhael stated that he was born in Egypt and came to the United States in 1967. He denied any prior knowledge of a conspiracy or an assassination. He does not know Sirhan. Mikhael stated that since his arrival in the United States, the only person he has corresponded with in Alexandria, Egypt is his mother.

HIKI, PAM

Miss Miki is the secretary for the Joe Pyne Show on television, KTTV in Los Angeles. She stated that for several days following the assassination of Senator Kennedy, the show was deluged with calls from people who indicated they recognized Sirhan as an individual who had recently appeared on the Joe Pyne Show. The callers indicated that Sirhan had been in the studio audience and had come up to the "Beef Box" to express a viewpoint supporting the Arab position. Miss Miki stated that individuals who appear in the "Beef Box" are requested to sign a waiver and a search had been conducted and no waiver was found bearing the name of Sirhan. Miss Miki stated the video and audio tapes of the shows have been erased.

MIKLOS, ELINOR M.

Miklos lives at 677 South New Hampshire, Los Angeles. She stated that she arrived home at 5:15 p.m., on June 4, 1968, and did not see a car resembling Sirhan's parked in the 600 block of South New Hampshire.

MILICIC, IVAN

Mr. Milicic is the owner of a Chevron Service Station, 233 North Altadena, Pasadena. He employed Sirhan from August 15, 1965 to September 17, 1965. He recalled Sirhan as a quiet, well-behaved young man who was a "loner" and did not have many friends.

Sirhan gave the reason for his leaving as "failing grades in college." The last time he saw Sirhan was at 11 a.m. on June 3, 1968, when Sirhan was purchasing gasoline at the Richfield Station.

MILLER, CHARLES

Mr. Miller was employed by NBC, as a security guard, to watch the mobile units outside the Ambassador Hotel. A young woman advised him that Senator Kennedy had been shot and Miller remained at his post. He reported that no one ran by him or left the hotel in a hurry. He was at the base of the outside stairway on the north-west corner of the Embassy Room.

MILLER, CHARLES B.

Mr. Miller was the owner of Richard and Gloria Abdo's residence. He stated that they were model tenants. He did not make a telephone call to the police suggesting that Abdo was involved in the assassination. He suggested that perhaps another tenant made the call.

MILLER, DEBBIE

Miss Miller stated that a person who looked like Sirhan came into the airline office at, 500 West 6th Street and asked about a flight from Denver to Los Angeles.

MILLER, DOROTHY (MRS.)

Mrs. Miller contacted investigators in the Indiana office of the F.B.I., and stated that she recalled observing Sirhan "hanging around" a building in Pasadena, California. She stated she resided in Pasadena from November, 1965 to November, 1966.

NOTE: Mrs. Miller currently lives in Warsaw, Indiana. She had no further information.

MILLER, ELIZABETH

Miss Miller stated she was a volunteer campaign worker for Senator Kennedy and that she arrived at the Ambassador Hotel on June 4, 1968, at 8 p.m. She went directly to the Ambassador Room and remained until after the shooting. She stated that shortly after midnight she heard an announcement over a radio that Senator Kennedy had been shot.

Miss Miller was interviewed on June 6, 1968, by Rampart Detectives during which time she stated that an unknown woman had approached her in the main ballroom and informed her that she overheard a third woman say, "We have shot Kennedy.

Miss Miller now states she was not approached by a woman and that it was nothing but a rumor and passed on to her by Kathy Lentine. She believes the rumor was not true.

MILLER, GENE (MRS.)

Mrs. Miller, Assistant Principal, John Muir High School, stated that all school records concerning Sirhan had been forwarded to Mr. John T. Harris, Coordinator of Pupil Personnel Services for the Pasadena School System.

MILLER, HYMAN

Mr. Miller came to Rampart Police Station on June 6, 1968, and stated he knew the suspect in the shooting. Mr. Miller was shown photographs including Sirhan's, but he failed to pick out Sirhan. He stated that he saw the suspect on television and that he resembled a Puerto Rican that frequents the "Slave Market" at 7th and San Pedro.

MILLER, MILTON A., DR,

Dr. Miller is an optometrist with offices at 824 South Main street, Corona, California. He stated that he first examined Sirhan Sirhan on November 8, 1966. He stated that Sirhan gave the history of being thrown from a horse while working at one of the local farms. Miller examined Sirhan's eyes and found 20-20 vision in both eyes. He stated that there was a small area of vision in the right eye that might have been restricted to a slight degree. He stated that Sirhan appeared to exaggerate his injuries and described him as a malingerer. Sirhan requested Dr. Miller to write a letter to his insurance company, and Miller advised him that his injury was not of a nature wherein he could collect compensation. He advised that this made Sirhan very angry and nervous. On December 20, 1966, approximately two hours after the previous conversation, he received a telephone call from Sirhan who told him something to the effect that if he did not grant his request he would, "get him."

MILLER, ROSS MATTHEW, DR.

Dr. Miller stated he was at the Ambassador Hotel on June 5, 1968. He advised he was downstairs watching television when news was received that Senator Kennedy had been shot. He responded to the kitchen when he heard the call for doctors. He went to the kitchen and saw Senator Kennedy lying on the floor with blood on his head. Dr. Miller stated he felt Kennedy's pulse which was strong but more rapid than it should have been. He then turned his attention to Schrade lying on the floor and from his examination, Schrade appeared to be in serious condition. Dr. Miller stated he then examined Stroll-who was wounded in the knee. He accompanied Schrade to Central Receiving Hospital.

MILLER, VERN ALLEN

Mr. Miller, a police officer, Pomona Police Department was assigned to the reception-luncheon held for Kennedy at Robbie's Restaurant in Pomona. Miller does not recall seeing a young couple detained on the restaurant staircase nor anyone resembling Sirhan B. Sirhan.

MILLER, VERNA C.

Verna Miller stated she is a member of the Ancient Mystical Order of Rosae Crucis at the Akhnaton Chapter in Pasadena. She is a hostess for the lodge and stands in the hallway and greets members as they enter. She stated she was at the meeting on May 28, 1968, and recalls greeting a young man who was attending his first meeting. She asked him his name and because of the difficulty in pronouncing this name, she had him write his name

in the guest book. Miss Miller recalls the name of Sirhan. She further advised that during the meeting an experiment was performed by the Grand Master, Mr. Ted Stevens, and Sirhan volunteered to assist in the experiment. She did not observe Sirhan after the meeting was concluded. Miss Miller was shown photographs and she selected Sirhan's as the person whom she saw at the meeting.

MILLNER, CHARLES M.

Mr. Millner, stated on June 4, 1968, he accompanied Russell Weaver to the San Gabriel Valley Gun Club. They arrived between 10 a.m., and 12 noon, and remained forty-five minutes. The range is divided into a pistol and rifle range. Millner and Weaver went to the pistol range portion. When they arrived, there was one other individual on the range. Several other men, including his neighbor, Jesse Cardona arrived later. He was shown photographs of Sirhan but could not say whether or not he had seen Sirhan at the range.

MILLS, ROY G.

Mr. Mills stated that he observed Sirhan in the pantry prior to Senator Kennedy's speech. Sirhan was talking with a young lady at the time, but the two did not appear to be together. Mills was in the anteroom at the time of the assassination.

MÍNASIAN, EDWARD

Mt. Minasian walked with Senator Kennedy into the kitchen from the stage. He was walking approximately three feet ahead and to the right of Senator Kennedy and Karl Uecker. He was looking back at the Senator and observed a person (the suspect), move up quickly from his right, pass Karl Uecker and begin shooting. As Uecker grabbed the suspect's arm and head, Minasian grabbed the suspect about the waist. He looked to his left, observed Paul Schrade on the floor and the Senator falling to the floor. He can identify the suspect.

MINNS, BLAISE MAX

Mr. Minns works for the Ambassador Hotel as a waiter in the banquet department. He was in the hallway leading into the north end of the kitchen at the time of the shooting. He heard what sounded like firecrackers, and walked through the swinging doors into the kitchen. He looked into the pantry and saw Mr. Timinson to his left. He saw a group scuffling and recognized Mr. Uecker who was holding a short man by the neck. He went behind Uecker and could see Senator Kennedy on the floor.

MIOCH, GEORGE S.

Mr. Mioch stated that on June 4, 1968, he went to the San Gabriel Valley Gun Club at 11 a.m., with his daughter, Mara Mioch, Mrs. Corliss Edwards, and her son, Robert Edwards. They were there for the purpose of practicing on the rifle and pistol range. They bought targets, and he and Corliss argued briefly over her possession of a revolver and the fact that she did not know how The range master, Everett Buckner, witnessed the to use it. brief argument. The foursome practiced at the rifle range until 12 noon, then went to target #13, on the pistol range. He and the rest of the group noticed a person they later identified as Sirhan Sirhan firing on target #9 or #10. Their attention was -drawn to Sirhan after an employee of the range asked the group who owned a De Soto. Sirhan held up his hand and identified himself as the owner and then left the range to move the car. None of the group had a conversation with Sirhan.

MIOCH, MARA

Miss Mioch went to the San Gabriel Valley Gun Club on June 4, 1968, with her father, George S. Mioch, Mrs. Corliss Edwards, and her son, Robert Earl Edwards. The group went at 11 a.m., to the rifle range after purchasing targets. Her father and Mrs. Edwards argued over Mr. Mioch's insistence that Mrs. Edwards learn to fire her revolver that day. The range master, Everett Buckner, heard the conversation and would have interpreted it as an argument. At 12 noon the group went to the pistol range and practiced at target #13. They noticed a man whom they later identified as Sirhan Sirhan practicing at target #9 or #10. Their attention was drawn to him when an employee of the club questioned the group as to the ownership of a De Soto. Sirhan identified himself as the owner and left the range briefly to move the car. None of the group had a conversation with Sirhan.

MISRACH, JACK L.

Misrach, the owner of United Sporting Goods, Los Angeles, was interviewed regarding the sale of sports equipment to Jerry Owen. Misrach knows most of the boxers and managers who come into his store. He does not know a Jerry Owen, Curly Owen, or Rip O'Riley. He was shown a picture of Owen, and did not recall seeing Owen in his store on June 3, 1968, or any other time. The sales receipts of June 3, 1968, were checked with the assistance of James Gallagher, credit manager, and no sales receipt for boxing shoes and robe was found.

MISTRI, GAYMOARD

Mr. Mistri was at Bob's Restaurant the night of June 4, 1968. He stated that he arrived at approximately 6:15 p.m., and Sirhan

arrived fifteen minutes later and sat next to him at the counter. They chatted for a short time, then Sirhan looked at a newspaper article reporting hostilities on the Jordan-Israeli boarder and stated, "This is bad, this is terrible." Later they went to Pasadena City College Cafeteria and joined some friends for coffee. A few minutes later the friends left for classes, leaving Mistri and Sirhan at the table. Sirhan showed Mistri a piece of metal, which Mistri thought was a bullet, and talked about rabbit hunting. At 7:15 p.m., they left and Sirhan invited Mistri to play pool, but he declined. Both left in their own -cars. He described his association with Sirhan as a campus acquaintance.

MITCHELL, CHARLES W.

Mr. Mitchell stated that he is a minister and the pastor of the Pasadena Seventh Day Adventist Church. He stated that he has known Mary Sirhan, John Weidner and Henry Peters through his church activities, but only knew of two or three services which Sirhan attended.

Mitchell stated Mr. Henry Peters and Sirhan had been involved in a Bible Study program. He described Peters as being an enthusiastic and aggressive church member who was quite active in his religious endeavors. Prior to returning to Wisconsin, Peters informed Mitchell that he had been visiting Sirhan for the purpose of teaching Bible lessons and requested someone continue the program when he left. Mitchell asked Mr. G. Heacock to continue the lessons. Mr. Heacock was unable to undertake the assignment and his wife, Margaret Heacock, assumed the task.

MITCHELL, TOM

Mr. Mitchell was employed by the National Tire Service, 1000 West Rosecrans Boulevard. He stated that just prior to the assassination, a man entered and asked to bring in a friend to purchase some tires. On June 12, 1968, the same man drove into the tire service and stated, "the man that I was going to bring in here to buy tires will not be in because he is the man who shot Senator Kennedy." Mitchell stated that the man was with another person and the two of them were speaking in a foreign language while they changed some tires.

MITCHELL, WILLIAM

Mr. Mitchell went to the Embassy Room, June 4, 1968, 6:20 p.m. From 8:30 p.m., until the completion of Kennedy's speech, he stood directly in front of the podium. After the speech he heard people shouting that Kennedy had been shot, and he went to the kitchen area and saw Senator Kennedy on the floor and people struggling. He did not see Sirhan until he was taken

out of the hotel by the police. He also observed a girl in a polka dot dress standing next to him near the podium, and this girl left shortly before the speech. He described her as a female Mexican, 21, 5'5", 105, blond hair with black roots. He described the dress as sleeveless, white with black polka dots, and a high neck. She was also wearing a Kennedy hat.

MOCK, JASPER R.

Mr. Mock was Sirhan's neighbor. He stated that he talked with Sirhan on several occasions and their conversations were about automobiles. He stated he did not know any of Sirhan's friends and recalled that Sirhan was always very quiet and caused absolutely no difficulty in the neighborhood.

MODJALLALY, MARIAN

Miss Modjallaly is a waitress at Ernie Junior's Taco House, 126 West Colorado, Pasadena. When shown pictures of Sirhan and Walter S. Crowe, she recalled Sirhan but not Crowe. She remembered Sirhan as a fellow student at Pasadena City College in 1965. She never knew Sirhan personally and never saw him or Walter Crowe in Ernie Junior's Taco House.

MOJICA, RICHARD

Mr. Mojica came to police headquarters and reported knowing of a Mafia plot involving Sirhan. He stated that Vito Loverde (a cousin of the Chicago Mafia boss), handed Sirhan the violin case containing the .38 Derringer that was used to kill Kennedy. Loverde then left the hotel with a girl wearing a polka dot dress.

NOTE: Investigation revealed statements made by Mr. Mojica were entirely false and without foundation.

MOKHTARIAN, ALEX

Mr. Mokhtarian stated he remembered meeting Mrs. Sirhan at the First Baptist Church in Pasadena. He did not meet any of the Sirhan children.

MOKHTARIAN, DEBORAH (MRS.)

Mrs. Mokhtarian advised that she met Mrs. Sirhan at the First Baptist Church in Pasadena during 1956. She recalls that the Sirhan boys attended the church but that their attendance was sporatic. She stated that Mrs. Sirhan's husband came to New York City for a short period, but did not go to California. From 1958 through 1962, Mrs. Mokhatarian lived approximately one block from the Sirhan residence on Howard Street. She had occasion to meet Sirhan Sirhan at the bus stop in the mornings during that period. She describes Sirhan Sirhan as bitter, and extremely unhappy. She never observed Sirhan smiling or in a good mood. In her conversations with Sirhan he constantly complained that he did not like the laws and orders of the United States and that he felt that there was no justice in the educational system of the United States. Sirhan once told her that he should be given a college degree in one year and that he did not like to work for this degree. He told her that he did not like to work for a living and felt that other people in the United States should give him money. She asked Sirhan if he had become a citizen of the United States and that Sirhan

Sirhan also complained to her about the lack of religious ceremonies at the First Baptist Church. Mrs. Mokhtarian told Sirhan Sirhan if he wanted ceremony, he should attend the Catholic Church.

Mrs. Mokhtarian's only contact with the Sirhan family was through the First Baptist Church in Pasadena and occasional contacts in the neighborhood.

MOKHTARIAN, HECTOR

Mr. Mokhtarian's parents attended the First Baptist Church located on North Marengo Avenue, Pasadena. He stated he learned that his mother knew Mary Sirhan through the church. He added that he was not acquainted with any members of the Sirhan family.

MOLITER, RAY E.

Mr. Moliter stated that his photograph was taken at Los Angeles International Airport just as he was preparing to shake Senator Kennedy's hand. He stated he was of the opinion that Sirhan was in one of the photographs.

NOTE: The photograph was examined and it was determined that the person was not Sirhan.

MOLLOY, ANNETTE (MRS.)

Mrs. Molloy was also known as Mrs. Hudson Roland Molloy. Mrs. Molloy stated she attended Pasadena City College in 1963 or 1964, and knows that Sirhan was a student but could not furnish any information concerning his background or associates.

MOLLOY, HUDSON ROLAND

Mr. Molloy stated that he attended Pasadena City College with

Sirhan in 1963 and 1964. He knew Sirhan as an average student who was friendly with everyone. Sirhan didn't appear to have any complaints with the Arab-Israeli situation.

MONTELLANO, DAVID

Mr. Montellano was at the San Gabriel Valley Gun Club on June 4, 1968. He was with Henry Carreon and arrived at 11 a.m. He went to the rifle range, then joined Carreon on the pistol range. He stated that he observed Sirhan firing on position number five or six and noted that he was practicing rapid firing techniques. He asked Sirhan the caliber and make of his revolver and Sirhan told him, .22 caliber and pointed at the top of the revolver and allowed Montellano to read the inscription that stated Iver Johnson. He noted a total of eight cartridge boxes in front of Sirhan, six of them empty yellow boxes, the other two being mini-mags. He stated that he left the range at 2 p.m., and that Sirhan was still firing at that time.

MONTOYA, RODRIGO

Mr. Montoya was interviewed after his landlady, Mrs. Leitta Mc Peak, reported observing a gun in his room. Montoya stated that the gun was a starter pistol operated by blanks.

NOTE: Investigation disclosed that Montoya was not connected with the assassination.

MOON, MIKE

Mr. Moon stated that from March, 1967, until August, 1967, he took oud lessons from Adel Sirhan. He took the lessons in the Sirhan home and on several occasions saw Sirhan Bishara Sirhan. Mr. Moon stated he did not engage in any extensive conversation with Sirhan. On a few occasions, Sirhan voiced an opinion that the government of the United States made the rich people richer and poor people poorer. He stated that Sirhan appeared to possess an intense pride in his Arabic heritage.

MOORE, BEATRICE (MRS.)

Mrs. Moore reported seeing a suspect enter the bank at 1255 North Lake Street, Pasadena, when the bank opened on June 4, 1968. She believed the suspect was related to Sirhan, due to his facial characteristics. Mrs. Moore stated that the suspect ran into the bank and went to Nellie Coumans, a teller. She stood behind the suspect and observed him withdrawing an unknown amount of money from his mother's account. She was unable to state the amount of money withdrawn as it was placed in an envelope by the teller. Mrs. Moore noticed the suspect

was very nervous and impatient. At the completion of the transaction the suspect ran from the bank.

NOTE: Mrs. Moore was shown photographs of Munir Sirhan, Adel Sirhan, Saidallah Sirhan, Nabil Khoury and Sirhan Sirhan. She stated that the suspect was not in the group of photographs. Mrs. Moore was in the company of Evelyn Fin at the time of the occurrence.

MOORE, LEE TAYLOR

Moore phoned the F.B.I. and stated that Abdoolah Manoocheri, an Iranian, was a friend of Sirhan's and should be investigated.

MOORE, MARIANNE

Moore was Dr. Tashmas secretary at the time Sirhan was being treated. She remembers Sirhan as being loud, sarcastic and a trouble maker.

MOORE, MELBA (MRS.)

Mrs. Moore was employed at 8555 Wilshire Boulevard. She stated that a female of Arabian extraction periodically walked by her window, wearing Arab type dresses. She stated that after the assassination the woman began wearing conventional clothing.

MOORE, ROGER GLEN

Mr. Moore worked as a mechanic for Jack Davies Garage in Pasadena from August or September, 1963 until June, 1966. During his employment he came to know Sirhan who was also working for Davies in the service station section of the business. Mr. Moore has worked on an old car of Sirhan's, a Cadillac, but he and Sirhan never became particularly friendly nor did they socialize. On occasion he and Sirhan may have had a beer at the station. Sirhan did not socialize with anyone and did not have friends come by the station to visit him. Sirhan never had any political discussion and never made any remarks that could be construed as being against the United States. Tn June, 1966, Mr. Moore rode to the racetrack with Sirhan but nothing unusual transpired. He has seen Sirhan only one time subsequent to this, which was in January, 1967, at the Santa Anita Race Track but did not engage in any conversation with him.

MOORE, RONALD LOUIS

Mr. Moore is the registered owner of the pick-up truck alleged

by Jerry Owen to be involved as the "getaway" car. Mr. Moore related that he traded his truck to Eddie Whitehead for a 1950 Chevrolet and that Whitehead in turn sold the truck to a riding stable at 3016 West Fifth Street, Santa Ana. Mr. Moore stated the truck has always been green and has not changed in appearance except for the additional of a horse statue on the hood.

MOORE, SPENCER

Mr. Moore manages a Chevron Service Station at 500 N. Mission Road, Los Angeles, He stated that during the last week in May 1968, a customer told him that he overheard a conversation, at a Free Press Meeting, on the U.C.L.A. campus, that someone intended to rough up Senator Kennedy when he met with Cesar Chavez in Fresno. Moore stated he has not seen the customer since that time.

MORALES, SAMUEL

Mr. Morales stated that he believed the assassination was a Communist inspired conspiracy. He had no evidence to this effect but wished to contact a CIA agent to elaborate on his ideas.

MORE, JEAN O. (MRS.)

Mrs. More, records clerk, John Munir High School, furnished information on Keith Phillip Mc Cormick, Bryant Meyers, Stephen Joseph White, and Patricia Neil Ferguson. Mrs. More furnished the original copies of two Pasadena City Schools Senior High program cards dated September 11, 1961, and January 29, 1962, for Sirhan B. Sirhan. Mrs. More stated she did not see Sirhan sign these documents.

MORENO, JOSEPH S.

Mr. Moreno stated he is employed at the Granja Vista Del Rio Ranch in Corona. Mr. Moreno states he recalls Sirhan Sirhan working at the ranch in June of 1966. During the time Sirhan was employed at the ranch he and Moreno had numerous conversations, but never discussed politics, or religion. Mr. Moreno describes Sirhan as being very well mannered and very cooperative with fellow workers. Moreno advised that Sirhan was a loner and always came to work alone and left alone. He recalls Sirhan being thrown from a horse, but does not know if he sustained any injuries from the fall. He has not seen Sirhan since November of 1966.

MORLEY, JAMES

Mr. Morley said he has never made a direct accusation against Bundakji, but has only reported rumors he heard at the gas station where Bundakji is employed. To his knowledge, Bundakji is a fine person and has always been law-abiding.

MORRIS, WILLIAM

Hr. Morris was the Vice Chairman of the Kennedy Campaign under Jesse Unruh and arrived at the hotel June 4, 1968, 8:30 p.m. During the Senator's speech he was standing ten feet south of the anteroom. During the shooting he was in the same approximate location and heard what he thought to be dishes breaking. He entered the kitchen approximately one half hour after the shooting. He left the hotel at 3 a.m.

MORSE, JOHN BERT

Mr. Morse was told by his waitress, Mabel Adaline Jacobs, that on June 5, 1968, 10 a.m., Jerry Owen entered the coffee shop and sat at the counter next to the cash register looking at a newspaper. Owen pointed to a picture of Sirhan and commented that he picked up this kid and some other hitchhikers; that he drove them to the Ambassador Hotel and they got out. Owen had a horse in the truck that he was taking to Oxnard. While waiting in his vehicle, Owen was approached by a well dressed man and told him that the kid wanted to buy the horse and if he would remain, he would give Owen the money for the horse. Owen gave the man his card so that they could get in touch with him. Owen then commented to Morse, "Maybe they want to use me." Morse told Owen to go to the police and make a report.

MOSER, LEONORE EVE

Miss Moser was a Student for Kennedy worker, she arrived at the Ambassador Hotel on June 4, 1968, and entered the Embassy Room via the kitchen a few minutes prior to the victory speech. No one stopped her from passing through the kitchen and she did not see any uniformed guards. Everyone in the kitchen appeared to be wearing white with the exception of one woman who was wearing a brightly colored dress. She heard the speech from the northwest portion of the room and was using the telephone to call her father when the shooting occurred. She remained in the Embassy Room until it cleared and then left.

MOST, VERNON

Mr. Most is the manager of the Houseware Department, F. C. Nash and Company in Pasadena. He is the immediate supervisor of Munir

sirhan. Mr. Most stated that Munir worked from 9 a.m., to 6 p.m., on June 4, 1968.

On June 5, 1968, at approximately 9 a.m., Munir came out of the employees coffee room where a television set was tuned to a station covering the Robert F. Kennedy shooting. Munir appeared to be very upset and stated, "My God, I think my brother shot Kennedy." Munir borrowed Mr. Mosts' car and left the store. He returned at approximately 10 a.m., and stated that he and his brother, Adel, had gone to the police department and identified their brother.

Mr. Most asked Munir if the gun used in the shooting was his, to which Munir replied, "I can't say." Soon after this some detectives from the Los Angeles Police Department arrived, they talked to Munir and when they left Munir accompanied them.

Mr. Most stated that on the first of each month Munir is required to report to someone, possibly his probation officer. On June 3, 1968, Munir left the store for this reason and did not return to work that day. The reason he gave was that he had lost the piece of paper which permits him to leave and return to work.

While employed at Nash's Department Store Munir became good friends with Richard Salas who terminated his employment on May 6, 1968, and entered the service.

MOTHERSHEAD, ALICE (MRS.)

Mrs. Mothershead is Director of the Community Liaison Center, Pasadena City College. Mrs. Motherhead advised she was in charge of the activities of the International Club. She has checked her records and has no recollection or knowledge of Sirhan belonging to the International Club. Mrs. Motherhead stated she also has no record of a student Mustafa Sermain being affiliated with the International Club. She recalls Abdul Dabbas and stated she met him in 1956 while he attended Pasadena City College on an immigrant visa. She further stated she had rented him a room in her house for a brief period of time. The last recollection she has of Dabbas was a brief conversation in 1962. She has no current knowledge of his present whereabouts.

MUNDELL, JAMES

Reverend Mundell stated that he was a personal friend of the Kennedy family and a laicized priest. He went to Central Receiving Hospital and administered the Last Rights to Senator Kennedy. He stated that Ethel Kennedy gave him a bundle containing the Senator's clothes, which he gave to a police officer.

MUNNO, TONY

Mn. Munno was employed as a waiter at the Fiore D'Italia Restaurant. He stated that a customer named Joe was asked to help the chef get a job for a friend who wanted to become a jockey. Nothing was discussed involving Sirhan, the assassination or Senator Kennedy.

NOTE: Reference - Joseph S. Euistolise

MURPHY, EILEEN NORMA

Miss Murphy stated that she met Sirhan Sirhan two years ago when she was dancing at the Fez Restaurant. She was engaged to marry Adel Sirhan in June 1967, but it was terminated because of family objection. She stated that they continued to date until June 3, 1968. She met Adel's family, including Sirhan, who appeared to be an introvert and he spent the majority of the time in his room. She asked Sirhan why he didn't get a job and he stated that he had other things to do.

MURPHY, FRED A.

Mr. Murphy was employed as a security officer at the Ambassador Hotel. On the night of June 4, 1968, Mr. Murphy stated he learned from an unknown female that the Senator would exit to the rear of the Embassy Room following his speech and proceed through the kitchen and pantry area. Murphy stationed himself between the Colonial Room and Embassy Room to prevent any of the crowd from entering. Shortly after the Senator finished his speech, Murphy heard the sound of three gunshots. He proceeded into the pantry and observed Sirhan Sirhan on a steam table being held by two men. He attempted to get the gun from Sirhan's left hand, but was pushed away. Immediately thereafter, Roosevelt Grier obtained the gun and passed it to Rafer Johnson. Mr. Murphy immediately placed a call to the bell captain to phone the police and request an ambulance. Mr. Murphy stated that he did not see Sirhan or a woman in a polka dot dress prior to the shooting.

MURRAY, BARBARA (MRS.)

Mrs. Murray was standing near a television monitor in the pantry at the time of the shooting. She stated that there were five or six people standing between her and the suspect and did not see him. She observed Irwin Stroll jumping around and shouting, "I've been shot."

MURRAY, DAVE

Mr. Murray states he is a reporter for the Chicago Sun Times.

He arrived at the hotel during Kennedy's speech. Mr. Murray advised he went to the Colonial Room for five to ten minutes and then went into the kitchen. He was inside the kitchen when he heard shots. Mr. Murray stated he ran towards the sound and observed a struggle in progress at one of the serving tables. He couldn't distinguish any individuals in the struggle but did see a gun. He saw Kennedy lying on the floor, blood streaked across his face, his head was raised and his eyes were half open. After seeing Kennedy he ran to a telephone.

MUSSELL, GARY L.

Mr. Mussell called investigators and stated that he saw Sirhan at the Kennedy Headquarters a week prior to the assassination.

NOTE: Upon reinterview, Mussell was unable to identify Sirhan's photograph as the person he observed at the headquarters.

NABER, JOHN

Mr. Naber stated that he did make the statement that he had double dated with Sirhan, but that he meant Sharif Sirhan. He verified that he had double dated with Sharif Sirhan in 1964, but never visited the Sirhan residence. He stated that he was not acquainted with Sirhan Sirhan. He reported knowing Ahmed Mohassin, but was unaware of his whereabouts.

NAFFA, KIM

Mr. Naffa, instructor at Fullerton Junior College, stated he teaches an adult education class pertaining to the general philosophies of life. Naffa stated he does not know Sirhan and that Sirhan has never appeared before his class to speak about the Arab situation.

NAFIUS, TEDDY MARIE

Miss Nafius was contacted during a search for Khalid Iqbal. She stated that she met the man (in the Time Magazine photograph) at a party in May, 1968. She stated his name was Ali Ahmand and was Jordanian.

NAGER, J. MRS.

Mrs. Nager, Personnel Director, I. Magnin and Company, stated that the employment application files in Los Angeles, Pasadena and San Francisco were searched, and no record for Sirhan B. Sirhan could be found.

NAGIN, LARRY

Mr. Nagin was a volunteer campaign worker and advance man for the Kennedy campaign. He went to the Ambassador Hotel on June 4, 1968, 5 p.m., with his wife, Sherri. He went to the Embassy Room and remained until 10:30 p.m. when he left and went to the Senator's suite. He remained in the suite until 11 p.m. When he was about to leave, he was informed by Peter Smith that the Senator was to attend a party at "The Factory," and Nagin was to arrange for a caravan to transport the guests. He was in front of the hotel waiting for Kennedy when he heard of the shooting and assisted Irwin Stroll into a taxi and sent him to Central Receiving Hospital.

-NALKI, MARIA CHRISTINA

Miss Nalki attended a meeting of the Peace and Freedom Party at 3800 Amesbury Road, on May 21, 1968. She was unsure that the

man at the meeting was Sirhan and could not identify his photograph.

NAUMIS, GEORGE

Mr. Naumis is the bartender at the "Talk of the Town Bar," 5230 North Citrus, Glendora. He stated he recalls Mr. Gearhart bringing a purse to the bar but does not recall the date. The purse belonged to a Mexican girl who worked at Riccar on Citrus Boulevard.

NEAL, CAROL FRANCIS

Miss Neal attended Eliot Junior High School in 1959 and was in Sirhan's class during Politics, Geography and English.

She regarded Sirhan as an odd person who did not associate with other students. Sirhan was considered quite intelligent and the teacher, Mr. Sogohomian, kept Sirhan's term paper to display as an example of how it should be done.

During political discussions Sirhan would compare America with his old country, which she thought to be Syria. She got the impression that Sirhan did not like the United States.

Sirhan frequently argued with the teacher, and if he wasn't acknowledged would wave his hand and snap his fingers. She has not seen Sirhan since 1960.

NEAL, WILLIAM B.

Doctor Neal treated William Weisel at Kaiser Hospital on June 5, 1968 at 2:30 a.m. He stated that the bullet wound did not penetrate the stomach wall. The bullet was removed and given to a Los Angeles Police Officer.

NEILSEN, EMMA

Miss Neilsen, Mrs. Blais, and Mrs. Jergenson were confronted by a young man, twenty-five to thirty, carrying a black suitcase. This young man told them that Kennedy would not be elected since he lost over a million votes in Chicago because of his stand on Israel.

NEILSON, JANET

Miss Neilson attended Pasadena City College from 1964 through 1966. She met Sirhan while in a Freshman Biology class. Sirhan would ask her questions or borrow notes and was quite

friendly, but never on a social basis. Sirhan never mentioned any of his pólitical beliefs.

NELSON EZELL

Mrs. Nelson recieved a letter from her son, Abbott, which was written on June 8, 1968, in Baghdad, Iraq. A portion of this letter stated "About two weeks ago we heard a rumor that Senator Kennedy had been shot. The second time was not a rumor."

NELSON, LAWRENCE

Mr. Nelson is the manager of Schick Service Center, 656 Market Street, San Francisco, California. He stated that John Henry Fahey was employed by the company from May 27, 1966 to September 23, 1966, he then transferred to the Schick Service Center in Los Angeles. He stated Fahey appeared emotionally unstable and was continually feuding with fellow employees.

NELSON, PATRICIA E.

Miss Nelson was an Orange County coordinator for "Students for Kennedy," and arrived at the Ambassador Hotel on June 4, 1968, at 8:45 p.m. At 12:10 a.m., on June 5, 1968, she was standing with Joseph T. Kline in the lobby of the Ambassador Hotel outside of the Embassy Room. She saw a man running through the lobby and heard him say "Excuse me, please." This individual appeared to be coming out of the Embassy Room and was carrying a package wrapped in a dark blue canvas cloth under his right arm. What appeared to be the wooden stock of a rifle protruded out of the blue canvas. The individual was in sight for about five seconds and then ran down the corridor of the hotel. This individual appeared unusual to her because of his wearing apparel, long hair, and long sideburns which were not characteristic of those present at the hotel. Kline informed her that he had seen the same person on the Frank Reynolds News Program on ABC television. On June 7, 1968, she viewed the news program in question and pointed out an unidentified man that appeared to be carrying a roll of posters or similar paper. This roll was presented to Senator Kennedy in the film for autographing. Nelson identified the man as the person she saw on June 5, in the lobby of the Ambassador Hotel.

NELSON, REBA E.

Mrs. Nelson stated that "on June 5, 1968, at approximately 12:30 a.m., Mrs McAllister notified us that Senator Robert F. Kennedy had been shot in the head and hip."

"Treatment Room #2 was set up in anticipation for the patient's

arrival. The other nurses prepared the room as I was still trying to complete the patient care in Treatment Room #4."

"At approximately 12:35 a.m., I heard a commotion in the hall. I looked out and saw the newsmen fighting to get pictures of the patient. Mr. Tinch (Hospital Detail) succeeded in getting the newsmen away from the stretcher and the patient was taken into Treatment Room #2."

"When I entered the Treatment Room, the patient was already on the treatment table. Dr. Bazilauskas asked for a stethoscope and I complied. At this time, Mrs. Eby and Mrs. Lightsey were placing the patient on the heart-lung machine and Dr. Bazilauskas was performing external cardiac message. Dr. Bazilauskas used the stethoscope to listen for the heart beat and asked for adrenalin. I then prepared the adrenalin with the cardiac needle. While I was preparing the adrenalin, I heard Mrs. Kennedy say, 'cut them off.' She was referring to the patient's coat and shirt. When the patient came in the shirt was unbuttoned. T took the adrenalin to Dr. Bazilauskas who was still listening to the chest. Dr. Bazilauskas stated that he did not need the adrenalin in the heart but to give it subcutaneously. I walked to the right shoulder to give the medication but he was wounded At that time, I noted there was no active bleeding from there. the shoulder or head wounds. I walked around to the left shoulder and gave the adrenalin in the left shoulder."

"Dr. Holt instructed Mrs. Lightsey to call the Good Samaritan Hospital and make arrangements for Senator Kennedy's hsopitalization. Dr. Holt also instructed Mrs. Lightsey to call Doctor's Cuneo, Andler and another doctor. Mrs. Eby asked Mrs. Kennedy if she wanted a priest for her husband. Mrs. Kennedy said, "Yes, there is one in the hall." Mrs. Kennedy left the room and returned with a man, who was not dressed in a priest's habit. Mrs. Kennedy sat down on a stool at the patient's right side with the man assisting her."

"Dr. Holt, with the assistance of Mrs. Mejia and I, took a blood sample for typing and cross matching from the left cubital space. The dextran had been started in the left upper arm by Dr. Holt."

"Mrs. Eby took the blood sample and it was sent to Good Samaritan Hospital by police radio car, "Stat." While I was holding the patient's left arm, I noted the eyes were open and fixed. The patient's respirations at this time were about twenty to twentytwo per minute. Dr. Bazilauskas ordered the heart-lung machine removed at this time as the patient was doing well on his own. I disconnected the machine and Dr. Bazilauskas and Mrs. Eby held the patient up as I removed the heart-lung machine, the blood pressure cuff and upper clothing. Mrs. Eby had put on a head dressing and eye patches with ointment to protect the patient's eyes. The patient was given continuous oxygen."

"Mrs. Lightsey came back into the treatment room and informed

Dr. Holt that Good Samaritan Hospital and Dr. Cuneo were ready for the patient. Mrs. Kennedy was quite concerned about the noise in the hall and treatment room. The patient was covered with a sheet and Mrs. Lightsey and I removed the lower clothing. Mrs. Mejia and I searched the clothing. There was no property or shoes on admission. As we were wrapping the clothing, Mrs. Kennedy said, 'Throw them away.' To my knowledge the clothing was sent with the patient to Good Samaritan Hospital."

"As I was about to wash the patient's right hand Mrs. Kennedy said, 'Don't wash that. Those are old.' I observed old scratches on the right hand plus the blood. I complied with her wishes and did not wash the hand."

"Dr. Holt and Mrs. Kennedy were talking. Mrs. Kennedy was reassured by Mrs. Eby and Dr. Holt that the patient would receive good care at the Good Samaritan Hospital. Dr. Holt told Mrs. Kennedy that he would accompany her and the Senator to Good Samaritan Hospital. At this time, a Negro man came into the room with a stethoscope around his neck. I asked Mrs. Eby who he was. Mrs. Eby asked the man, and he stated that he was Dr. Miller and had been at the scene of the accident. He tried to interfere with the patient's treatment and was informed that arrangements had been made and his assistance was not needed."

"The patient was moved to the ambulance stretcher. He was given continuous oxygen and was having continuous intravenous solutions. Dr. Holt, Mrs. Kennedy, Mr. Van Ness and Mr. Nine, accompanied the patient to Good Samaritan Hospital. After the patient left the room, I noted that a priest in full habit was standing in the room. I was informed that the patient had received the 'Last Rites'."

NELSON, RICHARD A.

Doctor Nelson treated Sirhan when he fell from a horse at Granja Vista Del Rio Ranch on September 25, 1966. Sirhan was treated at Corona Community Hospital where he remained overnight. X-rays were taken and showed no permanent damage.

Dr. Nelson describes Sirhan as unduly nervous regarding the treatment and appeared to be an angry young person. Dr. Nelson examined Sirhan again on September 29, 1966, and October 26, 1966, and indicated Sirhan was healing and fully active. Sirhan complained of a little trouble with his left eye, and Dr. Nelson referred him to Dr. Milton A. Miller, an optometrist.

NEME, GEORGE

Mr. Neme stated he used to work with Saidallah Sirhan at Michael Ganguin, Incorporated, 53 W. Union Street, Pasadena.

Neme stated that he never engaged in any serious or political conversations with Saidallah.

NESS, EDWIN JERALD

Mr. Ness was living with Dorothy Manning in May of 1968. Mr. Ness was interviewed regarding Robert Andrese and his involvement at the Golden Garter Inn. Mr. Ness related that Mr. Andrese resembles Sirhan B. Sirhan.

NEWMAN, KATHRYN ANNE

Miss Newman worked the Anchor Desk in the Embassy Room on June 4, 1968, beginning at 6:30 p.m. Between 6:30 p.m. and 10:30 p.m., she made four or five trips through the kitchen corridor and did not see Sirhan Sirhan. She went to dinner at approximately 10:30 p.m., then resumed her duties at the Anchor Desk. She was at this location during Senator Kennedy's speech and when the shooting occurred.

NICKENS, R. L.

Mr. Nickens is the manager of the Milner Highland Hotel, 813 South Flower Street, Los Angeles. Mr. Nickens stated that John Wright stayed at his hotel prior to June 10, 1968. Wright stated that he was flying to Pensacola, Florida on a job and would return in two or three months. Mr. Nickens stated Wright had no friends in the hotel and that he had spoken to Wright several times but never mentioned the shooting of Robert Kennedy. Wright left no forwarding address.

NILSSON, PAUL

Doctor Nilsson recalled Sirhan coming into his office for an eye examination and possible treatment. His office records reflect he first saw Sirhan on November 8, 1966. Dr. Nilsson noted that the examination showed Sirhan to have 20-20 vision and there seemed to be no impairment of his peripheral vision. Sirhan was not satisfied with the examination and requested further action. Dr. Nilsson referred Sirhan to his partner, Dr. Milton Miller.

NISHIMURA, ROSE

Mrs. Nishimura stated she is not acquainted with Gilderdine Oppenheimer.

HISHIO, RUBY

Mrs. Nishio found a polka dot dress in the alley at the rear of her home and released it to investigators. She stated that she had no knowledge of it's origin.

HOERNBERG, KENNETH

Mr. Noernberg was working at the IBM Building next door to the Ambassador Hotel. Just after the shooting he was standing outside the hotel and observed a blond man getting into a cab and tell the driver "Let's get the hell out of here."

NORRIS, CHARLES

Mr. Norris was a block captain for Kennedy and went to the Ambassador Hotel on June 4, 1968, 8 p.m., with Richard Foster. He passed through the kitchen area numerous times during the evening, the last time being 11 p.m., and at no time did he see Sirhan or a girl in a polka dot dress. At the time of the snooting he was located twenty feet south of the kitchen doors. He heard three shots and was told by a Kennedy Girl who was exiting the kitchen that Kennedy had been shot. He ran into the kitchen and saw Kennedy on the floor. At this time he locked arms with two other males and attempted to hold back the crowd. A few moments later Mrs. Ethel Kennedy and Doctor Ross Miller entered the room, and he led them to the Senator. He remained in the kitchen for approximately forty-five minutes and went home at 4 a.m.

NORRIS, JERRY

Mr. Norris is a horse trainer at Granja Vista Del Rio Ranch in Norco.

He stated that he met Sirhan at the farm in October 1966, where Sirhan was working as an exercise boy. Sirhan had just returned to work after a fall which Sirhan told him was not very serious.

Mr. Norris stated that Sirhan was not a very good rider as he appeared to be afraid of horses.

After being discharged from the farm, Sirhan went to work for Warner Robert Lynn Wheeler at Santa Anita Race Track.

NOWAKOWSKI, CARLOS G.

Mr. Nowakowski, who works at ITT Cannon Electric, described Sharif Sirhan as a very quiet person who seldom talked to anyone on the job. Sharif acted like he had a problem which

Nowakowski believed was his interest in horse racing. After the assassination, Sharif did not come to work for a few days.

NUGENT, MAURICE W.

poctor Nugent is an opthalmologist and Sirhan was referred to him by Anne P. Toomer, an attorney, for an examination relative to a industrial injury sustained on or about September 24, 1966. He examined Sirhan on October 10, 1967. Sirhan advised him that he was thrown from a horse and was unconscious for a short time and regained consciousness in the Corona Community Hospital. Sirhan returned to work at the Granja Vista Del Rio Ranch two weeks later and then noted poor movement in his left eye. Doctor Nugent's examination reflected that Sirhan's vision was better than normal but that his left upper eyelid showed a very small scar remnant. He concluded that Sirhan had an excellent pair of eyes and there was no indication of further treatment, complications or resultant disabilities. Sirhan never discussed his political beliefs and impressed him as a very pleasant and cooperative young man. Doctor Nugent believes that Sirhan obtained the services of the attorney to assist him in a workmans compensation case as a result of the injury.
