On June 7, 1968, Mrs. Ruth Gutowski, Manager, Alpine Motel, 26131 Michigan Avenue, Inkster, advised that M. J. Zaroian is currently staying in unit 25 and has been registered at the motel since April 8, 1968. She made available his registration card, which revealed his home address as 503 Niagara Street, Niagara Falls, New York. The card indicated he represented the "U.S.C.S. Comm." His car license number was shown as New York 8E6367.

Mrs. Gutowski advised that Zaroian does some type of construction work and that he is usually in his room during the evening hours. Mrs. Gutowski maintains a record of long-distance telephone calls made by residents of the motel, and upon checking this, advised Zaroian has made no long-distance calls. She said Zaroian frequently calls a woman at telephone number TR 4-0900. She believed this woman may be a girl friend of his and he refers to her as Matti (phonetic).

The R.L. Polk Company, Detroit, Michigan, maintains a 1967 City Directory for Niagara Falls, New York. A check of this directory reveals one Minas J. Zaroian residing at 503 Niagara Street, Apartment 2. It was indicated he was retired.

The 1967-68 Cross Index Directory for Detroit listed telephone number TR 4-0900 as being for Merchandising Directors, 7338 Woodward Avenue.

On June 13, 1968, Minas J. Zaroian was interviewed and furnished the following information:

FEDERAL BUREAU OF INVESTIGATION

Date 6/14/68

MINAS J. ZAROIAN, Alpine Motel, Unit 25, 26131 Michigan Avenue, Inkster, advised that he has always been outspoken against former Senator ROBERT KENNEDY. He called him a "carpet-bagging S.O.B.", said he has always hated him and never hesitated to let anyone know how intensely he hated KENNEDY. He has told people in the past that if the Senator was not "hit" in New York, he would get it elsewhere.

While ZAROIAN readily admitted his dislike for Senator KENNEDY, he denied that he himself would have taken any physical action against the Senator. He denied knowing the accused assassin, SIRHAN SIRHAN, and denied any knowledge of the shooting.

ZAROIAN said he had more respect for former President JOHN F. KENNEDY because of his stand against the Russians during the Cuban crisis and his actions against big business.

ZAROIAN said he worked as a Postal Clerk for the United States Post Office, Niagara Falls, from approximately 1959 to 1966 when he was forced to take a medical retirement. He had a gastrotomy performed in 1965 in Niagara Falls, which caused him to later retire from the Post Office. He exhibited a card dated December 21, 1965 from the United States Civil Service Commission, Bureau of Retirement and Insurance, stating that MINAS J. ZAROIAN has been retired from Civil Service of the United States and has been granted an annuity. This card bears the number CSA 934376. ZAROIAN said his annuity amounts to \$212.00 per month.

He said he registered at the Alpine Motel and should have put the word "retired" after his employment. He said he was unemployed at the time he registered and had he indicated that fact on the registration card, the motel probably would not have rented the room to him. He is currently employed as a laborer for VASILE KOVA, 9701 Carter Place, Detroit, Michigan, a cement contractor.

ZAROIAN said he enlisted in the United States Navy in 1943 and used the name Tockov John Zaroian because he was under age at the time. While in the Navy, he tried to hang

himself which resulted in his being placed in St. Elizabeth's Hospital, Washington, D.C. from March to September, 1945, when he was discharged from the Navy. Upon his discharge he went to Los Angeles, California where he visited relatives for a short period of time.

From 1946 to 1952, ZAROIAN said he was in Veterans Administration hospitals for psychiatric treatment. During this period of time, he had suicidal and homicidal tendencies. His Veterans Administration Claim Number is 5322516. In 1946 and 1947, he was in Sawtelle Hospital, Los Angeles; from 1947 to 1948, he was in Canandaigua Hospital, Canandaigua, New York; in 1948 and 1949, he was again in Sawtelle Hospital and from 1951 to 1952, he was back in the Canandaigua Hospital. While in the Sawtelle Hospital during 1948-1949, he had a lobotomy performed (severance of nerves in the head to relieve mental disorders). He said the only violence he was involved in during these hospital confinements was in approximately 1952 while at the Canandaigua Hospital when a homosexual made an improper advance. He struck the individual and was arrested for assault and was fined \$100.00.

ZAROIAN said he was also arrested for drunk and disorderly in Los Angeles in approximately 1949. He and another individual left the Sawtelle Hospital without permission and both got drunk and were arrested.

ZAROIAN claims he has overcome his mental problems; however, his mother is still afraid of him and for this reason, he has not visited her for years. His mother is Mrs. ANNA OHANESIAN, 5755 Clemson Street, Los Angeles. A sister, Mrs. QUEENYE SARKISSIAN, resides at 5657 Clemson Street, Los Angeles, and another sister, Mrs. SUSAN KALPAKIAN resides at 404 West Almore, Monterey Park, California.

ZAROIAN said he is divorced from MARIA JOSEPHINE MC KEAN (her present married name), 2722 Grand Avenue, Niagara Falls. She has custody of one child, JOHN, age 11. The divorce took place in approximately 1961

ZAROIAN said his fiancée is MARITZA DERDERIAN, 9369 Jerome, Redford, Michigan. He refers to her as MARI and said she is employed as a secretary for Merchandising Distributors, Inc., located on Woodward Avenue, Detroit.

ZAROIAN drives a 1964 Oldsmobile, Jetstar convertible, turquoise with a black top, bearing Michigan license FC 8426. ZAROIAN denied any knowledge whatsoever of anyone involved in the death of Senator KENNEDY. He recalled his father, now deceased, mentioning one time there was an organization known as Fedyah, which was active in the old country and was composed of Arabs and Lebanese who hate Jews. He is not sure of the correct spelling of the name; however, it means mountain fighter in the Turkish language. He said he heard a rumor a number of years ago to the effect that this organization might be in existence in New York City. He said if this is true, he felt the organization should be checked into because of the possibility of it having some connection with Senator KENNEDY's death.

LHM is being submitted for dissemination in view of the questionable mental stability of ZAROIAN and the possibility that he could pose a future threat to Government figures whose protection is the responsibility of Secret Service.

FBI,

You asked for it.

When a police officer arrests a person he basically has no hate for that person neither a just judge when he passes a verdict; Thus in my reference to people, nations, or groups is not a hate but as the LORD directs to "Sweep away the refuge of lies" (Isa. 28:17). Also GOD says, Dan shall judge GOD'S people as one of the tribes of Israel. (Genesis 49:16). GODS law not Jew- Judah, Judge and Jury. designed to belittle GOD's laws and in cease sin.

The Jew (Judah) is only one of the tribes of Israel but they have spread themselves over the world and like a Jew owned store, the Jew sits in the background and pulls the strings while the gentler gentiles meet the public. GOD calls the Jew treacherous, hard hearted, and stiff necked. God divorced the Jew before they wrote the new (Jew) Testament. Police Clamp Security Lid on Suspect

Sirhan Bishara Sirhan, 24, was indicted Friday on a charge of murdering Sen. Robert F. Kennedy and then was arraigned in a County Jail chapel amid probably the greatest security precautions ever taken for a court proceeding in this country.

The County Grand Jury also accused the slight, wiry Jordanian of assaulting, with a deadly weapon and with intent to commit murder, five other persons wounded during a shooting spree early Wednesday at the Ambassador.

Friday's extraordinary proceedings took nine hours.

They started at 9:30 am with the summoning of the first of 22 witnesses before the County Grand Jury in the Hall of Justice.

Then, late in the afternoon, followed the formal indictment. "The grand jury," said Foreman L. E. McKee, "has reviewed the

evidence presented and has voted to appear to be the primary consideration.

Newsman covering the grand jury hearing were required to identify themselves, and witnesses were provided escorts both to and from the investigative panel's chambers on the Hall of Justice's fifth floor.

But that was just the beginning.

22 Witnesses Are Called

The same intense security conditions prevailed when the indictment was returned before Superior Judge Arthur L. Alarcon in his courtroom three floors above and later at the Central County Jail, where every person entering the third-floor chapel was searched for weapons, including Judge Alarcon.

Dep. Dist. Atty. John E. Howard and Morio Fukuda called 22 witnesses to testify before the grand jury.

They included eyewitnesses to the crime, police officers, ambulance drivers and attendants.

Because they were in New York to attend Sen. Kennedy's funeral, Rafter Johnson, former Olympic champion, and Roosevelt Grier, mammoth tackle for the Los Angeles Rams, were excused.

Both of them reportedly aided in the capture of Sirhan moments after

For information, referenced complaint form reflects information from MEL WOLF, General Manager of Wolf - Brown, Inc., 636 South Broadway, Los Angeles, telephone number MA 3-1421. WOLF telephonically advised that one of the employees in his office, PAUL BENEDICT, claimed to have been at the Ambassador Hotel the night Senator KENNEDY was shot and the next day at work made statements to the effect, "He deserved to be shot", and "many others should get the same".

On 6/17/68, Mr. PAUL BENEDICT was interviewed at his place of employment by SA RICHARDS and SA G. J. MOOREHEAD. From the outset of the interview, it was apparent to both Agents that BENEDICT was very irrational in his thinking and that he appeared to be mentally deranged. BENEDICT claimed to have just recently arrived from New Orleans approximately one month ago, and, on the other hand, he claimed to have been a KENNEDY campaigner in Los Angeles for two or three months. He stated that he and his aunt and uncle, Mr. and Mrs. CHRIS MARSHALL, 12741 Chandler Boulevard, North Hollywood, California, had been at the Ambassador Hotel on the evening of the KENNEDY victory speech and that he had been entertaining the KENNEDY campaigners inasmuch as he "had the gift of music and dance given to him by God". BENEDICT stated that he and his relatives were in a room on another floor below that one on which the Senator was shot when somebody ran past their room shouting that someone had been shot. He stated that he then went up the fire escape and met coming down the fire escape a girl in a polka dot dress who stated that Senator KENNEDY had been shot. At this point, BENEDICT stated that he knew that the Cubans working for the CIA were responsible for the KENNEDY shooting inasmuch as they had stated that because of the "Bay of Pigs incident" they would eventually get all the KENNEDY brothers". He stated

that he saw a man on the stage where he was performing whom he knew to be a Cuban and that he was sure this man had something to do with the shooting.

BENEDICT stated that he was very sad because he had not been given the opportunity to help the people of the world as he had been sent here to do by God. He stated that he had received from God all the gifts that could possibly be given, such as the gifts of "dance, music, art, design, etc." He stated that he had seen and talked to God on many occasions and that he had been up to Heaven two or three times recently. He also stated that Heaven was not very far away but was just up above the cloud, only he was the only one who could see it because he was good and the rest of the world was bad. BENEDICT stated that if he was President of the United States, he would solve all the problems of the world because the world was evil and he had received a gift from God to help people. He said that he had been born several thousands of years ago as a "little angel" and that no one believed that he had these tremendous gifts and ability to help people. He stated he had been sick most of his life because when he was two years old, a Negro man in New Orleans put a "voodoo curse" on him and his grandmother.

At this point, BENEDICT became quite irrational and incoherent and talked at great length about visions he had seen and the things he could do to help people. It was apparent to both Agents that he was very mentally disturbed and he was advised that he would be recontacted if any further assistance or information was desired from him. He stated that he had just been told that he was losing his job and he thought that he might possibly go to the Veterans Hospital in the San Fernando Valley to try to be cured of the sickness caused by the "voodoo curse". Agent MOOREHEAD told him that he thought this would be a good idea and thanked him for his help.

ASSASSINATION OF SENATOR ROBERT F. KENNEDY
LOS ANGELES, CALIFORNIA
JUNE 5, 1968

The Visa Section, American Embassy, Rome, Italy, advised on June 11, 1968, that GIUSEPPE PIRAINO, an Italian citizen born February 4, 1930, at Vicari, Palermo, Sicily, applied for a visitor's visa to the United States. PIRAINO was in possession of Italian passport No. [REDACTED] issued April 15, 1965, by the Italian Consulate, Basle, Switzerland. He furnished his address as Via Vittorio Veneto 6, Busso, Campobasso, Italy.

PIRAINO indicated the purpose of his visit to the United States was to contact the family of the late ROBERT F. KENNEDY and furnish them with information regarding SIRHAN BISHARA SIRHAN, whom newspapers have identified as Senator KENNEDY's assailant. PIRAINO indicated in his application that the KENNEDY family would pay for his travel to the United States although he admitted he did not have authority from the KENNEDY family. He displayed a letter dated May 19, 1968, written by PHILLIP M. WRONKA, the late Senator KENNEDY's staff assistant, which acknowledged PIRAINO's telephone call early in May, 1968. WRONKA's letter informed PIRAINO that he could not clearly understand him over the telephone and suggested PIRAINO write another letter to him directly rather than to Senator KENNEDY.

The Visa Section did not issue a visa to PIRAINO.

PIRAINO was interviewed at the American Embassy, Rome, Italy, on June 11, 1968, and furnished the following information:

In approximately July, 1965, PIRAINO traveled to Copenhagen, Denmark, for the purpose of finding employment. After about one week of searching, he found himself in the vicinity of the central railroad station in Copenhagen and there encountered a dark, swarthy man about 1.65 to 1.67 meters in height. This individual had black, curly hair, black eyes and a deep olive complexion. PIRAINO said he is convinced after seeing photographs

of SIRHAN BISHARA SIRHAN in the newspapers that SIRHAN and the man he met in Copenhagen are one and the same person. PIRAINO does not recall the man's name but was told by him that he came from Naples, Italy, and PIRAINO noted that he spoke with a Neopolitan accent. According to PIRAINO, he never heard the individual speak English nor did this person ever mention that he had been in the United States. PIRAINO noted that the man was traveling with an Italian passport but declared that false passports were very easily obtained.

PIRAINO said he became quite friendly with this individual who displayed to PIRAINO a cut he had received across the abdomen in a fight over a girl in Germany. PIRAINO said the cut, which was on the right side of this man's abdomen, was still giving him pain. Several days later, PIRAINO and the individual proceeded to Stockholm, Sweden, where they remained for about three days. The last time PIRAINO saw this individual was in Stockholm when he was visited by a young Italian male who was accompanied by a young girl with blond hair. The three left Stockholm in the latter part of July, 1965, and he has not seen or heard from them again.

PIRAINO believes the young blond girl is the same person whom newspapers have reported is wanted for questioning by the Los Angeles Police Department. He said he is unable to furnish any other identifying data concerning the dark, swarthy male he met in Copenhagen or the blond girl.

Throughout the interview with PIRAINO, he often expressed his admiration for the United States of America and how he longed to reside in the United States. He said that ever since President JOHN F. KENNEDY was assassinated in 1963, he has been obsessed with a feeling of impending tragedy for other members of the KENNEDY family. He said he has sent at least eight letters to Senator ROBERT F. KENNEDY prior to his assassination disclosing his desire to enter the United States. Although he could furnish no facts to substantiate his feeling, he said he felt certain something was going to happen to Senator ROBERT F. KENNEDY prior to his assassination on June 5, 1968.
