On 6-26-68, un, namen advised one FRED COOPER, a parolee, formerly in SLMO, appears to answer WEUB's description.

COOPER was sentenced 5-12-55, to 20 years. He was pareled 7-1-62. He violated his parele and returned to prison 7=25-63. was re-paroled 11-13-67. He is under parole supervision until 10-3-67. He is under parole supervison until 10-3-76. Each instance that COOPER was paroled he came to SLMO, but did not stay here. His nother lived at 1238 Watts in University City, St. Louis Co., Mo. The family, consisting of FRED COOPER, his mother and brother, were given permission to move to Miami, Fla. About a month ago COOPER, while at Probation Office in Minni, Fla., telephoned SLMO and was given permission to move to Youngstown, Chio. This was on 5-16-68. The Probation Officer in Hisai is a MR, ROBINSON, COOPER's file was then sent to Probation Officer HOHERT M. WALKER, Youngstown, Chio, Number 310, Post Office Building.

LUBIC noted KENNEDY had arrived at the speaker's rostrum via a door behind the rostrum and anticipated that he might depart through this same door. A minute or less prior to the termination of the speech, LUBIC checked to determine if this area might be appropriate to speak to KENNEDY. LUBIC noted that access to this area could be made through two doors. He also made casual observation of the corridor area beyond the doors and has a recollection of seeing a woman dressed in white in the corridor. LUBIC assumed the woman was a hotel employee, probably assigned to the kitchen. After making this brief check, LUBIC returned to the Embassy Room as KENNEDY completed his speech. LUBIC departed the Embassy Room just ahead of Senator KENNEDY, and LUBIC noted KENNEDY took the long way to one of doors behind the rostrum. LUBIC entered the closer door and was at KENNEDY's right shoulder as he walked down the corridor.

And continued walking with KENNEDY waiting for KENNEDY to stop shaking hands with people who swept into this area and to acknowledge him. LUBIC heard an unidentified voice saying "KENNEDY, you son of & bitch", and then heard two shots which sounded to LUBIC like shots from a starter pistol at a track meet. LUBIC did not identify the source of the voice and could not immediately determine the source of the pistol shots. He quickly noted, however, an individual with a gun. This individual was located on the left side of the corridor and had his knee on a small table or air conditioning unit and had lifted himself up on this knee to obtain elevation while shooting.

LUBIC has no recollection of hearing the sounds of additional shots, but recalls seeing the gun and the arm of the assailant and noted the jerk of the gun and the arm apparently caused by the recoil action of the gun. LUBIC noted KENNEDY had fallen and was bleeding from his head. LUBIC immediately sought cover behind an ice machine or table in the corridor under the assumption the shooting would continue. LUBIC observed the expression in KENNEDY's eyes and assumed he was mortally wounded.

LUBIC then noted one or more of the hotel employees and other people were struggling with the assailant in an attempt to disarm and to subdue him. LUBIC got up and linked arms with two hotel security employees to keep the crowd in the

kitchen area from coming into the corridor. During this period the assailant was still being subdued and disarmed. LUBIC remained in this area until police took custody of the assailant and removed him from the hotel. The following day, LUBIC recognized news media photographs of SIRHAN B. SIRHAN as being identical with the assailant.

- LUBIG-additionally advised as follows:

During the time he was associated with television station KHJ, Los Angeles, he produced a television interview show called "Tempo". This show consists of interviews with controversial reople and the discussion of controversial subjects. At the time the New Orleans District Attorney JIM GARRISON was attempting to subpoens individuals from the Southern california area, discussions on the matter were held on the program and some attempts were made to invite EDGAR EUGENE HRADLEY and LAWRENCE HOWARD as guests on the program.

In about May, 1968, exect date not recalled, LUBIC was contacted by one STEVEN JAMEE who introduced himself as an investigator for JIM CARRISON and who presented appropriate credentials. JAFFE said he had been instructed by GARRISON to ascertain if LUBIC could arrange a meeting between GARRISON and Senator ROBERT F. KENNEDY. JAFFE explained that CARRISON was concerned for the safety of KENNEDY and wanted to present evidence that the assassination of President JOHN F. KENNEDY, MARTIN LUTHER KING, and a possible threat against ROBERT F. KENNEDY were part of the same plot. JAFFE said TOBIC had been selected to make these arrangements because of has known association with ROBERT KENNEDY and KENNEDY campaign people.

LUBIC questioned JAFFE's identity and his authority to speak for GARRISON and asked that JAFFE telephonically contact GARRISON in his presence and permit him to speak with GARRISON personally. JAFFE did this and LUBIC spoke with GARRISON. LUBIC said he recognized GARRISON'S voice from seeing and hearing GARRISON on various television news programs. GARRISON affirmed that he was concerned for the safety of ROBERT F. KENNEDY and desired to meet with KENNEDY to furnish him evidence concerning the plot which had resulted in the death of President JOHN F. KENNEDY and which plot continued as a threat against ROBERT F. KENNEDY. CARRISON indicated that JAFFE would furnish LUBIC information about this plot.

JAFFE explained that GARRISON had determined the assassination of JOHN F. KENNEDY had been planned and executed by a group referred to by GARRISON as "The Committee". "The Committee" is composed of individuals from various groups including the National States Rights Party, Anti-CASTRO Cubans, oil depletion interests, and individuals opposed to the U.S. policy of rapprochement with the communists.

JAFFE said GARRISON located a letter prepared in 1960 or 1961, by the National States Rights Party which indicated JOHN F. KENNEDY, MARTIN LUTHER KING, and ROBERT F. KENNEDY would have to be executed. The plot to assassinate JOHN F. KENNEDY was developed by "The Committee" after KENNEDY indicated he did not favor oil depletion tax benefits and following KENNEDY's meetings with CHARLES DE GAULLE and then Soviet Premier MIKITA KHRUSHCHEV which resulted in an apparent new era of friendship with DE GAULLE and rapproachement with the Russians. At this same time, the invasion of Cuba by anti-CASTRO elements failed because of President KENNEDY's withdrawal of premised U.S. air support which decision apparently had the concurrence of ROBERT F. KENNEDY.

According to JAFFE, "The Counittee" placed ten million dollars into the hands of a secondary group. This secondary group was instructed to locate appropriate individuals to carry out the assassination of President KENNEDY and to plan the assassination. JAFFE indicated that ADGAR EUGENE BRADLEY, North Hollywood, California, LAWRENCE HOYARD, El Monte, California, and other people being subpoenaed by GARRISON are members of this secondary group. JAFFE also indicated that BRADLEY was formerly a member of the OSS and later of the CIA and that BRADLEY's employer is subsidized by the CIA. JAFFE said BRADLEY was instrumental in locating LEE HARVEY OSWALD and other people connected with the assassination of President KENNEDY.

JAFFE said that OSWALD did not defect to the Soviet Union as the U.S. public believes, but was sent into the Soviet Union by the U.S. Government. He said OSWALD was a cryptographic expert and had received training in the U.S. Marine Corps in codes and ciphers. OSWALD's assignment in the Soviet

Union was related to the U-2 photographic surveillance flights. OSWALD returned to the United States when the U-2 flights were discontinued. OSWALD subsequently acted as a paid informant for the CIA. OSWALD also was an FBI informant during the time he was in New Orleans. According to JAFFE, and GARRISON has proof of these relationships.

JAFFE indicated that by the time the assassination of President KENNEDY was accomplished a total of ninëty-five people were involved. JAFFE said the actual assassination was executed by four anti-CASTRO Cubans who fired at President KENNEDY simultaneously with unsighted Mausen rifles at the distance of approximately sixty yards. One assailant was on a railroad car located on a track adjacent to the highway, another was on the overpass above the highway, and a third was in a "counting building". The location of the fourth was not recalled by LUBIC. JAFFE said a "dry run" of the procession had been observed and timed the previous day and it had been noted that the procession slowed to about seven miles per hour just as it approached the Texas Book Depository building. It was decided that the shooting would commence when the procession slowed down.

JAFFE said Dallas additionally was selected as the city in which President KENNEDY would be assassinated because "The Committee" had great influence in Dallas which extended into the Dallas Police Department and the Dallas Sheriff's Office. JAFFE suggested that individuals in "The Committee" are well known to President LYNDON JOHNSON and that while JOHNSON was not associated with "The Committee" and was not connected with the assassination that JOHNSON now has knowledge of the people who were responsible.

JAFFE said that when the procession slowed by the Book Depository building that a total of six shots were fired. Four shots were fired simultaneously and then two shots quickly thereafter. The bullets used were special made bullets which shatter upon impact to cause extensive damage. A fragment of one of the bullets struck the face of a female bystander. GARRISON has possession of this fragment, according to JAFFE. LUBIC is not clear concerning the part OSWALD played in the shooting.

JAFFE said that one of the plotters made a diary of his activity and plans leading up to the assassination which includes the timing of the procession on its "dry run" and the notation of the time and the speed at the Book Depository. GARRISON has possession of this diary.

JAFFE said the pilot DAVIO W. FERRIE was employed to fly the four anti-CASTRO; out of the country. FERRIE wrote a story of his involvement in the plot. GARRISON has a copy of this story, and JAFFE indicated the FEI also had a copy of the story.

One of the Cubans involved either is in the United States or has been located by GARRISON outside of the United States, and currently is cooperating with GARRISON. JAFFE indicated FERRIE was killed with a special acid which was assimilated into his system through his facial skin area causing a cardiac reaction which was diagnozed as a heart attack.

LUBIC indicated in connection with the above-mentioned shooting ereas that JAFFE had in his possession a photograph apparently taken at the time of the assassination which depicted the railroad car. He also has a copy of the photograph which JAFFE said was presented to the Varren Commission in which the railroad car has been deleted.

JAFFE also had in his possession copies of two or more pieces of alleged communications from the FBI, Dallas, to the Director, FBI, which LUBIC described as possibly teletype messages in which Dallas advised of the existence of a possible plot to assassinate President KENNEDY and later advised that definite evidence had been developed which indicated a plot to assassinate President KENNEDY. The communications indicated the FBI was referring the matter to the Secret Service for handling.

JAFFE indicated that the same group which directed the assassination of President KENNEDY also directed the assassination of MARTIN LUTHER KING, and that GARRISON was concerned that ROBERT F. KENNEDY would be their next victim.

LUBIC said that when JAFFE first presented him with the above information, that he did not want to accept the information and could not believe that JAFFE honestly believed the story and probably had some ulterior motive in furnishing him the information. LUBIC advised JAFFE of his disbelief and asked if JAFFE would relate the information in the presence of an attorney selected by LUBIC. JAFFE agreed to do this and subsequently related substantially the same information to LUPIC in the presence of Mr. ROPALD BUCK, Los Angeles attorney, and partner of Mr. PIERRE SALINGER in the operation of The Factory, a Los Angeles might club.

INDEED subsequently contacted FRANK MARKTEWICZ, Senator KENNEDY's Press Secretary, and advised him briefly that CARRISON had contacted him to determine at a meeting could be arranged between KENNEDY and GARRISON in order that GARRISON could personally present information concerning the assessination of President KENNEDY and his concern for the present safety of Senator ROBERT KENNEDY, MANKIEWICZ was rushed for time, and LUBRE did not have an opportunity to furnish him more detailed information.

LUBIC heard nothing from MANKIEWICZ and therefore recontacted MANKIEWICZ for his decision. MANKIEWICZ again was pressed for time and briefly told LUBIC that KENNEDY was not interested in meeting with GARRISON. LUBIC telephonically relayed this decision to GARRISON.

Following the assassination of Senator KENNEDY, LURIC telephonically contacted GARRISON to obtain his comments as a matter of personal interest. GARRISON told LUBIC that SIRHAN SIRHAN was a "company man". In prior conversations, CARRISON had referred to CIA as the "company". GARRISON commented that Senator KENNEDY was killed with a special bullet which shattered upon impact and that the bullet was similar in type to the bullets which killed President KENNEDY and MARTIN LUTHER KING. GARRISON suggested that knowledge of the characteristics of these bullets is not widely known and suggested evidence of the continuation of the same plot.

GARRISON further suggested that the plot to assassinate ROBERT KENNEDY apparently was delayed until it was certain he

had won the California election which apparently would have made him the leading contender for the Democratic nomination. GARRISON also suggested that if SIRHAN's bullets had failed to kill or mortally wound the Senator, that a back-up man stationed somewhere in the crowd probably would have fired additional shots.

GARRISON said SIRHAN apparently belonged to a group named Young Jordanians or Young Arabs for Freedom and suggested that the Ambassador Hotel probably had employees of Arabic background who could have permitted SIRHAN to enter the hotel out of friendship and not necessarily as part of the assassination plot.

GARRISON further advised that he believes he may be the next victim in the continuing plot because of his ability to exposs "The Committee". GARRISON indicated he was traveling to Los Angeles in the near future and would contact LUBIC.

On the basis of the foregoing, it is apparent that GARRISON's concern for the safety of Senator ROBERT F. KENNADY was nebulous in nature and was predicated upon the same information he is basing his investigation of the assassination of the late President JOHN F. KENNEDY. GARRISON's proposal of meeting with Senator ROBERT F. KENNEDY must also be viewed from the context of political motivations which might have existed at the time.

Los Angeles is conducting no additional investigation into the GARRISON allegations and does not plan interviews with RONALD BUCK or FRANK MANKIEWICZ concerning this matter. LUBIC's information concerning the assassination of Senator ROBERT F. KENNEDY has been prepared on FD 302. Pertinent information furnished Bureau by teletype dated 6/25/68.

The taye was made available by Mr. RON REYNOLDS, Program Director, MNEW Radio Broadcasting Station, 66 Jack London Square, Oakland, California, on June 19, 1968. Mr. REYNOLDS noted that GEORGE_PLIMPTON of New York was the guest of ROSE during his morning broadcast of May 90. An anonymous caller, whose voice was not recognized as a regular caller, estimated to be a male in his 50s or 60s, appeared to be a supporter of ROBERT F. KENNEDY. This caller asked if consideration had been given by ROBERT F. KENNEDY to the possibility that he could be killed as had his brother, JOHN F. KENNEDY. The reply to the caller was that anyone in the public light must expect that such things are a possibility.

He stated WORTHY resides *** In Apt. 3 at the same address.

On 6/20/68 JOSEPH WILSON, 1844 Victoria Ave. Apt.1 advised he is the manager of the Victorian Apts. at that address. WILSON stated CLARK WORTHY has not resided at in Apt. 3 for the past six months and the occupant of Apt. 12 is RICHARD TRENT. He said the name D. WILLIAMS is unknown to him.

Mr. WILSON was displayed a photograph of SIRHAN and advised he never saw this individual in the vicinity of 1844 Victoria.

On the same date SIRHANs photograph was displayed to RICHARD TRENT. THOMAS BENSON and LARRY BATES all residence of 1844 Victoria Ave. All were acquainted with CLARK WORTHY but none had any knowledge of SIRHAN visiting Apt. 3. None of these individuals are aquainted with or have any knowledge of D. WILLIAMS. THOMAS BENSON advised WORTHY may currently reside with his parentsat 3636 6th Ave. Los Angeles.

On 6/20/68 CLARK WORTHY, 2635 6th Ave., LA, Tel. 734-4691 advised he resided at 1844 Victoria Apt.3, approximately six months ago. He still has friend at that address and therefore has been their on numerious occasions. He is not aquainted with SIRHAN SIRHAN and to his knowledge SIRHAN has never been to his apt. He said while he did reside in apt.3 he had one continuous party and literally hundreds of people he didn't even know were in and out of his apartment.

WORTHY was unable to furnish any information concerning

October 4, 1967, the United States Department of Justice, Washington, D. C., advised that the subject received material from the Arab Information Center, which appears to contain political propaganda as designed in the Registration Act. The department, therefore, requested investigation to determine whether the subject is under obligation to register and whether he is disseminating political propaganda at the order, request or under the direction and control of the Center or other foreign principal.

On October 17, 1967, Ernst Beickert, Superintendent, 57 West 10th Street, New York, New York, advised that the subject has resided here, in Apartment C 3, for the past one and a half years. His wife, Marjorie Lawrence, nee Friedlander, had resided in the above apartment for two years prior to her marriage to the subject. He added that three weeks ago the subject and his wife gave him circulars which were pro-Arab in nature. He added that the subject and his wife operated a small stand on the corner of 8th Street and 6th Avenue, New York, New York, for the purpose of selling pro-Arab pamphlets.

Beickert continued that several months ago the subject and his wife were active in activities that were against American involvement in the war of Vietnam. He could not advise as to any specific activities on the part of the subject or his wife concerning this.

He further stated that about two weeks ago he heard the subject singing the German National Anthem.

Beickert did not have any information concerning specific disloyalty to the United States on the part of the subject or his wife and added that they are good tenants and quiet people. He further stated that the subject is very pro-Arab and anti-Israel and that the subject and his wife have a strong dislike for the Jewish people.

On October 19, 1967, Nathan Brodsky, President, Village Reality Service, 84 5th Avenue, New York, New York, advised that he is the managing agent and the owner of 57 West 10th Street, New York, New York. He added that the subject's wife had been residing there in Apartment C 3 since October, 1963, and that the subject has been there for about one and a half years. He added that he does not know whether or not the subject is employed and stated that the subject's wife pays the rent by check. He stated that he has met them on one or two occasions and does not know them well personally. He added that they pay the rent on time and are satisfactory tenants. He said that the only association he has had with the activities was when his superintendent, Ernst Beickert, brought to him some pro-Arab pamphlets. He did not keep these pamphlets and stated that he threw them away.

On October 18, 1967, Benjamin Gordon, Supervising Clerk, County Clerk's Office, New York County, 60 Centre Street, New York, New York, advised he had no information concerning the registration of a corporation known as, Federated Americans Against Israeli Racism, or of the subject.

On October 17, 1967, the subject and his wife were observed operating a stand at 8th Street and 6th Avenue, which was used for the selling of information published by the Arab Information Center, 757 3rd Avenue, New York. On the stand was a sign reflecting the name Federated Americans Against Israeli Racism, 57 West 10th Street, New York, New York. On this date, by use of a suitable pretext, the subject advised that he is the President of the Federated Americans Against Israeli Racism and that his wife is the secretary and treasurer of this corporation. He also stated that this corporations does not have any meetings and has no other members other than himself and his wife.

On October 25, 1967, a suitable pretext was again used and the subject advised that he was in a position to set up a person in business and that he would supply pamphlets, at a forty per cent discount, which he, Lawrence, would obtain from the Arab Information Center. The subject stated that he buys these pamphlets from the Arab Information Center at a discount. He would also furnish an account book and would show him how an accounting procedure should be set up. He added

that he would, also arrange for police protection if needed. The subject also stated that he has supplied others in this venture in the cities of Philadelphia, Pennsylvania, Danbury, Connecticut and Cambridge, Massachusetts. The subject spelled his name as John Lawrence. He showed an example of this matter which was a pamphlet entitled "Israel and the Arab Minority" by Sami Hadawi. On the cover page of the pamphlet is the name Arab Information Center, 757 Third Avenue, New York. New York.

On August 25, 1967, Theodore Heermance, 241
Lawrence Street, New Haven, Connecticut, advised that he recently contacted Marjorie and John Lawrence, 57 West
Tenth Street. Apartment C-3, New York, New York, telephone number GR 7-1826, and that he determined at this time that the Lawrences are currently very active in an organization known as Federated Americans Against Israeli Racism. He added that they furnished him with two booklets entitled "Decisive Years in Palestine, 1918-1948" and "Israel and the Arab Minority" by Sami Hadawi.

The records of the Credit Bureau of Greater New York were checked on October 27, 1967, and no record was located for the subject and his wife.

The records of the New York City Police Department (NYCPD). New York, New York, were checked on October 27, 1967, and no record was located for the subject or his wife.

Several confidential informants, who are familiar with various phases of Arab activities in the New York City area, advised in November, 1967, that they are not acquainted with the subject or his wife.

On October 30, 1967, Paul Trimiar, Registration Section, Internal Security Division, United States Department of Justice, Washington, D.C., advised that the files of his office contained no record of the subject or of the organization known as Federated Americans Against Israeli Racism, Incorporated.

On November 20, 1967, James Post, Clerk, "The New York Times" Information Bureau, 229 West 43rd Street, New York, New York, advised that his records contained no information concerning Laurence or the Federated Americans Against Israeli Racism.

On November 2, 1967, Lawrence Keenan, Division of Corporate Records, New York State Department of State, Washington Avenue, Albany, New York, advised that he has no record of the Federated Americans Against Israeli Racism ever having been incorporated in the State of New York.

On December 4, 1967, by the use of a suitable pretext, the subject advised that he had been in Bridgeport, Connecticut, for the past two weeks, and that he was arrested during the latter part of November, 1967, and charged with disturbing the peace, loitering and selling obscene literature. He added that there was no obscene literature, and that the only literature he was selling was pro-Arab literature published by the Arab Information Center, New York, New York. He again stated that he obtains his literature from the Arab Information Center at a discount, and does not receive these pamphlets on consignment.

On December 4, 1967, a confidential source who has furnished reliable information in the past and who has knowledge of business firms in the New York City area, advised that he could furnish no information concerning Federated Americans Against Israeli Racism.

On November 20, 1967, Miss Tammy Benamy, 736 West End Avenue, New York City, telephonically advised that on approximately November 15, 1967, she observed a male and female in charge of a table full of literature at 8th Street and Sixth Avenue, New York City.

Upon inspection, Benamy noted that the literature, which was for sale to pedestrians, was pro-Arab and anti-Israeli.

On December 22, 1967, Sergeant Edward Keating, Detective Bureau, Danbury, Connecticut, Police Department, furnished the following information concerning the arrest of John M. Laurence, 57 West 18th Street, New York, New York:

Data December 22, 1967

Sergeant EDWARD KEATING, Detective Bureau, Danbury, Connecticut, Police Department, advised that Danbury Police File #4938 reflects that JOHN M. LAURENCE, 57 West 18th Street, New York, New York, was arrested by Officer ROBERT O'NEIL on September 3, 1967, for breach of peace; soliciting in violation of Danbury City Ordundee #11-5; loitering and unlawful assembly, Section 12-13 and refusal to submit to taking of fingerprints in violation of Section 29-17 of Danbury Cith Ordnance.

LAURENCE was born December 4, 1921, in Fort Worth, Texas. He is a male of white race.

Sergeant KEATING related that Reverend SEMAN FERRIS, Pastor, St. Anthony's Church, Danbury, on September 3, 1967, complained to Danbury Police that LAURENCE was in front of his church passing out literature to parishioners. LAURENCE, when told to leave by Reverend FERRIS, became belligerent.

Sergeant KEATING stated that Officer ROBERT O'NEIL on arrival at the scene found LAURENCE in front of St. Anthony's Church distributing literature. LAURENCE was at a card table which had a poster with following printing on it: "FEDERATED AMERICANS AGAINST ISRAELI RACISM." LAURENCE refused to move on request by Officer O'NEIL and was arrested.

Sergeant KEATING mentioned that Reverend FERRIS reported that LAURENCE was distributing literature of a political nature against the Jews. When asked to leave by FERRIS, he commenced using insulting language.

Sergeant KEATING also related that EDWARD ACKELL, a member of St. Anthony's Church, told arresting officer that he observed LAURENCE distributing literature in front of the church and asked if he had a license to distribute the material. LAURENCE, according to ACKELL, stated he did not need a license because his constitutional rights granted him permission. ACKELL requested him to respect the cloth of the clergy and remove himself. LAURENCE was reported to have replied that the cloth of

Caption of this photograph describes the LAURENCES as leaders of The Federated Americans Against Israeli Racism (FAIR) and depicts them setting up a literature stand on Main Street in Danbury. Signs on the literature table were reflected as follows: "Restore Palestine To The Arab People" and "Arab Victims of Jewish Racism in Israel."

Sergeant KEATING also informed that a communication in department files reflects that Danbury Police received a communication from Nassau County Police, New York, on July 5, 1967, advising that JOHN LAURENCE, 57 West 18th Street, New York City, date of birth - December 4, 1921, had been charged with public loitering and resisting arrest, and warrants had been issued for his arrest. A notation reflected that EDWARD F. CURRAN, Chief of Detectives, Nassau County Police Department, advised Danbury Police on October 6, 1967 that LAURENCE had appeared in Nassau County Court on October 3, 1967, to respond to the charges.

Sergeant KEATING stated that charges in Danbury are pending against LAURENCE. He said trial has been postponed as LAURENCE has made counter charges against members of the Danbury Police Department.



LINDA related that she has been employed as a barmaid at the Golden Garter Bar for approximately one month. She advised that when she first began employment there was a barmaid there named DOROTHY MANNING. DOROTHY MANNING had a friend, who LINDA STURGEON knew only as "IM". She described him as being a male; white; 24 years of age; blue eyes; curly, sandy hair (usually a curl was hanging down his forehead); heavy eyebrows; 5'10", 170 pounds. He had a "beer" stomach and talked slowly. On one occasion he offered her narcotics and referred to them specifically as the "red, white and blues." He attempted to force a red, identified as seconal by STURGEON, into her hand. When STURGEON refused "JIM" said DOROTHY uses them."

STURGEON was unable to furnish any information concerning SIRHAN.



She advised that within the last two weeks, believed to be May 31, 1968, she was in the Golden Garter Bar, West Valley Boulevard, Alhambra, seated at the bar with HAL. SUTTON, who resides with one BOB JORDAN at 844 Leaken Avenue, Apartment 9, Santa Monica. VENNE continued that during the course of the evening, an individual whom she knows as "ERNIE" was also sitting at the bar and she had conversed with him concerning tunes played on the jukebox. 
