



At approximately 11:30PM, 7/19/68, while O'BRIEN was having a beer in the Prowrite Bar, located at the corner of Hollywood & Western, Los Angeles, a man named John introduced himself to O'BRIEN and Eddie the bartender, and advised that he was a friend of SIRHAN B. SIRHAN's brother, and knew the SIRHAN family well. O'BRIEN continued that John atated that either he (John) or a member of the SIRHAN family worked at the FEZ Restaurant, located at the corner of Vermont & Sunset, Los Angeles.

O'BRIEN advised that all the man had to say was that all Jordanians shouldn't be blamed for the Kennedy assination.

O'BRIEN advised that he did not recall having ever seen John beføre, and that he was furnishing the information in case it might be of value to the FBI. He described John as follows:


