CHAVEZ interviewed Coachella, California, and advised that had no firsthand knowledge of killing of Senator KENNEDY. CHAVEZ advised had predicted that President JOHN F. KENNEDY, MARTIN LUTHER KING, and Senator ROBERT F. KENNEDY would be killed before it happened and had told a friend about his predictions. CHAVEZ advised that God had revealed this to him, and this was "God's prediction and not just his." CHAVEZ stated that when he made the prediction, he did not know who would do the killing and has no other information concerning the death of Senator KENNEDY. No further investigation will be conducted on this matter by the Los Angeles office.

Also Miss URSO has appeared on a San Diego TV station to be interviewed during a news show.

He said hearing some commotion he went outside about 12-25pm that kww night and observed a blonde headed fellow running between Sixth and Wilshire. He entered a red MG or Truimph and sped away up Alexandria Street. He said t his man was young and looked to be about 6 2" tall. He said almost simultaneously another shorter, (5'6-7") dark haired man also came running up Alexandria and entered the apartment building located at 526 S. Alexandria.

C said he realizes the above incidents might be coincidental, however it was a published fact that SIRHANS car was found on Alexandria. Further the time is relative (12-25pm) wherein it would be conveivable that these might have been fleeing the shooting scene. In any event, he felt it should be reported.

C was advised his call would be made a matter of record.
