Mrs. RACHEL WHITE, South 2503 Teko, Spokane, Washington, furnished the following information:

WHITE advised that during the summer she is residing with her parents, Mr. and Mrs. HOWARD FOSTER, South 2503 Teko, Spokane, Washington, while her husband is working in Milton-Freewater, Oregon. She stated that during the school year she and her husband reside at 12D South Fairway. Pullman, Washington.

WHITE stated that on August 13, 1968, she and her sister-in-law, BONNIE WHITE, were returning from Milton-Freewater, Oregon, en route to Spokane, Washington. She stated that as they left Walla Walla, Washington, at approximately 11:30 PM, they observed a young man beside the road hitchhiking in the direction of Spokane, Washington. She stated that they felt sorry for the young man due to the time of night and decided to pick him up. The man gave his name as PHILLIP ETHRIDGE, age 19, and stated that he had come from Alaska and was on his way to Coeur d'Alene, Idaho. He stated that he had been hitchhiking and as he had no place to sleep in Walla Walla, Washington, decided to keep going en route to Coeur d'Alene, Idaho.

WHITE stated that ETHRIDGE got into the back seat of the 1967 Chevrolet two-door hardtop, and sat behind BONNIE WHITE who was sitting on the passenger side of the front seat. WHITE stated that the vehicle in which she was driving belongs to her father, Mr. HOWARD FOSTER.

WHITE stated that at the time ETHRIDGE got into the vehicle, he had only a small creme-colored suitcase. She stated that she did not observe how he was dressed.

WHITE stated that as they proceeded toward Colfax, Washington, ETHRIDGE twice asked how far it was to Spokane, Washington. She stated that at approximately 15 miles from Colfax, Washington, he asked how far it was. She sated that this time BONNIE WHITE was dozing, and after telling ETHRIDGE that it was approximately 15 miles, she

heard him moving around in the back seat and assumed that he was getting in a more comfortable position.

She stated that approximately three miles from Colfax, Washington, he again asked how far it was. She once again told him that it was about three miles to Colfax and from there about an hours drive to Spokane. WHITE stated that at this time ETHRIDGE informed them that he had a gun pointed at BONNIE's head and that he was naked and if either girl looked back he would shoot. He told RACHEL WHITE to continue driving. WHITE stated that he did not tell her where to drive and so when she reached Colfax, Washington, she turned towards Pullman, Washington, instead of going toward Spokane. She stated that the reason she turned toward Pullman was that the traffic is usually heavier between Pullman and Colfax and there are more farm houses between Pullman and Colfax than there are between Colfax and Spokane.

WHITE stated that while going through Colfax, Washington, they observed a Colfax policeman and this seemed to make ETHRIDGE extremely nervous. He attempted to cover himself up and keep low as to not be observed. She stated that he also did not notice as they went through Colfax, Washington, that they were proceeding toward Pullman instead of Spokane. She sated that when he was aware that they were going toward Pullman it did not seem to upset him.

WHITE stated that after ETHRIDGE informed that he had a gun, he made several statements to convince them of his seriousness and, it seemed, to build up his own ego. WHITE stated that he informed them that he had killed two policeman and had wounded more men. WHITE stated that she asked him if he did this to everyone that gave him a ride and he informed her that it had just been men in the past that had given him trouble and that he didn't like to kill women. WHITE stated that he then asked them if they had heard of the KENNEDY assassination and the killing of MARTIN LUTHER KING. WHITE stated that they informed that they had informed him that they had and he then stated that he had been in on those killings and so he was not afraid to use a gun.

WHITE stated that as they proceeded toward Pullman, Washington, ETHRIDGE informed them that he was going to have

them undress and take their car and their money. ETHRIDGE emphasized the fact that he was not going to in any way molest either of them.

WHITE stated that outside Colfax, Washington, they passed a dirt road and at this time he ordered her to stop the vehicle and back up. She stated that she told him that she could not back up and then he informed her to turn around. WHITE stated that she turned the vehicle around and headed back toward Colfax, Washington. As they passed a road, now known to her as the Albion Road, he told her to turn. She stated that they drove about five miles up the road away from the highway at which time he ordered her to stop the vehicle.

WHITE stated that ETHRIDGE told her to get out of the vehicle and go to the left side of the road. She stated that ETHRIDGE then got out on the same side of the vehicle, the driver's side. He told BONNIE not to look but at this time BONNIE turned around to see what was happening and he then ordered her to get out of the vehicle on the driver's side of the car. Both girls were told to cross the road while ETHRIDGE stayed by the car. He then told them to undress. WHITE stated that they did as they were told and while undressing she noticed that ETHRIDGE had a gun in one hand and had a pair of dark pants on but did not have a shirt on. She stated she did not observe whether he had shoes on.

WHITE stated that after undressing, he then ordered the girls to leave their clothes where they had piled them on the side of the road and to walk in the direction of what is now known to them to be Albion. She stated that the car had been left running and the headlights were left on. She stated that they walked away from the vehicle until they were out of sight of the car headlights and then moved off the road in to the ditch where they stopped walking and sat down in an area which was hidden from the road. WHITE stated that at no time had ETHRIDGE made any advances whatsoever toward either girl. She stated that at the time they had undressed and were walking down the road, she looked at her watch and it was 2:30 AM. August 14, 1968.

WHITE stated that she and BONNIE remained in the side ditch for approximately ten minutes and didn't hear any sounds coming from the direction of the car. She stated

that she then heard what they thought was the trunk being closed and a short time after that the vehicle moved in their direction. She stated that ETHRIDGE drove past them and did not appear to notice either girl hiding in the ditch. She stated that he proceeded in the direction of Albion, Washington, and this is the last time that she had seen either ETHRIDGE or the vehicle.

WHITE stated that after ETHRIDGE drove past she and BONNIE proceeded down the road toward the Colfax Pullman Highway. She stated that they observed a road leading off the Albion Road and followed it to a farm house, reaching the farm house at approximately 3:00 AM. She stated that they knocked on the door until the people of the house answered. She stated that they were given clothing and the farmer called the Whitman County Sheriff's Office and reported the incident. A short time later Deputy BERT EATON of the Whitman County Sheriff's Office came to the farm house and began investigation of the incident.

WHITE furnished the following description of the individual known to her as PHILLIPETHRIDGE.

Date August 16, 1968

Miss BONNIE LOUISE WHITE, 1303 South Crestline, Spokane, Washington, furnished the following information:

WHITE adviced that on August 13, 1968, she and her sister-in-law, RACHEL WHITE, were returning from Milton Freewater, Oregon, to Spokane, Washington. She stated that at approximately 11:30 PM they left Walla Walla, Washington, and observed a man standing on the side of the road hitchhiking near what is known as the Bacon Road. WHITE stated that she has hitchhiked before and therefore understands that it is hard to get a ride, especially late at night, and therefore they decided to offer assistance to the individual hitchhiking. She stated that the man got into the back seat of the vehicle and told them that his name was PHILLIP ETHRIDGE and that he was 19 years of age. She stated that when he entered the car he had with him a small creme-colored suitcase.

WHITE stated that ETHRIDGE told them that he was going from Alaska to Coeur d'Alene, Idaho, where he had employment in a lime plant.

WHITE stated that as they proceeded toward Colfax, Washington, she was dozing in the front seat of the car but she heard the man ask RACHEL several times how far it was to Spokane, Washington. She stated that she also heard some moving in the back seat of the car but did not think anything of it. She stated that she then heard the man state that he had a gun at the back of her head and was naked and if either girl looked back he would shoot. WHITE stated that this was a short distance outside Colfax, Washington.

WHITE stated that as they proceeded to Colfax, Washington, the man made several statements which seemed to be an attempt to scare them and to build up his own confidence. She stated that he told them that he had killed two policemen and had wounded other men. She stated that he also asked them if they had heard of the KENNEDY assassination

and the killing of MARTIN LUTHER KING. WHITE stated that they informed him that they had and he then told them that he had participated in the killing of these individuals and was therefore not afraid to use a gun. WHITE stated that she then asked him what kind of a gun he had, and he told them that it was a .36 Mauser which was larger than a policeman's gun and had a hairpin trigger.

WHITE stated that when they went through Colfax, Washington, they observed a policeman's car and this seemed to frighten ETHRIDGE a lot. She stated that he attempted to get out of sight and to hide in the back seat. She stated as they proceeded through Colfax, and toward Pullman, Washington, he emphasized the fact that he did not intend to molest either girl but was going to have them undress, take ther car, and their money.

WHITE stated that following the man informing them that he had a gun pointed at her head, she heard some noise coming from the back seat that sounded like he was loading the gun, and possibly opening his suitcase which was on the seat beside him. She stated that he had warned them not to look back so she could not observe what was going on in the back seat.

WHITE stated that outside of Colfax, Washington, ETHRIDGE told RACHEL to stop after they passed a dirt road. RACHEL stopped the vehicle and turned around and proceeded back toward Colfax, Washington. When they passed a road leading toward what is now known as Albion, Washington, he informed RACHEL to turn up the road. WHITE stated that they proceeded down the road three or four miles at which time he informed RACHEL to stop the vehicle. He then informed RACHEL to get out of the vehicle and walk to the other side of the road. WHITE stated that the man told her not to look but at this time she had decided to look as the man obviously was going to use the gun on them or abandon them in the She stated that she turned around to see what was going on and at that time he ordered ther to get out of the vehicle, and join RACHEL on the other side of the road. She stated that he stood beside the vehicle and told both girls to undress. WHITE advised that they did as he ordered and he then told them to proceed down the highway. stated that they walked away from the car toward Albion, Washington, until they were out of sight of the vehicle,

at which time they left the road and hid in the ditch beside the road. She stated that they stayed in the ditch for over ten minutes and during that period of time they heard what they decided was the trunk of the vehicle being closed.

WHITE stated that after ten to fifteen minutes the vehicle passed them and proceeded toward Albion, Washington. She stated that after ETHRIDGE drove past them they then got back on the road and proceeded to the Pullman-Colfax Highway. She stated that when they found a road leading off the Albion Highway up to a farm house, they proceeded to the farm house, beat on the door until they got the people of the house up, and informed them of what had happened. She stated that this was at approximately 3:00 AM. The people of the house gave them clothing and notified the Whitman County Sheriff's Office.

WHITE furnished the following description of the individual known to her as PHILLIP ETHRIDGE:

DANIEL JOHN CURTYN, 236 Seventh Street, Jersey City, New Jersey, was interviewed and furnished the following information:

CURTIN advised that in June, 1968, he was a full-time student, majoring in psychology, at Southwest College, Imperial and Western Boulevard, Los Angeles, California, during the time preceding the California Primary. He was a supporter and workor in the campaign of Senator ROBERT F. KENNEDY. On election day, June 4, 1968, he was engaged during the greater part of the day in transporting voters to the polls. At approximately 8:00 P. M. he went to the Ambassador Hotel to take part in a KENNEDY victory party for the press and campaign workers.

CURTIN stated that at twelve midnight he was in the ballroom of the Ambassador Hotel, when Senator KENNEDY delivered his victory speech. CURTIN said that his location during the speech was to the right front of the podium approximately three feet from Senator KENNEDY. This location is as he was facing the podium. CURTIN said that Senator KENNEDY's speech lasted approximately nine to ten minutes, and at the conclusion of the speech he (CURTIN) engaged in jubliant shouting with the rest of the individuals in the ballroom.

CORTIN advised that at the end of the speech Senator KENNEDY turned and proceeded through the curtains at the rear of the podium into an antercom. EMTIN stated that he then climbed over the podium and followed the crowd as it was surging after Senator KENNEDY. He stated that he was caught up in the movement of the crowd and proceeded through the antercom into a corridor and then turned right and proceeded toward the kitchen area. CURTIN stated that he did not actually see Senator KENNEDY throughout the entire time that the group was moving through the antercom into the corridor but caught intermittent glances of Senator KENNEDY through the moving crowd. CURTIN stated that the procession moved through swinging doors into a pantry area, and at the time he was approximately 15 feet behind Senator KENNEDY. CURTIN said that as he was about to go through the swinging doors he heard one loud report followed by two other loud reports in quick succession. CURTIN

said that he then jumped quickly through the swinging doors and observed Senator KENNEDY falling to the floor in the pantry corridor.

CURTIN stated that the crowd of people immediately behind Senator KENNEDY seemed to suddenly open, enabling him to lunge to the side of Senator KENNEDY as he fell to the floor. CURTIN stated that Senator KENNEDY fell to his right and threw his right arm up in the air as if to grasp the right side of his head.

CLETIN advised that he was one of the very first, if not the first person, to reach Senstor KENNEDY, and he immediately handed Senstor KENNEDY a string of rosary beads. CLETIN and KENNEDY clutched the beads as CLETIN placed his lips near KENNEDY's ear and began an Act of Contrition prayer.

C RTIN stated that mass confusion in the area occurred at this time, and he recalled hearing various individuals
around him screaming, and asking him if he was a priest. CURTIN
stated that at this point after being over Senator KENNEDY for
approximately a minute an unknown man helped him to his feet
and told him that he had done all that could be done. This individual helped CURTIN a few feet away and at this point Mrs.
ETHEL KENNEDY and her sister had arrived at KENNEDY's side.

CURTIN stated that it was at this time that he observed ROSIE GREER and several other individuals holding a person later determined to be SIRHAN SIRHAN in the area of the bins several feet down the corridor from KENNEDY's location. CURTIN stated that the surging crowd was screaming and trying to get to SIRHAN, but GREER and others were protecting SIRHAN from the crowd, and at the same time they were trying to subdue him.

CURTIN said that he did not observe the shots being fired, and as he was leaning over Senator KENNEDY, KENNEDY appeared as if he was starting to say something, but if anything was actually said, the noise of the crowd prevented CURTIN from understanding it.

CURTIN stated that during the next few minutes he was in a state of near shock but recalls the press and television commentators around him asking questions and following him wherever he went in the cogridor.

At this time an individual who identified himself as STU BLOCK came to CURTIN's assistance and took him upstairs is the hotel away from the press and television commentators. CURTIN stated that BLOCK told him that he was from fine Diego and was a member of the EKHNEDY staff. While upstairs in the hotel, CURTIN was also assisted by STEPHEN SMITH, a EKHNEDY staff member.

Reurairtel 8-22-68. You may advise the Los Angeles Police Department of the following information.

Turner entered on duty in the FBI as a Special Agent on February 5, 1951, in Grade GS-10. He was dismissed effective July 19, 1961, being then in Grade GS-12. Among the charges on which his dismissal was based were that he had demonstrated through various untrue or unjustified statements that he lacked the truthfulness, accuracy, and responsibility required of an FBI Agent, and that he had shown a poor attitude toward the FBI and its Director.

Turner appealed the dismissal to the U. S. Civil Service Commission and was given a hearing. The Commission's Appeals Examining Office in Washington, D. C., sustained his dismissal on December 20, 1961. Turner appealed this decision to the Civil Service Commission Board of Appeals and Review and that Board sustained the dismissal. He then filed a civil action in the U. S. District Court, District of Columbia, seeking reinstatement. The Court denied his motion for summary judgment on May 20, 1963, and granted the Government's motion for summary judgment. Turner appealed to the U. S. Court of Appeals of the District of Columbia Circuit. A three-judge panel affirmed his dismissal April 2, 1964. He then petitioned for a rehearing by the full bench of the Circuit Court and the full bench denied his petition May 20, 1964. Finally, he petitioned to the U. S. Supreme Court for a writ of certiorari and this was denied November 9, 1964.

Throughout the proceedings against him, and even before they began,
Turner addressed numerous pleas to members of Congress and other high
officials. After the failure of his efforts in the courts he resorted to the radio and
the press in a continuing campaign to vilify the FBI and Mr. Hoover. His

vitriolic articles have appeared in such publications as "Saga," "The Nation," "Playboy," and "Ramparts." He has allied himself with New Orleans District Attorney Jim Garrison's campaign to prove that President Kennedy's assassination was the result of a highly organized plot and not the work of one man (Lee Harvey Oswald) acting alone. Turner's recent book, "The Police Establishment," criticizes law enforcement.

Turner was a candidate for the Democratic nomination for Congress in the 6th District in California in 1968 and lost in the primary. He is 41 and married, residing in Mill Valley, California. LEWIS, Administrative Dean of Students Personnel Services, Pasadena City College (PCC), on June 17, 1968 advised there was an Iranian student who attended PCC in 1961 and 1962 who was extremely attractive in figure, being quite petite. She had no idea whether or not SIRHAN knew this girl, but furnished the following information concerning her:

Mr. HENRY SCHEPPS, 1121 Palm Terrace, Pasadena, California, on June 21, 1958, advised he is the owner of the apartment at 999 Palm Terrace and that Mr. WALTER E. STEINER resided at 9992 Palm Terrace for approximately two years. He stated STEINER left his apartment on February 1, 1968, and believed by him to be living in Downey, California.

Mr. SCHEPPS stated STEINER is employed by the Ios Angeles County Probation Department and works at the County facility at Downey. He advised that STEINER was formerly a student at Pasadena City College and resided with "Latin Type" male prior to leaving the apartment. He said FARIDEH MONGHATE was always a mystery to him and he believed MONGHATE was in Iran. Mr. SCHEPPS advised that MONGHATE went to Iran approximately six or seven months prior to the time STEINER left his apartment and to the best of his knowledge, was still in Iran at the time STEINER vacated the apartment. SCHEPPS stated he was positive MONGHATE was in Iran since he is a stamp collector and STEINER would give him all the stamps from MONGHATE's letters. He stated he would tease STEINER about the fact that MONGHATE would not come back to the United States. SCHEPPS stated he never knew MONGHATE and STEINER to be married and believes STEINER always referred to MONGHATE as his girl friend. He said MONGHATE never resided at 9992 Palm Terrace and he never saw her at the apartment over four or five times in the two years STEINER resided there. He stated he frequents the apartments two or three times a week since it is so close to his residence and because there was always something to do. said he recalled that on a few occasions STEINER did say he was planning to marry MONGHATE.

SCHEPPS advised he considered STEINER a good tenant and a fine fellow. He stated STEINER had many guests at the apartment and he believes they were mainly friends from Pasadena City College. He said STEINER never discussed

STRING advised that while at PCC he cannot recall seeing SIRHAN SIRHAN nor does he believe SIRHAN SIRHAN is known to have associated within the group which he and INCOLMED kept while at this school.

She advised MONGHATE worked for her from October October 27, 1964 through June 18, 1966.

Miss MARY MEGERDICHIAN, Owner-operator of Maries Coiffures, 7705 Santa Monica Boulevard, Hollywood, California, on June 25, 1968, advised that FARIDEH MONGHATE worked for her from January 1, 1967, through May 24, 1967, at which time MONGHATE reportedly returned to Iran to visit her family. Miss MEGERDICHIAN stated she does not know if and when MONGHATE returned to the United States.

She advised she knew WALTER STRINER as MONGHATE's boy friend but did not know them to be married. She stated MONGHATE is an exceptionally fine person and never known, to MEGERDICHIAN to be interested or to take an active part in politics.

MONGHATE stated she attended Montebello High School from September, 1957 through December, 1961. She stated while in high school she lived with the KATMAN family at 649 Markland Drive, Monterey Park, California. She stated upon completing high school she entered Pasadena City College and attended that school until May, 1963. She advised while attending Pasadena City College, she lived in various apartments in the Pasadena area.

MONGHATE advised after she completed her courses at Pasadana City College she entered the Hollywood College of Beauty and she took a nine to ten month beauty course. She stated once she received her beauticians license she worked for CHRISTYN BIIDEN at Arlene's Beauty Shop, 8022 West Sixth Street, Los Angeles, California, for approximately two years during which time she lived in various apartment houses in the Hollywood area. "She advised she left BILDEN because of personal reasons and because" the working arrangements were not the best as far as she was concerned.

MONGHATE claimed to have married WALTER E. STEINER, JR. on June 5, 1966 and to have resided with STEINER at 9992 Palm Terrace, Pasadena, California from the time, of her marriage until she was returned to IRAN in July, 1967. She stated after she left BILDEN she worked for MARY MAGERDICHIAN at Marie's Coiffures, 7705 Santa Monica Boulevard for approximately six to seven months prior to going to IRAN to visit her parents in July, 1967, and returned to the United States February 15, 1968.

She advised upon returning to the United States she had been working for Ama. Katcher's House of Beauty, 6111 Wilshire Bouleard, Los Angeles and living at her present address. She advised she is presently residing with VIDA BADIES.

BEVANS inquired regarding the fact that both she and Miss BADIEE were using their maiden names and living at 1517 North Fuller, while their "husbands" STEINER and VAN RAALTEN are both living together at Apartment 10, 932 Maltman Avenue, Los Angeles, California.

MONGHATE stated she and STEINER had a falling out just prior to her going to Iran in July, 1967, and that they were not divorced and just were separated on a temporary basis. SA BEVANS asked MONGHATE if her and Miss BADILE's relations were not just "marriage of convenience" in order to satisfy immigration requirements at which time she stated that the relations were not made just to satisfy the immigration requirements.

She advised Immigration and Naturalization Service requirement was not a factor in her marrying STEINER since they planned to marry, but it was a time factor causing them to marry sooner than they had planned.

MCNGHATE stated she cannot recall meeting SIRHAN SIRHAN while at Pasadena City College nor did she belong to any political groups or associations while attending the college. She stated she has never had any connections with the Students for a Democratic Society (SDS) or the W. E. B. Du Bois Clubs or to the best of her knowledge does she know anyone connected with either of these groups. She stated that Iranians do not consider themselves Arabs and therefore she would not have anything in common with SIRHAN SIRHAN nor the other Arab students attending Pasadena City College. She believes in good government but has not been active in any American politics while residing in this country. She stated on June 4, 1968, she worked until approximately 6:00 P.M. and stayed home the rest of the evening.

The following investigation was conducted at Pasadena, Cdalifornia by SA POWELL:

On 8/2/68 BOB MEDIMA, manager of the jewelry and photography counter at Lucky Discount Store, 488 East Villa, advised that he has been manager of this counter since July 11, 1968. MR. MEDINA checked his records of all film processed from his counter in 1968 without locating any record of any film ever having been deposited there by anyone named SIRHAN. Records prior to 1968 would be maintained by the main office, APCO Inc., P. O. Box 20, Fullerton, California 92632, phone (714) 526-6686. There were/customers with a \$10 - \$12 weekly volume.

He further advised that HENRY A. ETIERE, 1072 No. Lake, Pasadena, a watchmaker, formerly operated the concession there. Possibly SERGE ETIENNE is related to him.

On 8/5/68 MR. HENRY ETIEME, supra, advised he operated the above concession prior to May 196%. His son, SERGE ETIEVNE, worked there with him and then also worked there part time for a few weeks after MR. ETIENNE gave up the concession. MR. ETIENNE was unable to recall anyone named SIRHAN as a customer of the counter. He stated that he knew very few names of customers, but if there had been a customer who had a volume of photography business in the range of \$10 to \$12 per week, his name would be at least familiar. He viewed photographsof the SIRHAN family at was unable to recall any of them as anyone he had seen in them past.

MR. ETIENNE advised he is certain his son would be fully cooperative. He lives in Highland Park and works in the maintainance shop of Lowry's, 568 San Fernando Road, but he doesnot know his address.

Inasmuch as there appears to be no basis in RECOMMENDATION: fact to the information furnished by MARGARET SCOTT, no further action is felt warranted. Jan Jan 1435914

## APPENDIX

## W. E. B. DU BOIS CLUBS OF AMERICA (DCA)

A source advised that on October 26-27, 1963, a conference of members of the Communist Party, USA (CPUSA), including national functionaries, met in Chicago, Illinois, for the purpose of setting in motion forces for the establishment of a new national Marxist-oriented youth organization which would hunt for the most peaceful transition to socialism. The delegates were told that it would be reasonable to assume that the young socialists attracted into this new organization would eventually pass into the CP itself.

A second source has advised that the founding convention for the new youth organization was held from June 19-21, 1964, at 150 Golden Gate Avenue, San Francisco, California, at which time the name W.E.B. Du Bois Clubs of America (DCA) was adopted. Approximately 500 delegates from throughout the United States attended this convention.

The second source advised in September, 1966, that Mike Zagarell, CPUSA Youth Director, stated that in Negro communities the Party still supported the plan to build "left" socialist centers and to solidify the Party base through the DCA. This source also advised in September, 1966; that Daniel Rubin, CPUSA National Organizational Secretary, stated the Party believes the DCA should have a working-class outlook and be a mass organization favorable to socialism, socialist countries and Marxism, and in April, 1967, advised that Gus Hall, CPUSA General Secretary, indicated the DCA primary emphasis should be on developing mass resistance to the draft.

A third source advised in September, 1967, that Jarvis Tyner was elected chairman of the DCA on September 10, 1967, at the Third National Convention of the DCA held in New York, New York, from September 8-10, 1967.

A fourth source advised during August, 1967, that Jarvis Tyner is a member of the National Committee of the CPUSA.

A fifth source advised on September 21, 1967, that the headquarters of the DCA is located at 34 West 17th Street, New York, New York.

CIA advised through Bureau liaison that ix June. 1968, a reliable source discussed with Simon Malley the assassination of Senator Robert Kennedy. According to CIA's source, Malley said the assassination had been perpetrated "by the American Red Hand," as had the assassinations of President Kennedy and Martin Luther King. The source said he told Malley this theory was ridiculous but Malley insisted it was true. CIA advised that arrangments could be made to interview source through Domestic Operations Division Office of CIA in New York City.

New York arrange through CIA to interview source and furnish results to Bureau and Los Angeles for inclusion in next investigative report in captioned matter.

No interview with Malley is desired. For information of Los Angeles, Malley is an accredited UN correspondent for a French language weekly publication and is a U.S. citizen of Egyptian origin. Bufiles reveal he has an unreliable reputation, possesses a "spy" complex and is prone to write half-truths. He has openly attacked the U.S. in his writings.

Mr. JAMES E. SMIZH telephonically advised that he had just returned from Australia and had learned through a friend that the FBI in Los Angeles had indicated an interest in talking to him. SMITH stated that he holds dual citizenship in the United States and Australia and at the time of this assassination was working for the campaign of Senator ROBERT F. KENNEDY. He advised that he did not witness the actual shooting, and at the approximate time of the assassination he was just about to enter the Ambassador Hotel.

According to SMITH, he determined that the FBI was interested in talking with him from a female acquaintance of his, Miss JOAN HULL of Los Angeles, California, who has already been questioned by the FBI. SMITH said that he did not know SIRHAN SIRHAN and did not believe he could furnish any information concerning the assassination; however, he indicated he wanted to cooperate with the FBI in any way he could.

At the present time he is residing at the Fox Plaza, Room 2715, San Francisco, telephone number 621-9848. He is currently unemployed.
