Enclosed for the Bureau are six copies of a letterhead memorandum setting forth the contemplated list of witnesses for the case in chief which the office of the Los Angeles County District Attorney anticipated using for the forthcoming trial of SIRHAN BISHARA SIRHAN.

The trial has been scheduled to commence 1/7/69, and according to Assistant Los Angeles County District Attorney DAVID FITTS, one of the three members of the prosecutive team who was contacted on 12/10/68, the names appearing in the enclosed letterhead memorandum, were included in the previous list submitted to the Bureau with the exception of the following:

FITTS also advised that on 12/10/68, a conference was held with the prosecutive staff and GRANT C. COOPER, one of SIRHAN's attorneys. During the conference it was suggested by COOPER that a polygraph examination be afforded to SIRHAN restricted to questions concerning any possible conspiratorial aspect to this investigation. COOPER suggested this with the understanding that anything obtained from such an examination would not be used against SIRHAN in his trial. Further, that anything COOPER desired to use in defense of SIRHAN at any subsequent executive clemency hearing could be used.

COOPER further suggested that the possibility of a nolle contendre plea be entered in SIRHAN's behalf with respect to the five counts he is charged with in addition to the assassination of ROBERT F. KENNEDY.

COOPER further expressed a desire for further psychiatric and/or physiological examinations of SIRHAN. He further suggested a possibility of an exchange of information with respect to the medical findings.

COOPER further submitted for consideration of the prosecutive staff a possible guilty plea in behalf of SIRHAN after the jury is selected and sworn in. This procedure would then, according to COOPER's desires, obviate the necessity of a trial to determine guilt. The jury would then merely hear evidence to determine the degree of penalty following the guilty plea.

FITTS advised further that during their conversation COOPER made reference to SIRHAN having been in Corona, California, on the Sunday preceding the assassination, 6/2/68. COOPER did not enlarge upon the allusion to the above date, nor was he questioned about it. According to FITTS, nothing has been developed to date in any investigative efforts which has possibly or suggestively placed SIRHAN in Corona, California on 6/2/68. Further, investigation by the Los Angeles Division has not placed SIRHAN in Corona, California, on that date.

On 11/12/68 telephone number 654-2205 was determined to be an unworking number.

On 11/12/68 a check failed to reflect any telephone listing for a DONALD CLARK on Kirkwood Drive in Los Angeles.

On 11/19/68 RICHARD E. TAYLOR, 8460 Colecrest Drive, Los Angeles advised that he owns the residence at 8464 Kirkwood Drive, Los Angeles. He stated that during February to June 1968 one JOHN WHITE, telephone 654-2705, resided at 8464 Kirkwood Drive and rented from him. TAYLOR stated the name DONALD CLARK is completely unknown to him and he, CLARK, has not resided at the Kirkwood address. TAYLOR stated that the description of CLARK in no way matches the description of any person known to him. TAYLOR advised WHITES's present whereabouts are unknown and there has been another male occupant rent at the Kirkwood address between June and July and at present the house is rented by two females. TAYLOR advised he has never met any one fitting CLARK's description or using the name of DONALD CLARK.

On 12/2/68, JIM FARNBERG, Manager, Employer's Clearing House Agency, Inc., 5225 Wilshire Boulevard, Los Angeles, advised that he was unable to locate any information pertaining to a DONALD CLARK. FARNBERG advised that there is nothing to indicate CLARK received employment through his agency.

On 12/2/68, MICKEY FINE, owner Mickey Fine's Pharmacy, 433 Roxbury, Beverly Hills, advised that DONALD CLARK worked for his pharmacy for two weeks in August 1967 until it was learned that CLARK was not licensed to work in a pharmacy. FINE advised he did not know the present whereabouts of CLARK.

I do herewith file criminal charges against two killers who murdered Presidential candidate Robert F. Kennedy. The names Beckmann and Beck are not their real names. Actually one of them is Mr. Sijan-Sijahm (sic), and the name of his accomplice, unfortunately, is unknown to me. Mr. Sijan-Sijahm's description is as follows: blue-gray, slit eyes, freckled face, and about 185 cm. (6'2") tall. Unfortunately, I cannot furnish you more information.

On 12/12/68, ROY KEENE made available a copy of a letter given to the Los Angeles County District Attorney's Office by Attorney GRANT C. COOPER, who represents SIRHAN BISHARA SIRHAN. A copy of this letter is attached hereto and sets forth additional information being sought by COOPER in the defense of his client.

On 12/12/68, the contents of this letter were discussed with Los Angeles County Deputy District Attorney DAVID FITTS, one of the three member prosecutive team who will prosecute SIRHAN. FITTS explained that his office was examining the information being requested by COOPER and had not, as of 12/12/68, given COOPER a reply. He stated, however, in preliminary discussion with Assistant Los Angeles County District Attorney LYNN COMPTON, it was decided that in all probability, the information being requested by COOPER would not be made available to him unless the court so ordered.

On 12/13/68, a conference was held in the office of the Deputy Chief of Police, ROBERT HOUGHTON, Los Angeles Police Department (LAPD), Detective Bureau. Present at the meeting in addition to Mr. HOUGHTON, were DAVID FITTS and JOHN HOWARD of the Los Angeles County District Attorney's Office; Captain HUGH BROWN and Lieutenant ROY KEENE of the LAPD; ROBERT L. BROSILO, Chief Criminal Deputy, Los Angeles United States Attorney's Office, and SA LA JEUNESSE.

At the meeting, the contents of the above described letter were discussed, at which time it was generally agreed upon, based upon the suggestions of FITTS and HOWARD, that none of the information requested by COOPER would be voluntarily turned over to him upon his request.

It is the intention of the Los Angeles County District Attorney's Office to abide by any court ruling with respect to the information being sought by COOPER.

Mr. FITTS explained that in all probability, COOPER could not appear before the court earlier than on or about 12/20/68 to petition the court for the information being sought by him under the California Law of Discovery. FITTS further explained that in all likelihood, Superior Court Judge HERBERT B. WALKER would rule favorably for COOPER and order the 16 items listed in the attached letter to be turned over to COOPER for the defense of SIRHAN.

In addition to the foregoing, FITTS and HOWARD advised that COOPER has discussed with their office the probability of his being indicted by Federal Grand Jury in connection with alleged activities arising out of the recent Friar's Club trial. COOPER represented one of the defendants in that trial in United States District Court. It is the contention of both HOWARD and FITTS that in the event COOPER is, in fact, indicted by Federal Grand Jury during the SIRHAN trial, that COOPER would seek and very possibly be granted a mistrial by Judge WALKER. In the event COOPER is indicted by a Federal Grand Jury prior to 1/6/69, he will in all probability withdraw as the attorney for SIRHAN. In the latter event, further proceedings against SIRHAN would in all probability be again delayed.

It was the stated intention of Mr. HOUGHTON that the LAPD would surrender no information to COOPER which they received from the FBI. His contention was that any such request or court order should be directed to the Office of the Los Angeles County District Attorney.

Mr. BROSIO, during the meeting, commented that in the event COOPER is, in fact, indicted by Federal Grand Jury, such an indictment could not possibly be accomplished prior to 12/22/68 explaining further that additional delays might be encountered since a new Federal Grand Jury would be impaneled to sit on or about that date.

9. Copies of any drawing done of the kitchen area, service pantry, Colonial Room, and Embassy Room, done for the purposes of showing the different physical locations of the fixtures and equipment located therein.
10. Access to a scale model mock-up of the kitchen area that the Prosecution intends to use in Court at the time of trial.
11. The names of all witnesses that the Prosecution intends to use at the time of trial.
12. The statements of and/or investigators' reports concerning the trainers and co-workers of Sirhan at the time he was employed at Burt Altfillisch's ranch.

TEDDY MARIE NAFIUS, 1518 Diamond Avenue, was interviewed at her residence, at which time she furnished the following information:

During April and May of 1968, she worked as a volunteer for Senator ROBERT F. KENNEDY. During this time she worked out of the campaign headquarters, which was located on Wilshire Boulevard. On the night of Senator KENNEDY'S assassination, she was at the Ambassador Hotel, however, at the time of the shooting, she was in the downstairs ballroom and not in the vicinity of Senator KENNEDY. She could furnish no information as to the circumstances surrounding the shooting.

She said that in talking with some of her friends who were also volunteers for KENNEDY, she had learned that the FBI had been attempting to identify various people who were around Senator KENNEDY at the time of the shooting. In observing some photographs in the June 14, 1968 "Time" magazine, she noticed a Jordanian, known to her as ALI AHMAD, standing on the podium near Senator KENNEDY, just prior to the time when he went into the kitchen. It appeared in the photograph that AHMAD was attempting to take photographs.

She had met AHMAD in May 1968 at a party held by the Volunteers for KENNEDY, after the Indiana Primary Election. She believed this party was on May 7, 1968, at the Ambassador Hotel. In talking with him, she learned that he was a Jordanian, that he had been in Los Angeles for two or three years, and although he was not actually working for Senator KENNEDY, he was interested in the political process in America, and that was the reason he came to the party at the Ambassador Hotel. They discussed foreign policy and various aspects of the American political scene. During this discussion, AHMAD made no comment which indicated he had any particularly militant attitudes towards any American politicians.

MIKE HEINEKE, Engineer, Microdot, 220 Pasadena, was interviewed at his place of employment at which time he furnished the following information:

He observed a photograph located on page 17 of the June 14, 1968 issue of "Time" magazine which showed ROBERT KENNEDY giving his victory speech after the California Primary Election, at the Ambassador Hotel, Los Angeles, California. In this photograph was a man who HEINEKE identified as KHALID IQBAL. It is noted that this is the same man who was pointed out by TEDDY MARIE NAFLUS at the time of her interview on November 26, 1968.

HEINEKE stated that he had known IQBAL for about nine months while he was working as an electrical engineer for Microdot at the South Pasadena Plant. He stated that IQBAL had often mentioned that he was at the Ambassador Hotel when Senator KENNEDY was shot, however, according to what he had been told by IQBAL, IQBAL did not actually see the shooting. In the course of these conversations IQBAL said that he did not know SIRHAN BISHARA SIRHAN and was not in sympathy with SIRHAN. HEINEKE stated that IQBAL was very much impressed by Senator KENNEDY and considered him to be a great man. At no time did he show any hatred of KENNEDY and in fact was very respectful and admiring. HEINEKE last saw IQBAL on about October 19, 1968 when he left Los Angeles for the Olympic Games in Mexico City. At that time it was IQBAL's intention to return to his native Pakistan and work there as an electrical engineer in the Government Program. HEINEKE said that he does not recall what city IQBAL was from. He believed it was Llyapur, Pakistan. He was not certain of the spelling of the city. To HEINEKE's knowledge, IQBAL had no intention of returning to the United States.

On 12/18/68, SIRHAN BISHARA SIRHAN reappeared in Los Angeles County Superior Court before Judge HERBERT V. WALKER. The purpose of that appearance was to include Attorney EMILE ZOLA BERMAN, of New York City, as another attorney to represent SIRHAN in his trial which is scheduled to commence on 1/5/69.

During the same appearance, Los Angeles County Deputy District Attorney JOHN HOWARD requested the court to hear the matter of sequestering the jury during the trial. HOWARD stated his objections to such sequestering and Attorney GRANT C. COOPER, also representing SIRHAN, argued in favor of a sequestered jury. Judge WALKER ruled that the jury would be sequestered during the entire trial. He further ruled that the members of the jury's family would be permitted to visit with them on weekends during the trial with usual security precaution in effect.

On 12/18/68, Lieutenant ROY KEENE, Los Angeles Police Department, SUS Unit, advised that his department has developed information indicating that SIRHAN BISHARA SIRHAN utilized the Corona, California, Police Department Pistol Range on 6/1/68. The register maintained at the range has been backed up by the Los Angeles Police Department and found to bear SIRHAN's signature. According to KEENE, investigation thusfar conducted at the range resulted in a tentative identity of SIRHAN at the range. However, that identity is somewhat tenuous and further investigation is being conducted.

In addition to the foregoing, the Los Angeles Police Department is in the process of obtaining the registers for all ranges in San Bernardino, Riverside, Orange, and Los Angeles Counties from February 1968 to 6/5/68.

The foregoing was developed and additional efforts being undertaken based upon a remark attributed to GRANT C. COOPER in the conversation some weeks ago with a member of the Los Angeles County District Attorney's Office. During that conversation, COOPER is alleged to have stated something to the effect that SIRHAN had practiced shooting three times. Inasmuch as two ranges utilized by SIRHAN have now been identified, the Los Angeles Police Department is seeking to identify the third range reportedly used by him.

KENNETH BLAY

Lieutenant KEENE also advised on 12/18/68, that his department has completed investigation regarding a check

bearing SIRHAN BISHARA SIRHAN's name which was passed in the Corona area in 1966. Information concerning this check has previously been furnished to the Bureau. It has been determined that KENNETH BLAY, a former employee of Altfillisch Horse Farm, for whom SIRHAN also worked, has admitted stealing and endorsing the checks in question, one of which was SIRHAN's.

On June 5, 1968, at 12:15 A.M., Sirhan Bishara Sirhan, at the conclusion of an election victory rally held by the late Senator Robert F. Kennedy (Democrat, New York), shot and killed Senator Kennedy while in a kitchen area leading off the Embassy Room at the Ambassador Hotel, Los Angeles, California. Sirhan utilized a .22 caliber revolver in committing this act. Sirhan is being held to answer, his trial being set for January 5, 1969, in the Los Angeles County Superior Court at Los Angeles, California.

Among the persons interviewed who were present in the Embassy Room at the Ambassador Hotel, Los Angeles, California, in the early morning hours of June 5, 1968, was Ceci Doucet, 1802 S. W. 10th Avenue, Portland, Oregon. She said on December 4, 1968, that Stus Pruszyński, of 2190 Crescent, Apartment 4, Montreal, Canada, or care of Cicero, 1248 West 24th Street, Los Angeles, California, had been present in the Embassy Room at the time of the assassination of Senator Robert F. Kennedy.

Mrs. Yolanda Chaney, 17563 Rinaldi Street, Granada Hills, California, advised on December 12, 1968, that she is the daughter of Rose Cicero, now in Spain, who owns the apartment property at 1248 West 12th Street, Los Angeles, California, where Stus Pruszyński was a former tenant in Apartment 4. She described Pruszyński as a free lance reporter and writer who did work for the Canadian newspapers "The Gazette" in Montreal and "The Star" in Toronto.

According to Mrs. Chaney, Pruszyński claimed that he was at the Ambassador Hotel, Los Angeles, California, and about fifteen feet behind Senator Robert Kennedy when Senator Kennedy was shot. Mrs. Chaney further advised that Pruszyński had claimed that he had made a tape recording during the time he was at the Ambassador Hotel. No further details were known

She is 5' 6", 125 pounds, black hair, brown eyes, Immigration and Naturalization file [REDACTED]

STOWELL stated the Immigration and Naturalization Services and Customs Bureau investigation regarding CAL indicates he has been employed in Dallas at the Curtis Mathis Company as a television technician from September, 1962, until August, 1966. He was employed at the Industrial Research Company, Dallas, from August, 1966, until December, 1966. Although his whereabouts are not known to the Customs Bureau, he has also been employed in Dallas as a waiter in various hotels.

CAL is of interest to the Customs Bureau because his brother was arrested in the State of Nebraska for smuggling marijuana, and the investigation indicates JOSE CAL rented the car his brother was driving at the time of the brother's arrest.

Investigation concerning location of photo at US Secret Service, WDC, regarding anonymous letter and the letter sent to President JOHNSON by DJURO STOKIC to date has been unsuccessful. Extensive investigation has been conducted at United States Department of State (USDS). LOUIS B. SIMS, ASAC, Secret Service, 1800 G Street, N.W., advised on 11/18/68, that the anonymous letter sent to Senator EDWARD KENNEDY on 6/11/68, had been forwarded to Legal Attache Headquarters, State Department, by their office on 8/27/68. SIMS advised that USDS has three photos in their files of DJURO STOKIC and that it would be impossible for them to state where these photos were obtained.

SIMS advised that the translation of the letter dated 6/11/68, reveals that there was a picture enclosed and that written on this photo were the words "forgive me brother TED". SIMS stated that none of the photographs contained in their files are identical with the photographs sent in the anonymous letter. He indicated that when this letter, sent to Senator EDWARD KENNEDY, was transmitted to the State Department by Secret Service, all enclosures, such as this photograph, probably were included therein.

Extensive investigation presently being conducted at USDS; however, no positive information regarding this photo has been developed. It appears that this photo, if presently in existence, is probably contained in files of Legat at Paris, France.

Re: News Article on Forged Check

An article appeared in the local press under dateline Corona, California, reflecting that the Corona, California, Police Chief advised that a forged check stolen from a construction company was cashed in a grocery store in Corona in November 1966, by a man believed to have been SIRHAN BISHARA SIRHAN.

This alleged forgery in the amount of \$81.57 was unnoticed by the store owner until contacted by the State Department of Justice. The check in question was made out in the name of SIRHAN and was endorsed in his name. Investigation by police in 1966 showed that nine blank checks had been stolen from the Altfillisch Construction Company. SIRHAN's name was typed on one of the checks and the amount filled in by a mechanical device.

On 12/9/68, BEN BIGGERS, Assistant Chief of Police, advised that the police report on this matter reflects that this concerned a forgery of the endorsement indicating that the check was actually made out to SIRHAN by the company but was stolen from him and cashed by an unknown person.

Re: News Article re Cost of Trial

Local press carried article that Los Angeles County Supervisor KENNETH HAHN suggested that Congress reimburse the County of Los Angeles for the cost associated with the trial of SIRHAN SIRHAN. He estimates the cost will exceed one million dollars.

His suggestion was contained in a letter to Senator GEORGE MURPHY, Senator-elect ALAN CRANSTON, and each member of Congress from Los Angeles County.

HAHN pointed out that Senator ROBERT KENNEDY was a Federal official running for a Federal office and the matter was of national and international concern.

Supervisor HAHN felt it unfair for the tax payer of Los Angeles County to bear this excessive cost.

Re: News Article Re Order Forbidding Discussion  
of SIRHAN Case

District Attorney EVELLE J. YOUNGER announced in the local press that his office will discontinue further legal testing of a court order forbidding persons connected with the SIRHAN case from discussing evidence outside of court.

This statement was made after the U. S. Supreme Court left standing the ban placed by Los Angeles Superior Court Judge ARTHUR L. ALACORN.

The higher court declined to hear YOUNGER's appeal of a lower court ruling sustaining Judge ALACORN's order. .
